1	A RESOLUTION urging annual training on the topic of interlocal agreements.
2	WHEREAS, the Interlocal Cooperation Act, KRS 65.210 to 65.300, has been
3	codified since 1962; and
4	WHEREAS, interlocal agreements represent a time-tested way to memorialize and
5	foster cooperation among local governments and their constituent parts; and
6	WHEREAS, interlocal agreements have provided tangible cost savings for
7	governments using them; and
8	WHEREAS, since the year 2000, the Department for Local Government has
9	reviewed more than eight hundred interlocal agreements that involve more than two
10	thousand five hundred units of government; and
11	WHEREAS, this number does not reflect interlocal agreements reviewed by the
12	Attorney General's office, which receives a substantial portion of interlocal agreements to
13	review; and
14	WHEREAS, there are one hundred twenty counties, over four hundred cities and
15	around two thousand special purpose governmental entities, with each potential
16	agreement entered into by two or more of these governments being an opportunity either
17	to effectuate the provision of governance in a more logical, effective, and regionalized
18	way, or to benefit from a more economical utilization of taxpayer funds; and
19	WHEREAS, being legal contacts, these agreements rise or fall by the precision with
20	which they are crafted; and
21	WHEREAS, while local governments and their constituent parts may remain stable
22	throughout time, officeholders and employees enter and leave office and employment by
23	various devises, and with their departure goes a certain amount of institutional
24	knowledge; and
25	WHEREAS, because of the ephemeral length of human lives and service, when
26	viewed in epochal time frames, the importance of a stable, centralized, organized, and
27	knowledgeable source of training becomes ever more important; and

WHEREAS, the most logical sources of institutional training for local government

- 2 training relating to interlocal agreements can be found in agencies already concerned with
- 3 local government best practices in general, those being, namely, the Kentucky
- 4 Department for Local Government, the Kentucky County Judge/Executive Association,
- 5 the Kentucky Association of Counties, and the Kentucky League of Cities; and
- 6 WHEREAS, while these entities provide some training related to interlocal
- 7 agreements, none offer solely-dedicated courses on the subject;
- 8 NOW, THEREFORE,
- 9 Be it resolved by the House of Representatives of the General Assembly of the
- 10 Commonwealth of Kentucky:
- → Section 1. The Kentucky Department for Local Government, the Kentucky
- 12 County Judge/Executive Association, the Kentucky Association of Counties, and the
- 13 Kentucky League of Cities are hereby urged to provide annual training to local officials
- 14 and employees through solely-dedicated courses that include instruction on the
- 15 background relating to, and benefits and best practices of entering into, interlocal
- 16 agreements. The Kentucky Department for Local Government, the Kentucky County
- 17 Judge/Executive Association, the Kentucky Association of Counties, and the Kentucky
- 18 League of Cities are furthermore urged to provide this training at least during each of
- 19 their annual conferences, but are also encouraged to provide it at other times and
- 20 locations when tangible benefits from the training may be realized.
