

1           A RESOLUTION adjourning the House of Representatives in honor and loving  
2 memory of Michael Wayne Wooden.

3           WHEREAS, Michael Wayne Wooden departed this earthly life and entered the  
4 kingdom of Heaven on September 1, 2016; and

5           WHEREAS, Michael Wooden received his Bachelors of Arts in History and  
6 Master's in Secondary Education from the University of Louisville. He also received his  
7 real estate sales associate's license; and

8           WHEREAS, Michael Wooden's career began as assistant director of the Louisville  
9 and Jefferson County Youth Commission and Department of Community Development  
10 for the Louisville Public Schools. He served as Vice President of Governmental Affairs  
11 for the Kentucky Hospital Association and Senior Public Affairs Manager for Humana,  
12 Inc. He was President of CLMS Properties, Inc., founded Wooden & Associates, Inc., and  
13 thereafter was Executive Director of the Kentucky Real Estate Commission. Michael was  
14 a member and chairman of the Louisville Downtown Management District; and

15           WHEREAS, Michael Wooden served one term in the Kentucky House of  
16 Representatives representing the 36th District from 1975 through 1976, during which he  
17 was a member of the Health and Welfare Committee, Cities Committee, Education  
18 Committee, and Kentucky Privacy Commission. He was District 6 board member on the  
19 Jefferson County Board of Education from 1979 through 1989, and served as its chair in  
20 1980 and 1986. Michael was appointed a member of the City of Louisville Board of  
21 Aldermen in 1990; and

22           WHEREAS, Michael Wooden was active in his community, receiving many awards  
23 recognizing his accomplishments in education, health care, arts, and civic affairs. Among  
24 his most notable accomplishments, he was a member of the Board of Directors of Music  
25 Theater Louisville from 1995 through 2003, during which he helped restructure the  
26 organization and ensured the vitality of outdoor musical theater and its importance to the  
27 city's arts heritage. Michael was founder of the Highland Park Concerned Citizens

1 Council and a member of the Kentucky Tomorrow Commission, and he served on the  
2 boards of directors for the Home of the Innocents, the Kentucky Chapter of the Leukemia  
3 and Lymphoma Society, and the national Leukemia and Lymphoma Society of America.  
4 He was a member of the Churchill Downs and Breeders' Cup Host Program and a  
5 graduate of Leadership Kentucky; and

6 WHEREAS, Michael Wooden was a lifelong New York Yankees fan, loved  
7 baseball and golf, and cheered for University of Louisville sports. His greatest fanfare  
8 was reserved for his wife of 26 years, his cherished Cecelia, and for his children,  
9 grandchildren, brothers, and other family and friends; and

10 WHEREAS, in addition to his wife, Michael Wooden is survived by his daughter,  
11 Kelly M. Redmon and her husband, Daniel; son, Kenton M. Wooden and his wife,  
12 Elizabeth; grandchildren Mikayla K. Spitler, Liam M. Wooden, Eliza Kate Wooden, and  
13 Ryan Robert Redmon; brothers Charles "Terry" Wooden and Martin A. Wooden and his  
14 wife, Jane; and nephews Benjamin and Caleb Henning and nieces Janette and Jessie  
15 Gayle Henning. He was preceded in death by his parents, Noah and Laura Wooden, and  
16 brother, Robert Wooden; and

17 WHEREAS, this honorable body recognizes the many accomplishments of its  
18 former member, the Gentleman from Jefferson 36, Michael Wayne Wooden, applauds  
19 him for his service to Louisville and the Commonwealth, and stands in solemn mourning  
20 upon his passing;

22 ***Be it resolved by the House of Representatives of the General Assembly of the***  
23 ***Commonwealth of Kentucky:***
