6	for the New York Yankees. On the advice of Jackie Robinson, he chose to attend college,
7	first at the University of Southern California and then at Michigan State University; and
8	WHEREAS, Matt Snorton was a standout football player at Michigan State
9	University, and after college he was drafted by both the Detroit Lions and the Denver
10	Broncos. He chose to play for the Broncos, but his professional career was cut short by an
11	injury; and
12	WHEREAS, Matt Snorton worked for the Ford Motor Company and was vice
13	president of the First National Bank of Chicago; and
14	WHEREAS, although he lived in many different cities in the United States, Matt
15	Snorton always returned to Hopkinsville, and his contributions to that city and to
16	Christian County are many. He served as the coordinator of emergency and disaster relief
17	for 16 years, helping the community through major floods, tornadoes, and ice storms. In
18	2006 he was the recipient of the W.W. Bill Bryan Award from the Pennyrile Area
19	Development District, and in 2009 he received an award for exemplary service from the
20	Commonwealth of Kentucky for his work during the 2009 ice storm; and
21	WHEREAS, Matt Snorton departed this earthly life and entered into the kingdom of
22	Heaven on December 30, 2016, leaving his family, friends, and all those whose lives he
23	touched in solemn mourning; and
24	WHEREAS, Matt Snorton was preceded in death by his son, Roy Snorton. He is
25	survived by his daughters, Shannon and Hollis Snorton; sisters, Margie and Mary;
26	brother, Eric; grandson, Clayton Cunningham; and a host of other family members,
27	friends, and loved ones who will dearly miss his presence in their lives;
