

1 A RESOLUTION adjourning the House of Representatives in honor and loving
2 memory of William Stewart "Billy" Singer.

3 WHEREAS, Billy Singer was born on November 14, 1929, the cherished son of the
4 late Tilford Stewart and Ruth Cooper Osborne Singer; and

5 WHEREAS, Billy Singer was a proud veteran of the United States Army, serving
6 two years in a MASH unit stationed in Germany during the Korean War; and

7 WHEREAS, a beloved seventh-generation resident of Scott County, Billy Singer
8 was a member and president of the John Scott Chapter of the Sons of the American
9 Revolution. A lover of history, he served on the Kentucky Historic Preservation Review
10 Board and the Kentucky Historic Advisory Commission for 25 years; and

11 WHEREAS, always active in state politics and a man unafraid to follow his own
12 way politically, he was also involved in his children's education, serving as the Garth
13 PTA president and the president of the Scott County High School Band Boosters; and

14 WHEREAS, Billy Singer was a founding member of Northside Christian Church, a
15 onetime member of the Georgetown Church of Christ, and at the time of his death was a
16 member of Royal Springs Baptist Church; and

17 WHEREAS, William Stewart "Billy" Singer departed this earthly life and entered
18 into the kingdom of Heaven on February 11, 2017, leaving his family, friends, and all
19 those whose lives he touched in solemn mourning; and

20 WHEREAS, Billy Singer is survived by his wife of 55 years, Marilyn Louise
21 Francis Singer; children, Polly Suzannah Singer-Eardley and her husband, Keith, William
22 Dwight Jon Singer and his wife, Mary Robey, and David Mark Singer; grandchildren,
23 William Beckham Osborne Singer, Henry Barkley Covington Singer, Emmaline Ruth
24 Singer, Elizabeth Agatha Singer, and Benjamin Gray Singer; and a host of other family
25 members, friends, and loved ones who will dearly miss his presence in their lives;
