

1 AN ACT relating to gubernatorial appointments and declaring an emergency.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 63.080 is amended to read as follows:

4 (1) Except as provided in subsection (2) of this section and otherwise provided by law,
5 any person appointed by the Governor, either with or without the advice and
6 consent of the Senate, may be removed from office by the Governor for any cause
7 the Governor deems sufficient, by an order of the Governor entered in the executive
8 journal removing the officer.

9 (2) **(a) Except as provided in subsections (3) and (4) of this section,** members of the
10 board of trustees of the University of Kentucky, the board of trustees of the
11 University of Louisville, members of the board of regents respectively of
12 Eastern Kentucky University, Western Kentucky University, Morehead State
13 University, Kentucky State University, Northern Kentucky University, Murray
14 State University, and the Kentucky Community and Technical College
15 System~~], and members of the Kentucky Board of Education and the Council~~
16 ~~on Postsecondary Education]~~ shall not be removed except for cause.

17 **(b) Members of the Kentucky Board of Education and the Council on**
18 **Postsecondary Education shall not be removed except for cause.**

19 **(c) A member of a board of trustees or board of regents specified in paragraph**
20 **(a) of this subsection may be removed for cause as follows:**

21 **1. The Governor or the board of trustees or board of regents, as**
22 **applicable, shall notify, in writing, the member and the Council on**
23 **Postsecondary Education that the member should be removed for**
24 **cause and shall specify the conduct warranting removal;**

25 **2. The member shall have seven (7) days to voluntarily resign or to**
26 **provide evidence to the Council on Postsecondary Education that the**
27 **member's conduct does not warrant removal;**

- 1 3. Within thirty (30) days after receipt of notice from the Governor or the
2 board, the Council on Postsecondary Education shall review the
3 written notice, investigate the member and the conduct alleged to
4 support removal, and make a nonbinding recommendation, in writing,
5 to the Governor as to whether the member should be removed, a copy
6 of which shall also be provided to the Legislative Research
7 Commission;
- 8 4. The Governor shall then make a determination, in writing, whether
9 the member should be removed and shall notify the member, the
10 applicable board, the Council on Postsecondary Education, and the
11 Legislative Research Commission of the determination; and
- 12 5. If the Governor's determination is to remove the member, the
13 Governor shall remove the member by executive order, and shall
14 replace the member with a new appointment according to the
15 applicable statutes for the board of trustees or board of regents.
- 16 (d) For the purposes of this subsection, a member may be removed for cause
17 for conduct including but not limited to malfeasance, misfeasance,
18 incompetence, or gross neglect of duty.
- 19 (3) For a board specified in subsection (2)(a) of this section that is required by law to
20 have proportional representation in its membership based on residence, political
21 affiliation, gender, minority racial composition, or professional qualifications,
22 the Governor or other appointing authority may remove any member of the board
23 and replace him or her with another individual in order to bring the membership
24 into compliance with the statutory proportional representation requirement for
25 the board, provided that the Governor or other appointing authority shall:
- 26 (a) Only exercise the removal authority granted in this subsection if
27 appointment at the end of the next expiring term of a member, or at the end

- 1 of the next expiring term of members if two (2) or more members' terms
2 expire at the same time, cannot cure the deficiency in the proportional
3 representation requirement;
- 4 (b) Remove the fewest number of members necessary to bring the membership
5 into compliance with the proportional representation requirement for the
6 board;
- 7 (c) Identify the order in which the members were appointed to their current
8 terms on the board and, beginning with the most recently appointed
9 member who may be removed and replaced to bring the membership into
10 compliance with the proportional representation requirement, remove the
11 member or members according to the length of their tenure on the board,
12 without taking into account any prior term of service on the board by the
13 member;
- 14 (d) Provide any member proposed to be removed with the following:
- 15 1. Written notice, at least seven (7) days prior to the member's removal
16 from the board, stating the statutory proportional representation
17 requirement that the member does not satisfy; and
- 18 2. An opportunity during the seven (7) day notice period for the member
19 to voluntarily resign or to provide evidence to the Governor or other
20 appointing authority that the member does satisfy the proportional
21 representation requirement or that another member on the board who
22 also does not satisfy the requirement has a shorter tenure than the
23 member proposed to be removed;
- 24 (e) Replace any removed member with only those individuals who will bring the
25 board into compliance with the proportional representation requirement;
26 and
- 27 (f) Appoint any new member in the same manner as provided by law for the

1 member being removed and to fill the remainder of the removed member's
2 unexpired term.

3 (4) For a board of trustees or board of regents specified in subsection (2)(a) of this
4 section, the Governor may remove for cause all appointed members of the board
5 and replace the entire appointed membership as follows:

6 (a) The Governor shall notify, in writing, the board and the Council on
7 Postsecondary Education that the entire appointed membership of the board
8 should be removed for cause and shall specify the conduct warranting
9 removal;

10 (b) The board or its members shall have seven (7) days to voluntarily resign or
11 to provide evidence to the Council on Postsecondary Education that the
12 conduct of the board or of individual members does not warrant removal;

13 (c) Within thirty (30) days after receipt of notice from the Governor, the
14 Council on Postsecondary Education shall review the written notice,
15 investigate the board and the conduct alleged to support removal, and make
16 a nonbinding recommendation, in writing, to the Governor as to whether
17 the appointed board membership should be removed, a copy of which shall
18 also be provided to the Legislative Research Commission;

19 (d) The Governor shall then make a determination, in writing, whether the
20 entire appointed board membership should be removed and shall notify the
21 members, the Council on Postsecondary Education, and the Legislative
22 Research Commission of the determination; and

23 (e) If the Governor's determination is to remove the entire appointed
24 membership of the board, the Governor shall remove the members by
25 executive order, and shall replace the members with new appointments
26 according to the applicable statutes for the board of trustees or board or
27 regents.

1 *For the purposes of this subsection, the entire appointed membership of a board*
2 *of trustees or board of regents may be removed for cause if the board is no longer*
3 *functioning according to its statutory mandate as specified in the enabling*
4 *statutes applicable to the board, or if the board membership's conduct as a whole*
5 *constitutes malfeasance, misfeasance, incompetence, or gross neglect of duty,*
6 *such that the conduct cannot be attributed to any single member or members.*

7 ➔Section 2. KRS 164.011 is amended to read as follows:

8 (1) There is hereby created and established a Council on Postsecondary Education in
9 Kentucky as an agency, instrumentality, and political subdivision of the
10 Commonwealth and a public body corporate and politic having all powers, duties,
11 and responsibilities as are provided to it by law, appointed for a term set by law
12 pursuant to Section 23 of the Constitution of Kentucky. The council shall be
13 composed of the commissioner of education, a faculty member, a student member,
14 and thirteen (13) citizen members appointed by the Governor. The citizen members
15 shall be confirmed by the Senate under KRS 11.160, and the commissioner of
16 education shall serve as a nonvoting ex officio member. Citizen council members
17 shall be selected from a list of nominees provided to the Governor under the
18 nominating process set forth in KRS 164.005. If the General Assembly is not in
19 session at the time of the appointment, persons appointed shall serve prior to
20 confirmation, but the Governor shall seek the consent of the Senate at the next
21 regular session or at an intervening extraordinary session if the matter is included in
22 the call of the General Assembly.

23 (2) By no later than thirty (30) days after May 30, 1997, the Governor's Postsecondary
24 Education Nominating Committee shall submit nominations to the Governor as set
25 forth in KRS 164.005. On making appointments to the council, the Governor shall
26 assure broad geographical and political representation; assure equal representation
27 of the two (2) sexes, inasmuch as possible; assure no less than proportional

1 representation of the two (2) leading political parties of the Commonwealth based
2 on the state's voter registration and the political affiliation of each appointee as of
3 December 31 of the year preceding the date of his or her appointment; and assure
4 that appointments reflect the minority racial composition of the Commonwealth
5 based on the total minority racial population using the most recent census or
6 estimate data from the United States Census Bureau. If the determination of
7 proportional minority representation does not result in a whole number of
8 minority members, it shall be rounded up to the next whole number. A particular
9 political affiliation shall not be a prerequisite to appointment to the council
10 generally; however, if any person is appointed to the council that does not
11 represent either of the two (2) leading political parties of the Commonwealth, the
12 proportional representation by political affiliation requirement shall be
13 determined and satisfied based on the total number of members on the council
14 less any members not affiliated with either of the two (2) leading political parties.

15 In filling vacancies to the council, the Governor shall act so as to provide, inasmuch
16 as possible, equal representation of the two (2) sexes by appointing a member of the
17 sex that is the lesser represented at the time of the appointment. If the remaining
18 membership already has an equal number of males and females, the Governor may
19 appoint a member of either sex. No more than two (2) members of the council shall
20 hold an undergraduate degree from any one (1) Kentucky university, and no more
21 than three (3) voting members of the council shall reside in any one (1) judicial
22 district of the Kentucky Supreme Court as of the date of the appointment. However,
23 change in residency after the date of appointment shall not affect the ability to serve.

24 (3) One (1) member shall be a full-time faculty member employed at a state institution
25 of postsecondary education. The faculty member shall be appointed to a four (4)
26 year term by the Governor from a list of three (3) nominees selected and submitted
27 by majority vote of the ten (10) faculty members who serve as faculty

- 1 representatives of the boards of trustees and boards of regents of the nine (9)
2 postsecondary education institutions.
- 3 (4) One (1) member shall be enrolled as a full-time student at a state institution of
4 postsecondary education and shall be selected annually in the following manner: not
5 later than June 1 of each year the eight (8) student body presidents of the four (4)
6 year state public institutions of higher education, the two (2) student members to the
7 Kentucky Community and Technical College System, and one (1) student body
8 president representing the members of the Association of Independent Kentucky
9 Colleges and Universities shall elect by majority vote three (3) nominees to submit
10 to the Governor. From this list of nominees, the Governor shall appoint a student
11 member.
- 12 (5) In filling any vacancies, the Governor shall ensure the continuing representation
13 upon the council of the broad constituencies as set forth in subsection (2) of this
14 section. Vacancies on the council shall be filled for the unexpired term in
15 accordance with the procedures established for the original appointments.
- 16 (6) Each citizen member shall serve a term of six (6) years **unless removed by the**
17 **Governor for cause**, except the initial appointments shall be as follows:
- 18 (a) Two (2) appointments shall expire December 31, 1997;
19 (b) Three (3) appointments shall expire December 31, 1998;
20 (c) Two (2) appointments shall expire December 31, 1999;
21 (d) Two (2) appointments shall expire December 31, 2000;
22 (e) Two (2) appointments shall expire December 31, 2001; and
23 (f) Two (2) appointments shall expire December 31, 2002.
- 24 (7) Any person, other than the chief state school officer, holding either an elective or
25 appointive state office or who is a member of the governing board of any state
26 university in Kentucky, shall be ineligible for membership or appointment on the
27 council during his term.

- 1 (8) The members of the council shall elect the chair and the vice chair of the council
2 from among the council's membership, and the chair and vice chair shall serve at
3 the pleasure of the council. The vice chair shall serve as chair in the absence of the
4 chair.
- 5 (9) The council shall meet at least quarterly and at other times upon the call of the chair
6 or a majority of the council.
- 7 (10) A quorum shall be a majority of the appointive membership of the council.
- 8 (11) A quorum shall be required to organize and conduct the business of the council,
9 except that an affirmative vote of eight (8) or more appointive members of the
10 entire council shall be required to dismiss from employment the president of the
11 council, and to adopt or amend the state strategic postsecondary education agenda.
- 12 (12) New appointees to the council shall not serve more than two (2) consecutive terms.†
13 ~~Appointees after May 30, 1997, who previously served on the Council of Higher~~
14 ~~Education may serve two (2) additional full consecutive terms.‡~~
- 15 (13) New appointees to the council shall complete an orientation and education program
16 set forth in KRS 164.020(25) to be eligible for appointment to a second term.

17 ➔Section 3. KRS 164.020 is amended to read as follows:

18 The Council on Postsecondary Education in Kentucky shall:

- 19 (1) Develop and implement the strategic agenda with the advice and counsel of the
20 Strategic Committee on Postsecondary Education. The council shall provide for and
21 direct the planning process and subsequent strategic implementation plans based on
22 the strategic agenda as provided in KRS 164.0203;
- 23 (2) Revise the strategic agenda and strategic implementation plan with the advice and
24 counsel of the committee as set forth in KRS 164.004;
- 25 (3) Develop a system of public accountability related to the strategic agenda by
26 evaluating the performance and effectiveness of the state's postsecondary system.
27 The council shall prepare a report in conjunction with the accountability reporting

- 1 described in KRS 164.095, which shall be submitted to the committee, the
2 Governor, and the General Assembly by December 1 annually. This report shall
3 include a description of contributions by postsecondary institutions to the quality of
4 elementary and secondary education in the Commonwealth;
- 5 (4) Review, revise, and approve the missions of the state's universities and the
6 Kentucky Community and Technical College System. The Council on
7 Postsecondary Education shall have the final authority to determine the compliance
8 of postsecondary institutions with their academic, service, and research missions;
- 9 (5) Establish and ensure that all postsecondary institutions in Kentucky cooperatively
10 provide for an integrated system of postsecondary education. The council shall
11 guard against inappropriate and unnecessary conflict and duplication by promoting
12 transferability of credits and easy access of information among institutions;
- 13 (6) Engage in analyses and research to determine the overall needs of postsecondary
14 education and adult education in the Commonwealth;
- 15 (7) Develop plans that may be required by federal legislation. The council shall for all
16 purposes of federal legislation relating to planning be considered the "single state
17 agency" as that term may be used in federal legislation. When federal legislation
18 requires additional representation on any "single state agency," the Council on
19 Postsecondary Education shall establish advisory groups necessary to satisfy federal
20 legislative or regulatory guidelines;
- 21 (8) Determine tuition and approve the minimum qualifications for admission to the
22 state postsecondary educational system. In defining residency, the council shall
23 classify a student as having Kentucky residency if the student met the residency
24 requirements at the beginning of his or her last year in high school and enters a
25 Kentucky postsecondary education institution within two (2) years of high school
26 graduation. In determining the tuition for non-Kentucky residents, the council shall
27 consider the fees required of Kentucky students by institutions in adjoining states,

1 the resident fees charged by other states, the total actual per student cost of training
2 in the institutions for which the fees are being determined, and the ratios of
3 Kentucky students to non-Kentucky students comprising the enrollments of the
4 respective institutions, and other factors the council may in its sole discretion deem
5 pertinent;

6 (9) Devise, establish, and periodically review and revise policies to be used in making
7 recommendations to the Governor for consideration in developing
8 recommendations to the General Assembly for appropriations to the universities,
9 the Kentucky Community and Technical College System, and to support strategies
10 for persons to maintain necessary levels of literacy throughout their lifetimes
11 including but not limited to appropriations to the Kentucky Adult Education
12 Program. The council has sole discretion, with advice of the Strategic Committee on
13 Postsecondary Education and the executive officers of the postsecondary education
14 system, to devise policies that provide for allocation of funds among the universities
15 and the Kentucky Community and Technical College System;

16 (10) Lead and provide staff support for the biennial budget process as provided under
17 KRS Chapter 48, in cooperation with the committee;

18 (11) (a) Except as provided in paragraph (b) of this subsection, review and approve all
19 capital construction projects covered by KRS 45.750(1)(f), including real
20 property acquisitions, and regardless of the source of funding for projects or
21 acquisitions. Approval of capital projects and real property acquisitions shall
22 be on a basis consistent with the strategic agenda and the mission of the
23 respective universities and the Kentucky Community and Technical College
24 System.

25 (b) The organized groups that are establishing community college satellites as
26 branches of existing community colleges in the counties of Laurel, Leslie, and
27 Muhlenberg, and that have substantially obtained cash, pledges, real property,

1 or other commitments to build the satellite at no cost to the Commonwealth,
2 other than operating costs that shall be paid as part of the operating budget of
3 the main community college of which the satellite is a branch, are authorized
4 to begin construction of the satellite on or after January 1, 1998;

5 (12) Require reports from the executive officer of each institution it deems necessary for
6 the effectual performance of its duties;

7 (13) Ensure that the state postsecondary system does not unnecessarily duplicate services
8 and programs provided by private postsecondary institutions and shall promote
9 maximum cooperation between the state postsecondary system and private
10 postsecondary institutions. Receive and consider an annual report prepared by the
11 Association of Independent Kentucky Colleges and Universities stating the
12 condition of independent institutions, listing opportunities for more collaboration
13 between the state and independent institutions and other information as appropriate;

14 (14) Establish course credit, transfer, and degree components as required in KRS
15 164.2951;

16 (15) Define and approve the offering of all postsecondary education technical, associate,
17 baccalaureate, graduate, and professional degree, certificate, or diploma programs in
18 the public postsecondary education institutions. The council shall expedite wherever
19 possible the approval of requests from the Kentucky Community and Technical
20 College System board of regents relating to new certificate, diploma, technical, or
21 associate degree programs of a vocational-technical and occupational nature.
22 Without the consent of the General Assembly, the council shall not abolish or limit
23 the total enrollment of the general program offered at any community college to
24 meet the goal of reasonable access throughout the Commonwealth to a two (2) year
25 course of general studies designed for transfer to a baccalaureate program. This
26 does not restrict or limit the authority of the council, as set forth in this section, to
27 eliminate or make changes in individual programs within that general program;

- 1 (16) Eliminate, in its discretion, existing programs or make any changes in existing
2 academic programs at the state's postsecondary educational institutions, taking into
3 consideration these criteria:
- 4 (a) Consistency with the institution's mission and the strategic agenda;
 - 5 (b) Alignment with the priorities in the strategic implementation plan for
6 achieving the strategic agenda;
 - 7 (c) Elimination of unnecessary duplication of programs within and among
8 institutions; and
 - 9 (d) Efforts to create cooperative programs with other institutions through
10 traditional means, or by use of distance learning technology and electronic
11 resources, to achieve effective and efficient program delivery;
- 12 (17) Ensure the governing board and faculty of all postsecondary education institutions
13 are committed to providing instruction free of discrimination against students who
14 hold political views and opinions contrary to those of the governing board and
15 faculty;
- 16 (18) Review proposals and make recommendations to the Governor regarding the
17 establishment of new public community colleges, technical institutions, and new
18 four (4) year colleges;
- 19 (19) Postpone the approval of any new program at a state postsecondary educational
20 institution, unless the institution has met its equal educational opportunity goals, as
21 established by the council. In accordance with administrative regulations
22 promulgated by the council, those institutions not meeting the goals shall be able to
23 obtain a temporary waiver, if the institution has made substantial progress toward
24 meeting its equal educational opportunity goals;
- 25 (20) Ensure the coordination, transferability, and connectivity of technology among
26 postsecondary institutions in the Commonwealth including the development and
27 implementation of a technology plan as a component of the strategic agenda;

- 1 (21) Approve the teacher education programs in the public institutions that comply with
2 standards established by the Education Professional Standards Board pursuant to
3 KRS 161.028;
- 4 (22) Constitute the representative agency of the Commonwealth in all matters of
5 postsecondary education of a general and statewide nature which are not otherwise
6 delegated to one (1) or more institutions of postsecondary learning. The
7 responsibility may be exercised through appropriate contractual relationships with
8 individuals or agencies located within or without the Commonwealth. The authority
9 includes but is not limited to contractual arrangements for programs of research,
10 specialized training, and cultural enrichment;
- 11 (23) Maintain procedures for the approval of a designated receiver to provide for the
12 maintenance of student records of the public institutions of higher education and the
13 colleges as defined in KRS 164.945, and institutions operating pursuant to KRS
14 165A.310 which offer collegiate level courses for academic credit, which cease to
15 operate. Procedures shall include assurances that, upon proper request, subject to
16 federal and state laws and regulations, copies of student records shall be made
17 available within a reasonable length of time for a minimum fee;
- 18 (24) Monitor and transmit a report on compliance with KRS 164.351 to the director of
19 the Legislative Research Commission for distribution to the Health and Welfare
20 Committee;
- 21 (25) (a) Develop in cooperation with each public university and the Kentucky
22 Community and Technical College System a comprehensive orientation and
23 education program for new members of the council and the governing boards
24 and continuing education opportunities for all council and board members.
25 For new members of the council and institutional governing boards, the
26 council shall:
- 27 1. Ensure that the orientation and education program comprises six (6)

- 1 hours of instruction time and includes but is not limited to information
2 concerning the roles of the council and governing board members, the
3 strategic agenda and the strategic implementation plan, and the
4 respective institution's mission, budget and finances, strategic plans and
5 priorities, institutional policies and procedures, board fiduciary
6 responsibilities, legal considerations including open records and open
7 meetings requirements, ~~and~~ ethical considerations arising from board
8 membership, and the board member removal and replacement
9 provisions of Section 1 of this Act;
- 10 2. Establish delivery methods by which the orientation and education
11 program can be completed in person or electronically by new members
12 within one (1) year of their appointment or election;
- 13 3. Provide an annual report to the Governor and Legislative Research
14 Commission of those new board members who do not complete the
15 required orientation and education program; and
- 16 4. Invite governing board members of private colleges and universities
17 licensed by the Council on Postsecondary Education to participate in the
18 orientation and education program described in this subsection;
- 19 (b) Offer, in cooperation with the public universities and the Kentucky
20 Community and Technical College System, continuing education
21 opportunities for all council and governing board members; and
- 22 (c) Review and approve the orientation programs of each public university and
23 the Kentucky Community and Technical College System for their governing
24 board members to ensure that all programs and information adhere to this
25 subsection;
- 26 (26) Develop a financial reporting procedure to be used by all state postsecondary
27 education institutions to ensure uniformity of financial information available to state

- 1 agencies and the public;
- 2 (27) Select and appoint a president of the council under KRS 164.013;
- 3 (28) Employ consultants and other persons and employees as may be required for the
4 council's operations, functions, and responsibilities;
- 5 (29) Promulgate administrative regulations, in accordance with KRS Chapter 13A,
6 governing its powers, duties, and responsibilities as described in this section;
- 7 (30) Prepare and present by January 31 of each year an annual status report on
8 postsecondary education in the Commonwealth to the Governor, the Strategic
9 Committee on Postsecondary Education, and the Legislative Research Commission;
- 10 (31) Consider the role, function, and capacity of independent institutions of
11 postsecondary education in developing policies to meet the immediate and future
12 needs of the state. When it is found that independent institutions can meet state
13 needs effectively, state resources may be used to contract with or otherwise assist
14 independent institutions in meeting these needs;
- 15 (32) Create advisory groups representing the presidents, faculty, nonteaching staff, and
16 students of the public postsecondary education system and the independent colleges
17 and universities;
- 18 (33) Develop a statewide policy to promote employee and faculty development in all
19 postsecondary institutions and in state and locally operated secondary area
20 technology centers through the waiver of tuition for college credit coursework in the
21 public postsecondary education system. Any regular full-time employee of a
22 postsecondary public institution or a state or locally operated secondary area
23 technology center may, with prior administrative approval of the course offering
24 institution, take a maximum of six (6) credit hours per term at any public
25 postsecondary institution. The institution shall waive the tuition up to a maximum
26 of six (6) credit hours per term;
- 27 (34) Establish a statewide mission for adult education and develop a twenty (20) year

1 strategy, in partnership with the Kentucky Adult Education Program, under the
2 provisions of KRS 164.0203 for raising the knowledge and skills of the state's adult
3 population. The council shall:

- 4 (a) Promote coordination of programs and responsibilities linked to the issue of
5 adult education with the Kentucky Adult Education Program and with other
6 agencies and institutions;
- 7 (b) Facilitate the development of strategies to increase the knowledge and skills
8 of adults in all counties by promoting the efficient and effective coordination
9 of all available education and training resources;
- 10 (c) Lead a statewide public information and marketing campaign to convey the
11 critical nature of Kentucky's adult literacy challenge and to reach adults and
12 employers with practical information about available education and training
13 opportunities;
- 14 (d) Establish standards for adult literacy and monitor progress in achieving the
15 state's adult literacy goals, including existing standards that may have been
16 developed to meet requirements of federal law in conjunction with the
17 Collaborative Center for Literacy Development: Early Childhood through
18 Adulthood; and
- 19 (e) Administer the adult education and literacy initiative fund created under KRS
20 164.041;
- 21 (35) Participate with the Kentucky Department of Education, the Kentucky Board of
22 Education, and postsecondary education institutions to ensure that academic content
23 requirements for successful entry into postsecondary education programs are
24 aligned with high school content standards and that students who master the high
25 school academic content standards shall not need remedial courses. The council
26 shall monitor the results on an ongoing basis;
- 27 (36) Cooperate with the Kentucky Department of Education and the Education

1 Professional Standards Board in providing information sessions to selected
 2 postsecondary education content faculty and teacher educators of the high school

- 13 (5) The Governor shall make his at-large appointments so as to divide the
 14 **appointed**~~[citizen]~~ representation upon the board to reflect:
- 15 (a) **The** proportional representation of the two (2) leading political parties in the
 16 Commonwealth based on the state's voter registration **and the political**
 17 **affiliation of each appointee as of December 31 of the year preceding the**
 18 **date of his or her appointment. A particular political affiliation shall not be**
 19 **a prerequisite to appointment to the board generally; however, if any person**

7 (6) Vacancies among the appointed~~[citizen]~~ members of the board occurring by death,
 8 resignation, or any other cause, other than expiration of a term, shall be filled by
 9 appointments made by the Governor for the remainder~~[expiration]~~ of the unexpired
 10 term, subject to the qualifications set forth in this section.

11 (7) Unless specifically approved by the board of trustees under the provisions of KRS
 12 164.367, no member of the teaching or administrative staff of the university shall be
 13 directly or indirectly interested in any contract with the university for the sale of
 14 property, materials, supplies, equipment, or services, with the exception of
 15 compensation to the faculty, staff, and student members.

16 **(8) The inability of the board to hold regular meetings, to elect a chairperson**
 17 **annually, to establish a quorum, to adopt an annual budget, to set tuition rates, to**
 18 **conduct an annual evaluation of the president of the university, to carry out its**
 19 **primary function to periodically evaluate the institution's progress in**
 20 **implementing its mission, goals, and objectives to conform to the strategic**
 21 **agenda, or to otherwise perform its duties under Section 9 of this Act shall be**
 22 **cause for the Governor to remove all appointed members of the board and replace**

25 ➔Section 9. KRS 164.830 is amended to read as follows:

26 (1) The board of trustees of the University of Louisville shall constitute a body
 27 corporate, with the usual corporate powers, and shall possess all the authorities,

1 immunities, rights, privileges, and franchises usually attaching to the governing
2 bodies of Kentucky public higher educational institutions. **A majority of the voting**
3 **members of the board shall constitute a quorum for the transaction of business.**

4 Powers of the board shall include the following:

5 (a) Appointment of a president, all faculty members, and other personnel and
6 determination of the compensation, duties, and official relations of each. No
7 relative of a board of trustee member shall be employed by the university.

8 (b) Suspension or removal of the president, officers, faculty, agents, or other
9 personnel that it is authorized to appoint, except that no president, professor,
10 or teacher shall be removed except for incompetence, neglect of or refusal to
11 perform his duty, or for immoral conduct and that the removal shall be made
12 in accordance with procedures established by law for state institutions.

13 (c) Election of a **chairperson, a** vice chairperson **to act in the absence or**
14 **temporary disability of the chairperson,** and any other officers as it deems
15 wise, including the annual election of a six (6) member executive committee
16 which shall have the powers that the board delegates to it and shall operate
17 under the rules the board shall establish under its authority to make bylaws,
18 rules, and regulations consistent with this chapter. The committee shall have
19 one (1) member representing the students, faculty, and nonteaching personnel
20 with the group alternating each year. The initial appointment to the executive
21 committee after **the effective date of this Act** ~~May 30, 1997~~, shall be a faculty
22 member, to be followed by a student and a nonteaching personnel,
23 respectively.

24 (d) Receipt, retention, and administration, on behalf of the university, subject to
25 the conditions attached, all revenues accruing from endowments,
26 appropriations, allotments, grants or bequests, and all types of property.

27 (e) Requirement of reports from the president, officers, faculty, and employees as

1 it deems necessary and proper from time to time.

2 (f) Granting degrees to graduates of the university, prescription of conditions
3 upon which postgraduate honors may be obtained, and conferment of
4 honorary degrees.

5 (g) The board shall periodically evaluate the institution's progress in
6 implementing its missions, goals, and objectives to conform to the strategic
7 agenda. Officers and officials shall be held accountable for the status of the
8 institution's progress.

9 **(h) The board shall adopt bylaws, rules, and regulations for the governance of**
10 **its members, officers, agents, and employees, which shall reference the**
11 **member removal and replacement provisions of Section 1 of this Act, and**
12 **the board shall enforce obedience to those bylaws, rules, and regulations.**

13 (2) **Board members shall receive no compensation for serving on the board, but shall**
14 **be reimbursed for travel expenses for attending meetings and performing other**
15 **official functions, consistent with the reimbursement policy for state employees.**

16 **Board members who reside outside the Commonwealth shall not be reimbursed**
17 **for out-of-state travel expenses.**

18 (3) The provisions of KRS 164.030, 164.200, and 164.410, shall be applicable to the
19 University of Louisville except where inconsistent with the purposes of KRS
20 164.810 to 164.870.

21 ➔Section 10. The General Assembly finds and declares that one or more of the
22 boards specified in Section 1 of this Act has a current membership that is not in
23 compliance with statutory proportional representation requirements, or that one or more
24 of the boards has a history of appointments being made that do not meet those statutory
25 requirements. Additionally, the General Assembly finds and declares that one or more of
26 the boards specified in Section 1 of this Act has a current membership that is no longer
27 functioning according to its statutory mandate, or that one or more of the boards has a

1 history of failing to function according to its statutory mandate. Therefore, the General
2 Assembly further finds and declares that the Governor or other appointing authority shall
3 have the power to remove certain members of a board and replace those members with
4 new appointees, consistent with and as specified in Sections 1 to 9 of this Act.

5 ➔Section 11. Because the membership of certain boards may not currently be in
6 compliance with the proportional representation requirements provided by law, an
7 emergency is declared to exist, and this Act takes effect upon its passage and approval by
8 the Governor or upon its otherwise becoming a law.
