

1 AN ACT relating to reorganization.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 18A.025 is amended to read as follows:

4 (1) The Governor shall appoint the secretary of personnel as provided in KRS 18A.015,  
5 who shall be considered an employee of the state. The secretary shall be a graduate  
6 of an accredited college or university and have at least five (5) years' experience in  
7 personnel administration or in related fields, have known sympathies with the merit  
8 principle in government and shall be dedicated to the preservation of this principle.  
9 Additional education may be substituted for the required experience and additional  
10 experience may be substituted for the required education.

11 (2) The secretary of the Personnel Cabinet or the secretary's designee, shall be  
12 responsible for the coordination of the state's affirmative action plan, established by  
13 KRS 18A.138.

14 (3) There is established within the Personnel Cabinet the following offices,  
15 departments, and divisions, each of which shall be headed by either a commissioner,  
16 executive director, or division director appointed by the secretary, subject to the  
17 prior approval of the Governor pursuant to KRS 12.040 or 12.050, depending on the  
18 level of the appointment, except that the Kentucky Employees Deferred  
19 Compensation Authority shall be headed by an executive director who shall be  
20 appointed by the authority's board of directors:

21 (a) Office of the Secretary, which shall be responsible for communication with  
22 state employees about personnel and other relevant issues and for the  
23 administration and coordination of the following:

24 1. Office of Employee Relations, composed of the following programs:

25 a. Workers' Compensation Program pursuant to KRS 18A.375;

26 b. Life Insurance Program pursuant to KRS 18A.205 to KRS  
27 18A.220;

- 1 c. Sick leave Sharing Program, pursuant to KRS 18A.197;
- 2 d. Annual Leave Sharing Program, pursuant to KRS 18A.203;
- 3 e. Health and Safety Program;
- 4 f. Employee Assistance Program;
- 5 g. Employee Incentive Programs, pursuant to KRS 18A.202; and
- 6 h. Employee Mediation Program;
- 7 2. Office of Administrative Services, which shall be responsible for the
- 8 Personnel Cabinet's administrative functions, **composed of the following**
- 9 **programs:**
- 10 **a. Division of Technology Services;**
- 11 **b. Division of Human Resources; and**
- 12 **c. Division of Financial Services;**
- 13 3. Office of Legal Services, which shall provide legal services to the
- 14 Personnel Cabinet and to executive branch agencies and their
- 15 representatives upon request;
- 16 4. Office of Diversity, ~~and~~ Equality, **and Training**, which shall
- 17 coordinate and implement diversity initiatives for state agencies, the
- 18 affirmative action plan established by KRS 18A.138, the state Equal
- 19 Employment Opportunity Program, and the Minority Management
- 20 Trainee Program;
- 21 5. Governmental Services Center, which shall be responsible for employee
- 22 and managerial training and organizational development;
- 23 6. Kentucky Public Employees Deferred Compensation Authority, which
- 24 shall maintain a deferred compensation plan for state employees; and
- 25 7. **Office of Public Affairs**~~[Center for Strategic Innovation]~~, which shall
- 26 assist in all aspects of developing and executing the strategic direction of
- 27 the cabinet;

1 (b) Department of Human Resources Administration, which shall be composed of  
2 the:

3 1. Division of Employee Management, which shall be responsible for  
4 payroll, records, classification, and compensation. The division shall  
5 also be responsible for implementing lay-off plans mandated by KRS  
6 18A.113 to 118A.1132 and shall monitor and assist state agencies in  
7 complying with the provisions of the federal Fair Labor Standards Act.

8 The division shall:

- 9 a. Maintain the central personnel files mandated by KRS 18A.020  
10 and process personnel documents and position actions;
- 11 b. Operate and maintain a uniform payroll system and certify payrolls  
12 as required by KRS 18A.125;
- 13 c. Maintain plans of classification and compensation for state service  
14 and review and evaluate the plans; and
- 15 d. Coordinate and implement the employee performance evaluation  
16 systems throughout state government; and

17 2. Division of Career Opportunities, which shall be responsible for  
18 employment counseling, applicant processing, employment register, and  
19 staffing analysis functions. The division shall:

- 20 a. Operate a centralized applicant and employee counseling program;
- 21 b. Operate, coordinate, and construct the examination program for  
22 state employment;
- 23 c. Prepare registers of candidate employment;
- 24 d. Coordinate outreach programs, such as recruitment and the  
25 Administrative Intern Program; and

26 ~~[3. Division of Technology Services, which shall be responsible for the~~  
27 ~~development and maintenance of all technology and technology~~

1 ~~infrastructure; and]~~

2 (c) Department of Employee Insurance, which shall be responsible for the:

- 3 1. Health Insurance Program, pursuant to KRS 18A.225;
- 4 2. Flexible Benefit Plan, pursuant to KRS 18A.227;
- 5 3. Division of Insurance Administration, which shall be responsible for
- 6 enrollment and service functions; and
- 7 4. Division of Financial and Data Services, which shall be responsible for
- 8 fiscal and data analysis functions.

9 (4) The cabinet shall include principal assistants appointed by the secretary, pursuant to  
10 KRS 12.050 or 18A.115(1)(g) and (h), as necessary for the development and  
11 implementation of policy. The secretary may employ, pursuant to the provisions of  
12 this chapter, personnel necessary to execute the functions and duties of the  
13 department.

14 ➔Section 2. KRS 12.020 is amended to read as follows:

15 Departments, program cabinets and their departments, and the respective major  
16 administrative bodies that they include are enumerated in this section. It is not intended  
17 that this enumeration of administrative bodies be all-inclusive. Every authority, board,  
18 bureau, interstate compact, commission, committee, conference, council, office, or any  
19 other form of organization shall be included in or attached to the department or program  
20 cabinet in which they are included or to which they are attached by statute or statutorily  
21 authorized executive order; except in the case of the Personnel Board and where the  
22 attached department or administrative body is headed by a constitutionally elected officer,  
23 the attachment shall be solely for the purpose of dissemination of information and  
24 coordination of activities and shall not include any authority over the functions,  
25 personnel, funds, equipment, facilities, or records of the department or administrative  
26 body.
