

1           A RESOLUTION adjourning the Senate in honor and loving memory of Mayor  
2 Kenny Robert Fankell.

3           WHEREAS, Mayor Fankell was born on March 7, 1959, the cherished son of the  
4 late Owen Thomas and Mary Conley Fankell; and

5           WHEREAS, Mayor Fankell was serving his second term as Mayor of Olive Hill,  
6 Kentucky. A former member of the Olive Hill City Council, he had served as the baseball  
7 and volleyball assistant coach for West Carter High School, and had retired from the  
8 Carter County Board of Education. He served on the FIVCO Board of Directors and the  
9 Board of Housing Development in Olive Hill, and was a proud believer in the vitality and  
10 future of his cherished community; and

11           WHEREAS, Mayor Fankell was a member of the First Baptist Church of Olive  
12 Hill; and

13           WHEREAS, Mayor Kenny Robert Fankell, beloved husband, father, and cherished  
14 public servant, departed this earthly life and entered into the kingdom of Heaven on  
15 February 22, 2017, leaving his family, friends, and all those whose lives he touched in  
16 solemn mourning; and

17           WHEREAS, Mayor Fankell was preceded in death by his first wife, Lesley Hope  
18 Waugh Fankell; sister, Clarice Johnson; and several nieces and nephews. He is survived  
19 by his wife of 13 years, Jenny Gail Lowe Fankell; son, Kendrick Fankell and his wife,  
20 Courtney Cundiff; brothers, Sonny and Larry Fankell; sisters, Betty Brown and her  
21 husband, Harold, and Teresa Wright and her husband, Leroy; stepsons, Devin Bailey and  
22 his wife, Kayla, and Daniel Bailey and his wife, Ruby; step-grandchildren, Graice, Pierce,  
23 and Gideon; aunt, Darlene Watson; and a host of other family members, friends, and  
24 loved ones who will dearly miss his presence in their lives;
