1	A RESOLUTION declaring the intention of the Senate to carefully monitor and		
2	encourage wise stewardship of public resources as the Cabinet for Health and Family		
3	Services undertakes systemic efforts to reform eligibility testing for benefits and welfar		
4	programs.		
5	WHEREAS, limited state and federal resources are available to assist our citizens		
6	that enroll in assistance programs; and		
7	WHEREAS, the Senate is deeply concerned about the use of these limited taxpayer		
8	resources and ensuring that these dollars are wisely stewarded to protect vulnerable		
9	citizens; and		
10	WHEREAS, the Cabinet for Health and Family Services is presently involved in a		
11	major effort to update its eligibility technology and ability to engage in continuous		
12	monitoring of benefits recipients; and		
13	WHEREAS, these technological updates provide an important opportunity to ensure		
14	that the needs of the most vulnerable Kentuckians are truly being met; and		
15	WHEREAS, combating fraud, waste, or abuse throughout these programs,		
16	especially at the eligibility stage, guards against negative attention that can overshadow		
17	the vital public good done for the Commonwealth and its citizens by these services;		
18	NOW, THEREFORE,		
19	Be it resolved by the Senate of the General Assembly of the Commonwealth of		
20	Kentucky:		
21	→ Section 1. This Resolution may be known and cited as the Citizen and Taxpayer		
22	Stewardship Resolution of 2017.		
23	→ Section 2. The Senate encourages the Cabinet for Health and Family Services to		
24	utilize enhanced eligibility verification and periodic continuing monitoring that is, at a		
25	minimum, quarterly, to ensure that the following information is verified concerning		
26	enrollees and applicants:

16	information pursuant to Section 2 of this Resolution that may impact an individual's		
17	eligibility for assistance programs, is encouraged to take the following steps:		
18	(1)	Review the individual's case file to determine the impact the new information	
19	has on the	individual or household's eligibility;	
20	(2)	Provide written notice to the individual throughout the investigation;	
21	(3)	Provide opportunity to the individual to explain any discrepancies, including	
22	an opportu	unity for a hearing that complies with KRS Chapter 13B; and	
23	(4)	Discontinue assistance if there is a substantial risk of fraud, waste, or abuse	
24	occurring in that case.		
25	<b>→</b> Se	ection 4. When an individual is using food stamps at a grocery store, the	
26	Senate strongly encourages the Cabinet for Health and Family Services to consider using		
27	methods to ensure that the benefits from that program go to benefit the household of the

- 2 by any member of a household using a benefits card.
- 3 **→**Section 5. The Cabinet for Health and Family Services may explore the 4 following options when updating its eligibility and monitoring infrastructure:
- 5 Signing of memoranda of understanding or agreement with any state agency
- 6 necessary to share or acquire needed information pursuant to Sections 2 or 4 of this
- 7 Resolution;
- 8 (2) Use of independent vendors to provide the information referenced in Section 2
- 9 of this Resolution if the agreement with the a vendor includes a requirement of an
- 10 annualized saving that exceeds the state's total annual cost;
- 11 (3) Use of public or private grants to research the abuse of food stamps or other
- 12 public programs; and
- 13 The use of multi-state collaborative agreements to share information and pool
- 14 staff or resources to better combat waste, fraud, and abuse.
- 15  $\rightarrow$  Section 6. (1) The Cabinet for Health and Family Services is encouraged to
- 16 refer suspected cases of fraud to the Office of the Inspector General for investigation,
- 17 criminal investigation, recovery of improper payments, and collection of civil penalties.
- 18 The cabinet is encouraged to refer suspected cases of identity fraud to the
- 19 appropriate county attorney or Commonwealth's attorney office for prosecution.
- 20 If a case of suspected fraud results in a conviction, the cabinet is encouraged
- 21 to review legal options to remove an enrollee from other public assistance programs and
- 22 garnish wages until an equal amount of the benefits fraudulently received is recovered.
- 23 (4) The cabinet is encouraged to refer any suspected cases of fraud,
- 24 misrepresentation, or inadequate documentation discovered pursuant to the appropriate
- 25 state or local agencies for review of eligibility discrepancies in any other public programs.
- 26  $\rightarrow$  Section 7. The Senate recommends that in no case shall the resource limit
- 27 standards of the food stamp program exceed the standards specified in 7 U.S.C. sec.

- 2 eligibility exempting households from these resource limits be granted for any non-cash,
- 3 in-kind or other benefit, unless expressly required by federal law.
- **→** Section 8. The Senate recommends that the work requirements and alternative
- 5 benefits requirements utilized in the KY HEALTH 1115 Waiver currently being sought
- 6 by the Cabinet for Health and Family Services be incorporated into any benefits reform.
- 7 The Senate further requests that the Cabinet for Health and Family Services request any
- 8 waivers necessary to apply work requirements to the food stamps program, Medicaid, and
- 9 the Temporary Assistance for Needy Families program.
- → Section 9. The Senate recommends that the 1996 work requirements established
- in federal welfare reform be utilized as a resource and policy goal as the benefits updates
- and technology updates are prepared and that these work requirements be restored or
- waivers requesting their restoration be prepared by the cabinet.
- → Section 10. The Senate requests that progress reports and final presentations
- about the updates and direction of benefits programs in Kentucky be given to the Interim
- 16 Joint Committee on Health and Welfare and the Medicaid Oversight and Advisory
- 17 Committee at the request of the chairs.
- The Senate requests that all updates be completed, legislation →
- recommended, and any necessary waivers requested by December 31, 2019.
