

1           A RESOLUTION adjourning the Senate in honor and loving memory of Paul  
2 Martin Clark Sr.

3           WHEREAS, Paul Martin Clark Sr. was born on July 11, 1932, in Stanley,  
4 Kentucky, the cherished son of Joseph Claude and Mary Frances Clark; and

5           WHEREAS, Paul Clark was a proud veteran of the United States Navy who served  
6 on the *U.S.S. Iowa* during the Korean War; and

7           WHEREAS, Paul Clark worked for thirty-three years for the Ford Motor Company  
8 before his retirement in 1982; and

9           WHEREAS, in 1977, Paul Clark was elected to the Kentucky House of  
10 Representatives. He would serve that honorable body for fifteen years, representing his  
11 constituents in south Louisville with dignity, honor, and the empathy for which he was  
12 widely known and respected both in the city of Louisville and throughout this great  
13 Commonwealth; and

14           WHEREAS, along with his cherished wife, Paul Clark was instrumental in  
15 founding The Lord's Kitchen, which still feeds the hungry today; and

16           WHEREAS, Paul Martin Clark Sr. departed this earthly life and entered into the  
17 kingdom of Heaven on December 11, 2016, leaving his family, friends, and all those who  
18 were touched by his presence in solemn mourning; and

19           WHEREAS, Paul Clark was preceded in death by his parents; his beloved wife,  
20 June Katharine Clark; son, Jeffery Dean Clark; grandchildren, Kenny Carlisle and  
21 Christopher Clark; great-grandchild, Levi Michael Clark; and six siblings. He is survived  
22 by his children, Paul Clark Jr. and his wife, Paula, Kentucky State Senator Perry Clark  
23 and his wife, Sheila, David Clark, John Clark and his wife, Wendy, Sylvia Carlisle Clark,  
24 Sally VonAllmen and her husband, Dwayne, and Sherrie; twenty grandchildren; fifteen  
25 great-grandchildren and one on the way; brothers, Bernard "Bud" Clark, Thomas Clark,  
26 and Tony Clark; sisters, Margaret Byke, Rosemary Moore, and Carolyn Clark Randall;
