4	cherish the common values of freedom, democracy, human rights, and the rule of law;

6	WHEREAS, in the year 2016, Taiwan held its sixth direct presidential election and
7	again demonstrated the strength and vitality of its democratic system, paving the way for
8	Taiwan as a beacon of democracy in Asia and beyond. Tsai Ing-wen was elected as the
9	14th President of Taiwan, becoming the first female president in the country's history, and
10	along with her Vice President Chen Chien-jen, she hopes to continue to build on the
11	country's already rich tradition of economic vitality, cultural growth, and innovation; and
12	WHEREAS, Taiwan serves the best interests of the Asia-Pacific region in the
13	continuation of stability and growth; and
14	WHEREAS, Taiwan and mainland China have signed more than 20 agreements in
15	the past decade. United States businesses can collaborate with innovative Taiwanese
16	companies in Taiwan's comprehensive protection of intellectual property rights, and then
17	use Taiwan as a springboard for entering mainland China and other key Asian markets;

19	WHEREAS, since 1982, the Commonwealth of Kentucky and Taiwan have enjoyed
20	long, cordial, and mutually beneficial sister-state relations, a friendship that continues to
21	strengthen with each passing year; and
22	WHEREAS, Taiwan is the United States' ninth-largest trading partner, and the
23	United States is Taiwan's second-largest trading partner; and
24	WHEREAS, the designation of Taiwan into the United States' Visa Waiver
25	Program is a significant step to draw travelers from Taiwan choosing the United States as
26	their destination for trade, investment, and sightseeing; and
27	WHEREAS, by working together with Taiwan, Kentucky welcomes all
