On page 4, beginning on line 1 and continuing through line 2, by deleting, "*election of trustees*" and by inserting in lieu thereof "*holding of a regular election*"; and

On page 4, line 11, by deleting, "at the same time as the terms of the elected trustees commence" and by inserting in lieu thereof, "on December 31 of the year the ordinance becomes effective"; and

Beginning on page 8, line 13, and continuing through page 9, line 1, by deleting subparagraph 3. in its entirety and by inserting in lieu thereof:

"3. After the alternative board structure is approved pursuant to Section 5 of this Act, a trustee shall not have his or her term of office affected by such approval, except as provided in this subparagraph. Any trustee whose term of office is scheduled to expire prior to January 1 of the year following the adoption of the alternative board structure shall have his or her term of office extended to December 31 of that year. If the term of office expires in a year in which no regular election is scheduled to be held, then that trustee's term shall be extended through December 31 of the year during which the next regular election is held. On the expiration of the respective terms, the successor to each shall have the same qualifications as his or her predecessor and shall be elected for a term of four (4) years. commence on January 1 of the year following the regular election at which they are elected and shall expire on December 31. The member appointed by the county judge/executive or executive head of a merged government shall serve for a term of four (4) years and the term shall commence on January 1 of the year following the regular election at which elected trustees are elected and shall expire on December 31. In the event of a vacancy in the term of an appointed or elected trustee, the county judge/executive or executive head of a merged government shall appoint a trustee with the approval of the respective fiscal court or the legislative body of a merged government, for the remainder of the term."; and

On page 10, line 4 after "(2)", by inserting, "(a) "; and

On page 10, beginning on line 5 and continuing on line 6, by deleting "<u>fourth Saturday of</u>

<u>June between the hours of 11:00 a.m. and 2:00 p.m.</u>", and by inserting in lieu thereof, "<u>same</u>

<u>day and during the same hours as the regular election in November.</u>"; and

On page 10, beginning on line 17 and continuing through line 19 by deleting, "The term of the trustee appointed by the county judge/executive or executive head of a merged government shall start at the same time as the terms of the elected trustees."; and

On page 10, after line 19 by inserting:

- "(b) 1. Prior to the commencement of voting on each regular election day, in every precinct polling place containing all or a portion of the fire district, a sign shall be posted by the fire district that:
 - a. Contains the following statement: "Elections for (name of fire district)

 board of trustees are being conducted today during the hours of 6 a.m.

 to 6 p.m. Property owners containing property within the boundaries of
 this fire district may cast their votes for property owner trustees of the

- fire district at: (name, address, and nonemergency telephone number of the principal fire house of the district);
- b. Contains letters at least one (1) inch in height, in black, on a white background; and
- c. Is easily visible by voters casting their vote at the precinct polling place,

 but separate from the operations of the election officers conducting the

 regular election activities.
- 2. The location of the sign shall be subject to regulation by the State Board of

 Elections through the promulgation of administrative regulations in

 accordance with KRS Chapter 13A. KRS 117.235, 119.185, and 119.255 shall

 apply to the posting and contents of the sign."
