

1 AN ACT relating to special license plates and making an appropriation therefor.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 186 IS CREATED TO  
4 READ AS FOLLOWS:

5 *(1) Upon application to the county clerk of the county of his or her residence, the*  
6 *owner or lessee of a motor vehicle registered under KRS 186.050(1) or (3)(a) or a*  
7 *motorcycle registered under KRS 186.050(2) may obtain a Break the Silence*  
8 *special license plate.*

9 *(2) Each initial or renewal application for a Break the Silence special license plate*  
10 *shall be subject to payment of the fees set forth in Section 2 of this Act.*

11 *(3) The EF portion of the fees collected under Section 2 of this Act for a Break the*  
12 *Silence special license plate shall be used to support programs for survivors of*  
13 *domestic violence and sexual assault and are hereby appropriated to the*  
14 *Kentucky Coalition Against Domestic Violence for that purpose, subject to the*  
15 *distribution and auditing requirements set forth in KRS 186.164.*

16 *(4) The Break the Silence special license plate shall be administered in the same*  
17 *manner as other special license plates as prescribed in Section 2 of this Act.*

18 *(5) The Transportation Cabinet shall consult with the Kentucky Coalition Against*  
19 *Domestic Violence on the design of the Break the Silence special license plate.*

20 ➔Section 2. KRS 186.162 (Effective January 1, 2018) is amended to read as  
21 follows:

22 (1) As used in this *chapter*~~[section and in KRS 186.043, 186.164, 186.166, 186.1722,~~  
23 ~~and 186.174]:~~

24 (a) "Special license plate" means a unique license plate issued under this chapter to  
25 a group or organization that readily identifies the operator of the motor vehicle  
26 or motorcycle bearing the plate as a member of a group or organization, or a  
27 supporter of the work, goals, or mission of a group or organization. The term

- 1 shall not include regular license plates issued under KRS 186.240;
- 2 (b) "Street rod" means a modernized private passenger motor vehicle
- 3 manufactured prior to the year 1949, or designed or manufactured to resemble
- 4 a vehicle manufactured prior to 1949;
- 5 (c) "SF" means the portion of an initial or renewal fee to obtain a special license
- 6 plate that is dedicated for use by the Transportation Cabinet;
- 7 (d) "CF" means the portion of an initial or renewal fee to obtain a special license
- 8 plate that is dedicated for use by a county clerk; and
- 9 (e) "EF" means the portion of an initial or renewal fee to obtain a special license
- 10 plate that is mandated by this chapter to be dedicated for use by a particular
- 11 group or organization.

12 (2) The initial purchase fee and renewal fee for a special license plate created under this  
 13 chapter shall be as established in this subsection and includes the name of group or  
 14 organization and the total initial and renewal fee required for the plate. The amount  
 15 in parentheses indicates how the total fee is required to be divided:

16 (a) Disabled veterans who receive assistance to purchase a vehicle from the United  
 17 States Department of Veterans' Affairs, veterans declared by the United States  
 18 Department of Veterans' Affairs to be one hundred percent (100%) service-  
 19 connected disabled, and recipients of the Congressional Medal of Honor:

- 20 1. Initial Fee: \$0 (\$0 SF/\$0 CF/\$0 EF).
- 21 2. Renewal Fee: \$0 (\$0 SF/\$0 CF/\$0 EF).

22 (b) Former prisoners of war and survivors of Pearl Harbor:

- 23 1. Initial Fee: \$20 (\$12 SF/\$3 CF/\$5 EF to the veterans'
- 24 program trust fund established under KRS 40.460).
- 25 2. Renewal Fee: \$3 (\$0 SF/\$3 CF/\$0 EF).

- 1           1.    Initial Fee:       \$0           (\$0 SF/\$0 CF/ \$0 EF).
- 2           2.    Renewal Fee:     \$0           (\$0 SF/\$0 CF/ \$0 EF).
- 3           3.    A person may receive a maximum of two (2) plates under this paragraph
- 4                 free of charge and may purchase additional plates for fees as established
- 5                 in subsection (2)(d) of this section.

21   (3) Any special license plate may be combined with a personalized license plate for a  
 22   twenty-five dollar (\$25) state fee in addition to all other fees for the particular  
 23   special license plate established in this section and in KRS 186.164(3). The twenty-  
 24   five dollar (\$25) fee required under this subsection shall be divided between the  
 25   cabinet and the county clerk of the county where the applicant is applying for the  
 26   license plate with the cabinet receiving twenty dollars (\$20) and the county clerk  
 27   receiving five dollars (\$5).

1 (4) Owners and lessees of motorcycles registered under KRS 186.050(2) may be eligible  
2 to receive special license plates issued under this section or established under the  
3 provisions of KRS 186.164 after the cabinet has received three hundred (300)  
4 applications and initial state fees from the sponsoring organization. Applicants for a  
5 special license plate for a motorcycle shall be required to pay the fee for a special  
6 plate as prescribed in this section or in KRS 186.164. The fee paid for the special  
7 plate for a motorcycle shall be in lieu of the registration fee required under KRS  
8 186.050(2).

9 ➔Section 3. KRS 186.166 (Effective January 1, 2018) is amended to read as  
10 follows:

11 (1) The Transportation Cabinet shall, unless directed otherwise by the General  
12 Assembly, perpetually produce the following special license plates: military license  
13 plates, U.S. Congressional license plates, firefighter license plates, emergency  
14 management license plates, Fraternal Order of Police license plates, Law  
15 Enforcement Memorial license plates, street rod license plates, nature license plates,  
16 amateur radio license plates, Kentucky General Assembly license plates, Kentucky  
17 Court of Justice license plates, Masonic Order license plates, collegiate license  
18 plates, independent college and university license plates, child victims' trust fund  
19 license plates, **Break the Silence license plates**, Kentucky Horse Council license  
20 plates, Ducks Unlimited license plates, Gold Star Mothers, Fathers, and Spouses  
21 license plates, Gold Star Siblings, Sons, and Daughters license plates, Silver Star  
22 Medal license plates, Bronze Star Medal license plates, spay neuter license plates,  
23 service academy license plates, and I Support Veterans license plates.

24 (2) The design of the plates identified for perpetual production under this section may be  
25 revised upon request of a group or organization requesting a design revision under  
26 the provisions of KRS 186.164(15).

27 (3) (a) The design of a Purple Heart license plate shall not include any representation



1                   of the word "Kentucky" that is a registered trademark or slogan which appears  
2                   on a general issue license plate.

3           (b)   The design of a Purple Heart license plate shall include a representation of the  
4           Purple Heart medal and the words "Combat Wounded."
