16	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
17	SECTION 1. A NEW SECTION OF KRS CHAPTER 500 IS CREATED TO
18	READ AS FOLLOWS:
19	(1) Except for unmanned aircraft systems operated by the United States Army, Navy,
20	Marine Corps, Air Force, or Coast Guard, or a reserve component thereof, or by
21	the Army National Guard or Air National Guard, unmanned aircraft systems
22	may not be equipped with a lethal payload.
23	(2) Any business entity doing business lawfully within this state may use an
24	unmanned aircraft system for business purposes, in compliance with 14 C.F.R.
25	<u>pt. 107.</u>
26	(3) Any recreational user may operate an unmanned aircraft system within this state,
27	in compliance with 14 C.F.R. pt. 101.

1	<u>(4)</u>	Any institution of higher education, or school district, may use an unmanned
2		aircraft system for educational, research, or testing purposes.
3	<u>(5)</u>	No law enforcement agency, or agent thereof, shall use an unmanned aircraft

5		the United States Constitution and Section 10 of the Kentucky Constitution. If

20		(b) Evidence which is offered against the owner or operator of an unmanned
21		aircraft system to show misconduct.
22	<u>(9)</u>	No law enforcement agency shall be required to operate unmanned aircraft

24	<u>(10)</u>	Operation of an unmanned aircraft system in violation of subsection (2) or (3) of
25		this section shall be a violation for the first offense and a Class B misdemeanor
26		for the second or subsequent offense.
27	<u>(11)</u>	This section may be cited as the "Citizens' Freedom from Unwarranted
