2	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
3	→SECTION 1. A NEW SECTION OF KRS CHAPTER 337 IS CREATED TO

6	(a) "Marketplace contractor" means a person or entity that enters into an
7	agreement with a marketplace platform to use its digital network or mobile

2	(d) The marketplace platform does not restrict the marketplace contractor from
3	engaging in another occupation or business; and
4	(e) The marketplace contractor bears all or substantially all of the expenses
5	incurred by the marketplace contractor in performing the services.
6	(3) For services performed by a marketplace contractor prior to the effective date of
7	this Act, the marketplace contractor shall be treated as an independent contractor
8	of the marketplace platform and not as an employee of the marketplace platform,
9	if the requirements set forth in subsection (2) of this section were met at the time
10	at which the services were performed.
11	(4) This section shall not apply to:
12	(a) Services performed in the employ of a state, or any political subdivision of a
13	state, or in the employ of an Indian tribe, or any instrumentality of a state,
14	any political subdivision of a state or any Indian tribe that is wholly owned
15	by one (1) or more states or political subdivisions or Indian tribes, provided
16	the service is excluded from employment as defined in 26 U.S.C. secs. 3301
17	<u>to 3311; or</u>
18	(b) Service performed in the employment of a religious, charitable, educational,
19	or other organization that is excluded from employment as defined in 26
20	<u>U.S.C. secs. 3301 to 3311, solely by reason of 26 U.S.C. sec. 3306(c)(8).</u>
21	→ Section 2. If any provisions of this Act or its application to any person or
22	circumstance is held invalid, the invalidity does not affect other provisions or applications
23	of the Act which can be given effect without the invalid provision or application, and to
24	this end the provisions of this Act are severable.
