AN ACT relating to elections.

2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

→Section 1. KRS 117.035 is amended to read as follows:

4 (1) There shall be a county board of elections, which shall, at the direction and under
5 the supervision of the State Board of Elections, administer the election laws and the
6 registration and purgation of voters within the county.

7 (2) (a) The <u>county</u> board <u>of elections</u> shall consist of the county clerk, the sheriff,
8 and two (2) members appointed by the State Board of Elections not later than
9 July 1 following the election of persons to statewide office, for a term of four
10 (4) years and until their successors are appointed.

11 (b) The sheriff shall not serve on the *county* board *of elections* during any year [in 12 which] he or she is a candidate, but he or she may [shall] recommend that a 13 *deputy sheriff be*[to the board] a temporary replacement to serve in his *or her* place. If the sheriff cannot serve because he or she is sick, injured, 14 15 *incapacitated*, or otherwise *unavailable*[incapacitated], he or she may 16 recommend a *deputy sheriff or other* temporary replacement to serve in his *or* 17 her place until the sheriff may resume his or her duties or a vacancy in office is declared. 18

(c) The county clerk may, at his <u>or her</u> option, continue to serve on the <u>county</u>
board <u>of elections</u> during a year in which he <u>or she</u> is a candidate. If the
<u>county</u> clerk elects not to serve, he <u>or she</u> shall recommend a temporary
replacement to serve in his <u>or her</u> place. If the county clerk cannot serve
because he <u>or she</u> is sick, injured, or otherwise incapacitated, he <u>or she</u> may
recommend a temporary replacement to serve in his <u>or her</u> place until the
county clerk may resume his <u>or her</u> duties or a vacancy in office is declared.

26 (d) 1. Notwithstanding the provisions of KRS 61.080, service on the <u>county</u>
27 board of elections shall be compatible with the holding of any other

1		county, urban-county government, charter county, consolidated local
2		government, unified local government, or city office.
3	2.	The members shall be at least twenty-one (21) years of age, qualified
4		voters in the county from which they are appointed, and shall not have
5		been convicted of any election law offense.
6	3.	One (1) member shall be appointed from a list of five (5) names
7		submitted by the county executive committee of each political party as
8		defined in KRS 118.015. If there are two (2) or more contending
9		executive committees of the same political party in any county, the one
10		recognized by the written certificate of the <i>chair</i> [chairman] of the state
11		central committee of the political party shall be the one authorized to
12		submit the lists.
13	4.	If the State Board of Elections does not receive the list as required by
14		subparagraph 3. of this paragraph for each political party for each county
15		by the deadline established in paragraph (a) of this subsection or within
16		one (1) month of a vacancy, then the chair of the state central
17		committees for the political parties may submit lists of five (5) names of
18		qualified residents from the remaining counties by August 1 following
19		the election of persons to statewide office or within two (2) months of a
20		vacancy.
21	5.	If the State Board of Elections does not receive a list from either the
22		county executive committee under subparagraph 3. of this paragraph or
23		the chair of the state executive committee under subparagraph 4. of this
24		paragraph, then the State Board of Elections shall appoint a qualified
25		resident from the county at its next regularly scheduled meeting in
26		September following the election of persons to statewide office or
27		within three (3) months of a vacancy.

24	(e)	Con	npensation and payment of actual expenses of members shall be set by the
25		fisca	al court either as an amount payable on an annual basis, or as an amount
26		paya	able on a per diem basis of not less than fifteen dollars (\$15) nor more than
27		one	hundred dollars (\$100) for each day the board meets.

A majority of the <u>county</u> board <u>of elections</u> shall constitute a quorum. The county
 clerk shall serve as <u>chair</u>[chairman] of the meetings and may vote. In case of a tie,
 the <u>chair</u>[chairman] may cast an additional vote. Records shall be kept of all
 proceedings, and the records shall be public and kept at the office of the county
 clerk.

(4) The <u>county</u> board <u>of elections</u> shall meet at least once a month and may meet more
frequently if necessary. The <u>county</u> board <u>of elections</u> shall stay in session on
election days to correct clerical errors and rule on questions regarding voter
registration and may make to the election officers such certifications as may be
necessary. On election days, appeals may be made to a Circuit Judge, but a ruling of
the <u>county</u> board <u>of elections</u> shall be reversed only upon a finding that it was
arbitrary and capricious.

13 (5) The *county* board *of elections* may employ, on a bipartisan basis, a staff sufficient
14 to carry out the duties assigned to the *county* board *of elections*.

15 → Section 2. KRS 117.075 is amended to read as follows:

The county clerk shall complete a postal form for a certificate of mailing for 3 mail-in absentee ballots mailed within the fifty (50) states, and it shall be stamped 4 by the postal service when the mail-in absentee ballots are mailed. A mail-in absentee ballot may be transmitted by facsimile machine or by the electronic 5 6 transmission system established under KRS 117A.030(4) to a covered voter as 7 defined in KRS 117A.010. The covered voter shall be notified of the options for 8 transmittal of the mail-in absentee ballot, and the mail-in absentee ballot shall be 9 transmitted by the method chosen for receipt by the resident of Kentucky who is a 10 covered voter.

or her mail-in absentee ballot and vote in person. The voter shall return the mail-in

1 absentee ballot to the county clerk's office on or before election day. Upon the 2 return of the mail-in absentee ballot, the county clerk shall mark on the outer 3 envelope of the sealed mail-in absentee ballot or the unmarked mail-in absentee ballot the words "Canceled because voter appeared to vote in person." Sealed 4 5 envelopes so marked shall not be opened. If the covered voter is unable to return the 6 mail-in absentee ballot to the county clerk's office on or before election day, at the 7 time he or she votes in person, he or she shall sign a written oath as to his or her 8 qualifications on the form prescribed by the State Board of Elections pursuant to 9 KRS 117.245. The county clerk shall remove the voter's name from the list of 10 persons who were sent mail-in absentee ballots and [.] provide the voter with written 11 authorization to vote at the precinct, and the voter may vote in the precinct in 12 which he or she is properly registered].

13 (9)[(10)] Notwithstanding the provisions of the Kentucky Open Records Act, KRS 14 61.870 to 61.884, the information contained in an application for a mail-in absentee 15 ballot shall not be made public until after the close of business hours on the election 16 day for which the application applies. This subsection shall not prohibit at any time 17 the disclosure, upon request, of the total number of applications for mail-in absentee 18 ballots that have been filed, or the disclosure to the Secretary of State or the State 19 Board of Elections, if requested or if otherwise required by law, of any information 20 in an application for a mail-in absentee ballot.

Section 4. KRS 117.145 is amended to read as follows:

At least <u>forty-five (45)</u>[fifteen (15)] days before any special election, and at least
fifty (50) days before any primary or regular election, the county clerk of each
county shall cause to be printed and ready for use ballot labels for each candidate
who, and each question which, is entitled to be voted upon in such election. The
ballot labels shall be printed on clear white paper or other material which shall be
furnished by the printer. They shall be printed in black ink, in plain, clear type

clearly legible to a person with normal vision, and shall be of a size to fit the ballot frames. The labels shall include the necessary party designations.

2 (2) Each county clerk shall have printed a sufficient number of paper absentee ballots.
The absentee ballot shall be used for voting by absent voters; by precinct officers
who have been assigned to a precinct other than their own; by members of a county
board of elections; by voters so disabled by age, infirmity or illness as to be unable
to appear at the polls; and for voting in an emergency situation. The ballot stubs
shall be consecutively numbered and the county board shall keep a record, by
number, of all absentee ballots used for any of the purposes listed herein.

10 (3) No later than the Friday preceding a special or regular election, the county clerk
shall equip the voting machines with the necessary supplies for the purpose of
write-in votes. The county clerk shall also attach a pencil or pen to the voting
machine for write-in purposes.

(4) If supplemental paper ballots have been approved as provided in KRS 118.215, the
county clerk shall cause to be printed a sufficient number of paper ballots for the
registered voters of each precinct. The paper ballots shall have stubs which are
numbered consecutively. The quality of paper on which the supplemental paper
ballots are printed shall be determined by regulations promulgated by the secretary
of the Finance and Administration Cabinet.

20 → Section 5. KRS 117.265 is amended to read as follows:

(1) A voter may, at any regular or special election, cast a write-in vote for any person qualified as provided in subsection (2) or (3) of this section, whose name does not appear upon the ballot label for any office, by writing the name of his or her choice upon the appropriate device for the office being voted on provided on the voting machine as required by KRS 117.125. Any candidate for city, county, urban-county, consolidated local government, charter county government, or unified local government office who is defeated in a partisan or nonpartisan primary shall be

ineligible as a candidate for the same office in the regular election. Any voter
utilizing an absentee ballot for a regular or special election may write in a vote for
any eligible person whose name does not appear upon the ballot, by writing the
name of his or her choice under the office.

5 (2)Write-in votes shall be counted only for candidates for election to office who have 6 filed a declaration of intent to be a write-in candidate with the Secretary of State or 7 county clerk, depending on the office being sought, on or before the fourth Friday in 8 October preceding the date of the regular election and not later than the second 9 Friday before the date of a special election. In the case of a special election 10 administered under KRS 118.730, a declaration of intent to be a write-in candidate 11 shall be filed at least *forty-nine* (49)[twenty eight (28)] days before the day of the 12 election. The declaration of intent shall be filed no earlier than the first Wednesday 13 after the first Monday in November of the year preceding the year the office will 14 appear on the ballot, and no later than 4 p.m. local time at the place of filing when 15 filed on the last date on which papers may be filed. The declaration of intent shall 16 be on a form prescribed by the Secretary of State.

17 (3) A person shall not be eligible as a write-in candidate:

- 18 (a) For more than one (1) office in a regular or special election; or
- (b) If his or her name appears upon the ballot label for any office, except that the
 candidate may file a notice of withdrawal prior to filing an intent to be a writein candidate for office when a vacancy in a different office occurs because of:
- 22 1. Death;

- 23 2. Disqualification to hold the office sought;
- 24 3. Severe disabling condition which arose after the nomination; or
 - 4. The nomination of an unopposed candidate.
- 26 (4) Persons who wish to run for President and Vice-President shall file a declaration of
 27 intent to be a write-in candidate, along with a list of presidential electors pledged to

1 those candidates, with the Secretary of State on or before the fourth Friday in 2 October preceding the date of the regular election for those offices. The declaration 3 of intent shall be filed no earlier than the first Wednesday after the first Monday in 4 November of the year preceding the year the office will appear on the ballot, and no 5 later than 4 p.m. local time at the place of filing when filed on the last date on which 6 papers may be filed. Write-in votes cast for the candidates whose names appear on 7 the ballot shall apply to the slate of pledged presidential electors, whose names shall 8 not appear on the ballot. 9 The county clerk shall provide to the precinct election officers certified lists of those (5)

- persons who have filed declarations of intent as provided in subsections (2) and (3)
 of this section. Only write-in votes cast for qualified candidates shall be counted.
- 12 (6) Two (2) election officers of opposing parties shall upon the request of any voter13 instruct the voter on how to cast a write-in vote.
