

1 AN ACT relating to abandoned property.

2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

3 ➔SECTION 1. KRS CHAPTER 393A IS ESTABLISHED AND A NEW
4 SECTION THEREOF IS CREATED TO READ AS FOLLOWS:

5 *As used in this chapter:*

6 *(1) "Administrator" means the Kentucky State Treasurer;*

7 *(2) "Administrator's agent":*

8 *(a) Means a person with which the administrator contracts to conduct an*
9 *examination under Sections 55 to 65 of this Act on behalf of the*
10 *administrator; and*

11 *(b) Includes an independent contractor of the person and each individual*
12 *participating in the examination on behalf of the person or contractor;*

13 *(3) "Apparent owner" means a person whose name appears on the records of a*
14 *holder as the owner of property held, issued, or owing by the holder;*

15 *(4) "Business association" means a corporation, joint stock company, investment*
16 *company other than an investment company registered under 15 U.S.C. secs.*
17 *80a-1 to 80a-64, as amended, partnership, unincorporated association, joint*
18 *venture, limited liability company, business trust, trust company, land bank, safe*
19 *deposit company, safekeeping depository, financial organization, insurance*
20 *company, federally chartered entity, utility, sole proprietorship, or other business*
21 *entity, whether or not for profit;*

22 *(5) "Confidential information" means records, reports, and information that are*
23 *confidential under Section 78 of this Act;*

24 *(6) "Domicile" means:*

25 *(a) For a corporation, the state of its incorporation;*

26 *(b) For a business association whose formation requires a filing with a state,*
27 *other than a corporation, the state of its filing;*

1 (c) For a federally chartered entity or an investment company registered under
2 15 U.S.C. secs. 80a-1 to 80a-64, as amended, the state of its home office;

3 and

4 (d) For any other holder, the state of its principal place of business;

5 (7) "Electronic" means relating to technology having electrical, digital, magnetic,
6 wireless, optical, electromagnetic, or similar capabilities;

7 (8) "Electronic mail" means a communication by electronic means which is
8 automatically retained and stored and may be readily accessed or retrieved;

9 (9) "Financial organization" means a savings and loan association, building and
10 loan association, savings bank, industrial bank, bank, banking organization, or
11 credit union;

12 (10) "Game-related digital content":

13 (a) Means digital content that exists only in an electronic game or electronic-
14 game platform;

15 (b) Includes:

16 1. Game-play currency such as a virtual wallet, even if denominated in
17 United States currency; and

18 2. The following if for use or redemption only within the game or
19 platform or another electronic game or electronic-game platform:

20 a. Points sometimes referred to as gems, tokens, gold, and similar
21 names; and

22 b. Digital codes; and

23 (c) Does not include an item that the issuer permits to be redeemed for use
24 outside a game or platform:

25 1. For money;

26 2. For goods or services that have more than minimal value; or

27 3. That otherwise monetizes for use outside a game or platform;

1 (11) "Gift card" means:

2 (a) A stored-value card:

3 1. The value of which does not expire;

4 2. That may be decreased in value only by redemption for merchandise,
5 goods, or services; and

6 3. That, unless required by law, may not be redeemed for or converted
7 into money or otherwise monetized by the issuer; and

8 (b) Includes a prepaid commercial mobile radio service, as defined in 47 C.F.R.
9 sec. 20.3, as amended;

10 (12) "Holder" means a person obligated to hold for the account of, or to deliver or
11 pay to, the owner, property subject to this chapter;

12 (13) "Insurance company" means an association, corporation, or fraternal or
13 mutual-benefit organization, whether or not for profit, engaged in the business of
14 providing life endowments, annuities, or insurance, including accident, burial,
15 casualty, credit-life, contract-performance, dental, disability, fidelity, fire, health,
16 hospitalization, illness, life, malpractice, marine, mortgage, surety, wage-
17 protection, and worker-compensation insurance;

18 (14) "Loyalty card":

19 (a) Means a record given without direct monetary consideration under an
20 award, reward, benefit, loyalty, incentive, rebate, or promotional program,
21 which may be used or redeemed only to obtain goods or services or a
22 discount on goods or services;

23 (b) Does not include a record that may be redeemed for money or otherwise
24 monetized by the issuer;

25 (15) "Mineral" means gas, oil, coal, oil shale, other gaseous liquid or solid
26 hydrocarbon, cement material, sand and gravel, road material, building stone,
27 chemical raw material, gemstone, fissionable and nonfissionable ores, colloidal

1 and other clay, steam and other geothermal resources, and any other substance
2 defined as a mineral by law of this state other than this chapter;

3 (16) "Mineral proceeds":

4 (a) Means an amount payable for extraction, production, or sale of minerals,
5 or, on the abandonment of the amount, an amount that becomes payable
6 after abandonment; and

7 (b) Includes an amount payable:

8 1. For the acquisition and retention of a mineral lease, including a
9 bonus, royalty, compensatory royalty, shut-in royalty, minimum
10 royalty, and delay rental;

11 2. For the extraction, production, or sale of minerals, including a net
12 revenue interest, royalty, overriding royalty, extraction payment, and
13 production payment; and

14 3. Under an agreement or option, including a joint-operating agreement,
15 unit agreement, pooling agreement, and farm-out agreement;

16 (17) "Money order":

17 (a) Means a payment order for a specified amount of money; and

18 (b) Includes an express money order and a personal money order on which the
19 remitter is the purchaser;

20 (18) "Municipal bond" means a bond or evidence of indebtedness issued by a
21 municipality or other political subdivision of a state;

22 (19) "Net card value" means the original purchase price or original issued value of a
23 stored-value card, plus amounts added to the original price or value, minus
24 amounts used and any service charge, fee, or dormancy charge permitted by law;

25 (20) "Non-freely transferable security":

26 (a) Means a security that cannot be delivered to the administrator by the
27 Depository Trust Clearing Corporation or similar custodian of securities

1 providing post-trade clearing and settlement services to financial markets or
2 cannot be delivered because there is no agent to effect transfer; and

3 (b) Includes a worthless security;

4 (21) "Owner":

5 (a) Means a person that has a legal, beneficial, or equitable interest in property
6 subject to this chapter or the person's legal representative when acting on
7 behalf of the owner; and

8 (b) Includes:

9 1. A depositor, for a deposit;

10 2. A beneficiary, for a trust other than a deposit in trust;

11 3. A creditor, claimant, or payee, for other property; and

12 4. The lawful bearer of a record that may be used to obtain money, a
13 reward, or a thing of value;

14 (22) "Payroll card" means a record that evidences a payroll-card account as defined
15 in 12 C.F.R. pt. 1005, as amended;

16 (23) "Person" means an individual, estate, business association, public corporation,
17 government or governmental subdivision, agency, or instrumentality or other
18 legal entity;

19 (24) "Property":

20 (a) Means tangible property described in Section 8 of this Act or a fixed and
21 certain interest in intangible property held, issued, or owed in the course of
22 a holder's business or by a government, governmental subdivision, agency,
23 or instrumentality;

24 (b) Includes all income from or increments to the property;

25 (c) Includes property referred to as or evidenced by:

26 1. Money, virtual currency, interest, or a dividend, check, draft, deposit,
27 or payroll card;

1 2. A credit balance, customer's overpayment, stored-value card, security
2 deposit, refund, credit memorandum, unpaid wage, unused ticket for
3 which the issuer has an obligation to provide a refund, mineral
4 proceeds, or unidentified remittance;

5 3. A security, except for:

6 a. A worthless security; or

7 b. A security that is subject to a lien, legal hold, or restriction
8 evidenced on the records of the holder or imposed by operation
9 of law, if the lien, legal hold, or restriction restricts the holder's
10 or owner's ability to receive, transfer, sell, or otherwise negotiate
11 the security;

12 4. A bond, debenture, note, or other evidence of indebtedness;

13 5. Money deposited to redeem a security, make a distribution, or pay a
14 dividend;

15 6. An amount due and payable under an annuity contract or insurance
16 policy; and

17 7. An amount distributable from a trust or custodial fund established
18 under a plan to provide health, welfare, pension, vacation, severance,
19 retirement, death, stock purchase, profit-sharing, employee-savings,
20 supplemental-unemployment insurance, or a similar benefit;

21 (d) Does not include:

22 1. Property held in a plan described in 26 U.S.C. sec. 529A, as amended;

23 2. Game-related digital content;

24 3. A loyalty card;

25 4. An in-store credit for returned merchandise; or

26 5. A gift card;

27 (25) "Putative holder" means a person believed by the administrator to be a holder,

1 until the person pays or delivers to the administrator property subject to this
2 chapter or the administrator or a court makes a final determination that the
3 person is or is not a holder;

4 (26) "Record" means information that is inscribed on a tangible medium or that is
5 stored in an electronic or other medium and is retrievable in perceivable form;

6 (27) "Security" means:

7 (a) A security as defined in KRS 355.8-102;

8 (b) A security entitlement as defined in KRS 355.8-102, including a customer
9 security account held by a registered broker-dealer, to the extent the
10 financial assets held in the security account are not:

11 1. Registered on the books of the issuer in the name of the person for
12 which the broker-dealer holds the assets;

13 2. Payable to the order of the person; or

14 3. Specifically indorsed to the person; and

15 (c) An equity interest in a business association not included in paragraph (a) or
16 (b) of this subsection;

17 (28) "Sign" means, with present intent to authenticate or adopt a record:

18 (a) To execute or adopt a tangible symbol; or

19 (b) To attach to or logically associate with the record an electronic symbol,
20 sound, or process;

21 (29) "State" means a state of the United States, the District of Columbia, the
22 Commonwealth of Puerto Rico, the United States Virgin Islands, or any territory
23 or insular possession subject to the jurisdiction of the United States;

24 (30) "Stored-value card":

25 (a) Means a record evidencing a promise made for consideration by the seller
26 or issuer of the record that goods, services, or money will be provided to the
27 owner of the record to the value or amount shown in the record;

1 **(b) Includes a:**

2 **1. Record that contains or consists of a microprocessor chip, magnetic**
3 **strip, or other means for the storage of information, which is**
4 **prefunded and whose value or amount is decreased on each use and**
5 **increased by payment of additional consideration;**

6 **2. Gift card; and**

7 **3. Payroll card; and**

8 **(c) Does not include a loyalty card or game-related digital content;**

9 **(31) "Utility" means a person that owns or operates for public use a plant, equipment,**
10 **real property, franchise, or license for the following public services:**

11 **(a) Transmission of communications or information;**

12 **(b) Production, storage, transmission, sale, delivery, or furnishing of electricity,**
13 **water, steam, or gas; or**

14 **(c) Provision of sewage or septic services, or trash, garbage, or recycling**
15 **disposal;**

16 **(32) "Virtual currency":**

17 **(a) Means a digital representation of value used as a medium of exchange, unit**
18 **of account, or store of value, which does not have legal tender status**
19 **recognized by the United States; and**

20 **(b) Does not include:**

21 **1. The software or protocols governing the transfer of the digital**
22 **representation of value;**

23 **2. Game-related digital content; or**

24 **3. Loyalty card; and**

25 **(33) "Worthless security" means a security whose cost of liquidation and delivery to**
26 **the administrator would exceed the value of the security on the date a report is**
27 **due under this chapter.**

1 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 393A IS CREATED TO
2 READ AS FOLLOWS:

3 *This chapter shall not apply to:*

4 *(1) Property held, due, and owing in a foreign country if the transaction out of which*
5 *the property arose was a foreign transaction;*

6 *(2) Money, funds, or any other intangible property held by or owing:*

7 *(a) To a nonprofit exempt under Section 501(c)(3) of the Internal Revenue*
8 *Code; or*

9 *(b) For any minerals or other raw materials capable of being used for fuel in*
10 *the course of manufacturing, processing, production, or mining;*

11 *(3) Wages or salaries of fifty dollars (\$50) or less that are not claimed by an*
12 *employee within one (1) year of the date the wages or salaries are earned, unless*
13 *the amounts are held on a payroll card;*

14 *(4) Moneys in inmate accounts and prisoner canteen accounts held by jailer under*
15 *KRS 441.137; or*

16 *(5) Funds held in a lawyer IOLTA trust account under Supreme Court Rule 3.830.*

17 ➔SECTION 3. A NEW SECTION OF KRS CHAPTER 393A IS CREATED TO
18 READ AS FOLLOWS:

19 *The administrator may promulgate administrative regulations under KRS Chapter 13A*
20 *to implement and administer this chapter. In promulgating the administrative*
21 *regulations, the administrator shall use the most cost-effective methods available for*
22 *the submission of reports to the administrator and the notice and advertisement of*
23 *property transferred to the administrator.*

24 ➔SECTION 4. A NEW SECTION OF KRS CHAPTER 393A IS CREATED TO
25 READ AS FOLLOWS:

26 *Subject to Section 12 of this Act, the following property shall be presumed abandoned*
27 *if it is unclaimed by the apparent owner during the period specified below:*

- 1 (1) A traveler's check, fifteen (15) years after issuance;
- 2 (2) A money order, seven (7) years after issuance;
- 3 (3) A state or municipal bond, bearer bond, or original-issue-discount bond, three (3)
4 years after the earliest of the date the bond matures or is called or the obligation
5 to pay the principal of the bond arises;
- 6 (4) A debt of a business association, three (3) years after the obligation to pay arises;
- 7 (5) A payroll card or demand, savings, or time deposit account, including a deposit
8 that is automatically renewable, three (3) years after the maturity of the deposit,
9 except a deposit that is automatically renewable is deemed matured on its initial
10 date of maturity unless the apparent owner consented in a record on file with the
11 holder to renewal at or about the time of the renewal, except:
- 12 (a) Property held in an interest-bearing, demand, savings, or time deposit
13 account shall, from the time it is presumed abandoned under this chapter,
14 be placed by the holder in an interest-bearing account made assignable to
15 the administrator;
- 16 (b) The administrator may examine the records of the holder relevant to the
17 establishment and maintenance of an interest-bearing account in
18 accordance with this chapter;
- 19 (c) Upon demand and proper proof by a person appearing entitled to payment
20 of property described in this subsection, the holder may withdraw the
21 property and any accrued interest for payment to the entitled person;
- 22 (d) Property described in this subsection deposited and not claimed ten (10)
23 years after it is presumed abandoned, or upon actual abandonment, shall be
24 paid to the administrator upon whichever abandonment occurs first; and
- 25 (e) The administrator shall not be required to credit interest on any property
26 described in this subsection after the property is received under paragraph
27 (d) of this subsection;

- 1 (6) Money or a credit owed to a customer as a result of a retail business transaction,
2 other than in-store credit for returned merchandise, three (3) years after the
3 obligation arose;
- 4 (7) An amount owed by an insurance company on a life or endowment insurance
5 policy or an annuity contract that has matured or terminated, three (3) years after
6 the obligation to pay arose under the terms of the policy or contract or, if a policy
7 or contract for which an amount is owed on proof of death has not matured by
8 proof of the death of the insured or annuitant, as follows:
- 9 (a) With respect to an amount owed on a life or endowment insurance policy,
10 three (3) years after the earlier of the date:
- 11 1. The insurance company has knowledge of the death of the insured; or
12 2. The insured has attained, or would have attained if living, the limiting
13 age under the mortality table on which the reserve for the policy is
14 based; and
- 15 (b) With respect to an amount owed on an annuity contract, three (3) years
16 after the date the insurance company has knowledge of the death of the
17 annuitant;
- 18 (8) Property distributable by a business association in the course of dissolution, one
19 (1) year after the property becomes distributable;
- 20 (9) Property held by a court, including property received as proceeds of a class
21 action, may be paid to the administrator one (1) year after the property becomes
22 distributable, but shall be paid to the administrator no later than five (5) years
23 after the property becomes distributable;
- 24 (10) Property held by a government or governmental subdivision, agency, or
25 instrumentality, including municipal bond interest and unredeemed principal
26 under the administration of a paying agent or indenture trustee, one (1) year
27 after the property becomes distributable;

1 (11) Property payable or distributable in the course of a demutualization of an
 2 insurance company, three (3) years after the earlier of the last contact with the
 3 policyholder, or the date the property became payable or distributable;

4 (12) Wages, commissions, bonuses, or reimbursements to which an employee is
 5 entitled, or other compensation for personal services, other than amounts held in
 6 a payroll card, one (1) year after the amount becomes payable;

7 (13) A deposit or refund owed to a subscriber by a utility, one (1) year after the deposit
 8 or refund becomes payable;

9 (14) All funds represented by unclaimed pari-mutual winning tickets held in this state
 10 by any person, association, or corporation operating a pari-mutual or similar
 11 system of betting at quarter horse or Appaloosa racetracks, two (2) years from the
 12 time the ticket became payable; and

13 (15) Property not specified in Section 5, 6, 7, 8, 9, or 10 of this Act, the earlier of three
 14 (3) years after the owner first has a right to demand the property or the obligation
 15 to pay or distribute the property arises.

16 ➔SECTION 5. A NEW SECTION OF KRS CHAPTER 393A IS CREATED TO
 17 READ AS FOLLOWS:

18 (1) Subject to Section 12 of this Act, property held in a pension account or retirement
 19 account that qualifies for tax deferral under the income-tax laws of the United
 20 States shall be presumed abandoned if it is unclaimed by the apparent owner
 21 three (3) years after the later of:

22 (a) The following dates:

23 1. Except as provided in subparagraph 2. of this paragraph, the date a
 24 second consecutive communication sent by the holder by first-class
 25 United States mail to the apparent owner is returned to the holder
 26 undelivered by the United States Postal Service; or

27 2. If the second communication is sent later than thirty (30) days after

1 the date the first communication is returned undelivered, the date the
2 first communication was returned undelivered by the United States
3 Postal Service; or

4 **(b) The earlier of the following dates:**

5 **1. The date the apparent owner becomes seventy and one-half (70 ½)**
6 **years of age, if determinable by the holder; or**

7 **2. If 26 U.S.C. secs. 1 et seq., as amended, requires distribution to avoid**
8 **a tax penalty, two (2) years after the date the holder:**

9 **a. Receives confirmation of the death of the apparent owner in the**
10 **ordinary course of its business; or**

11 **b. Confirms the death of the apparent owner under subsection (2)**
12 **of this section.**

13 **(2) If a holder in the ordinary course of its business receives notice or an indication**
14 **of the death of an apparent owner and subsection (1)(b) of this section applies,**
15 **the holder shall attempt not later than ninety (90) days after receipt of the notice**
16 **or indication to confirm whether the apparent owner is deceased.**

17 **(3) If the holder does not send communications to the apparent owner of an account**
18 **described in subsection (1) of this section by first-class United States mail, the**
19 **holder shall attempt to confirm the apparent owner's interest in the property by**
20 **sending the apparent owner an electronic-mail communication not later than two**
21 **(2) years after the apparent owner's last indication of interest in the property.**
22 **However, the holder promptly shall attempt to contact the apparent owner by**
23 **first-class United States mail if:**

24 **(a) The holder does not have information needed to send the apparent owner**
25 **an electronic-mail communication or the holder believes that the apparent**
26 **owner's electronic-mail address in the holder's records is not valid;**

27 **(b) The holder receives notification that the electronic-mail communication**

- 1 was not received; or
- 2 (c) The apparent owner does not respond to the electronic-mail communication
 3 within thirty (30) days after the communication was sent.
- 4 (4) If first-class United States mail sent under subsection (3) of this section is
 5 returned to the holder undelivered by the United States Postal Service, the
 6 property shall be presumed abandoned three (3) years after the later of:
- 7 (a) Except as provided in paragraph (b) of this subsection, the date a second
 8 consecutive communication to contact the apparent owner sent by first-class
 9 United States mail is returned to the holder undelivered;
- 10 (b) If the second communication is sent later than thirty (30) days after the date
 11 the first communication is returned undelivered, the date the first
 12 communication was returned undelivered; or
- 13 (c) The date established by subsection (1)(b) of this section.

14 ➔SECTION 6. A NEW SECTION OF KRS CHAPTER 393A IS CREATED TO
 15 READ AS FOLLOWS:

16 Subject to Section 12 of this Act and except for property described in Section 5 of this
 17 Act and property held in a plan described in 26 U.S.C. sec. 529A, property held in an
 18 account or plan, including a health savings account, that qualifies for tax deferral
 19 under the income-tax laws of the United States shall be presumed abandoned if it is
 20 unclaimed by the apparent owner three (3) years after the earlier of:

- 21 (1) The date, if determinable by the holder, specified in the income-tax laws and
 22 regulations of the United States by which distribution of the property shall begin
 23 to avoid a tax penalty, with no distribution having been made; or
- 24 (2) Thirty (30) years after the date the account was opened.

25 ➔SECTION 7. A NEW SECTION OF KRS CHAPTER 393A IS CREATED TO
 26 READ AS FOLLOWS:

27 (1) Subject to Section 12 of this Act, property held in an account established under

1 the Uniform Transfers to Minors Act, KRS 385.012 to 385.242, shall be presumed
2 abandoned if it is unclaimed by or on behalf of the minor on whose behalf the
3 account was opened three (3) years after the later of:

4 (a) Except as provided in paragraph (b) of this subsection, the date a second
5 consecutive communication sent by the holder by first-class United States
6 mail to the custodian of the minor on whose behalf the account was opened
7 is returned undelivered to the holder by the United States Postal Service;

8 (b) If the second communication is sent later than thirty (30) days after the date
9 the first communication is returned undelivered, the date the first
10 communication was returned undelivered; or

11 (c) The date on which the custodian is required to transfer the property to the
12 minor or the minor's estate in accordance with the Uniform Gifts to Minors
13 Act or Uniform Transfers to Minors Act of the state in which the account
14 was opened.

15 (2) If the holder does not send communications to the custodian of the minor on
16 whose behalf an account described in subsection (1) of this section was opened by
17 first-class United States mail, the holder shall attempt to confirm the custodian's
18 interest in the property by sending the custodian an electronic-mail
19 communication not later than two (2) years after the custodian's last indication
20 of interest in the property. However, the holder promptly shall attempt to contact
21 the custodian by first-class United States mail if:

22 (a) The holder does not have information needed to send the custodian an
23 electronic-mail communication or the holder believes that the custodian's
24 electronic-mail address in the holder's records is not valid;

25 (b) The holder receives notification that the electronic-mail communication
26 was not received; or

27 (c) The custodian does not respond to the electronic-mail communication

- 1 within thirty (30) days after the communication was sent.
- 2 (3) If first-class United States mail sent under subsection (2) of this section is
3 returned undelivered to the holder by the United States Postal Service, the
4 property shall be presumed abandoned three (3) years after the later of:
- 5 (a) The date a second consecutive communication to contact the custodian by
6 first-class United States mail is returned to the holder undelivered by the
7 United States Postal Service; or
- 8 (b) The date established by subsection (1)(c) of this section.
- 9 (4) When the property in the account described in subsection (1)(c) of this section is
10 transferred to the minor on whose behalf an account was opened or to the
11 minor's estate, the property in the account shall no longer be subject to this
12 section.

13 ➔SECTION 8. A NEW SECTION OF KRS CHAPTER 393A IS CREATED TO
14 READ AS FOLLOWS:

15 Tangible property held in a safe-deposit box and proceeds from a sale of the property
16 by the holder permitted by law of this state other than this chapter are presumed
17 abandoned if the property remains unclaimed by the apparent owner five (5) years
18 after the earlier of the:

- 19 (1) Expiration of the lease or rental period for the box; or
- 20 (2) Earliest date when the lessor of the box is authorized by law of this state other
21 than this chapter to enter the box and remove or dispose of the contents without
22 consent or authorization of the lessee.

23 ➔SECTION 9. A NEW SECTION OF KRS CHAPTER 393A IS CREATED TO
24 READ AS FOLLOWS:

- 25 (1) Subject to Section 12 of this Act, the net card value of a stored-value card, other
26 than a payroll card or a gift card, shall be presumed abandoned on the latest of
27 three (3) years after:

1 (a) December 31 of the year in which the card is issued or additional funds are
2 deposited into it;

3 (b) The most recent indication of interest in the card by the apparent owner; or

4 (c) A verification or review of the balance by or on behalf of the apparent
5 owner.

6 (2) The amount presumed abandoned in a stored-value card shall be the net card
7 value at the time it is presumed abandoned.

8 ➔SECTION 10. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
9 TO READ AS FOLLOWS:

10 (1) Subject to Section 12 of this Act, a security shall be presumed abandoned three
11 (3) years after:

12 (a) The date a second consecutive communication sent by the holder by first-
13 class United States mail to the apparent owner is returned to the holder
14 undelivered by the United States Postal Service; or

15 (b) If the second communication is made later than thirty (30) days after the
16 first communication is returned, the date the first communication is
17 returned undelivered to the holder by the United States Postal Service.

18 (2) If the holder does not send communications to the apparent owner of a security
19 by first-class United States mail, the holder shall attempt to confirm the apparent
20 owner's interest in the security by sending the apparent owner an electronic-mail
21 communication not later than two (2) years after the apparent owner's last
22 indication of interest in the security. However, the holder promptly shall attempt
23 to contact the apparent owner by first-class United States mail if:

24 (a) The holder does not have information needed to send the apparent owner
25 an electronic-mail communication or the holder believes that the apparent
26 owner's electronic-mail address in the holder's records is not valid;

27 (b) The holder receives notification that the electronic-mail communication

1 was not received; or

2 (c) The apparent owner does not respond to the electronic-mail communication
 3 within thirty (30) days after the communication was sent.

4 (3) If first-class United States mail sent under subsection (2) of this section is
 5 returned to the holder undelivered by the United States Postal Service, the
 6 security shall be presumed abandoned three (3) years after the date the mail is
 7 returned.

8 ➔SECTION 11. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 9 TO READ AS FOLLOWS:

10 At and after the time property is presumed abandoned under this chapter, any other
 11 property right or interest accrued or accruing from the property and not previously
 12 presumed abandoned shall also be presumed abandoned.

13 ➔SECTION 12. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 14 TO READ AS FOLLOWS:

15 (1) The period after which property shall be presumed abandoned shall be measured
 16 from the later of:

17 (a) The date the property is presumed abandoned under this chapter; or

18 (b) The latest indication of interest by the apparent owner in the property.

19 (2) Under this chapter, an indication of an apparent owner's interest in property
 20 includes:

21 (a) A record communicated by the apparent owner to the holder or agent of the
 22 holder concerning the property or the account in which the property is held;

23 (b) An oral communication by the apparent owner to the holder or agent of the
 24 holder concerning the property or the account in which the property is held,
 25 if the holder or its agent contemporaneously makes and preserves a record
 26 of the fact of the apparent owner's communication;

27 (c) Presentment of a check or other instrument of payment of a dividend,

- 1 interest payment, or other distribution, or evidence of receipt of a
2 distribution made by electronic or similar means, with respect to an
3 account, underlying security, or interest in a business association;
- 4 (d) Activity directed by an apparent owner in the account in which the property
5 is held, including accessing the account or information concerning the
6 account, or a direction by the apparent owner to increase, decrease, or
7 otherwise change the amount or type of property held in the account;
- 8 (e) A deposit into or withdrawal from an account at a financial organization,
9 including an automatic deposit or withdrawal previously authorized by the
10 apparent owner other than an automatic reinvestment of dividends or
11 interest;
- 12 (f) Subject to subsection (5) of this section, payment of a premium on an
13 insurance policy; and
- 14 (g) Any other action by the apparent owner which reasonably demonstrates to
15 the holder that the apparent owner knows that the property exists.
- 16 (3) An action by an agent or other representative of an apparent owner, other than
17 the holder acting as the apparent owner's agent, shall be presumed to be an
18 action on behalf of the apparent owner.
- 19 (4) A communication with an apparent owner by a person other than the holder or
20 the holder's representative shall not be an indication of interest in the property by
21 the apparent owner unless a record of the communication evidences the apparent
22 owner's knowledge of a right to the property.
- 23 (5) If the insured dies or the insured or beneficiary of an insurance policy otherwise
24 becomes entitled to the proceeds before depletion of the cash surrender value of
25 the policy by operation of an automatic-premium-loan provision or other
26 nonforfeiture provision contained in the policy, the operation shall not prevent
27 the policy from maturing or terminating.

1 ➔SECTION 13. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
2 TO READ AS FOLLOWS:

3 (1) As used in this section, "death master file" means the United States Social
4 Security Administration Death Master File or other database or service that is at
5 least as comprehensive as the United States Social Security Administration Death
6 Master File for determining that an individual reportedly has died.

7 (2) With respect to a life or endowment insurance policy or annuity contract for
8 which an amount is owed on proof of death, but which has not matured by proof
9 of death of the insured or annuitant, the company has knowledge of the death of
10 an insured or annuitant when:

11 (a) The company receives a death certificate or court order determining that the
12 insured or annuitant has died;

13 (b) The company conducts a comparison for any purpose between a death
14 master file and the names of some or all of the company's insureds or
15 annuitants, finds a match that provides notice that the insured or annuitant
16 has died, and validates the death;

17 (c) The administrator or the administrator's agent conducts a comparison for
18 the purpose of finding matches during an examination conducted under
19 Sections 55 to 65 of this Act between a death master file and the names of
20 some or all of the company's insureds or annuitants, finds a match that
21 provides notice that the insured or annuitant has died, and the company
22 validates the death; or

23 (d) The company:

24 1. Receives notice of the death of the insured or annuitant from an
25 administrator, beneficiary, policy owner, relative of the insured, or
26 trustee or from a personal representative, executor, or other legal
27 representative of the insured's or annuitant's estate; and

1 2. *Validates the death of the insured or annuitant.*

2 (3) *The following rules apply under this section:*

3 (a) *A death-master-file match under subsection (2)(b) or (c) of this section*
 4 *occurs if the criteria for an exact or partial match are satisfied as provided*
 5 *by KRS 304.15-420;*

6 (b) *The death-master-file match shall not constitute proof of death for the*
 7 *purpose of submission to an insurance company of a claim by a beneficiary,*
 8 *annuitant, or owner of the policy or contract for an amount due under an*
 9 *insurance policy or annuity contract; and*

10 (c) *The death-master-file match or validation of the insured's or annuitant's*
 11 *death shall not alter the requirements for a beneficiary, annuitant, or owner*
 12 *of the policy or contract to make a claim to receive proceeds under the terms*
 13 *of the policy or contract.*

14 ➔SECTION 14. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 15 TO READ AS FOLLOWS:

16 *If proceeds payable under a life or endowment insurance policy or annuity contract are*
 17 *deposited into an account with check or draft-writing privileges for the beneficiary of*
 18 *the policy or contract and, under a supplementary contract not involving annuity*
 19 *benefits other than death benefits, the proceeds are retained by the insurance company*
 20 *or the financial organization where the account is held, the policy or contract includes*
 21 *the assets in the account.*

22 ➔SECTION 15. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 23 TO READ AS FOLLOWS:

24 *In Sections 15 to 21 of this Act:*

25 (1) *The last-known address of an apparent owner shall be any description, code, or*
 26 *other indication of the location of the apparent owner which identifies the state,*
 27 *even if the description, code, or indication of location shall not be sufficient to*

1 direct the delivery of first-class United States mail to the apparent owner;

2 (2) If the United States postal zip code associated with the apparent owner is for a
 3 post office located in this state, this state shall be deemed to be the state of the
 4 last-known address of the apparent owner unless other records associated with
 5 the apparent owner specifically identify the physical address of the apparent
 6 owner to be in another state;

7 (3) If the address under subsection (2) of this section is in another state, the other
 8 state shall be deemed to be the state of the last-known address of the apparent
 9 owner; and

10 (4) The address of the apparent owner of a life or endowment insurance policy or
 11 annuity contract or its proceeds shall be presumed to be the address of the
 12 insured or annuitant if a person other than the insured or annuitant is entitled to
 13 the amount owed under the policy or contract and the address of the other person
 14 is not known by the insurance company and cannot be determined under Section
 15 16 of this Act.

16 ➔SECTION 16. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 17 TO READ AS FOLLOWS:

18 The administrator may take custody of property that is presumed abandoned, whether
 19 located in this state, another state, or a foreign country if:

20 (1) The last-known address of the apparent owner in the records of the holder is in
 21 this state; or

22 (2) The records of the holder do not reflect the identity or last-known address of the
 23 apparent owner, but the administrator has determined that the last-known
 24 address of the apparent owner is in this state.

25 ➔SECTION 17. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 26 TO READ AS FOLLOWS:

27 (1) Except as provided in subsection (2) of this section, if records of a holder reflect

1 multiple addresses for an apparent owner and this state is the state of the most
2 recently recorded address, this state may take custody of property presumed
3 abandoned, whether located in this state or another state.

4 (2) If it appears from records of the holder that the most recently recorded address of
5 the apparent owner under subsection (1) of this section is a temporary address
6 and this state is the state of the next most recently recorded address that is not a
7 temporary address, this state may take custody of the property presumed
8 abandoned.

9 ➔SECTION 18. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
10 TO READ AS FOLLOWS:

11 (1) Except as provided in subsection (2) of this section or Section 16 or 17 of this Act,
12 the administrator may take custody of property presumed abandoned, whether
13 located in this state, another state, or a foreign country, if the holder is domiciled
14 in this state or is this state or a governmental subdivision, agency, or
15 instrumentality of this state, and:

16 (a) Another state or foreign country shall not be entitled to the property
17 because there is no last-known address of the apparent owner or other
18 person entitled to the property in the records of the holder; or

19 (b) The state or foreign country of the last-known address of the apparent
20 owner or other person entitled to the property does not provide for custodial
21 taking of the property.

22 (2) Property shall not be subject to the custody of the administrator under subsection
23 (1) of this section if the property is specifically exempt from custodial taking
24 under the law of this state or the state or foreign country of the last-known
25 address of the apparent owner.

26 (3) If a holder's state of domicile has changed since the time property was presumed
27 abandoned, the holder's state of domicile in this section shall be deemed to be the

1 state where the holder was domiciled at the time the property was presumed
2 abandoned.

3 ➔SECTION 19. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
4 TO READ AS FOLLOWS:

5 Except as in Section 16, 17, or 18 of this Act, the administrator may take custody of
6 property presumed abandoned whether located in this state or another state if:

7 (1) The transaction out of which the property arose took place in this state;

8 (2) The holder is domiciled in a state that does not provide for the custodial taking of
9 the property, except that if the property is specifically exempt from custodial
10 taking under the law of the state of the holder's domicile, the property shall not
11 be subject to the custody of the administrator; and

12 (3) The last-known address of the apparent owner or other person entitled to the
13 property is unknown or in a state that does not provide for the custodial taking of
14 the property, except that if the property is specifically exempt from custodial
15 taking under the law of the state of the last-known address, the property shall not
16 be subject to the custody of the administrator.

17 ➔SECTION 20. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
18 TO READ AS FOLLOWS:

19 The administrator may take custody of sums payable on a traveler's check, money
20 order, or similar instrument presumed abandoned to the extent permissible under 12
21 U.S.C. secs. 2501 to 2503, as amended.

22 ➔SECTION 21. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
23 TO READ AS FOLLOWS:

24 If the administrator asserts a right to custody of unclaimed property, the administrator
25 has the burden to prove:

26 (1) The existence and amount of the property;

27 (2) The property shall be presumed abandoned; and

1 **(3) The property shall be subject to the custody of the administrator.**

2 ➔SECTION 22. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
3 TO READ AS FOLLOWS:

4 **(1) A holder of property presumed abandoned and subject to the custody of the**
5 **administrator shall report in a record to the administrator concerning the**
6 **property. A holder shall not be required to file a report if the holder has no**
7 **property that is presumed abandoned. The administrator shall not require a**
8 **holder to file a paper report.**

9 **(2) A holder may contract with a third party to make the report required under**
10 **subsection (1) of this section.**

11 **(3) Whether or not a holder contracts with a third party under subsection (2) of this**
12 **section, the holder shall be responsible:**

13 **(a) To the administrator for the complete, accurate, and timely reporting of**
14 **property presumed abandoned; and**

15 **(b) For paying or delivering to the administrator property described in the**
16 **report.**

17 ➔SECTION 23. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
18 TO READ AS FOLLOWS:

19 **(1) The report required under Section 22 of this Act shall:**

20 **(a) Be signed by or on behalf of the holder and verified as to its completeness**
21 **and accuracy;**

22 **(b) If filed electronically, be in a secure format approved by the administrator**
23 **which protects confidential information of the apparent owner in the same**
24 **manner as required of the administrator and the administrator's agent**
25 **under Sections 77 to 83 of this Act;**

26 **(c) Describe the property;**

27 **(d) Except for a traveler's check, money order, or similar instrument, contain**

- 1 the name, if known, last-known address, if known, and Social Security
2 number or taxpayer identification number, if known or readily
3 ascertainable, of the apparent owner of property with a value of fifty dollars
4 (\$50) or more;
- 5 (e) For an amount held or owing under a life or endowment insurance policy
6 or annuity contract, contain the name and last-known address of the
7 insured, annuitant, or other apparent owner of the policy or contract and of
8 the beneficiary;
- 9 (f) For property held in or removed from a safe-deposit box, indicate the
10 location of the property, where it may be inspected by the administrator, and
11 any amounts owed to the holder under Section 36 of this Act;
- 12 (g) Contain the commencement date for determining abandonment under
13 Sections 4 to 14 of this Act;
- 14 (h) State that the holder has complied with the notice requirements of Section
15 27 of this Act;
- 16 (i) Identify property that is a non-freely transferable security and explain why
17 it is a non-freely transferable security; and
- 18 (j) Contain other information the administrator prescribes.
- 19 (2) A report under Section 22 of this Act may include in the aggregate items valued
20 under fifty dollars (\$50) each. If the report includes items in the aggregate valued
21 under fifty dollars (\$50) each, the administrator shall not require the holder to
22 provide the name and address of an apparent owner of an item unless the
23 information is necessary to verify or process a claim in progress by the apparent
24 owner.
- 25 (3) A report under Section 22 of this Act may include personal information as
26 described in subsection (1) of Section 78 of this Act about the apparent owner or
27 the apparent owner's property to the extent not otherwise prohibited by federal

1 law.

2 (4) If a holder has changed its name while holding property presumed abandoned or
3 is a successor to another person that previously held the property for the apparent
4 owner, the holder shall include in the report under Section 22 of this Act its
5 former name or the name of the previous holder, if any, and the known name and
6 address of each previous holder of the property.

7 ➔SECTION 24. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
8 TO READ AS FOLLOWS:

9 (1) Except as otherwise provided in subsection (2) of this section, and subject to
10 subsection (3) of this section, the report under Section 22 of this Act shall be filed
11 before November 1 of each year and cover the 12 months preceding July 1 of that
12 year.

13 (2) Subject to subsection (3) of this section, the report under Section 22 of this Act to
14 be filed by an insurance company shall be filed before May 1 of each year for the
15 immediately preceding calendar year.

16 (3) Before the date for filing the report under Section 22 of this Act, the holder of
17 property presumed abandoned may request the administrator extend the time for
18 filing. The administrator may grant an extension. If the extension is granted, the
19 holder may pay or make a partial payment of the amount the holder estimates
20 ultimately will be due. The payment or partial payment terminates accrual of
21 interest on the amount paid.

22 ➔SECTION 25. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
23 TO READ AS FOLLOWS:

24 A holder required to file a report under Section 22 of this Act shall retain records for
25 ten (10) years after the later of the date the report was filed or the last date a timely
26 report was due to be filed, unless a shorter period shall be provided by rule of the
27 administrator. The holder may satisfy the requirement to retain records under this

1 section through an agent. The records shall contain:

2 (1) The information required to be included in the report;

3 (2) The date, place, and nature of the circumstances that gave rise to the property
4 right;

5 (3) The amount or value of the property;

6 (4) The last address of the apparent owner, if known to the holder; and

7 (5) If the holder sells, issues, or provides to others for sale or issue in this state
8 traveler's checks, money orders, or similar instruments, other than third-party
9 bank checks, on which the holder is directly liable, a record of the instruments
10 while they remain outstanding indicating the state and date of issue.

11 ➔SECTION 26. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
12 TO READ AS FOLLOWS:

13 Property shall be reportable and payable or deliverable under this chapter even if the
14 owner fails to make demand or present an instrument or document otherwise required
15 to obtain payment.

16 ➔SECTION 27. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
17 TO READ AS FOLLOWS:

18 (1) Subject to subsection (2) of this section, the holder of property presumed
19 abandoned shall send to the apparent owner notice by first-class United States
20 mail that complies with Section 28 of this Act in a format acceptable to the
21 administrator not more than one hundred eighty (180) days nor less than sixty
22 (60) days before filing the report under Section 22 of this Act if:

23 (a) The holder has in its records an address for the apparent owner which the
24 holder's records do not disclose to be invalid and is sufficient to direct the
25 delivery of first-class United States mail to the apparent owner; and

26 (b) The value of the property is fifty dollars (\$50) or more.

27 (2) If an apparent owner has consented to receive electronic-mail delivery from the

1 holder, the holder shall send the notice described in subsection (1) of this section
 2 both by first-class United States mail to the apparent owner's last-known mailing
 3 address and by electronic mail, unless the holder believes that the apparent
 4 owner's electronic-mail address is invalid.

5 ➔SECTION 28. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 6 TO READ AS FOLLOWS:

7 (1) Notice under Section 27 of this Act shall contain a heading that reads
 8 substantially as follows: "Notice. The Commonwealth of Kentucky requires us to
 9 notify you that your property may be transferred to the custody of the Kentucky
 10 State Treasurer if you do not contact us before (insert date that is thirty (30) days
 11 after the date of this notice)."

12 (2) The notice under Section 27 of this Act shall:

13 (a) Identify the nature and, except for property that does not have a fixed value,
 14 the value of the property that is the subject of the notice;

15 (b) State that the property shall be turned over to the administrator;

16 (c) State that after the property is turned over to the administrator, an apparent
 17 owner that seeks return of the property shall file a claim with the
 18 administrator;

19 (d) State that property that is not legal tender of the United States may be sold
 20 by the administrator; and

21 (e) Provide instructions that the apparent owner shall follow to prevent the
 22 holder from reporting and paying or delivering the property to the
 23 administrator.

24 ➔SECTION 29. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 25 TO READ AS FOLLOWS:

26 (1) The administrator shall give notice to an apparent owner that property presumed
 27 abandoned and appears to be owned by the apparent owner shall be held by the

1 administrator under this chapter.

2 (2) In providing notice under subsection (1) of this section, the administrator shall:

3 (a) Not be required to use newspaper publication to provide notice; and

4 (b) Maintain a Web site or database accessible by the public and electronically
 5 searchable that contains the names reported to the administrator of all
 6 apparent owners for whom property is being held by the administrator.

7 (3) The Web site or database maintained under subsection (2)(b) of this section shall
 8 include instructions for filing with the administrator a claim to property and a
 9 printable claim form with instructions for its use.

10 (4) In addition to giving notice under subsection (2) of this section, the administrator
 11 may use printed publication, telecommunication, the Internet, or other media to
 12 inform the public of the existence of unclaimed property held by the
 13 administrator.

14 ➔SECTION 30. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 15 TO READ AS FOLLOWS:

16 Unless prohibited by law other than this chapter, on request of the administrator, each
 17 officer, agency, board, commission, division, and department of this state, any body
 18 politic and corporate created by this state for a public purpose, and each political
 19 subdivision of this state shall make its books and records available to the administrator
 20 and cooperate with the administrator to determine the current address of an apparent
 21 owner of property held by the administrator under this chapter.

22 ➔SECTION 31. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 23 TO READ AS FOLLOWS:

24 In Sections 31 to 39 of this Act, payment or delivery of property shall be made in good
 25 faith if a holder:

26 (1) Had a reasonable basis for believing, based on the facts then known, that the
 27 property was required or permitted to be paid or delivered to the administrator

1 under this chapter; or

2 (2) Made payment or delivery:

3 (a) In response to a demand by the administrator or administrator's agent; or

4 (b) Under a guidance or ruling issued by the administrator which the holder
5 reasonably believed required or permitted the property to be paid or
6 delivered.

7 ➔SECTION 32. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
8 TO READ AS FOLLOWS:

9 (1) A holder may deduct a dormancy charge from property required to be paid or
10 delivered to the administrator if:

11 (a) A valid contract between the holder and the apparent owner authorizes
12 imposition of the charge for the apparent owner's failure to claim the
13 property within a specified time; and

14 (b) The holder regularly imposes the charge and regularly does not reverse or
15 otherwise cancel the charge.

16 (2) The amount of the deduction under subsection (1) of this section shall be limited
17 to an amount that shall not be unconscionable considering all relevant factors,
18 including the marginal transactional costs incurred by the holder in maintaining
19 the apparent owner's property and any services received by the apparent owner.

20 ➔SECTION 33. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
21 TO READ AS FOLLOWS:

22 (1) Except as otherwise provided in this section, on filing a report under Section 22
23 of this Act, the holder shall pay or deliver to the administrator the property
24 described in the report.

25 (2) If property in a report under Section 22 of this Act is an automatically renewable
26 deposit and a penalty or forfeiture in the payment of interest would result from
27 paying the deposit to the administrator at the time of the report, the date for

- 1 payment of the property to the administrator is extended until a penalty or
2 forfeiture no longer would result from payment, if the holder informs the
3 administrator of the extended date.
- 4 (3) Tangible property in a safe-deposit box shall not be delivered to the administrator
5 until one hundred twenty (120) days after filing the report under Section 22 of
6 this Act.
- 7 (4) If property reported to the administrator under Section 22 of this Act is a security,
8 the administrator may:
- 9 (a) Make an endorsement, instruction, or entitlement order on behalf of the
10 apparent owner to invoke the duty of the issuer, its transfer agent, or the
11 securities intermediary to transfer the security; or
- 12 (b) Dispose of the security under Section 41 of this Act.
- 13 (5) If the holder of property reported to the administrator under Section 22 of this
14 Act is the issuer of a certificated security, the administrator may obtain a
15 replacement certificate in physical or book-entry form under KRS 355.8-405. An
16 indemnity bond shall not be required.
- 17 (6) The administrator shall establish procedures for the registration, issuance,
18 method of delivery, transfer, and maintenance of securities delivered to the
19 administrator by a holder.
- 20 (7) An issuer, holder, and transfer agent or other person acting under this section
21 under instructions of and on behalf of the issuer or holder shall not be liable to
22 the apparent owner for, and shall be indemnified by the state against, a claim
23 arising with respect to property after the property has been delivered to the
24 administrator.
- 25 (8) A holder shall not be required to deliver to the administrator a security identified
26 by the holder as a non-freely transferable security. If the administrator or holder
27 determines that a security is no longer a non-freely transferable security, the

1 holder shall deliver the security on the next regular date prescribed for delivery of
2 securities under this act. The holder shall make a determination annually
3 whether a security identified in a report filed under Section 22 of this Act as a
4 non-freely transferable security is no longer a non-freely transferable security.

5 ➔SECTION 34. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
6 TO READ AS FOLLOWS:

7 (1) On payment or delivery of property to the administrator under this chapter, the
8 administrator as agent for the state assumes custody and responsibility for
9 safekeeping the property. A holder that pays or delivers property to the
10 administrator in good faith and substantially complies with Sections 27 and 28 of
11 this Act shall be relieved of liability arising thereafter with respect to payment or
12 delivery of the property to the administrator.

13 (2) This state shall defend and indemnify a holder against liability on a claim against
14 the holder resulting from the payment or delivery of property to the administrator
15 made in good faith and after the holder substantially complied with Sections 27
16 and 28 of this Act.

17 ➔SECTION 35. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
18 TO READ AS FOLLOWS:

19 (1) A holder that pays money to the administrator under this chapter may file a claim
20 for reimbursement from the administrator of the amount paid if the holder:

21 (a) Paid the money in error; or

22 (b) After paying the money to the administrator, paid money to a person the
23 holder reasonably believed to be entitled to the money.

24 (2) If a claim for reimbursement under subsection (1) of this section is made for a
25 payment made on a negotiable instrument, including a traveler's check, money
26 order, or similar instrument, the holder shall submit proof that the instrument
27 was presented and payment was made to a person the holder reasonably believed

- 1 entitled to payment. The holder may claim reimbursement even if the payment
2 was made to a person whose claim was made after expiration of a period of
3 limitation on the owner's right to receive or recover property, whether specified
4 by contract, statute, or court order.
- 5 (3) A holder that delivers property other than money to the administrator under this
6 chapter may file a claim under section 51 of this Act for return of the property
7 from the administrator if:
- 8 (a) The holder delivered the property in error; or
9 (b) The apparent owner has claimed the property from the holder.
- 10 (4) If a claim for return of property under subsection (3) of this section is made, the
11 holder shall include with the claim evidence sufficient to establish that the
12 apparent owner has claimed the property from the holder or that the property was
13 delivered by the holder to the administrator in error.
- 14 (5) The administrator may determine that an affidavit submitted by a holder is
15 evidence sufficient to establish that the holder shall be entitled to reimbursement
16 or to recover property under this section.
- 17 (6) A holder shall not be required to pay a fee or other charge for reimbursement or
18 return of property under this section.
- 19 (7) Not later than ninety (90) days after a claim is filed under subsection (1) or (3) of
20 this section, the administrator shall allow or deny the claim and give the claimant
21 notice of the decision in a record. If the administrator does not take action on a
22 claim during the ninety (90) day period, the claim shall be deemed denied.
- 23 (8) The claimant may initiate a proceeding under KRS Chapter 13B for review of the
24 administrator's decision or the deemed denial under subsection (7) of this section
25 not later than:
- 26 (a) Thirty (30) days following receipt of the notice of the administrator's
27 decision; or

1 (b) One hundred twenty (120) days following the filing of a claim under
 2 subsection (1) or (3) of this section in the case of a deemed denial under
 3 subsection (7) of this section.

4 (9) A final decision in an administrative proceeding initiated under subsection (8) of
 5 this section shall be subject to judicial review under KRS Chapter 13B.

6 ➔SECTION 36. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 7 TO READ AS FOLLOWS:

8 Property removed from a safe-deposit box and delivered under this Act to the
 9 administrator shall be subject to the holder's right to reimbursement for the cost of
 10 opening the box and a lien or contract providing reimbursement to the holder for
 11 unpaid rent charges for the box. The administrator shall reimburse the holder from the
 12 proceeds remaining after deducting the expense incurred by the administrator in
 13 selling the property.

14 ➔SECTION 37. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 15 TO READ AS FOLLOWS:

16 (1) The administrator may decline to take custody of property reported under Section
 17 22 of this Act if the administrator determines that:

18 (a) The property has a value less than the estimated expenses of notice and sale
 19 of the property; or

20 (b) Taking custody of the property would be unlawful.

21 (2) A holder may pay or deliver property to the administrator before the property
 22 shall be presumed abandoned under this chapter if the holder:

23 (a) Sends the apparent owner of the property notice required by Section 27 of
 24 this Act and provides the administrator evidence of the holder's compliance
 25 with this paragraph;

26 (b) Includes with the payment or delivery a report regarding the property
 27 conforming to Section 23 of this Act; and

1 (c) First obtains the administrator's consent in a record to accept payment or
2 delivery.

3 (3) A holder's request for the administrator's consent under subsection (2)(c) of this
4 section shall be in a record. If the administrator fails to respond to the request not
5 later than thirty (30) days after receipt of the request, the administrator shall be
6 deemed to consent to the payment or delivery of the property and the payment or
7 delivery shall be considered to have been made in good faith.

8 (4) On payment or delivery of property under subsection (2) of this section, the
9 property shall be presumed abandoned.

10 ➔SECTION 38. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
11 TO READ AS FOLLOWS:

12 (1) If the administrator takes custody of property delivered under this chapter and
13 later determines that the property has no substantial commercial value or that the
14 cost of disposing of the property will exceed the value of the property, the
15 administrator may return the property to the holder or destroy or otherwise
16 dispose of the property.

17 (2) In disposing of property under subsection (1) of this section, the administrator
18 may deliver the property to the Kentucky Historical Society, or any other
19 museum, historical society, or organization approved by the administrator, and
20 on such terms as the administrator deems appropriate. Upon delivery of the
21 property to a third party described in this subsection, the administrator shall no
22 longer be responsible for the safekeeping of the property.

23 (3) An action or proceeding shall not be commenced against the state, an agency of
24 the state, the administrator, another officer, employee, or agent of the state, or a
25 holder for or because of an act of the administrator under this section, except for
26 intentional misconduct or malfeasance.

27 ➔SECTION 39. A NEW SECTION OF KRS CHAPTER 393A IS CREATED

1 TO READ AS FOLLOWS:

2 (1) Expiration, before, on, or after the effective date of this Act, of a period of
 3 limitation on an owner's right to receive or recover property, whether specified by
 4 contract, statute, or court order, shall not prevent the property from being
 5 presumed abandoned or affect the duty of a holder under this chapter to file a
 6 report or pay or deliver property to the administrator.

7 (2) The administrator shall not commence an action or proceeding to enforce this
 8 chapter with respect to the reporting, payment, or delivery of property more than
 9 five (5) years after the holder filed a non-fraudulent report under Section 22 of
 10 this Act with the administrator. The parties may agree in a record to extend the
 11 limitation in this subsection.

12 (3) The administrator shall not commence an action, proceeding, or examination
 13 with respect to a duty of a holder under this chapter more than ten (10) years
 14 after the duty arose.

15 ➔SECTION 40. A NEW SECTION OF KRS CHAPTER 393A IS CREATED

16 TO READ AS FOLLOWS:

17 (1) Subject to Section 41 of this Act, the administrator may sell the property no
 18 earlier than three (3) years after receipt of property presumed abandoned.

19 (2) Before selling property under subsection (1) of this section, the administrator
 20 shall give notice to the public of:

21 (a) The date of the sale; and

22 (b) A reasonable description of the property.

23 (3) A sale under subsection (1) of this section shall be to the highest bidder:

24 (a) At public sale at a location in this state which the administrator determines
 25 to be the most favorable market for the property;

26 (b) On the Internet; or

27 (c) On another forum the administrator determines is likely to yield the highest

1 net proceeds of sale.

2 (4) The administrator may decline the highest bid at a sale under this section and
3 reoffer the property for sale if the administrator determines the highest bid is
4 insufficient.

5 (5) If a sale held under this section is to be conducted other than on the Internet, the
6 administrator shall publish at least one (1) notice of the sale, at least three (3)
7 weeks but not more than five (5) weeks before the sale, in a newspaper of general
8 circulation in the county in which the property is sold.

9 ➔SECTION 41. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
10 TO READ AS FOLLOWS:

11 (1) The administrator shall not sell or otherwise liquidate a security until three (3)
12 years after the administrator receives the security and gives the apparent owner
13 notice under Section 29 of this Act that the administrator holds the security.

14 (2) The administrator shall not sell a security listed on an established stock exchange
15 for less than the price prevailing on the exchange at the time of sale. The
16 administrator may sell a security not listed on an established exchange by any
17 commercially reasonable method.

18 ➔SECTION 42. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
19 TO READ AS FOLLOWS:

20 (1) If securities are sold by the administrator before the expiration of three (3) years
21 after their delivery to the administrator, a person making a claim under this
22 chapter before the end of the three (3) year period shall be entitled to the proceeds
23 of the sale of the securities or the market value of the securities at the time the
24 claim is made, plus dividends, interest, and other increments up to the time the
25 claim is made, less any deduction for expenses of the sale.

26 (2) A person making a claim under this chapter after the expiration of the three (3)
27 year period shall be entitled to receive the securities delivered to the administrator

1 by the holder, if the securities remain in the custody of the administrator, or the
 2 net proceeds received from the sale, and shall not be entitled to receive any
 3 appreciation in the value of the property occurring after the delivery to the
 4 administrator.

5 ➔SECTION 43. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 6 TO READ AS FOLLOWS:

7 A purchaser of property at a sale conducted by the administrator under this chapter
 8 takes the property free of all claims of the owner, a previous holder, or a person
 9 claiming through the owner or holder. The administrator shall execute documents
 10 necessary to complete the transfer of ownership to the purchaser.

11 ➔SECTION 44. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 12 TO READ AS FOLLOWS:

13 (1) The administrator shall not sell a medal or decoration awarded for military
 14 service in the Armed Forces of the United States.

15 (2) The administrator, with the consent of the respective organization under
 16 paragraphs (a) to (c) of this subsection, may deliver a medal or decoration
 17 described in subsection (1) of this section to be held in custody for the owner, to:

18 (a) A military veterans organization qualified under 26 U.S.C. sec. 501(c)(19);

19 (b) The agency that awarded the medal or decoration;

20 (c) The Kentucky Historical Society, or any museum or historical society
 21 approved by the administrator; or

22 (d) A governmental entity.

23 (3) On delivery under subsection (2) of this section, the administrator shall not be
 24 responsible for safekeeping the medal or decoration.

25 ➔SECTION 45. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 26 TO READ AS FOLLOWS:

27 The administrator shall deposit in the State Treasury all funds received under this

1 chapter, including proceeds from the sale of property under Sections 40 to 44 of this
2 Act.

3 ➔SECTION 46. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
4 TO READ AS FOLLOWS:

5 The administrator shall:

- 6 (1) Record and retain the name and last-known address of each person shown on a
7 report filed under Section 22 of this Act to be the apparent owner of property
8 delivered to the administrator;
9 (2) Record and retain the name and last-known address of each insured or annuitant
10 and beneficiary shown on the report;
11 (3) For each policy of insurance or annuity contract listed in the report of an
12 insurance company, record and retain the policy or account number, the name of
13 the company, and the amount due or paid; and
14 (4) For each apparent owner listed in the report, record and retain the name of the
15 holder that filed the report and the amount due or paid.

16 ➔SECTION 47. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
17 TO READ AS FOLLOWS:

- 18 (1) In addition to the expenses permitted under Section 92 of this Act, the
19 administrator may deduct:
20 (a) Expenses of disposition of property delivered to the administrator under this
21 chapter;
22 (b) Costs of mailing and publication in connection with property delivered to
23 the administrator under this chapter;
24 (c) Reasonable service charges; and
25 (d) Expenses incurred in examining records of or collecting property from a
26 putative holder or holder.
27 (2) In addition to any expenses in subsection (1) of this section, the administrator

1 shall deduct the proportionate costs of advertisement and operations from the
 2 amount of any claim allowed in an amount greater than ten dollars (\$10). The
 3 administrator shall deduct at least one dollar (\$1).

4 ➔SECTION 48. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 5 TO READ AS FOLLOWS:

6 Property received by the administrator under this chapter shall be held in custody for
 7 the benefit of the owner and shall not be owned by the state.

8 ➔SECTION 49. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 9 TO READ AS FOLLOWS:

10 (1) If the administrator knows that property held by the administrator under this
 11 chapter is subject to a superior claim of another state, the administrator shall:

12 (a) Report and pay or deliver the property to the other state; or

13 (b) Return the property to the holder so that the holder may pay or deliver the
 14 property to the other state.

15 (2) The administrator shall not be required to enter into an agreement to transfer
 16 property to the other state under subsection (1) of this section.

17 ➔SECTION 50. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 18 TO READ AS FOLLOWS:

19 (1) Property held under this chapter by the administrator shall be subject to the right
 20 of another state to take custody of the property if:

21 (a) The property was paid or delivered to the administrator because the records
 22 of the holder did not reflect a last-known address in the other state of the
 23 apparent owner and:

24 1. The other state establishes that the last-known address of the apparent
 25 owner or other person entitled to the property was in the other state;

26 or

27 2. Under the law of the other state, the property has become subject to a

1 claim by the other state of abandonment;

2 (b) The records of the holder did not accurately identify the owner of the
3 property, the last-known address of the owner was in another state, and,
4 under the law of the other state, the property has become subject to a claim
5 by the other state of abandonment;

6 (c) The property was subject to the custody of the administrator of this state
7 under Section 19 of this Act and, under the law of the state of domicile of
8 the holder, the property has become subject to a claim of abandonment by
9 the state of domicile of the holder; or

10 (d) The property:

11 1. Is a sum payable on a traveler's check, money order, or similar
12 instrument that was purchased in the other state and delivered to the
13 administrator under Section 20 of this Act; and

14 2. Under the law of the other state, has become subject to a claim by the
15 other state of abandonment.

16 (2) A claim by another state to recover property under this section shall be presented
17 in a form prescribed by the administrator, unless the administrator waives
18 presentation of the form.

19 (3) The administrator shall decide a claim under this section not later than ninety
20 (90) days after it is presented. If the administrator determines that the other state
21 is entitled under subsection (1) of this section to custody of the property, the
22 administrator shall allow the claim and pay or deliver the property to the other
23 state.

24 (4) The administrator may require another state, before recovering property under
25 this section, to agree to indemnify this state and its agents, officers, and
26 employees against any liability on a claim to the property.

27 ➔SECTION 51. A NEW SECTION OF KRS CHAPTER 393A IS CREATED

1 TO READ AS FOLLOWS:

- 2 (1) A person claiming to be the owner of property held under this chapter by the
3 administrator may file a claim for the property on a form prescribed by the
4 administrator. The claimant shall verify the claim as to its completeness and
5 accuracy.
- 6 (2) The administrator may permit persons claiming to be the owner of property to
7 submit claims in electronic format.
- 8 (3) The administrator may waive the requirement in subsection (1) of this section
9 and may pay or deliver property directly to a person if:
- 10 (a) The person receiving the property or payment is shown to be the apparent
11 owner included on a report filed under Section 22 of this Act;
- 12 (b) The administrator reasonably believes the person is entitled to receive the
13 property or payment; and
- 14 (c) The property has a value of less than two hundred fifty dollars (\$250).

15 ➔SECTION 52. A NEW SECTION OF KRS CHAPTER 393A IS CREATED

16 TO READ AS FOLLOWS:

- 17 (1) The administrator shall pay or deliver property to a claimant under subsection (1)
18 of Section 51 of this Act if the administrator receives evidence sufficient to
19 establish to the satisfaction of the administrator that the claimant is the owner of
20 the property.
- 21 (2) Not later than ninety (90) days after a claim is filed under subsection (1) of
22 Section 51 of this Act, the administrator shall allow or deny the claim and give
23 the claimant notice in a record of the decision.
- 24 (3) If the claim is denied under subsection (2) of this section:
- 25 (a) The administrator shall inform the claimant of the reason for the denial
26 and specify what additional evidence, if any, is required for the claim to be
27 allowed;

1 **(b) The claimant may file an amended claim with the administrator or request**
2 **and administrative hearing under Section 54 of this Act; and**

3 **(c) The administrator shall consider an amended claim filed under paragraph**
4 **(b) of this subsection as an initial claim.**

5 **(4) If the administrator does not take action on a claim during the ninety (90) day**
6 **period following the filing of a claim under subsection (1) of Section 51 of this**
7 **Act, the claim shall be deemed denied.**

8 ➔SECTION 53. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
9 TO READ AS FOLLOWS:

10 **(1) Not later than thirty (30) days after a claim is allowed under subsection (2) of**
11 **Section 52 of this Act, the administrator shall pay or deliver to the owner the**
12 **property or pay to the owner the net proceeds of a sale of the property. On request**
13 **of the owner, the administrator may sell or liquidate a security and pay the net**
14 **proceeds to the owner, even if the security had been held by the administrator for**
15 **less than three (3) years or the administrator has not complied with the notice**

17 **(2) Property held under this chapter by the administrator shall be subject to a claim**
18 **for the payment of an enforceable debt the owner owes in this state for:**

19 **(a) Child-support arrearages, including child-support collection costs and**
20 **child-support arrearages that are combined with maintenance;**

21 **(b) A civil or criminal fine or penalty, court costs, a surcharge, or restitution**
22 **imposed by a final order of an administrative agency or a final court**
23 **judgment; or**

24 **(c) State or local taxes, penalties, and interest that have been determined to be**
25 **delinquent or as to which notice has been recorded with the county sheriff**
26 **or local taking authority.**

27 **(3) Before delivery or payment to an owner under subsection (1) of this section of**

1 property or payment to the owner of net proceeds of a sale of the property, the
 2 administrator first shall apply the property or net proceeds to a debt under
 3 subsection (2) of this section the administrator determines is owed by the owner.
 4 The administrator shall pay the amount to the appropriate state or local agency
 5 and notify the owner of the payment.

6 (4) The administrator may make periodic inquiries of state and local agencies in the
 7 absence of a claim filed under Section 51 of this Act to determine whether an
 8 apparent owner included in the unclaimed-property records of this state have
 9 enforceable debts described in subsection (2) of this section. The administrator
 10 first shall apply the property or net proceeds of a sale of property held by the
 11 administrator to a debt under subsection (2) of this section of an apparent owner
 12 which appears in the records of the administrator and deliver the amount to the
 13 appropriate state or local agency. The administrator shall notify the apparent
 14 owner of the payment.

15 ➔SECTION 54. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 16 TO READ AS FOLLOWS:

17 Not later than one (1) year after filing a claim under subsection (1) of Section 51 of
 18 this Act, the claimant may request in writing an administrative hearing, to be
 19 conducted in accordance with KRS Chapter 13B.

20 ➔SECTION 55. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 21 TO READ AS FOLLOWS:

22 If a person does not file a report required by Section 22 of this Act or the administrator
 23 believes that a person may have filed an inaccurate, incomplete, or false report, the
 24 administrator may require the person to file a verified report in a form prescribed by
 25 the administrator. The verified report shall:

26 (1) State whether the person is holding property reportable under this chapter;

27 (2) Describe property not previously reported or about which the administrator has

1 inquired;

2 (3) Specifically identify property described under subsection (2) of this section about
3 which there is a dispute whether it is reportable under this chapter; and

4 (4) State the amount or value of the property.

5 ➔SECTION 56. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
6 TO READ AS FOLLOWS:

7 The administrator, at reasonable times and on reasonable notice, may:

8 (1) Examine the records of a person, including examination of appropriate records
9 in the possession of an agent of the person under examination, if the records are
10 reasonably necessary to determine whether the person has complied with this
11 chapter;

12 (2) Issue an administrative subpoena requiring the person or agent of the person to
13 make records available for examination; and

14 (3) Bring an action seeking judicial enforcement of the subpoena.

15 ➔SECTION 57. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
16 TO READ AS FOLLOWS:

17 (1) The administrator shall promulgate administrative regulations in accordance
18 with KRS Chapter 13A governing procedures and standards for an examination
19 under Section 56 of this Act, including rules for use of an estimation,
20 extrapolation, and statistical sampling in conducting an examination.

21 (2) An examination under Section 56 of this Act shall be performed under
22 administrative regulations promulgated under subsection (1) of this section and
23 with generally accepted examination practices and standards applicable to an
24 unclaimed-property examination.

25 (3) If a person subject to examination under Section 56 of this Act has filed the
26 reports required under Sections 22 and 55 of this Act and has retained the
27 records required by Section 25 of this Act, the following shall apply to the

1 examination:

2 (a) The examination shall include a review of the person's records;

3 (b) The examination shall not be based on an estimate unless the person
4 expressly consents in a record to the use of an estimate; and

5 (c) The person conducting the examination shall consider the evidence
6 presented in good faith by the person in preparing the findings of the
7 examination under Section 61 of this Act.

8 ➔SECTION 58. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
9 TO READ AS FOLLOWS:

10 Records obtained and records, including work papers, compiled by the administrator in
11 the course of conducting an examination under Section 56 of this Act:

12 (1) Shall be subject to the confidentiality and security provisions of Sections 77 to 83
13 of this Act and are not public records;

14 (2) May be used by the administrator in an action to collect property or otherwise
15 enforce this chapter;

16 (3) May be used in a joint examination conducted with another state, the United
17 States, a foreign country or subordinate unit of a foreign country, or any other
18 governmental entity if the governmental entity conducting the examination is
19 legally bound to maintain the confidentiality and security of information
20 obtained from a person subject to examination in a manner substantially
21 equivalent to Sections 77 to 83 of this Act;

22 (4) Shall be disclosed, on request, to the person that administers the unclaimed
23 property law of another state for that state's use in circumstances equivalent to
24 circumstances described in this Sections 55 to 65 of this Act, if the other state is
25 required to maintain the confidentiality and security of information obtained in a
26 manner substantially equivalent to Sections 77 to 83 of this Act;

27 (5) Shall be produced by the administrator under an administrative or judicial

1 subpoena or administrative or court order; and

2 (6) Shall be produced by the administrator on request of the person subject to the
3 examination in an administrative or judicial proceeding relating to the property.

4 ➔SECTION 59. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
5 TO READ AS FOLLOWS:

6 (1) A record of a putative holder showing an unpaid debt or undischarged obligation
7 shall be prima facie evidence of the debt or obligation.

8 (2) A putative holder may establish by a preponderance of the evidence that there is
9 no unpaid debt or undischarged obligation for a debt or obligation described in
10 subsection (1) of this section or that the debt or obligation was not, or no longer
11 is, a fixed and certain obligation of the putative holder.

12 (3) A putative holder may overcome prima facie evidence under subsection (1) of this
13 section by establishing by a preponderance of the evidence that a check, draft, or
14 similar instrument was:

15 (a) Issued as an unaccepted offer in settlement of an unliquidated amount;

16 (b) Issued but later was replaced with another instrument because the earlier
17 instrument was lost or contained an error that was corrected;

18 (c) Issued to a party affiliated with the issuer;

19 (d) Paid, satisfied, or discharged;

20 (e) Issued in error;

21 (f) Issued without consideration;

22 (g) Issued but there was a failure of consideration;

23 (h) Voided not later than ninety (90) days after issuance for a valid business
24 reason set forth in a contemporaneous record; or

25 (i) Issued but not delivered to the third-party payee for a sufficient reason
26 recorded within a reasonable time after issuance.

27 (4) In asserting a defense under this section, a putative holder may present evidence

1 of a course of dealing between the putative holder and the apparent owner or of
2 custom and practice.

3 ➔SECTION 60. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
4 TO READ AS FOLLOWS:

5 If a person subject to examination under Section 56 of this Act does not retain the
6 records required by Section 25 of this Act, the administrator may determine the value
7 of property due using a reasonable method of estimation based on all information
8 available to the administrator, including extrapolation and use of statistical sampling
9 when appropriate and necessary, consistent with examination procedures and
10 standards adopted under Section 57 of this Act.

11 ➔SECTION 61. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
12 TO READ AS FOLLOWS:

13 At the conclusion of an examination under Section 56 of this Act, the administrator
14 shall provide to the person whose records were examined a complete and unredacted
15 examination report that specifies:

16 (1) The work performed;

17 (2) The property types reviewed;

18 (3) The methodology of any estimation technique, extrapolation, or statistical
19 sampling used in conducting the examination;

20 (4) Each calculation showing the value of property determined to be due; and

21 (5) The findings of the person conducting the examination.

22 ➔SECTION 62. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
23 TO READ AS FOLLOWS:

24 (1) If a person subject to examination under Section 56 of this Act believes the
25 person conducting the examination has made an unreasonable or unauthorized
26 request or is not proceeding expeditiously to complete the examination, the
27 person in a record may ask the administrator to intervene and take appropriate

1 remedial action, including countermanding the request of the person conducting
 2 the examination, imposing a time limit for completion of the examination, or
 3 reassigning the examination to another person.

4 (2) If a person in a record requests a conference with the administrator to present
 5 matters that are the basis of a request under subsection (1) of this section, the
 6 administrator shall hold the conference not later than thirty (30) days after
 7 receiving the request. The administrator may hold the conference in person, by
 8 telephone, or by electronic means.

9 (3) If a conference is held under subsection (2) of this section, not later than thirty
 10 (30) days after the conference ends, the administrator shall provide a report in a
 11 record of the conference to the person that requested the conference.

12 ➔SECTION 63. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 13 TO READ AS FOLLOWS:

14 (1) As used in this section, "related to the administrator" means an individual who
 15 is:

16 (a) The administrator's spouse, partner in a civil union, domestic partner, or
 17 reciprocal beneficiary;

18 (b) The administrator's child, stepchild, grandchild, parent, stepparent, sibling,
 19 stepsibling, half-sibling, aunt, uncle, niece, or nephew;

1 **(b) A business entity, the entity shall not be owned in whole or in part by the**
 2 **administrator or an individual related to the administrator.**

3 **(4) If the administrator contracts with a person under subsection (2) of this section:**

4 **(a) The contract may provide for compensation of the person based on a fixed**
 5 **fee, hourly fee, or contingent fee;**

6 **(b) A contingent fee arrangement shall not provide for a payment that exceeds**
 7 **ten percent (10%) of the amount or value of property paid or delivered as a**
 8 **result of the examination; and**

9 **(c) On request by a person subject to examination by a contractor, the**
 10 **administrator shall deliver to the person a complete and unredacted copy of**
 11 **the contract and any contract between the contractor and a person**
 12 **employed or engaged by the contractor to conduct the examination.**

13 **(5) A contract under subsection (2) of this section shall be subject to KRS 61.870 to**
 14 **61.884.**

15 ➔SECTION 64. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 16 TO READ AS FOLLOWS:

17 **The administrator or an individual employed by the administrator who participates in,**
 18 **recommends, or approves the award of a contract under Section 63 of this Act on or**
 19 **after the effective date of this Act shall not be employed by, contract with, or**
 20 **compensated in any capacity by the contractor or an affiliate of the contractor for two**
 21 **(2) years after the latest of participation in, recommendation of, or approval of the**
 22 **award or conclusion of the contract.**

23 ➔SECTION 65. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 24 TO READ AS FOLLOWS:

25 **If the administrator determines from an examination conducted under Section 56 of**
 26 **this Act that a putative holder failed or refused to pay or deliver to the administrator**
 27 **property which is reportable under this chapter, the administrator shall issue a**

1 determination of the putative holder's liability to pay or deliver and give notice in a
2 record to the putative holder of the determination.

3 ➔SECTION 66. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
4 TO READ AS FOLLOWS:

5 (1) Not later than thirty (30) days after receipt of a notice under Section 65 of this
6 Act, the putative holder may request an informal conference with the
7 administrator to review the determination. Except as otherwise provided in this
8 section, the administrator may designate an employee to act on behalf of the
9 administrator.

10 (2) If a putative holder makes a timely request under subsection (1) of this section for
11 an informal conference:

7 given an opportunity to confer informally with the administrator and the person
8 that examined the records of the putative holder to:
- 9 (a) Discuss the determination made under Section 65 of this Act; and

- 11 (5) If the administrator fails to act within the period prescribed in paragraph (a) or
12 (g) of subsection (2) of this section, the failure shall not affect a right of the
13 administrator, except that interest shall not accrue on the amount for which the
14 putative holder was determined to be liable under Section 65 of this Act during
15 the period in which the administrator failed to act until the earlier of:
- 16 (a) The date under Section 68 of this Act the putative holder initiates
17 administrative review or files an action under Section 69 of this Act; or
18 (b) Ninety (90) days after the putative holder received notice of the

20 initiated under Section 68 of this Act and no action was filed under Section
21 69 of this Act.

23 a determination under Section 65 of this Act without a request at any time before
24 the putative holder initiates administrative review under Section 68 of this Act or
25 files an action under Section 69 of this Act.
- 26 (7) Interest and penalties under Section 73 of this Act continue to accrue on property
27 not reported, paid, or delivered as required by this chapter after the initiation, and

1 during the pendency, of an informal conference under this section.

2 ➔SECTION 67. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
3 TO READ AS FOLLOWS:

4 A putative holder may seek relief from a determination under Section 65 of this Act by:

5 (1) Administrative review under Section 68 of this Act; or

6 (2) Judicial review under Section 69 of this Act.

7 ➔SECTION 68. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
8 TO READ AS FOLLOWS:

9 (1) Not later than ninety (90) days after receiving notice of the administrator's
10 determination under Section 65 of this Act, a putative holder may initiate a
11 proceeding under KRS Chapter 13B for review of the administrator's

13 (2) A final decision in an administrative proceeding initiated under subsection (1) of
14 this section shall be subject to judicial review under KRS Chapter 13B.

26 only if the state or foreign country has confidentiality and security requirements
27 substantially equivalent to those in Sections 77 to 83 of this Act or agrees in a

1 record to be bound by this state's confidentiality and security requirements.

4 (1) The administrator may join another state or foreign country to examine and seek

17 property subject to this chapter but delivered to the custody of another state if the
18 administrator believes the property is subject to the custody of the administrator.

20 country to commence an action to recover property on behalf of the administrator
21 and may agree to pay attorney's fees based in whole or in part on a fixed fee,
22 hourly fee, or a percentage of the amount or value of property recovered in the
23 action.

24 (6) Expenses incurred by this state in an action under this section may be paid from
25 property received under this chapter or the net proceeds of the property. Expenses
26 paid to recover property shall not be deducted from the amount that is subject to a
27 claim under this chapter by the owner.

3 (1) A holder that fails to report, pay, or deliver property within the time prescribed by

12 dollars (\$200) for each day the duty is not performed, up to a cumulative
13 maximum amount of five thousand dollars (\$5,000).

16 (1) If a holder enters into a contract or other arrangement for the purpose of evading

23 (2) Any provision of Sections 77 to 83 of this Act that applies to the administrator or
24 the administrator's records applies to an administrator's agent or the agent's
25 records.

26 ➔SECTION 78. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
27 TO READ AS FOLLOWS:

1 (1) Except as otherwise provided in this chapter, the following are confidential and
 2 exempt from public inspection or disclosure:

3 (a) Records of the administrator and the administrator's agent related to the
 4 administration of this chapter;

5 (b) Reports and records of a holder in the possession of the administrator or the
 6 administrator's agent; and

7 (c) Personal information and other information derived or otherwise obtained
 8 by or communicated to the administrator or the administrator's agent from
 9 an examination under this chapter of the records of a person.

10 (2) A record or other information that is confidential under law of this state other
 11 than this chapter, another state, or the United States continues to be confidential
 12 when disclosed or delivered under this chapter to the administrator or
 13 administrator's agent.

14 ➔SECTION 79. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
 15 TO READ AS FOLLOWS:

16 (1) When reasonably necessary to enforce or implement this chapter, the
 17 administrator may disclose confidential information concerning property held by
 18 the administrator or the administrator's agent only to:

19 (a) An apparent owner or the apparent owner's personal representative,
 20 attorney, other legal representative, relative, or agent designated under
 21 Section 76 of this Act to have the information;

22 (b) The personal representative, executor, other legal representative, relative of
 23 a deceased apparent owner, agent designated under Section 76 of this Act
 24 by the deceased apparent owner, or a person entitled to inherit from the
 25 deceased apparent owner;

26 (c) Another department or agency of this state or the United States;

27 (d) The person that administers the unclaimed property law of another state, if

1 the other state accords substantially reciprocal privileges to the
2 administrator of this state if the other state is required to maintain the

5 (e) A person subject to an examination as required by subsection (6) of Section
6 60 of this Act.

7 (2) Except as otherwise provided in subsection (1) of Section 78 of this Act, the
8 administrator shall include on the Web site or in the database required by
9 subsection (2)(b) of Section 29 of this Act the name of each apparent owner of
10 property held by the administrator. The administrator may include in published
11 notices, printed publications, telecommunications, the Internet, or other media
12 and on the Web site or in the database additional information concerning the
13 apparent owner's property if the administrator believes the information will assist
14 in identifying and returning property to the owner and does not disclose personal
15 information except the home or physical address of an apparent owner.

16 (3) The administrator and the administrator's agent shall not use confidential
17 information provided to them or in their possession, except as expressly
18 authorized by this chapter or required by law other than this chapter.

8 *(1) If a holder is required to include confidential information in a report to the*
9 *administrator, the information shall be provided by a secure means.*

10 *(2) If confidential information in a record is provided to and maintained by the*
11 *administrator or administrator's agent as required by this chapter, the*
12 *administrator or agent shall:*

13 *(a) Implement administrative, technical, and physical safeguards to protect the*
14 *security, confidentiality, and integrity of the information as required by*

1 **(b) Shall ensure that an administrator's agent adopts and implements a similar**
2 **plan with respect to confidential information in the agent's possession.**

3 **(4) The administrator and the administrator's agent shall educate and train their**
4 **employees regarding the plan adopted under subsection (3) of this section.**

5 **(5) The administrator and the administrator's agent shall in a secure manner return**
6 **or destroy all confidential information no longer reasonably needed under this**
7 **chapter.**

25 **(3) If an event described in subsection (1) of this section occurs, the administrator**
26 **and the administrator's agent shall:**

27 **(a) Take action necessary for the holder to understand and minimize the effect**

- 1 of the event and determine its scope; and
- 2 **(b) Cooperate with the holder with respect to:**
- 3 **1. Any notification required by law concerning a data or other security**
- 4 **breach; and**
- 5 **2. A regulatory inquiry, litigation, or similar action.**

13 **This chapter modifies, limits, or supersedes 15 U.S.C. secs. 7001 et seq., but does not**
14 **modify, limit, or supersede 15 U.S.C. sec. 7001(c), or authorize electronic delivery of**
15 **any of the notices described in 15 U.S.C. sec. 7003(b).**

16 ➔SECTION 86. A NEW SECTION OF KRS CHAPTER 393A IS CREATED
17 TO READ AS FOLLOWS:

18 **(1) An initial report filed under this chapter for property that was not required to be**
19 **reported before the effective date of this Act, but that is required to be reported**
20 **under this chapter, shall include all items of property that would have been**
21 **presumed abandoned during the ten (10) year period preceding the effective date**
22 **of this Act as if this chapter had been in effect during that period.**

23 **(2) This chapter shall not relieve a holder of a duty that arose before the effective**

7 employment leaving unclaimed in the hands of the State Treasurer a sum arising
8 from such deduction not equal to the amount for which such a bond may be

11 the records of the Personnel Cabinet, a notice stating the sum held by the State

16 the date of mailing the letter, the officer or employee has not made claim for the
17 sum due him, the sum shall, as of July 1 following the expiration of such six-
18 months' period, be presumed abandoned.

19 (2) On or before September 1 of each year, the State Treasurer shall report to the
20 Department of Revenue, in duplicate, a list of the sums presumed to be abandoned
21 as of the preceding July 1, giving the name of the officer or employee and his last-
22 known address. The *State Treasurer*~~[Department of Revenue]~~ shall cause the report

4 debt, liability, or obligation of the Kentucky Higher Education Assistance
5 Authority, but shall be payable solely from the fund. Each prepaid tuition
6 contract shall contain a statement that the obligation shall be payable solely
7 from the fund.

8 (2) The purposes of the fund are:

9 (a) To provide affordable access to participating institutions for the qualified

11 (b) To provide students and their parents economic protection against rising
