

1 AN ACT relating to direct shipment of alcoholic beverages and declaring an
2 emergency.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 243.0305 is amended to read as follows:

- 5 (1) Any licensed Kentucky distiller that is located in wet territory or in any precinct that
6 has authorized the limited sale of alcoholic beverages at distilleries under KRS
7 242.1243 and that has a gift shop or other retail outlet on its premises may conduct
8 the activities permitted under this section as a part of its distiller's license.
- 9 (2) ***For purposes of all retail drink and package sales under this section,*** a wholesaler
10 registered to distribute the brands of any distiller ~~shall~~~~may~~ permit the distiller to
11 deliver ~~its products~~~~[a souvenir package]~~ directly from the distillery proper to any
12 portion of the distillery premises. However, ***for purposes of all retail drink and***
13 ***package sales by distillers under subsections (3), (8), and (9) of this section*** all
14 direct shipments shall be invoiced from the distiller to the wholesaler and from the
15 wholesaler to the distiller, and all products directly shipped shall be included in the
16 wholesaler's inventory and depletions for purposes of tax collections imposed
17 pursuant to KRS 243.710 to 243.895 and 243.990.
- 18 (3) A distiller may sell souvenir packages at retail~~[-to]~~:
- 19 ***(a) To*** distillery visitors of legal drinking age, in quantities not to exceed an
20 aggregate of four and one-half (4-1/2) liters per ~~purchaser~~~~[visitor]~~ per day ***for***
21 ***sales prior to January 1, 2021, and in quantities not to exceed an aggregate***
22 ***of nine (9) liters per purchaser per day on and after January 1, 2021. At the***
23 ***purchaser's request, an order may be delivered or shipped directly to the***
24 ***purchaser. All deliveries or shipments shall be made through a licensed***
25 ***common carrier authorized to deliver or ship distilled spirits in the***
26 ***jurisdiction to which the products will be delivered or shipped; and***
- 27 ***(b) Pursuant to subscription or distillery-sponsored club programs, in***

1 quantities not to exceed an aggregate of nine (9) liters per calendar year,
2 provided that the enrollment and payment for the subscription or club is
3 arranged in person at the distillery. At the member's request, an order may
4 be delivered or shipped directly to the member. All deliveries or shipments
5 shall be made through a licensed common carrier authorized to deliver or
6 ship distilled spirits in the jurisdiction to which the products will be
7 delivered or shipped.

- 8 (4) Hours of sale for souvenir packages at retail shall be in conformity with KRS
9 244.290(3).
- 10 (5) Except as provided in this section, souvenir package sales shall be governed by all
11 the statutes and administrative regulations governing the retail sale of distilled
12 spirits by the package.
- 13 (6) No wholesaler may restrict the sale of souvenir packages to the distiller of origin
14 exclusively, but shall make souvenir packages available to any Kentucky retail
15 licensee licensed for the sale of distilled spirits by the package.
- 16 (7) Notwithstanding any provision of KRS 244.050 to the contrary, a distillery holding
17 a sampling license may allow visitors to sample distilled spirits under the following
18 conditions:
- 19 (a) Sampling shall be permitted only on the licensed premises during regular
20 business hours;
- 21 (b) A distillery shall not charge for the samples; and
- 22 (c) A distillery shall not provide more than one and three-fourths (1-3/4) ounces
23 of samples per visitor per day.
- 24 (8) Notwithstanding the provisions of KRS 243.110, in accordance with this section, a
25 distillery located in wet territory or in any territory that has authorized the limited
26 sale of alcoholic beverages under an election held pursuant to KRS 242.1243 may:
- 27 (a) Hold an NQ2 retail drink license for the sale of alcoholic beverages on the

- 1 distillery premises~~]. Notwithstanding KRS 243.110, a licensed distiller may~~
2 ~~also hold any of the retail licenses available to it under this section]; **and**~~
- 3 (b) ~~[Sell alcoholic beverages produced or bottled on the premises of its Kentucky~~
4 ~~licensed distillery for on premises purposes without having to transfer~~
5 ~~physical possession of those alcoholic beverages to a licensed wholesaler if:~~
- 6 1. ~~All direct shipments are invoiced from the distiller to its wholesaler and~~
7 ~~from the wholesaler to the distiller; and~~
- 8 2. ~~All products directly shipped are included in the wholesaler's inventory~~
9 ~~and depletions for purposes of tax collections imposed pursuant to KRS~~
10 ~~243.710 to 243.890 and 243.990; and~~
- 11 ~~(c)]Employ persons to engage in the sale or service of alcohol under an NQ2~~
12 ~~license, if each employee completes the department's Server Training in~~
13 ~~Alcohol Regulations program within thirty (30) days of beginning~~
14 ~~employment.~~
- 15 (9) A distiller may sell to consumers at fairs, festivals, and other similar types of events
16 located in wet territory alcoholic beverages by the drink, containing spirits distilled
17 or bottled on the premises of the distillery.
- 18 (10) Except as expressly stated in this section, this section does not exempt the holder of
19 a distiller's license from:
- 20 (a) The provisions of KRS Chapters 241 to 244;
21 (b) The administrative regulations of the board; and
22 (c) Regulation by the board at all the distiller's licensed premises.
- 23 (11) Nothing in this section shall be construed to vitiate the policy of this
24 Commonwealth supporting an orderly three (3) tier system for the production and
25 sale of alcoholic beverages.
- 26 ➔Section 2. KRS 243.120 is amended to read as follows:
- 27 (1) A distiller's, rectifier's, or winery license shall authorize the licensee to engage in

- 1 the business of distiller, rectifier, or winery at the premises specifically designated
2 in the license, to maintain aging warehouses, and to transport for himself or herself
3 only any alcoholic beverage which he or she is authorized under the license to
4 manufacture or sell. The licensee shall transport alcoholic beverages only by a
5 vehicle operated by himself or herself, which has affixed to its sides at all times a
6 sign of form and size prescribed by the state board, containing among other things
7 the name and license number of the licensee. No distilled spirits or wine shall be
8 transported on the same truck or vehicle with malt beverages, except by a common
9 carrier, unless the owner of the truck or vehicle holds a distributor's license.
- 10 (2) (a) Distillers that produce more than fifty thousand (50,000) gallons of distilled
11 spirits per calendar year at the premises shall obtain a distiller's license, Class
12 A.
- 13 (b) Distillers that produce fifty thousand (50,000) gallons or less of distilled
14 spirits per calendar year at the premises shall obtain a distiller's license, Class
15 B (craft distillery).
- 16 (3) (a) Rectifiers that rectify more than fifty thousand (50,000) gallons of distilled
17 spirits per calendar year at the premises shall obtain a rectifier's license, Class
18 A.
- 19 (b) Rectifiers that rectify fifty thousand (50,000) gallons or less of distilled spirits
20 per calendar year at the premises shall obtain a rectifier's license, Class B
21 (craft rectifier).
- 22 (4) (a) A distiller that is located in wet territory, or in any precinct that has authorized
23 the limited sale of alcoholic beverages at distilleries under KRS 242.1243,
24 may sell distilled spirits by the drink ***or by the package*** at retail to consumers
25 in accordance with KRS 243.0305.
- 26 (b) Any distilled spirits sold under this subsection shall be taxed and distributed
27 in the same manner as ~~souvenir package~~ sales under KRS 243.0305(2).

- 1 (c) Except as provided in this subsection, sales under this subsection shall be
2 governed by all of the statutes and administrative regulations governing the
3 retail sale of distilled spirits by the drink.

4 **(5) Nothing in this section shall be construed to:**

5 **(a) Vitiating the policy of this Commonwealth supporting an orderly three (3) tier**
6 **system for the production and sale of alcoholic beverages; or**

7 **(b) Allow delivery or shipment of alcohol into dry or moist territory.**

8 ➔Section 3. KRS 243.130 is amended to read as follows:

- 9 (1) Sales and deliveries of distilled spirits and wine may be made at wholesale, and
10 from the licensed premises only:
- 11 (a) By distillers to rectifiers, wineries, holders of special nonbeverage alcohol
12 licenses so far as they may make the purchases, or other distillers;
- 13 (b) By rectifiers to wineries or to distillers if distilled spirits sold to distillers are
14 packaged in retail containers;
- 15 (c) By wineries to rectifiers or other wineries, or to the holders of special
16 nonbeverage alcohol licenses;
- 17 (d) By distillers, rectifiers, or wineries to wholesalers; or
- 18 (e) By distillers, rectifiers, or wineries for export out of the state.
- 19 (2) No distiller, rectifier, or winery shall sell or contract to sell, give away, or deliver
20 any alcoholic beverages to any person who is not authorized by the law of the state
21 of the person's residence, and of the United States government if located in the
22 United States, to receive and possess those alcoholic beverages. **Except as provided**
23 **in Section 1 of this Act,** no distiller, rectifier, or winery shall sell or contract to sell,
24 give away, or deliver any of its products to any retailer or consumer in Kentucky.
- 25 (3) Employees of distillers, rectifiers, and wineries may sample the products produced
26 by that manufacturer for purposes of education, quality control, and product
27 development.

- 1 (4) Distillers may purchase distilled spirits only from other licensed distillers in this
2 state or in another state or province, but distillers may purchase from rectifiers
3 licensed in Kentucky, distilled spirits which are packaged in retail containers.
- 4 (5) Rectifiers may purchase distilled spirits and wine only from licensed distillers or
5 wineries in Kentucky, or from nonresident distillers or wineries authorized by the
6 law of the state of their residence and by the United States government, if the
7 distillers or wineries are located in the United States, to make the sales.
- 8 (6) Wineries may purchase distilled spirits or wine only from licensed distillers or
9 wineries in Kentucky, or from nonresident distillers or wineries authorized by law
10 of the state of their residence, and by the United States government if located in the
11 United States, to make the sales.
- 12 (7) Nothing shall prohibit the purchase or sale of warehouse receipts by any person, but
13 this subsection does not authorize the owner of a warehouse receipt to accept
14 delivery of any distilled spirits unless the owner is a person who is permitted by law
15 to receive the distilled spirits.
- 16 **(8) Nothing in this section shall be construed to:**
- 17 **(a) Vitate the policy of this Commonwealth supporting an orderly three (3) tier**
18 **system for the production and sale of alcoholic beverages; or**
- 19 **(b) Allow delivery or shipment of alcohol into dry or moist territory.**
- 20 ➔Section 4. KRS 243.155 is amended to read as follows:
- 21 (1) Any in-state or out-of-state small farm winery may apply for a small farm winery
22 license. In addition to all other licensing requirements, an applicant for a small farm
23 winery license shall submit with its application a copy of the small farm winery's
24 federal basic permit and proof documenting its annual wine production. An out-of-
25 state winery shall submit additional documentation evidencing its resident state. As
26 part of the application process, an out-of-state winery shall publish its notice of
27 intent, as required by KRS 243.360, in the Kentucky newspaper of highest

1 circulation. The board shall promulgate administrative regulations establishing the
2 form the documentation of proof of production shall take.

3 (2) A small farm winery license shall authorize the licensee to perform the following
4 functions without having to obtain separate licenses, except that each small farm
5 winery off-premises retail site shall be separately licensed:

6 (a) Engage in the business of a winery under the terms and conditions of KRS
7 243.120 and 243.130. The manufacture of wine at the small farm winery shall
8 not be less than two hundred fifty (250) gallons, and shall not exceed one
9 hundred thousand (100,000) gallons, in one (1) year;

10 (b) Bottle wines produced by that small farm winery and other licensed small
11 farm wineries;

12 (c) Enter into an agreement with another licensed small farm winery under which
13 it crushes, processes, ferments, bottles, or any combination of these services,
14 the grapes, fruits, or other agricultural products of the other small farm winery
15 for a production year. The resulting wine shall be considered the product of
16 the small farm winery that provides the fruit. The small farm winery providing
17 the custom crushing services may exclude the wine produced under this
18 paragraph from its annual production gallonage;

19 (d) If the licensed small farm winery or off-premises retail site premises is located
20 in wet territory or in a precinct that has authorized alcoholic beverage sales by
21 the small farm winery under KRS 242.124:

22 1. Serve complimentary samples of wine produced by it in amounts not to
23 exceed six (6) ounces per patron per day; and

24 2. Sell by the drink for on-premises consumption or by the package wine
25 produced by it or by another licensed small farm winery, at retail to
26 consumers;

27 (e) Sell by the drink or by the package, at fairs, festivals, and other similar types

1 of events, wine produced by it or by another licensed small farm winery, at
2 retail to consumers if all sales occur in a wet territory;

3 (f) Sell and transport wine produced by it to licensed small farm winery off-
4 premises retail sites, wholesale license holders, and small farm winery license
5 holders;

6 (g) Consume on the premises wine produced by the small farm winery or a
7 licensed small farm winery and purchased by the drink or by the package at
8 the licensed premises, if the small farm winery is located in wet territory; and

9 (h) Deliver or ship packages of wine at retail:

10 1. To small farm winery visitors of legal drinking age, in quantities not
11 to exceed four (4) cases per purchaser per day. A winery shall deliver
12 or ship the packages to the purchaser through a licensed common
13 carrier that is authorized to deliver or ship wine in the jurisdiction to
14 which the products will be delivered or shipped; and

15 2. Pursuant to subscription or small farm winery-sponsored club
16 programs, in quantities not to exceed an aggregate of one (1) case per
17 month per calendar year, provided that the enrollment and payment
18 for the subscription or club is arranged in person at the small farm
19 winery. At the member's request, an order may be delivered or shipped
20 directly to the member. All deliveries or shipments shall be made
21 through a licensed common carrier authorized to deliver or ship wine
22 in the jurisdiction to which the products will be delivered or shipped to

23 a customer wine produced by a small farm winery if:

24 1. The wine is shipped by licensed common carrier; and

25 2. The amount of wine shipped is limited to two (2) cases per customer per
26 order].

27 (3) If the requirements of KRS 242.1241 or 244.290(5) relating to Sunday sales on the

1 licensed premises of a small farm winery are met, a small farm winery within that
2 territory may sell alcoholic beverages on Sunday only in accordance with this
3 section between the hours of 1 p.m. until the prevailing time for that locality.

4 (4) A small farm winery license holder may also hold an NQ2 retail drink license or an
5 NQ4 retail malt beverage drink license if:

6 (a) The small farm winery is located in wet territory or in a precinct that has
7 authorized alcoholic beverage sales by the small farm winery under KRS
8 242.124; and

9 (b) The issuance of these licenses is in connection with the establishment and
10 operation of a restaurant, hotel, inn, bed and breakfast, conference center, or
11 any similar business enterprise designed to promote viticulture, enology, and
12 tourism.

13 (5) This section shall not exempt the holder of a small farm winery license from the
14 provisions of KRS Chapters 241 to 244, nor from the administrative regulations of
15 the board, nor from regulation by the board at all premises licensed by the small
16 farm winery, except as expressly stated in this section.

17 (6) Nothing contained in this section shall exempt a licensed out-of-state winery from
18 obeying the laws of its resident state.

19 (7) Upon the approval of the department, a small farm winery license may be renewed
20 after the licensee submits to the department the winery's federal basic permit and
21 proof of its annual wine production.

22 (8) An employee of a small farm winery may sample the products produced by that
23 small farm winery for purposes of education, quality control, and product
24 development.

25 ➔Section 5. KRS 243.200 is amended to read as follows:

26 (1) A transporter's license may be issued as a primary license to a motor carrier
27 authorized to transact business in the Commonwealth by the Transportation Cabinet

1 or the Federal Motor Carrier Safety Administration or to another person engaged in
2 business as a common carrier. A person holding a transporter's license may
3 transport alcoholic beverages to or from the licensed premises of any licensee under
4 this chapter **to an individual consumer** if both the consignor and consignee in each
5 case are authorized by the law of the states of their residence to sell, purchase,
6 **deliver**, ship, or receive the alcoholic beverages.

7 (2) **A transporter may deliver or ship directly to consumers over twenty-one (21)**
8 **years of age in packages clearly marked "Alcoholic Beverages, adult signature**
9 **(21 years of age or over) required," and must request adult-signature-only service**
10 **from the carrier. Deliveries or shipments of alcoholic beverages shall only be**
11 **made into areas of the state in which alcoholic beverages may be lawfully sold.**
12 **When the shipper requests adult-signature-only service, it shall be a violation for**
13 **a common carrier not to inspect government-issued identification for proof of age**
14 **or to knowingly deliver or ship alcoholic beverages into areas of the state in**
15 **which alcoholic beverages are not legally sold.**

16 (3) **Except for a common carrier that has been assigned a USDOT number issued by**
17 **the Federal Motor Carrier Safety Administration,** the holder of a transporter's
18 license shall cause each truck or vehicle to display the name of the licensee and the
19 state license numbers in a manner prescribed by an administrative regulation
20 promulgated by the board.

21 ~~(4)~~ **Except for an application by a common carrier that has been assigned a**
22 **USDOT number issued by the Federal Motor Carrier Safety Administration,** an
23 application for a transporter's license shall include a statement that the applicant, if
24 issued a license, shall allow any authorized investigators of the department to stop
25 and examine the cargo of any truck or vehicle in which alcoholic beverages are
26 being transported within the boundaries of the Commonwealth of Kentucky.

27 ~~(5)~~ ~~(4)~~ Applicants for the transporter's license under this section, and their employees,

1 shall be exempt from the residency requirements of KRS 243.100.

2 ~~(6)~~~~(5)~~ A licensee may move, within the same county, alcoholic beverages from one
 3 (1) of the licensee's licensed premises to another without a transporter's license. A
 4 licensee may move alcoholic beverages from one (1) of the licensee's licensed
 5 premises located in one (1) county to a licensed premises located in another county,
 6 without a transporter's license, with prior written approval of the administrator for
 7 good cause shown. The licensee shall keep and maintain, in one (1) of its licensed
 8 premises, adequate books and records of the transactions involved in transporting
 9 alcoholic beverages from one (1) licensed premises to another in accordance with
 10 standards established in administrative regulations promulgated by the board. The
 11 records shall be available to the department and the Department of Revenue upon
 12 request.

13 ~~(7)~~~~(6)~~ Distilled spirits and wine may be transported by any licensed retailer selling
 14 distilled spirits or wine, by the package or by the drink, from the premises of a
 15 licensed wholesaler to the licensed premises of the retail licensee. Any retailer
 16 transporting alcoholic beverages under this subsection shall do so in a vehicle
 17 marked in conformity with administrative regulations of the board. Both the
 18 wholesaler and the retailer engaging in activity under this subsection shall be
 19 responsible for maintaining records documenting the transactions.

20 ➔Section 6. KRS 243.240 is amended to read as follows:

21 (1) A quota retail package license shall authorize the licensee to:

22 (a) Purchase, receive, possess, and sell distilled spirits and wine at retail in
 23 unbroken packages only, and only for consumption off the licensed
 24 premises~~[-];~~ and

25 (b) *Deliver or ship to the customer, at the customer's request, alcoholic*
 26 *beverages that are purchased:*

27 *1. From the licensed premises where eighty percent (80%) of the monthly*

1 gross sales receipts are sales to Kentucky residents, in quantities not to
 2 exceed four and one-half (4 1/2) liters of distilled spirits and four (4)
 3 cases of wine per purchaser per day for sales prior to January 1, 2021,
 4 and in quantities not to exceed an aggregate of nine (9) liters of
 5 distilled spirits and four (4) cases of wine per purchaser per day on
 6 and after January 1, 2021; and

7 2. By subscription members or club program members, in quantities not
 8 to exceed an aggregate of nine (9) liters per calendar year for distilled
 9 spirits, and an aggregate of one (1) case of wine per month per
 10 calendar year, provided that the enrollment and payment for the
 11 subscription or club is arranged in person at the premises.

12 (2) The licensee shall purchase distilled spirits and wine in retail packages only and
 13 only from licensed wholesalers.

14 (3) All deliveries or shipments made pursuant to this section shall be made through a
 15 licensed transporter or licensed common carrier authorized to deliver or ship
 16 distilled spirits in the jurisdiction to which the products will be delivered or
 17 shipped.

18 ➔Section 7. KRS 244.165 is amended to read as follows:

19 (1) Except as provided in subsections~~[subsection]~~ (2), (3), and (4) of this section, it
 20 shall be unlawful for any person in the business of selling alcoholic beverages in
 21 another state or country to deliver or ship or cause to be delivered or shipped any
 22 alcoholic beverage directly to any Kentucky resident who does not hold a valid
 23 wholesaler or distributor license issued by the Commonwealth of Kentucky.

24 (2) A winery or small farm winery located in another state may deliver or ship wine to
 25 a customer in Kentucky if:

26 (a) The wine, subscription, or club program membership, is purchased by the
 27 customer in person at the winery or small farm winery;

1 (b) *The Kentucky purchaser is of legal age;*

2 (c) *The out of state winery or small farm winery is licensed in Kentucky;*

3 (d) *Either:*

4 *1. No more than four (4) cases of wine are purchased per day per visit;*

5 *or*

6 *2. The wine is purchased pursuant to subscription, or winery-sponsored*

7 *or small farm winery-sponsored club programs, in quantities not to*

8 *exceed an aggregate of one (1) case of wine per month per calendar*

9 *year; and*

10 (e) The wine is *delivered or* shipped *through a licensed transporter or licensed*

11 *common carrier authorized to deliver or ship wine in the jurisdiction in*

12 *which the delivery or shipment will occur*~~[by licensed common carrier; and~~

13 ~~(c) The amount of wine shipped is limited to two (2) cases per customer per~~

14 ~~visit].~~

15 (3) *A distillery located in another state may deliver or ship distilled spirits directly to*

16 *a customer in Kentucky if:*

17 (a) *The distilled spirits, subscription, or club program membership, is*

18 *purchased by the customer in person at the distillery;*

19 (b) *The Kentucky purchaser is of legal age;*

20 (c) *The distillery is licensed in Kentucky;*

21 (d) *Either:*

22 *1. No more than four and one-half (4 1/2) liters of distilled spirits are*

23 *purchased per day per visit for sales prior to January 1, 2021, and in*

24 *quantities not to exceed an aggregate of nine (9) liters per purchaser*

25 *per day for sales on and after January 1, 2021; or*

26 *2. The distilled spirits are purchased pursuant to subscription or*

27 *distillery-sponsored club programs, in quantities not to exceed an*

1 aggregate of nine (9) liters of distilled spirits per calendar year; and
 2 (e) The distilled spirits are delivered or shipped through a licensed transporter
 3 or licensed common carrier authorized to deliver or ship distilled spirits in
 4 the jurisdiction in which the delivery or shipment will occur.

5 (4) A licensed transporter or common carrier making deliveries or shipments
 6 pursuant to this section shall deliver or ship directly to consumers over twenty-
 7 one (21) years of age in packages clearly marked "Alcoholic Beverages, adult
 8 signature (21 years of age or over) required," and must request adult-signature-
 9 only service from the carrier. Deliveries or shipments of alcoholic beverages shall
 10 only be made into areas of the state in which alcoholic beverages may be lawfully
 11 sold. When the shipper requests adult-signature-only service, it shall be a
 12 violation for a common carrier not to inspect government-issued identification
 13 for proof of age or to knowingly deliver or ship alcoholic beverages into areas of
 14 the state in which alcoholic beverages are not legally sold.

15 (5) Nothing contained in this section shall exempt a licensed out-of-state alcoholic
 16 beverage producer from obeying the laws of its resident state.

17 (6) Any person who violates subsection (1) of this section shall, for the first offense, be
 18 mailed a certified letter by the department ordering that person to cease and desist
 19 any deliveries or shipments of alcoholic beverages to Kentucky residents, and for
 20 the second and each subsequent offense, be guilty of a Class D felony.

21 ➔Section 8. KRS 244.240 is amended to read as follows:

22 (1) No distiller, rectifier, winery, or wholesaler and no employee, servant, or agent of a
 23 distiller, rectifier, winery, or wholesaler shall:

24 (a) Except as provided in Sections 1 and 4 of this Act, be interested directly or
 25 indirectly in any way in any premises where distilled spirits or wine is sold at
 26 retail or in any business devoted wholly or partially to the sale of distilled
 27 spirits or wine at retail;

- 1 (b) Make or cause to be made any loan to any person engaged in the manufacture
2 or sale of distilled spirits or wine at wholesale or retail;
- 3 (c) Make any gift or render any kind of service whatsoever, directly or indirectly,
4 to any licensee that may tend to influence the licensee to purchase the product
5 of the distiller, rectifier, winery, or wholesaler; or
- 6 (d) Enter into a contract with any retail licensee under which the licensee agrees
7 to confine the licensee's sales to distilled spirits or wine manufactured or sold
8 by one (1) or more distillers, rectifiers, wineries, or wholesalers. This type of
9 contract shall be void.

- 16 (1) No person, while representing either the buyer or seller, shall distribute, solicit, or
17 receive contracts, proposals, or orders for the purchase or sale of any alcoholic
18 beverages, or distribute any handbills or posters advertising them in dry territory.
- 19 (2) Each act of distributing, soliciting, or receiving contracts, proposals, or orders as
20 denounced in subsection (1), and each day in which advertising matter is
21 distributed, shall constitute a separate offense.
