- (1) The trust shall exercise ownership of all contributions made under any participation agreement and all interest derived from the investment of the contributions made by the participant up to the date of utilization for payment of *educational*[higher education] costs for the beneficiary. All contributions made under any participant agreement and interest derived from the investment of the contributions made by the participant shall be deemed to be held in trust for the benefit of the beneficiary;
- 18 Any participant may cancel a participation agreement at any time, and terminate the (2) 19 trust's ownership rights thereby created in whole or in part, by delivering an 20 instrument in writing signed and delivered to the program administrator or his 21 designee. - (b) The beneficiary's receipt of a scholarship, an educational assistance allowance under Chapters 30, 31, 32, 34, or 35 of Title 38, United States Code, or a payment exempt from income taxation by any law of the United States, other than a gift, bequest, devise, or inheritance within the meaning of Section 102(a) of the Internal Revenue Code, 26 U.S.C. sec. 102(a), for educational expenses, or attributable to attendance at an institution of higher education, to the extent that the amount refunded does not exceed the amount of the scholarship, allowance, or payment; and

The property of the trust and its income from operations shall be exempt from all taxation by the Commonwealth of Kentucky or any of its political subdivisions. Investment income earned on contributions paid by any participant and used for *qualified educational expenses*[higher education costs] defined in *subsection (13) of Section 1 of this Act*[KRS 164A.305(6)] or refunded under KRS 164A.350[(8)(a) or (b)] shall not be subject to Kentucky income tax by either a participant or any beneficiary of a participation agreement, the purposes for which the investment income was accrued being deemed and declared to be entirely public in nature. Earnings that are not used for *qualified educational expenses*[higher education costs] as defined in *subsection (13) of Section 1 of this Act*-[KRS 164A.305(6)] and are refunded shall be subject to Kentucky
