6		substantiated to show that a person is practicing the profession or trade without a
7		license, the disciplinary review committee shall prepare a letter signed by the
8		chair or an authorized representative that notifies the person of the committee's
9		belief that the person is practicing without a license. The letter shall request that
10		a person voluntarily cease practice of the profession or trade without a license.
11		The board may forward the complaint to the appropriate county attorney or
12		Commonwealth's attorney with a request that appropriate action be taken. The
