8	→SECTION 3. A NEW SECTION OF KRS CHAPTER 148 IS CREATED TO

10	(1) The authority shall be governed by a board consisting of fifteen (15) members
11	appointed as follows:
12	(a) The mayor shall appoint five (5) members to the board, including the vice
13	chair, representing diverse interests in Louisville; and
