2	WHEREAS, Working Interdisciplinary Networks of Guardianship Stakeholders,			
3	otherwise known as WINGS, is an innovative movement to improve adult guardianship;

5	WHEREAS, WINGS is a court-community partnership that drives changes affecting			
6	the ways courts and guardians practice; and			
7	WHEREAS, WINGS is broad-based and multi-disciplinary, including judges and			
8	court staff, the aging and disability networks, the public and private bar, mental health			
9	agencies, advocacy groups, medical and mental health professionals, service providers,			
10	and family members and individuals affected by guardianship; and			
11	WHEREAS, WINGS is a consensus-driven, problem-solving mechanism that offers			
12	a forum for considering how adult guardianship is working in the state, where pressure			
13	points exist, and possible solutions; and			
14	WHEREAS, the creation of WINGS by all states was a core recommendation of the			
15	2011 Third National Guardian Summit, sponsored by the ten National Guardianship			
16	Network organizations; and			
17	WHEREAS, the Conference of Chief Justices and the Conference of State Court			
18	Administrators have urged implementation of WINGS; and			
19	WHEREAS, over 20 states have already created WINGS or similar guardianship			
20	stakeholder partnerships;			
21	NOW, THEREFORE,			
22	Be it resolved by the General Assembly of the Commonwealth of Kentucky:			
23	→ Section 1. (1) The General Assembly recommends that the Cabinet for
