1	A RESOLUTION adjourning the House of Representatives in honor and loving
2	memory of Donald Ray Ball.
3	WHEREAS, Donald Ray Ball was a son of this Commonwealth, having been born
4	near Henderson on July 27, 1936, to the late James and Marjorie Ball; and
5	WHEREAS, Don Ball was a 1954 graduate of Hebbardsville High School who
6	attended the University of Kentucky before obtaining his real estate license. He and his
7	wife, Mira Ball, incorporated Ball Homes in 1959, and the business would go on to
8	become recognized not only in Kentucky but across the country; and
9	WHEREAS, Don Ball was a passionate advocate for affordable housing, and Ball
10	Homes reflected this philosophy. His humanitarianism toward Kentucky's most
11	vulnerable citizens, and his enduring compassion and empathy for his fellow citizens, will
12	endure long after his passing; and
13	WHEREAS, at the age of 28, Don Ball began service in the Kentucky General
14	Assembly as the State Representative for Kentucky's 55th Legislative District. He was a
15	member of the legislature from 1964 until 1969, serving as Caucus Chairman and
16	Minority Leader, and his commitment to advocacy and community engagement would
17	continue long after his career as a lawmaker concluded; and
18	WHEREAS, Don Ball served as President of the Building Industry Association, and
19	had been a member of that body since 1962. He was also a member of the National
20	Association of Home Builders Committee on Affordable Housing Task Force, the Federal
21	Commission for Distressed Public Housing, and the Lexington Board of Realtor's
22	Housing Foundation. He helped organize REACH, which assists lower-income
23	individuals and families in the home financing and buying process, and was essential in
24	the creation of Lexington's Affordable Housing Alliance. For his extraordinary work in
25	affordable housing, Mr. Ball was recognized by BUILDER Magazine with its first ever
26	Hearthstone BUILDER Humanitarian Award, and in 2012 the Homebuilders Association
27	of Lexington inducted Don and Mira Ball into its Hall of Fame; and

1	WHEREAS, in 1990, Don Ball helped to organize the HOPE Center, Lexington's
2	homeless shelter and recovery program for men. In 1993 he and Mira incorporated
3	Barkham, LLC, a nonprofit construction firm. Through Barkham, Mr. Ball built a one-
4	parent apartment facility now known as Scholar House; the HOPE Center for Women;
5	Chrysalis House Apartments; and Shepherd's House, a halfway house for men who have
6	completed substance abuse counseling; and
7	WHEREAS, Don Ball served with then-First Lady Jane Beshear on the Governor's
8	Recovery Kentucky Task Force, an ongoing initiative designed to combat the
9	Commonwealth's drug problem. In this capacity he was instrumental in the construction
10	of 16 residential recovery centers for men and women located around Kentucky; and
11	WHEREAS, in the 1970s, Don and Mira Ball established Donamire Farm, a 640-
12	acre Thoroughbred farm in Lexington. An avid horseman, Mr. Ball was deeply concerned
13	with the livelihood of backside workers, and in this spirit he was active with the
14	Kentucky Racing Health and Welfare Fund, which uses funds from pari-mutel wagering
15	to assist backside workers with health care costs. He also served three terms as president
16	of the Kentucky Thoroughbred Association, as past commissioner of the Kentucky Horse
17	Racing Authority, and was chair and a longtime board member of the Kentucky
18	Thoroughbred Development Fund; and
19	WHEREAS, throughout his extraordinary life, Don Ball kept his Henderson roots
20	close to his heart. In 2014, he was awarded an honorary associate's degree from
21	Henderson Community College for his contributions to education and to various
22	Henderson County activities, and for helping to better the lives of all citizens of the
23	Commonwealth, particularly those who are under-resourced; and
24	WHEREAS, Don Ball departed this earthly life on March 23, 2018, leaving his
25	family, friends, and an entire Commonwealth in solemn mourning; and
26	WHEREAS, Don Ball is survived by his wife, Mira Ball; children, Donald Ray Ball
27	Jr. and his wife, Linda, Michael Bryant Ball and his wife, Katherine, and Lisa Hays Ball;
