

1 AN ACT relating to retirement.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 6.505 is amended to read as follows:

4 (1) (a) Each legislator in office on July 1, 1980, may within thirty (30) days after that
5 date, and any legislator thereafter taking office may within thirty (30) days
6 after the date thereof, elect to make monthly contributions to the Legislators'
7 Retirement Plan, in an amount equal to five percent (5%) of his monthly
8 creditable compensation, as defined in KRS 61.510(13), **or the amount**
9 **specified by paragraph (d) of this subsection.** The election shall be effective
10 to establish membership in the plan as of July 1, 1980, or as of the date from
11 which the thirty (30) day period is measured, as the case may be. Provided,
12 however, that any legislator who was in office on July 1, 1980, and who is in
13 office at the time he makes the election may, after the expiration of the thirty
14 (30) day period and until May 1, 1982, make the election, in which event he
15 shall pay to the Legislators' Retirement Plan, for the months between July 1,
16 1980, and the date of his election such sum as, when added to any member's
17 contribution by him that is transferred from another retirement system under
18 KRS 6.535, will equal the member's contribution required by this section. If
19 the member makes his election after February 1, 1981, he shall in addition pay
20 to the plan interest on the foregoing sum, at six percent (6%) per annum,
21 calculated as if the sum consisted of equal monthly payments, one (1) of
22 which was due at the end of each month between July 1, 1980, and the date
23 the election was made. The election shall be addressed to and filed with the
24 secretary of the Finance and Administration Cabinet and shall constitute an
25 authorization to the secretary to thereafter cause to be deducted from the
26 member's monthly creditable compensation an amount equal to five percent
27 (5%) thereof, as a voluntarily elected contribution by the member towards the

1 funding of the Legislators' Retirement Plan.

2 (b) 1. For a member who begins participating in the Legislators' Retirement
3 Plan prior to January 1, 2014, the election shall operate to create an
4 inviolable contract between such member and the Commonwealth,
5 guaranteeing to and vesting in the member the rights and benefits
6 provided for under KRS 6.515 to 6.530, except that the General
7 Assembly reserves the right to amend, reduce, or suspend any
8 legislative changes to the provisions of KRS 6.500 to 6.577 that
9 become effective on or after July 1, 2018.

10 2. a. For members who begin participating in the Legislators'
11 Retirement Plan on or after January 1, 2014, the General Assembly
12 reserves the right to amend, suspend, or reduce the benefits and
13 rights provided under KRS 6.500 to 6.577 if, in its judgment, the
14 welfare of the Commonwealth so demands, except that the amount
15 of benefits the member has accrued at the time of amendment,
16 suspension, or reduction shall not be affected.

17 b. For purposes of this subparagraph, the amount of benefits the
18 member has accrued at the time of amendment, suspension, or
19 reduction shall be limited to the accumulated account balance the
20 member has accrued at the time of amendment, suspension, or
21 reduction.

22 c. The provisions of this subsection shall not be construed to limit the
23 General Assembly's authority to change any other benefit or right
24 specified by KRS 6.500 to 6.577, for members who begin
25 participating in the Legislators' Retirement Plan on or after January
26 1, 2014, except the benefits specified by subparagraph 2.b. of this
27 paragraph.

- 1 3. The provisions of this paragraph shall not be construed to limit the
2 General Assembly's authority to amend, reduce, or suspend the benefits
3 and rights of members of the Legislators' Retirement Plan as provided by
4 KRS 6.500 to 6.577 that the General Assembly had the authority to
5 amend, reduce, or suspend, prior to July 1, 2013.
- 6 (c) An election once made under this section either to participate or not to
7 participate in the Legislators' Retirement Plan, shall be considered to apply to
8 all future service as a legislator except as provided by Section 7 of this Act or
9 subsection (3) of Section 8 of this Act, whether in the same or a different
10 office as a legislator, and whether or not it is in successive terms.
- 11 (d) Notwithstanding the provisions of this subsection:
- 12 1. A legislator who becomes a member of the Legislators' Retirement Plan
13 on or after September 1, 2008, but prior to January 1, 2014, shall make
14 monthly contributions to the Legislators' Retirement Plan in an amount
15 equal to six percent (6%) of his monthly creditable compensation, as
16 defined in KRS 61.510(13);~~[-]~~
- 17 2. A legislator who becomes a member of the Legislators' Retirement Plan
18 on or after January 1, 2014, shall make monthly contributions to the
19 Legislators' Retirement Plan in an amount equal to six percent (6%) of
20 his or her monthly creditable compensation, as defined in KRS
21 61.510(13), of which:
- 22 a. Five percent (5%) of his or her monthly creditable compensation,
23 as defined in KRS 61.510(13), shall be used to provide funding for
24 benefits provided under KRS 21.402; and
- 25 b. One percent (1%) of his or her monthly creditable compensation,
26 as defined in KRS 61.510(13), shall be used exclusively to help
27 fund retiree health benefits as provided by KRS 6.577 and shall not

1 be refunded to the member if the member withdraws his or her
2 accumulated account balance as provided by KRS 21.460. The
3 amounts deducted under this subdivision shall be credited to an
4 account established pursuant to 26 U.S.C. sec. 401(h), within the
5 fund established by KRS 6.530.

6 (2) A legislator entitled to elect membership in the retirement system who failed to
7 elect membership within thirty (30) days after taking office may elect membership
8 not later than August 31, 2005. An election, upon being made pursuant to this
9 section, shall operate to create an inviolable contract between the member entitled
10 to elect membership under this subsection and the Commonwealth, guaranteeing to
11 and vesting in the member the rights and benefits provided for under the terms and
12 conditions of KRS 6.500 to 6.577, *except that the General Assembly reserves the*
13 *right to amend, reduce, or suspend any legislative changes to the provisions of*
14 *KRS 6.500 to 6.577 that become effective on or after July 1, 2018.*

15 (3) When any legislator makes a delayed election of membership in the Legislators'
16 Retirement Plan under subsection (2) of this section, his active membership in the
17 Kentucky Employees Retirement System shall terminate, as of the date his
18 membership in the Legislators' Retirement Plan becomes effective, and any credit in
19 the Kentucky Employees Retirement System, earned for service as a legislator,
20 which he then has or which he subsequently regains while being an active member
21 of the Legislators' Retirement Plan, shall be transferred to and counted as service
22 credit in the Legislators' Retirement Plan, and shall no longer constitute credit in the
23 Kentucky Employees Retirement System, except for the purpose of validating any
24 other credit in that system if the member pays the difference, if any, between the
25 amount transferred from the Kentucky Employees Retirement System and the
26 actuarial value of the transferred service. However, any credit he then has in the
27 Kentucky Employees Retirement System, earned for service in any capacity other

1 than a legislator, shall not be affected. No person may attain credit in more than one
2 (1) of the retirement plans or systems mentioned in this section for the same period
3 of service. When credit is transferred from the Kentucky Employees Retirement
4 System to the Legislators' Retirement Plan, the Kentucky Employees Retirement
5 System shall transfer to the Legislators' Retirement Fund an amount equal to the
6 employee's and employer's contributions attributable to that credit, together with
7 interest on the contributions from the date made to the date of transfer at the
8 actuarially assumed interest rate of the Kentucky Employees Retirement System in
9 effect at the time the contributions were made, compounded annually at that same
10 interest rate.

11 (4) The state shall, solely for the purpose of compliance with Section 414(h) of the
12 United States Internal Revenue Code, pick up the employee contributions required
13 by this section for all compensation earned after August 1, 1982, and the
14 contributions so picked up shall be treated as employer contributions in determining
15 tax treatment under the United States Internal Revenue Code and KRS 141.010(10).
16 The picked-up employee contribution shall satisfy all obligations to the retirement
17 system satisfied prior to August 1, 1982, by the employee contribution, and the
18 picked-up employee contribution shall be in lieu of an employee contribution. The
19 state shall pay these picked-up employee contributions from the same source of
20 funds which is used to pay earnings to the employee. The employee shall have no
21 option to receive the contributed amounts directly instead of having them paid by
22 the employer to the system. Employee contributions picked up after August 1, 1982,
23 shall be treated for all purposes of KRS 6.500 to 6.535 in the same manner and to
24 the same extent as employee contributions made prior to August 1, 1982.

25 (5) When any legislator elects membership in the Legislators' Retirement Plan in
26 accordance with this section, his active membership in the Kentucky Employees
27 Retirement System, State Police Retirement System, County Employees Retirement

1 System, or Teachers' Retirement System shall terminate, as of the date his
2 membership in the Legislators' Retirement Plan becomes effective, and any credit in
3 such other system or systems, earned for service as a legislator, which he then has or
4 which he subsequently regains while being an active member of the Legislators'
5 Retirement Plan, shall be transferred to and counted as service credit in the
6 Legislators' Retirement Plan, and shall no longer constitute credit in such other
7 retirement system except for the purpose of validating any other credit in that
8 system. However, any credit he then has in such other retirement system, earned for
9 service in any capacity other than a legislator, shall not be affected. No person may
10 attain credit in more than one (1) of the retirement plans or systems mentioned in
11 this section, for the same period of service.

12 (6) A member of the Legislators' Retirement Plan who would be entitled, under KRS
13 61.552, to repurchase credit in the Kentucky Employees Retirement System, for
14 previous service as a legislator, which credit had been lost by refund of
15 contributions, may pay the amount required by KRS 61.552 directly to the
16 Legislators' Retirement Plan and thereby obtain credit in that plan for such service,
17 rather than making payment to the Kentucky Employees Retirement System for
18 credit which would be transferred to the Legislators' Retirement Plan. In such event,
19 the Kentucky Employees Retirement System shall transfer to the Legislators'
20 Retirement Plan an amount equal to the employer's contributions that originally
21 were made to the Kentucky Employees Retirement System for the regained service
22 credit, with interest as provided in KRS 6.535. Six (6) months' current service shall
23 be required in the Legislators' Retirement Plan in order for the repurchased credit to
24 remain in force, the same as provided in KRS 61.552. Service purchased under this
25 subsection on or after January 1, 2014, shall not be used to determine the member's
26 participation date in the Legislators' Retirement Plan.

27 ➔Section 2. KRS 6.518 is amended to read as follows:

- 1 (1) For purposes of this section, "bona fide promotion or career advancement":
- 2 (a) Means a professional advancement in substantially the same line of work held
- 3 by the member in the four (4) years immediately prior to the final five (5)
- 4 annual years preceding retirement or a change in employment position based
- 5 on the training, skills, education, or expertise of the member that imposes a
- 6 significant change in job duties and responsibilities to clearly justify the
- 7 increased compensation to the member; and
- 8 (b) Does not include any circumstance in which a legislator participating in the
- 9 Legislators' Retirement Plan takes a position of employment with an employer
- 10 participating in any of the other state-administered retirement systems.
- 11 (2) (a) For members retiring on or after January 1, 2018, the plan shall, for each of
- 12 the retiring member's last five (5) annual years of service in the General
- 13 Assembly or with any employer participating in any of the state-administered
- 14 retirement systems, identify any annual year in which the creditable
- 15 compensation used to calculate benefits in the Legislators' Retirement Plan
- 16 increased at a rate of ten percent (10%) or more annually over the immediately
- 17 preceding annual year's creditable compensation.
- 18 (b) Except as limited or excluded by subsections (3) and (4) of this section, any
- 19 amount of increase in creditable compensation for an annual year identified
- 20 under paragraph (a) of this subsection that exceeds ten percent (10%) more
- 21 than the member's creditable compensation from the immediately preceding
- 22 annual year shall not be included in the creditable compensation used to
- 23 calculate the member's monthly pension benefits. If the creditable
- 24 compensation for a specific annual year identified under paragraph (a) of this
- 25 subsection as exceeding the ten percent (10%) increase limitation is not used
- 26 to calculate the retiring member's monthly pension benefits, then no reduction
- 27 in creditable compensation shall occur for that annual year. Reductions to

1 creditable compensation as provided by this paragraph shall include any
2 creditable compensation used to calculate the retiring member's benefits,
3 including creditable compensation earned in another state-administered
4 retirement system.

5 (c) If the creditable compensation of the retiring member is reduced as provided
6 by paragraph (b) of this subsection, the retirement system shall,
7 notwithstanding KRS 21.460 and as applicable, refund the member
8 contributions attributable to the reduction in creditable compensation.

9 (3) In order to ensure the prospective application of the limitations on increases in
10 creditable compensation contained in subsection (2) of this section, only the
11 creditable compensation earned by the retiring member on or after July 1, 2017,
12 shall be subject to reduction under subsection (2) of this section. Creditable
13 compensation earned by the retiring member prior to July 1, 2017, shall not be
14 subject to reduction under subsection (2) of this section.

15 (4) Subsections (2) and (3) of this section shall not apply to increases that are the direct
16 result of a bona fide promotion or career advancement.

17 (5) The Judicial Form Retirement System board of trustees shall determine whether
18 increases in creditable compensation during the last five (5) annual years of
19 employment prior to retirement constitute a bona fide promotion or career
20 advancement and may promulgate administrative regulations in accordance with
21 KRS Chapter 13A to administer this section. All state-administered retirement
22 systems shall cooperate to implement this section.

23 (6) This section shall not apply to:

24 (a) Employees participating in the hybrid cash balance ~~plans~~^{plan} as provided by
25 KRS 21.402 or Section 19 of this Act; or

26 (b) Service earned in the 401(a) money purchase plan as provided by Section 12
27 of this Act.

1 ➔Section 3. KRS 6.520 is amended to read as follows:

- 2 (1) A member of the Legislators' Retirement Plan who retires on or after his normal
3 retirement date shall receive a service retirement allowance, payable monthly during
4 his lifetime, in an amount per month equal to three and fifty one-hundredths percent
5 (3.50%) of his final compensation multiplied by the number of years of his service,
6 but in no event to exceed one hundred percent (100%) of final compensation. For
7 this purpose, "final compensation" means the average monthly creditable
8 compensation as determined in KRS 61.510(13) of the member for services as a
9 legislator for the three (3) years during which the member had the highest creditable
10 legislative compensation.
- 11 (2) A member shall have rights, with respect to retirement before reaching normal
12 retirement date in the Legislators' Retirement Plan, identical in terms with those
13 rights provided in KRS 21.400(2) and (3) in the Judicial Retirement Plan for
14 members of that plan, except that the reduction in a legislators' service retirement
15 allowance for early retirement shall be at the rate of five percent (5%) of the
16 allowance for each year that retirement precedes the normal retirement date.
- 17 (3) Subsections (1) and (2) of this section to the contrary notwithstanding, each
18 legislator in office on July 1, 1982, that is a member of the Legislators' Retirement
19 Plan, who retires on or after his normal retirement date, shall receive a service
20 retirement allowance, payable monthly, on a formula equal to that of a justice or
21 judge of the Court of Justice with an equivalent service entrance date, but in no
22 event less than that specified in subsection (1) of this section, of his final
23 compensation multiplied by the number of years of his service, but in no event to
24 exceed one hundred percent (100%) of his final compensation. For this purpose,
25 "final compensation" means the average monthly creditable compensation as
26 determined in KRS 61.510(13) of the three (3) years during which the member had
27 the highest creditable legislative compensation.

1 (4) Notwithstanding any other provision of KRS 6.500 to 6.577 or 21.345 to
 2 21.580~~[Subsections (1) and (2) of this section]~~ to the contrary~~[notwithstanding]~~, a
 3 member of the Legislators' Retirement Plan with a service entrance date after July 1,
 4 1982 but prior to January 1, 2014, who retires on or after his normal retirement date,
 5 shall receive a service retirement allowance, payable monthly during his lifetime, in
 6 an amount per month equal to:

7 (a) Two and seventy-five one-hundredths percent (2.75%) of his final
 8 compensation multiplied by the number of years of his service *accrued prior*
 9 *to January 1, 2019; and*

10 (b) *One and ninety-seven one-hundredths percent (1.97%) of his or her final*
 11 *compensation multiplied by the number of years of his or her service*
 12 *accrued on or after January 1, 2019.*~~[, but]~~

13 In no event *shall the benefit provided by this subsection*~~[to]~~ exceed one hundred
 14 percent (100%) of final compensation. For this purpose, "final compensation"
 15 means the average monthly creditable compensation as determined in KRS
 16 61.510(13) of the member for services as a legislator for the three (3) years during
 17 which the member had the highest creditable legislative compensation.

18 (5) Subsections (1) to (4) of this section shall not apply to members who begin
 19 participating in the Legislators' Retirement Plan on or after January 1, 2014.

20 ➔Section 4. KRS 6.525 is amended to read as follows:

21 The Legislators' Retirement Plan shall be governed by KRS 21.560 and by provisions
 22 identical in terms with those provided in KRS 21.345(1), 21.345(3) to (6), 21.357,
 23 21.360(1), 21.370 to 21.410, 21.374, 21.420, 21.425, 21.450, 21.460, 21.470, 21.480,
 24 21.525, 21.540, and 61.552 for the Judicial Retirement Plan, except that:

25 (1) Five (5) years of service as a legislator will be sufficient for vesting; and

26 (2) (a) A member of the Legislators' Retirement Plan may combine his service credit
 27 with his service credit in the Teachers' Retirement System, Kentucky

1 Employees Retirement System, County Employees Retirement System, and
2 State Police Retirement System at the time of his retirement, according to the
3 procedure of KRS 61.680(2)(a), except that the salary used to determine final
4 compensation, if applicable, shall be based on the creditable compensation in
5 KRS 61.510(13) for service while a member of the General Assembly whether
6 or not a member of the Legislators' Retirement Plan.

- 7 (b) 1. For members contributing on or after June 20, 2005 but prior to January
8 1, 2014, who have service credit in the State Police Retirement System,
9 Kentucky Employees Retirement System, County Employees
10 Retirement System, or Teachers' Retirement System prior to January
11 1, 2019: Upon retirement, a member's accounts under the Legislators'
12 Retirement Plan, State Police Retirement System, Kentucky Employees
13 Retirement System, County Employees Retirement System, and
14 Teachers' Retirement System shall be consolidated for the purpose of
15 determining eligibility and amount of benefits as provided in KRS
16 61.680(2)(a) and in the same manner as for the other retirement systems
17 using the highest salary regardless of the system in which it was earned,
18 except that any salary earned in the State Police Retirement System,
19 Kentucky Employees Retirement System, County Employees
20 Retirement System, or Kentucky Teachers' Retirement System on or
21 after January 1, 2019, shall not be used to determine benefits in the
22 Legislators' Retirement Plan.
- 23 2. The consolidation of accounts as provided by this paragraph shall not
24 apply to accounts in the State Police Retirement System, the Kentucky
25 Employees Retirement System, the County Employees Retirement
26 System, and the Teachers' Retirement System, from which the member
27 is receiving a retirement benefit.

- 1 **3.** For purposes of this paragraph, "retirement" means the month in which
2 the member elects to begin receiving benefits or benefits become
3 payable due to the member's death.
- 4 (c) A member who has an account in the Legislators' Retirement Plan and the
5 Judicial Retirement Plan may combine his service in both plans for purposes
6 of determining:
- 7 1. Eligibility and the amount of benefits; and
8 2. Final compensation, provided the member began participating in the
9 Legislators' Retirement Plan prior to January 1, 2014, and except that
10 any salary earned in the Judicial Retirement Plan on or after January
11 1, 2019, shall not be used to determine final compensation in the
12 Legislators' Retirement Plan.
- 13 (d) A member who began participating in the Legislators' Retirement Plan prior to
14 January 1, 2014, may retire at the completion of twenty-seven (27) or more
15 years of combined service credit, so long as at least fifteen (15) years of such
16 credit were earned after January 1, 1960, and there shall be no reduction in the
17 retirement allowance because of retirement before the age of sixty-five (65).
- 18 (e) For the purposes of this section, any reference in the KRS sections listed
19 above to the Judicial Retirement Plan shall also be read as a reference to the
20 Legislators' Retirement Plan, and any reference to the Legislators' Retirement
21 Plan shall also be read as a reference to the Judicial Retirement Plan.
- 22 (3) Any other statute to the contrary notwithstanding, a member of any state-
23 administered retirement system who has ceased to qualify for membership but
24 subsequently returns to a qualified status, shall, for the purposes of determining the
25 date of entry into the state-administered retirement system for the subsequent period
26 or periods of service, be deemed to have never left the retirement system.
- 27 ➔Section 5. KRS 21.360 is amended to read as follows:

- 1 (1) (a) Each Judge of the District Court in office on July 1, 1978, may within thirty
2 (30) days after that date, and any judge or justice of any court entitled to be a
3 member thereafter taking office may within thirty (30) days after taking office,
4 elect to make monthly contributions to the retirement system in an amount
5 equal to:
- 6 1. Five percent (5%) of his or her monthly official salary, if the judge or
7 justice became a member of the Kentucky Judicial Retirement Plan prior
8 to September 1, 2008;
 - 9 2. Six percent (6%) of his or her monthly official salary, if the judge or
10 justice became a member of the Kentucky Judicial Retirement Plan on
11 or after September 1, 2008, but prior to January 1, 2014; or
 - 12 3. Six percent (6%) of his or her monthly official salary, if the judge or
13 justice who becomes a member of the Kentucky Judicial Retirement
14 Plan on or after January 1, 2014, which shall be used to fund benefits as
15 follows:
 - 16 a. Five percent (5%) of the monthly official salary shall be used to
17 provide funding for benefits provided under KRS 21.402; and
 - 18 b. One percent (1%) of the monthly official salary to be used
19 exclusively to help fund retiree health benefits as provided by KRS
20 21.427 and which shall not be refunded to the member if the
21 member withdraws his or her accumulated account balance as
22 provided by KRS 21.460. The deducted amounts under this
23 subdivision shall be credited to an account established pursuant to
24 26 U.S.C. sec. 401(h), within the fund established by KRS 21.347.
- 25 (b) The election shall be effective to establish membership in the system as of
26 July 1, 1978, or as of the date the judge or justice took office, as the case may
27 be. The election shall be addressed to and filed with the secretary of the

1 Finance and Administration Cabinet, and shall constitute an authorization by
2 the member, to the secretary, to thereafter cause to be deducted from the
3 member's official salary, each month, the amount required by paragraph (a) of
4 this subsection, as a voluntary contribution by the member towards the
5 funding of the retirement system. For a member who began contributing to the
6 Judicial Retirement Plan prior to January 1, 2014, the contribution shall
7 continue until the judge or justice is vested in a service retirement allowance
8 equal to one hundred percent (100%) of final compensation. Thereafter
9 employee contributions shall be discontinued but continued service and
10 retirement benefits shall not be affected thereby.

11 (2) A judge or justice entitled to elect membership in the retirement system who failed
12 to elect membership within thirty (30) days after taking office in 1980 or who
13 elected membership in the Kentucky Employees Retirement System may elect
14 membership not later than August 31, 2005. An election, upon being made pursuant
15 to this section, shall operate to create an inviolable contract between the member
16 entitled to elect membership under this subsection and the Commonwealth,
17 guaranteeing to and vesting in the member the rights and benefits provided for
18 under the terms and conditions of KRS 21.350 to 21.510, **except that the General**
19 **Assembly reserves the right to amend, reduce, or suspend any legislative changes**
20 **to the provisions of KRS 21.345 to 21.580 that become effective on or after July 1,**
21 **2018.**

22 (3) (a) When any judge makes a delayed election of membership in the Judicial
23 Retirement Plan under subsection (2) of this section, his active membership in
24 the Kentucky Employees Retirement System shall terminate, as of the date his
25 membership in the Judicial Retirement Plan becomes effective, and any credit
26 in the Kentucky Employees Retirement System, earned for service as a judge,
27 which he then has or which he subsequently regains while being an active

1 member of the Judicial Retirement Plan, shall be transferred to and counted as
2 service credit in the Judicial Retirement Plan, and shall no longer constitute
3 credit in the Kentucky Employees Retirement System, except for the purpose
4 of validating any other credit in that system, if the member pays the
5 difference, if any, between the amount transferred from the Kentucky
6 Employees Retirement System and the actuarial value of the transferred
7 service.

8 (b) Any credit he then has in the Kentucky Employees Retirement System, earned
9 for service in any capacity other than a judge, shall not be affected.
10 Notwithstanding any provisions of KRS 61.680 to the contrary, final
11 compensation used to determine benefits for any service credit remaining in
12 the Kentucky Employees Retirement System shall be based on the highest
13 years of compensation as a judge whether the years occur before or after the
14 judge elects membership in the Judicial Retirement Plan.

15 (c) No person may attain credit in more than one (1) of the retirement plans or
16 systems mentioned in this section for the same period of service. When credit
17 is transferred from the Kentucky Employees Retirement System to the Judicial
18 Retirement Plan, the Kentucky Employees Retirement System shall transfer to
19 the Judicial Retirement Fund an amount equal to the employee's and

23 transfer as permitted under the applicable sections of the Internal
24 Revenue Code and any regulations or rulings issued thereunder, through
25 a direct rollover as contemplated by and permitted under 26 U.S.C. sec.
26 401(a)(31) and any regulations or rulings issued thereunder, or through a
27 rollover of funds pursuant to and permitted under the rules specified in

1 26 U.S.C. secs. 402(c) and 408(d)(3). The Kentucky Retirement Systems
2 shall accept the transfer or rollover to the extent permitted under the
3 rules specified in the applicable provisions of the Internal Revenue Code
4 and any regulations and rulings issued thereunder.

5 (b) For purposes of this subsection, "grandfathered service" means service
6 purchases for which a member, whose membership date in the system is prior
7 to July 1, 1999, is eligible to purchase under KRS 16.505 to 16.652, 61.510 to
8 61.705, or 78.510 to 78.852, that were available for all members of the system
9 to purchase on August 5, 1997.

10 (c) 1. For service purchased under a before-tax or after-tax installment
11 purchase of service agreement as provided by paragraph (a)2. of this
12 subsection, the cost of the service shall be computed in the same manner
13 as for a lump-sum payment which shall be the principal, except that
14 interest compounded annually at the actuarial rate in effect at the time
15 the member elects to make the purchase shall be added for the period
16 that the installments are to be made.

17 2. Multiple service purchases may be combined under a single installment
18 agreement, except that no employee may make more than one (1)
19 installment purchase at the same time.

20 3. For after-tax installment purchase of service agreements, the employee
21 may elect to stop the installment payments by notifying the retirement
22 system; may have the installment purchase recalculated to add one (1) or
23 more additional service purchases; or may pay by lump sum the
24 remaining principal or a portion of the remaining principal.

25 4. Before-tax installment purchase of service agreements shall be
26 irrevocable, and the employee shall not be able to stop installment
27 payments or to pay off the remaining balance of the purchase of service

- 1 agreement, except upon termination of employment or death.
- 2 5. One (1) year of installment payments shall be made for each one
3 thousand dollars (\$1,000) or any part thereof of the total cost, except that
4 the total period allowed for installments shall not be less than one (1)
5 year and shall not exceed five (5) years.
- 6 6. The employee shall pay the installments by payroll deduction for after-
7 tax purchase of service agreements, and the employer shall pick up
8 installments for before-tax purchase of service agreements. Upon
9 notification by the retirement system, the employer shall report the
10 installment payments either monthly or semimonthly continuously over
11 each twelve (12) month period at the same time as, but separate from,
12 regular employee contributions on the forms or by the computer format
13 specified by the board.
- 14 7. The retirement system shall determine how much of the total cost
15 represents payment for one (1) month of the service to be purchased and
16 shall credit one (1) month of service to the member's account each time
17 this amount has been paid. The first service credited shall represent the
18 first calendar month of the service to be purchased and each succeeding
19 month of service credit shall represent the succeeding months of that

- 21 8. If the employee utilizing an installment purchase of service agreement
22 dies, retires, does not continue employment in a position required to
23 participate in the retirement system, or elects to stop an after-tax
24 installment purchase of service agreement, the member, or in the case of
25 death, the beneficiary, shall have sixty (60) days to pay the remaining
26 principal or a portion of the remaining principal of the installment
27 purchase of service agreement by lump sum, subject to the restrictions of

1 paragraph (a)1. of this subsection, or by transfer of funds under
2 paragraph (a)3. of this subsection, except that payment by the member
3 shall be filed with the system prior to the member's effective retirement
4 date. If the member or beneficiary does not pay the remaining cost, the
5 retirement system shall refund to the member or the beneficiary the
6 payment, payments, or portion of a payment that does not represent a
7 full month of service purchased, except as provided by subsection (22)
8 of this section.

9 9. If the employer does not report installment payments on an employee for
10 sixty (60) days for an after-tax installment purchase of service
11 agreement, except in the case of employees on military leave or sick
12 leave without pay, the installment purchase shall cease and the
13 retirement system shall refund to the employee the payment, payments,
14 or portion of a payment that does not represent a full month of service
15 purchased.

16 10. Installment payments of employees on military leave or sick leave
17 without pay shall be suspended during the period of leave and shall
18 resume without recalculation upon the employee's return from leave.

19 11. If payments have ceased under subparagraph 8. or 9. of this paragraph
20 and the member later becomes a participating employee in one (1) of the
21 three (3) systems administered by Kentucky Retirement Systems, the
22 employee may complete the adjusted original installment purchase by
23 lump sum or installment payments, subject to the restrictions of this
24 subsection. If the employee elects to renew the installment purchase, the
25 cost of the remaining service shall be recalculated in accordance with
26 paragraph (a) of this subsection.

27 (d) Except as provided by paragraph (a)2.a. of this subsection, the cost of

1 purchasing service shall not be picked up, as described in KRS 16.545(4),
2 61.560(4), or 78.610(4), by the employer.

3 (e) The cost of purchasing service credit under any provision of this section,
4 except as provided by subsections (1) and (20) of this section, shall be
5 determined by the delayed contribution method as provided by KRS 61.5525.

6 (f) Member payments, including interest, properly received pursuant to this
7 subsection shall be deposited to the member's account and considered as
8 accumulated contributions of the individual member.

9 (15) After August 1, 1998, any employee participating in one (1) of the retirement
10 systems administered by Kentucky Retirement Systems who is age sixty-five (65) or
11 older and has forty-eight (48) months of service credit or, if younger, who has sixty
12 (60) months of service credit in systems administered by Kentucky Retirement
13 Systems may purchase service credit in the system in which the employee has the
14 service credit for up to ten (10) years service in a regular full-time position that was
15 credited to a state or local government-administered public defined benefit plan in
16 another state other than a defined benefit plan for teachers. The employee shall
17 provide proof that he is not eligible for a retirement benefit for the period of service
18 from the other state's plan.

19 (16) After August 1, 1998, any employee participating in one (1) of the retirement
20 systems administered by Kentucky Retirement Systems, who has sixty (60) or more
21 months of service in the State Police Retirement System or in a hazardous position
22 in the Kentucky Employees Retirement System or the County Employees
23 Retirement System, may purchase service credit in the system in which the
24 employee has the sixty (60) months of service credit for up to ten (10) years of
25 service in a regular full-time position that was credited to a defined benefit
26 retirement plan administered by a state or local government in another state, if the
27 service could be certified as hazardous pursuant to KRS 61.592. The employee shall

1 provide proof that he is not eligible for a retirement benefit for the period of service
2 from the other unit of government's plan.

3 (17) Any employee participating in one (1) of the retirement systems administered by
4 Kentucky Retirement Systems who has at least forty-eight (48) months of service if
5 age sixty-five (65) or at least sixty (60) months of service if under age sixty-five
6 (65) in the systems administered by Kentucky Retirement Systems and who has
7 completed service as a volunteer in the Kentucky Peace Corps, created by KRS
8 154.1-720, may purchase service credit for the time served in the corps.

9 (18) An employee participating in any retirement system administered by Kentucky
10 Retirement Systems who has at least forty-eight (48) months of service if age sixty-
11 five (65), or at least sixty (60) months of service if under age sixty-five (65) in the
12 systems administered by Kentucky Retirement Systems, and who was formerly
13 employed in a regional community services program for mental health and
14 individuals with an intellectual disability, organized and operated under the
15 provisions of KRS 210.370 to 210.480, which does not participate in a state-
16 administered retirement system may purchase service credit for the period of his
17 service in the regional community program for mental health and individuals with
18 an intellectual disability.

19 (19) An employee participating in one (1) of the retirement systems administered by
20 Kentucky Retirement Systems who has at least forty-eight (48) months of service if
21 age sixty-five (65) or at least sixty (60) months of service if under age sixty-five
22 (65) in the systems administered by the Kentucky Retirement Systems, who was
23 employed by a vocational technical school in a noncertified part-time position
24 averaging eighty (80) or more hours per month, determined by using the number of
25 months actually worked within a calendar or fiscal year, may purchase service credit
26 in the Kentucky Employees Retirement System.

27 (20) (a) Any person who is entitled to service credit for employment which was not

1 reported in accordance with KRS 16.543, 61.543, or 78.615 may obtain credit
2 for the service by paying the employee contributions due within six (6)
3 months of notification by the system. No interest shall be added to the
4 contributions. The service credit shall not be credited to the member's account
5 until the employer contributions are received. If a retired member makes the
6 payment within six (6) months, the retired member's retirement allowance
7 shall be adjusted to reflect the added service after the employer contributions
8 and any interest or penalties on the delinquent employer contributions are
9 received by the retirement system.

10 (b) Any employee participating in one (1) of the state-administered retirement
11 systems who is entitled to service credit under paragraph (a) of this subsection

20 on or after September 1, 2008, shall be considered service credited under KRS
21 16.543(1), 61.543(1), or 78.615(1) for purposes of determining eligibility for
22 retirement benefits under KRS 16.505 to 16.652, 61.510 to 61.705, and
23 78.510 to 78.852.

24 (d) Employees who begin participating on or after January 1, 2014, in the hybrid
25 cash balance plan provided by KRS 16.583 and 61.597 shall, upon payment of
26 the employee and employer contributions due under this subsection, have their
27 accumulated account balance increased by the employee contributions,

1 employer pay credits, and interest credits that would have been credited to
2 their member's account if the contributions had been paid on time.

3 (e) An employee participating in the 401(a) money purchase plan as provided
4 by Section 12 of this Act shall, upon payment of the employee and employer
5 contributions due under this subsection, have his or her accumulated
6 account balance increased by the employee contributions and employer
7 contributions that would have been credited to his or her member account if
8 the contributions had been paid on time.

9 ~~(f)(e)~~ Employer contributions payable under this subsection shall be
10 considered delinquent and the employer shall be required to pay interest and
11 any other penalties on the delinquent contributions in accordance with KRS
12 61.675(3)(b) and 78.625(2)(a) from the date the employee should have been
13 reported and received service credit in accordance with KRS 16.543, 61.543,
14 and 78.615.

15 (21) Any employee participating in one (1) of the retirement systems administered by
16 Kentucky Retirement Systems who has at least forty-eight (48) months of service if
17 age sixty-five (65) or at least sixty (60) months of service if under age sixty-five
18 (65) in the systems administered by the Kentucky Retirement Systems may
19 purchase service credit for employment with a public agency that would have been
20 eligible to participate under KRS 61.520 but which did not participate in the
21 Kentucky Employees Retirement System or a political subdivision that would have
22 been eligible to participate under KRS 78.530 but which did not participate in the
23 County Employees Retirement System if the former public agency or political
24 subdivision has merged with or been taken over by a participating department or
25 county.

26 (22) Any employee participating in one (1) of the retirement systems administered by the
27 Kentucky Retirement Systems prior to July 15, 2002, who has accrued at least forty-

1 eight (48) months of service if age sixty-five (65) or at least sixty (60) months of
2 service if under age sixty-five (65) in the systems administered by the Kentucky
3 Retirement Systems and who has total service in all state-administered retirement
4 systems of at least one hundred eighty (180) months of service credit may purchase
5 a combined maximum total of five (5) years of retirement service credit which is
6 not otherwise purchasable under any of the provisions of KRS 16.505 to 16.652,
7 61.510 to 61.705, and 78.510 to 78.852. The purchase shall be made in any of the
8 systems administered by Kentucky Retirement Systems in which the employee is a
9 member. The service purchased under this subsection shall not be used in
10 determining a retirement allowance until the member has accrued at least two
11 hundred forty (240) months of service, excluding service purchased under this
12 subsection. If the member does not accrue at least two hundred forty (240) months
13 of service, excluding service purchased under this subsection, upon retirement,
14 death, or written request following termination, the payment, plus interest as
15 provided in KRS 61.575, shall be refunded.

16 (23) An employee participating in one (1) of the retirement systems administered by
17 Kentucky Retirement Systems, who has at least forty-eight (48) months of service if
18 age sixty-five (65), or at least sixty (60) months of service if under age sixty-five
19 (65), in the systems administered by Kentucky Retirement Systems, may obtain
20 credit in the County Employees Retirement System for the period of that employee's
21 service with a community action agency created under KRS 273.405 to 273.453 if
22 that service was not covered by a state-administered retirement system.

23 (24) An employee may obtain credit for regular full-time service with an agency prior to
24 August 1, 1998, for which the employee did not receive credit due to KRS
25 61.637(1). Service credit obtained under this subsection shall not be used in
26 determining benefits under KRS 61.702. The employee may purchase credit for
27 service prior to August 1, 1998, if:

- 1 (a) The employee retired from one (1) of the retirement systems administered by
2 the Kentucky Retirement Systems and was reemployed prior to August 1,
3 1998, earning less than the maximum permissible earnings under the Federal
4 Social Security Act;
- 5 (b) The employee elected to participate in a second retirement account effective
6 August 1, 1998, in accordance with KRS 61.637(7); and
- 7 (c) The employee has at least forty-eight (48) months of service if age sixty-five
8 (65), or at least sixty (60) months of service if under age sixty-five (65), in a
9 second account in the systems administered by Kentucky Retirement Systems.

11 Kentucky Retirement Systems, who has at least forty-eight (48) months of service if

13 (65) in the systems administered by the Kentucky Retirement Systems, may obtain
14 credit for the service in a regular full-time position otherwise creditable under the
15 Kentucky Employees Retirement System, the County Employees Retirement
16 System, or the State Police Retirement System for service in the United States
17 government, other than service in the Armed Forces, for which service is not
18 otherwise given.
- 19 (26) An employee participating in a hazardous position in one (1) of the retirement
20 systems administered by the Kentucky Retirement Systems, who has at least forty-
21 eight (48) months of service if age sixty-five (65) or at least sixty (60) months of
22 service if under age sixty-five (65) in the systems administered by the Kentucky
23 Retirement Systems, may obtain credit for service in a regular full-time position in
24 an urban-county government that would qualify for hazardous duty coverage under
25 KRS 61.592.
- 26 (27) Subsections (2) to (5), (7) to (13), (15) to (19), and (21) to (26) of this section shall
27 not apply to members who begin participating in the systems administered by

1 Kentucky Retirement Systems on or after January 1, 2014, or to members who
2 make an election as provided by Section 7, 12, or 38 of this Act.

3 (28) Service purchases made pursuant to subsections (2) to (5), (7), (10) to (13), (15) to
4 (19), (21) to (23), (25), and (26) of this section shall be purchased by the entire
5 amount of service available pursuant to that subsection or by increments. Service
6 purchases made pursuant to subsections (1), (20), and (24) of this section shall be
7 purchased by the entire amount of service available.

8 ➔Section 26. KRS 61.555 is amended to read as follows:

9 (1) (a) After August 1, 1998, any employee entering the Armed Forces of the United
10 States after he first participates in the system, who joins the Armed Forces
11 within three (3) months of the last day of paid employment, being on leave of
12 absence from service and not withdrawing his accumulated account balance,
13 shall be credited for retirement purposes with service credit and creditable
14 compensation as provided in 38 U.S.C. sec. 4318 for his period of active
15 military duty in the Armed Forces of the United States, not to exceed six (6)
16 years, if:

17 1. The member's military service was terminated in a manner other than as

14 (1) of the systems administered by the Kentucky Retirement Systems and
15 within three (3) months entered the Armed Forces of the United States and
16 who returns to work with an employer participating in one (1) of the
17 retirement systems administered by the Kentucky Retirement Systems within
18 two (2) years after completion of the period of active military duty, or upon

15 (8) years' service while on military duty during this period, shall have that portion of
16 his active military duty, necessary to the completion of eight (8) years' current
17 service, credited to his account, as current service without having to meet the
18 reemployment criteria.

19 (4) Any employee eligible for retirement as prescribed in KRS 61.559 or any employee
20 upon completion of five (5) years of service shall receive current service credit for a

24 (7) Any employee participating in one (1) of the retirement systems administered by the
25 Kentucky Retirement Systems age sixty-five (65) or older who has forty-eight (48)
26 months of service, at least twelve (12) of which are current service, or if younger
27 who has sixty (60) months of service, at least twelve (12) of which are current

1 service, shall receive one (1) month of current service for each six (6) months of
2 service in the National Guard or the military reserves of the United States, by
3 paying the retirement system a delayed contribution payment in accordance with the
4 payment options and restrictions established by KRS 61.552(14). The service shall
5 be treated as service earned prior to participation in the system and shall not be
6 included in the member's final compensation. Service purchases made pursuant to
7 this subsection shall be purchased by the entire amount of service available pursuant
8 to this subsection or by increments.

9 (8) For members who begin participating in the systems administered by Kentucky
10 Retirement Systems on or after January 1, 2014, in the hybrid cash balance plan
11 prescribed by KRS 16.583 and 61.597, **and for members who make an election to**
12 **participate in the 401(a) money purchase plan as provided by Section 7, 12, or 38**
13 **of this Act**, the provisions of subsections (4) to (7) of this section shall not apply.

14 ➔Section 27. KRS 61.595 is amended to read as follows:

15 **Except as limited by Section 12 or 38 of this Act:**

16 (1) Effective July 1, 1990, upon retirement at normal retirement date or subsequent
17 thereto, a member may receive an annual retirement allowance, payable monthly
18 during his lifetime, which shall consist of an amount equal to two and two-tenths
19 percent (2.2%) for the County Employees Retirement System and one and ninety-
20 seven hundredths percent (1.97%) for the Kentucky Employees Retirement System
21 of final compensation multiplied by the number of years of service credit, except
22 that:

15 allowance upon retirement at normal retirement date or later shall be equal to
16 two percent (2%) of final compensation multiplied by the number of years of
17 service credit and shall be payable monthly during his lifetime;

18 (c) The annual normal retirement allowance for members of the General
19 Assembly, who serve during the 1974 or 1976 General Assembly, and will
20 have eight (8) years or more of total legislative service as of January 6, 1978,
21 shall not be less than two hundred forty dollars (\$240) multiplied by the
22 number of years of service as a member of the General Assembly;

23 (d) For a member of the Kentucky Employees Retirement System or the County
24 Employees Retirement System who begins participating on or after September
25 1, 2008, the annual retirement allowance upon retirement shall be equal to:

26 1. a. One and one-tenth percent (1.1%) of final compensation for each
27 year of service if the member has earned ten (10) or less years of

- 1 service at retirement;

- 3 each year of service if the member has earned greater than ten (10)

- 8 d. One and three-quarters percent (1.75%) of final compensation for
- 9 each year of service if the member has earned greater than twenty-
- 10 six (26) but no more than thirty (30) years of service at retirement;
- 11 and
- 12 2. Two percent (2.0%) of final compensation for each year of service
- 13 earned in excess of thirty (30) years of service at retirement;
- 14 (e) The annual normal retirement allowance for members of the General
- 15 Assembly who will have fewer than eight (8) years of service as of December
- 16 31, 1975, shall be as prescribed in Chapter 116, section 36(1), Acts of the
- 17 1972 General Assembly for legislative service prior to January 1, 1974;
- 18 (f) Former members of the General Assembly who have eight (8) or more years
- 19 of legislative service prior to the 1976 Regular Session are eligible for an
- 20 increased retirement allowance of two hundred forty dollars (\$240) times the
- 21 years of legislative service, if the member pays to the Kentucky Employees
- 22 Retirement System thirty-five percent (35%) of the actuarial cost of the higher
- 23 benefit, as determined by the system, except that a former member with
- 24 sixteen (16) or more years of legislative service, or his beneficiary, who is
- 25 receiving a retirement allowance, also is eligible under this section and may
- 26 apply for a recomputation of his retirement allowance. The employer's share
- 27 of sixty-five percent (65%) of the computed actuarial cost shall be paid from

1 the State Treasury to the Kentucky Employees Retirement System upon
2 presentation of a properly documented claim to the Finance and
3 Administration Cabinet. If any member with sixteen (16) or more years of
4 legislative service previously applied for and is receiving a retirement
5 allowance, he may reapply and his retirement allowance shall be recomputed
6 in accordance with this paragraph, and he shall thereafter be paid in
7 accordance with the option selected by him at the time of the reapplication;
8 and

9 (g) The annual normal retirement allowance for a member with ten (10) or more
10 years of service, in the Kentucky Employees Retirement System, at least one
11 (1) of which is current service, shall not be less than five hundred twelve
12 dollars (\$512).

13 (2) (a) Upon service retirement prior to normal retirement date, a member may
14 receive an annual retirement allowance payable monthly during his lifetime
15 which shall be determined in the same manner as for retirement at his normal
16 retirement date with years of service and final compensation being determined
17 as of the date of his actual retirement, but the amount of the retirement
18 allowance so determined shall be reduced at an amount determined by the
19 board's actuary to reflect the earlier commencement of benefits.

20 (b) A member of the Kentucky Employees Retirement System or the County
21 Employees Retirement System who begins participating before September 1,
22 2008, who has twenty-seven (27) or more years of service credit, at least
23 fifteen (15) of which are current service, may retire with no reduction in the

2 the necessary years of service credit as provided in KRS 61.559(2)(c) and (d)
3 to qualify for a retirement allowance. The credit from a Kentucky institution
4 of higher education, the Council on Postsecondary Education, or the Higher
5 Education Assistance Authority shall not be used toward the minimum fifteen
6 (15) years of current service required by KRS 61.559(2)(c) and (d) or to
7 calculate his retirement allowance pursuant to this section. The provisions of
8 this paragraph shall not be construed to limit the use of Teachers' Retirement
9 System credit pursuant to KRS 61.680(2)(a).

10 (c) A member of the Kentucky Employees Retirement System or the County
11 Employees Retirement System who begins participating on or after September
12 1, 2008, may retire with no reduction in benefits if the member is fifty-seven
13 (57) years of age or older and has an age and years of service total of at least
14 eighty-seven (87) years. The years of service used to determine eligibility for
15 an unreduced retirement allowance under this paragraph shall only include
16 years of service credited under KRS 16.543(1), 61.543(1), or 78.615(1) or
17 another state-administered retirement system.

18 (3) Subsections (1) and (2) of this section shall not apply to members who begin
19 participating in the system on or after January 1, 2014. Members who begin
20 participating in the system on or after January 1, 2014, shall receive the retirement
21 benefits prescribed by KRS 61.597 or Section 12 of this Act, as applicable.

22 ➔Section 28. KRS 61.637 is amended to read as follows:

23 (1) A retired member who is receiving monthly retirement payments under any of the
24 provisions of KRS 61.510 to 61.705 and 78.510 to 78.852 and who is reemployed
25 as an employee by a participating agency prior to August 1, 1998, shall have his
26 retirement payments suspended for the duration of reemployment. Monthly
27 payments shall not be suspended for a retired member who is reemployed if he

1 anticipates that he will receive less than the maximum permissible earnings as
2 provided by the Federal Social Security Act in compensation as a result of
3 reemployment during the calendar year. The payments shall be suspended at the
4 beginning of the month in which the reemployment occurs.

5 (2) Employer and employee contributions shall be made as provided in KRS 61.510 to
6 61.705 and 78.510 to 78.852 on the compensation paid during reemployment,
7 except where monthly payments were not suspended as provided in subsection (1)
8 of this section or would not increase the retired member's last monthly retirement
9 allowance by at least one dollar (\$1), and the member shall be credited with
10 additional service credit.

11 (3) In the month following the termination of reemployment, retirement allowance
12 payments shall be reinstated under the plan under which the member was receiving
13 payments prior to reemployment.

14 (4) (a) Notwithstanding the provisions of this section, the payments suspended in
15 accordance with subsection (1) of this section shall be paid retroactively to the
16 retired member, or his estate, if he does not receive more than the maximum
17 permissible earnings as provided by the Federal Social Security Act in
18 compensation from participating agencies during any calendar year of
19 reemployment.

20 (b) If the retired member is paid suspended payments retroactively in accordance
21 with this section, employee contributions deducted during his period of
22 reemployment, if any, shall be refunded to the retired employee, and no
23 service credit shall be earned for the period of reemployment.

24 (c) If the retired member is not eligible to be paid suspended payments for his
25 period of reemployment as an employee, his retirement allowance shall be
26 recomputed under the plan under which the member was receiving payments
27 prior to reemployment as follows:

- 1 1. The retired member's final compensation shall be recomputed using
2 creditable compensation for his period of reemployment; however, the
3 final compensation resulting from the recalculation shall not be less than
4 that of the member when his retirement allowance was last determined;
 - 5 2. If the retired member initially retired on or subsequent to his normal
6 retirement date, his retirement allowance shall be recomputed by using
7 the formula in KRS 61.595(1);
 - 8 3. If the retired member initially retired prior to his normal retirement date,
9 his retirement allowance shall be recomputed using the formula in KRS

11 be his age at the time of his initial retirement increased by the number of
12 months of service credit earned for service performed during
13 reemployment;
 - 14 4. The retirement allowance payments resulting from the recomputation
15 under this subsection shall be payable in the month following the
16 termination of reemployment in lieu of payments under subparagraph 3.
17 The member shall not receive less in benefits as a result of the
18 recomputation than he was receiving prior to reemployment or would
19 receive as determined under KRS 61.691; and
 - 20 5. Any retired member who was reemployed prior to March 26, 1974, shall
21 begin making contributions to the system in accordance with the
22 provisions of this section on the first day of the month following March
23 26, 1974.
- 24 (5) A retired member, or his estate, shall pay to the retirement fund the total amount of
25 payments which are not suspended in accordance with subsection (1) of this section
26 if the member received more than the maximum permissible earnings as provided
27 by the Federal Social Security Act in compensation from participating agencies

1 during any calendar year of reemployment, except the retired member or his estate
2 may repay the lesser of the total amount of payments which were not suspended or
3 fifty cents (\$0.50) of each dollar earned over the maximum permissible earnings
4 during reemployment if under age sixty-five (65), or one dollar (\$1) for every three
5 dollars (\$3) earned if over age sixty-five (65).

6 (6) (a) "Reemployment" or "reinstatement" as used in this section shall not include a
7 retired member who has been ordered reinstated by the Personnel Board under
8 authority of KRS 18A.095.

9 (b) A retired member who has been ordered reinstated by the Personnel Board
10 under authority of KRS 18A.095 or by court order or by order of the Human
11 Rights Commission and accepts employment by an agency participating in the
12 Kentucky Employees Retirement System or County Employees Retirement
13 System shall void his retirement by reimbursing the system in the full amount
14 of his retirement allowance payments received.

15 (7) (a) Effective August 1, 1998, the provisions of subsections (1) to (4) of this
16 section shall no longer apply to a retired member who is reemployed in a
17 position covered by the same retirement system from which the member
18 retired. Reemployed retired members shall be treated as new members upon
19 reemployment. Any retired member whose reemployment date preceded
20 August 1, 1998, who does not elect, within sixty (60) days of notification by
21 the retirement systems, to remain under the provisions of subsections (1) to
22 (4) of this section shall be deemed to have elected to participate under this
23 subsection.

24 (b) A retired member whose disability retirement was discontinued pursuant to
25 KRS 61.615 and who is reemployed in one (1) of the systems administered by

12 systems to confirm the individual's employment or volunteer status.

13 (9) If the retired member is under a contract, the member shall submit a copy of that
14 contract to the retirement system, and the retirement system shall determine if the
15 member is an independent contractor for purposes of retirement benefits. The
16 retired member and the participating employer shall submit the information required
17 or requested by the systems to confirm the individual's employment or volunteer
18 status.

19 (10) If a member is receiving a retirement allowance, or has filed the forms required for
20 a retirement allowance, and is employed within one (1) month of the member's
21 initial retirement date in a position that is required to participate in the same
22 retirement system from which the member retired, the member's retirement shall be
23 voided and the member shall repay to the retirement system all benefits received.
24 The member shall contribute to the member account established for him prior to his
25 voided retirement. The retirement allowance for which the member shall be eligible
26 upon retirement shall be determined by total service and creditable compensation.

27 (11) (a) If a member of the Kentucky Employees Retirement System retires from a

1 department which participates in more than one (1) retirement system and is
2 reemployed within one (1) month of his initial retirement date by the same
3 department in a position participating in another retirement system, the retired
4 member's retirement allowance shall be suspended for the first month of his
5 retirement and the member shall repay to the retirement system all benefits
6 received for the month.

7 (b) A retired member of the County Employees Retirement System who after
8 initial retirement is hired by the county from which the member retired shall
9 be considered to have been hired by the same employer.

10 (12) (a) If a hazardous member who retired prior to age fifty-five (55), or a
11 nonhazardous member who retired prior to age sixty-five (65), is reemployed
12 within six (6) months of the member's termination by the same employer, the
13 member shall obtain from his previous and current employers a copy of the
14 job description established by the employers for the position and a statement
15 of the duties performed by the member for the position from which he retired
16 and for the position in which he has been reemployed.

17 (b) The job descriptions and statements of duties shall be filed with the retirement
18 office.

19 (13) If the retirement system determines that the retired member has been employed in a
20 position with the same principal duties as the position from which the member
21 retired:

22 (a) The member's retirement allowance shall be suspended during the period that
23 begins on the month in which the member is reemployed and ends six (6)
24 months after the member's termination;

25 (b) The retired member shall repay to the retirement system all benefits paid from
26 systems administered by Kentucky Retirement Systems under reciprocity,
27 including medical insurance benefits, that the member received after

1 reemployment began;

2 (c) Upon termination, or subsequent to expiration of the six (6) month period
3 from the date of termination, the retired member's retirement allowance based
4 on his initial retirement account shall no longer be suspended and the member
5 shall receive the amount to which he is entitled, including an increase as
6 provided by KRS 61.691;

7 (d) Except as provided in subsection (7) of this section, if the position in which a
8 retired member is employed after initial retirement is a regular full-time
9 position, the retired member shall contribute to a second member account
10 established for him in the retirement system. Service credit gained after the
11 member's date of reemployment shall be credited to the second member
12 account; and

13 (e) Upon termination, the retired member shall be entitled to benefits payable
14 from his second retirement account.

15 (14) (a) If the retirement system determines that the retired member has not been
16 reemployed in a position with the same principal duties as the position from
17 which he retired, the retired member shall continue to receive his retirement
18 allowance.

19 (b) If the position is a regular full-time position, the member shall contribute to a
20 second member account in the retirement system.

21 (15) (a) If a retired member is reemployed at least one (1) month after initial
22 retirement in a different position, or at least six (6) months after initial
23 retirement in the same position, and prior to normal retirement age, the retired
24 member shall contribute to a second member account in the retirement system
25 and continue to receive a retirement allowance from the first member account.

26 (b) Service credit gained after reemployment shall be credited to the second
27 member account. Upon termination, the retired member shall be entitled to

1 benefits payable from the second member account.

2 (16) A retired member who is reemployed and contributing to a second member account
3 shall not be eligible to purchase service credit under any of the provisions of KRS
4 16.505 to 16.652, 61.510 to 61.705, or 78.510 to 78.852 which he was eligible to
5 purchase prior to his initial retirement.

6 (17) Notwithstanding any provision of subsections (1) to (7)(a) and (10) to (15) of this
7 section, the following shall apply to retired members **who retired prior to January**
8 **1, 2019, and** who are reemployed by an agency participating in one (1) of the
9 systems administered by Kentucky Retirement Systems on or after September 1,
10 2008:

11 (a) Except as provided by paragraphs (c) and (d) of this subsection, if a member is
12 receiving a retirement allowance from one (1) of the systems administered by
13 Kentucky Retirement Systems, or has filed the forms required to receive a
14 retirement allowance from one (1) of the systems administered by Kentucky
15 Retirement Systems, and is employed in a regular full-time position required
16 to participate in one (1) of the systems administered by Kentucky Retirement
17 Systems or is employed in a position that is not considered regular full-time
18 with an agency participating in one (1) of the systems administered by
19 Kentucky Retirement Systems within three (3) months following the member's
20 initial retirement date, the member's retirement shall be voided, and the
21 member shall repay to the retirement system all benefits received, including
22 any health insurance benefits. If the member is returning to work in a regular
23 full-time position required to participate in one (1) of the systems
24 administered by Kentucky Retirement Systems:

25 1. The member shall contribute to a member account established for him or
26 her in one (1) of the systems administered by Kentucky Retirement
27 Systems, and employer contributions shall be paid on behalf of the

1 member by the participating employer; and

2 2. Upon subsequent retirement, the member shall be eligible for a
3 retirement allowance based upon total service and creditable
4 compensation, including any additional service or creditable
5 compensation earned after his or her initial retirement was voided;

6 (b) Except as provided by paragraphs (c) and (d) of this subsection, if a member is
7 receiving a retirement allowance from one (1) of the systems administered by
8 Kentucky Retirement Systems and is employed in a regular full-time position
9 required to participate in one (1) of the systems administered by Kentucky
10 Retirement Systems after a three (3) month period following the member's
11 initial retirement date, the member may continue to receive his or her

20 coverage with the Kentucky Employees Retirement System or the County
21 Employees Retirement System, and is employed in a regular full-time position
22 required to participate in the State Police Retirement System or in a hazardous

25 initial retirement date, the member's retirement shall be voided, and the
26 member shall repay to the retirement system all benefits received, including

2 administered by Kentucky Retirement Systems:

3 1. The member shall contribute to a member account established for him or
4 her in one (1) of the systems administered by Kentucky Retirement
5 Systems, and employer contributions shall be paid on behalf of the
6 member by the participating employer; and

7 2. Upon subsequent retirement, the member shall be eligible for a
8 retirement allowance based upon total service and creditable
9 compensation, including any additional service or creditable
10 compensation earned after his or her initial retirement was voided;

11 (d) If a member is receiving a retirement allowance from the State Police
12 Retirement System or from hazardous duty retirement coverage with the
13 Kentucky Employees Retirement System or the County Employees Retirement
14 System and is employed in a regular full-time position required to participate
15 in the State Police Retirement System or in a hazardous duty position with the

7 not earn any additional benefits for any work performed during the

- 9 3. Except as provided by KRS 70.291 to 70.293 and 95.022, the employer
10 shall pay employer contributions as specified by KRS 61.565 and 61.702
11 on all creditable compensation earned by the employee during the period
12 of reemployment. The additional contributions paid shall be used to
13 reduce the unfunded actuarial liability of the systems; and
- 14 4. Except as provided by KRS 70.291 to 70.293 and 95.022, the employer
15 shall be required to reimburse the systems for the cost of the health
16 insurance premium paid by the systems to provide coverage for the
17 retiree, not to exceed the cost of the single premium;
- 18 (e) Notwithstanding paragraphs (a) to (d) of this subsection, a retired member
19 who qualifies as a volunteer for an employer participating in one (1) of the
20 systems administered by Kentucky Retirement Systems and who is receiving
21 reimbursement of actual expenses, a nominal fee for his or her volunteer
22 services, or both, shall not be considered an employee of the participating
23 employer and shall not be subject to paragraphs (a) to (d) of this subsection if:
- 24 1. Prior to the retired member's most recent retirement date, he or she did
25 not receive creditable compensation from the participating employer in
26 which the retired member is performing volunteer services;
- 27 2. Any reimbursement or nominal fee received prior to the retired

1 member's most recent retirement date has not been credited as creditable
2 compensation to the member's account or utilized in the calculation of
3 the retired member's benefits;

4 3. The retired member has not purchased or received service credit under
5 any of the provisions of KRS 61.510 to 61.705 or 78.510 to 78.852 for
6 service with the participating employer for which the retired member is
7 performing volunteer services; and

8 4. Other than the status of volunteer, the retired member does not become
9 an employee, leased employee, or independent contractor of the
10 employer for which he or she is performing volunteer services for a
11 period of at least twenty-four (24) months following the retired
12 member's most recent retirement date.

13 If a retired member, who provided volunteer services with a participating
14 employer under this paragraph violates any provision of this paragraph, then
15 he or she shall be deemed an employee of the participating employer as of the
16 date he or she began providing volunteer services and both the retired member
17 and the participating employer shall be subject to paragraphs (a) to (d) of this
18 subsection for the period of volunteer service; and

19 (f) Notwithstanding any provision of this section, any mayor or member of a city
20 legislative body who has not participated in the County Employees Retirement
21 System prior to retirement, but who is otherwise eligible to retire from the
22 Kentucky Employees Retirement System or the State Police Retirement
23 System, shall not be:

24 1. Required to resign from his or her position as mayor or as a member of
25 the city legislative body in order to begin drawing benefits from the
26 Kentucky Employees Retirement System or the State Police Retirement

- 1 2. Subject to any provision of this section as it relates solely to his or her
2 service as a mayor or member of the city legislative body.

3 *(18) Notwithstanding any provision of subsections (1) to (7)(a) and (10) to (17) of this*
4 *section, the following shall apply to retired members, retirees, or annuitants of*
5 *the systems or plans administered by the Kentucky Retirement Systems, the*
6 *Judicial Form Retirement System, and the Teachers' Retirement System, who*
7 *retire and begin drawing a retirement allowance on or after January 1, 2019, and*
8 *are reemployed on or after January 1, 2019, by an agency participating in the*
9 *systems administered by the Kentucky Retirement Systems:*

10 *(a) Except as provided by paragraphs (c) and (d) of this subsection, if a retired*
11 *member is receiving a retirement allowance from the systems administered*

14 *Retirement Systems, regardless of whether or not the position is considered*
15 *regular full-time under KRS 61.510(21), 78.510(21), or paragraph (g) of*
16 *this subsection, within a three (3) month period following the member's*
17 *initial retirement date from the systems, the member's retirement shall be*
18 *voided and the member shall repay to the system all benefits received,*
19 *including any health insurance benefits. If the member's retirement is*
20 *voided as provided by this paragraph and the member has returned to work*
21 *in a position that is considered a regular full-time position in the systems*
22 *administered by Kentucky Retirement Systems as defined in KRS 61.510(21)*
23 *or 78.510(21), as applicable:*

- 24 *1. The member shall contribute to a member account established for him*
25 *or her in one (1) of the systems administered by the Kentucky*
26 *Retirement Systems and employer contributions shall be paid on*
27 *behalf of the member by the participating employer; and*

1 2. Upon subsequent retirement, the member shall be eligible for a
2 retirement allowance based upon total service, accumulated account
3 balance, and creditable compensation, including any additional
4 service, creditable compensation, or accumulated account balance
5 earned after his or her initial retirement was voided, subject to the
6 limitations of Section 4, 7, 12, or 38 of this Act;

7 (b) Except as provided by paragraphs (c) and (d) of this subsection, if a retired
8 member, annuitant, or retiree is receiving a retirement allowance from the

11 systems administered by the Kentucky Retirement Systems after a three (3)

3. The retired member may continue to draw his or her retirement allowance during the period of reemployment if:

a. The period of reemployment is not considered regular full-time as defined by paragraph (g) of this subsection; or

b. The period of reemployment is considered regular full-time but the member has not returned to reemployment for at least a twelve (12) month period following his or her initial retirement.

If the member returns to reemployment in a regular full-time position after a three (3) month but prior to a twelve (12) month period following his or her initial retirement, then the member's retirement allowance shall be suspended until twelve (12) months following his or her initial retirement; and

4. The employer shall pay the employer normal cost contributions as specified by subsection (1)(b) of Section 18 of this Act and Section 30 of this Act, on all creditable compensation earned by the employee during the period of regular full-time reemployment, based upon the system in which the member is reemployed. The employer normal cost contributions shall be payable on the employee's behalf for the period of regular full-time reemployment and shall be used to pay down the unfunded liability of the systems;

(c) If a member is receiving a retirement allowance from the State Police Retirement System or from hazardous duty retirement coverage with the Kentucky Employees Retirement System or the County Employees Retirement System or is a certified peace officer as provided in KRS Chapter 15, and is reemployed in any position with an agency participating in the systems or plans administered by the Kentucky Retirement Systems,

1 regardless of whether or not the position is considered regular full-time
2 under KRS 61.510(21), 78.510(21), or paragraph (g) of this subsection,
3 within a one (1) month period following the member's initial retirement
4 date from the system, the member's retirement shall be voided and the

25 ➔SECTION 43. A NEW SECTION OF KRS 161.220 TO 161.716 IS CREATED

26 TO READ AS FOLLOWS:

27 (1) An individual who becomes a member of the Teachers' Retirement System on or

1 after January 1, 2019, shall receive the retirement benefits provided by this
2 section in lieu of the retirement benefits provided under Sections 69 and 73 of
3 this Act. The retirement benefits provided by this section shall be known as the
4 hybrid cash balance plan and shall operate as another benefit tier within the
5 Teachers' Retirement System.

6 (2) The hybrid cash balance plan shall provide a retirement benefit based upon the
7 member's accumulated account balance, which shall include:

8 (a) Contributions made by the member as provided by KRS 161.220 to 161.716,
9 except for employee contributions prescribed by subsection (1)(a)2., (1)(b)2.,
10 or (1)(c) of Section 57 of this Act;

11 (b) An employer pay credit for:

12 1. Nonuniversity employees equal to eight percent (8%) of the
13 compensation earned by the employee for each month the employee is
14 contributing to the hybrid cash balance plan provided by this section;
15 and

16 2. University employees equal to four percent (4%) of the compensation
17 earned by the employee for each month the employee is contributing
18 to the hybrid cash balance plan provided by this section; and

19 (c) Regular interest added annually to the member's accumulated account
20 balance as provided by this section.

21 (3) (a) Member contributions and employer pay credits as provided by subsection
22 (2)(a) and (b) of this section shall be credited to the member's account
23 monthly as contributions are reported and posted to the system in
24 accordance with KRS 161.560.

25 (b) Regular interest, as provided by subsection (2)(c) of this section, shall be
26 credited to the member's account annually on June 30 of each fiscal year,
27 as determined by subsection (4) of this section.

1 (4) (a) On June 30 of each fiscal year, the system shall determine if the member
2 contributed to the hybrid cash balance plan or another state-administered
3 retirement system during the fiscal year.

4 (b) If the member contributed to the hybrid cash balance plan or another state-
5 administered retirement system during the fiscal year, the regular interest
6 added to the member's account for that fiscal year shall be determined by
7 multiplying the member's accumulated account balance on June 30 of the

15 (d) For purposes of this subsection, "system's geometric average net investment

17 1. Means the annual average geometric investment return, net of
18 administrative and investment fees and expenses, over the last ten (10)
19 fiscal years as of the date the regular interest is credited to the

22 (e) No employer pay credits or regular interest shall be provided to a member
23 who has taken a refund of his or her accumulated account balance as

26 (5) (a) Upon termination of employment, a member who has less than five (5)
27 years of service credited under Section 51 of this Act, who elects to take a

4 (b) Upon termination of employment, a member who has five (5) or more years

8 (6) A member participating in the hybrid cash balance plan provided by this section
9 may qualify for service retirement by meeting one (1) of the following
10 requirements:

11 (a) On or after age sixty-five (65), if he or she has earned five (5) or more years
12 of service credited under Section 51 of this Act, or another state-

14 (b) If the member is at least age fifty-seven (57) and has an age and years of

14 (1) As used in this section:

15 (a) "Teacher" shall mean any person for whom certification is required as a basis
 16 of employment in the common schools of the state;

17 (b) "Employee" shall mean any person, other than a teacher, employed in the
 18 public schools, whether on a full or part-time basis;

19 (c) "Immediate family" shall mean the teacher's or employee's spouse, children
 20 including stepchildren and foster children, grandchildren, daughters-in-law
 21 and sons-in law, brothers and sisters, parents and spouse's parents, and
 22 grandparents and spouse's grandparents, without reference to the location or
 23 residence of said relative, and any other blood relative who resides in the
 24 teacher's or employee's home;

25 (d) "Sick leave bank" shall mean an aggregation of sick leave days contributed by
 26 teachers or employees for use by teachers or employees who have exhausted
 27 all sick leave and other available paid leave days; and

1 (e) "Assault" shall mean an act that intentionally causes injury so significant that
2 the victim is determined to be, by certification of a physician or surgeon duly
3 qualified under KRS Chapter 342, incapable of performing the duties of his or
4 her job.

5 (2) Each district board of education shall allow to each teacher and full-time employee
6 in its common school system not less than ten (10) days of sick leave during each
7 school year, without deduction of salary. Sick leave shall be granted to a teacher or
8 employee if he or she presents a personal affidavit or a certificate of a physician
9 stating that the teacher or employee was ill, that the teacher or employee was absent
10 for the purpose of attending to a member of his or her immediate family who was
11 ill, or for the purpose of mourning a member of his or her immediate family. The
12 ten (10) days of sick leave granted in this subsection may be taken by a teacher or
13 employee on any ten (10) days of the school year and shall be granted in addition to
14 accumulated sick leave days that have been credited to the teacher or employee

16 (3) A school district shall coordinate among the income and benefits from workers'
17 compensation, temporary disability retirement, and district payroll and benefits so
18 that there is no loss of income or benefits to a teacher or employee for work time

20 duties for a period of up to one (1) year after the assault. In the event a teacher or
21 employee suffers an assault while performing his or her assigned duties that results
22 in injuries that qualify the teacher or employee for workers' compensation benefits,

24 the assault with no loss of income or benefits under the following conditions:

25 (a) The district shall pay the salary of the teacher or employee between the time

3 (b) The district shall pay, for up to one (1) year from the time of the assault, the
4 difference between the salary of the teacher or employee and any workers'
5 compensation income benefits received by the teacher or employee resulting
6 from the assault. Payments by the district shall include payments for
7 intermittent work time missed as a result of the assault during the one (1) year
8 period. If the teacher's or employee's workers' compensation income benefits
9 cease during the one (1) year period after the assault, the district shall also
10 cease to make payments under this paragraph;

11 (c) The Commonwealth, through the Kentucky Department of Education, shall
12 make the employer's health insurance contribution during the period that the
13 district makes payments under paragraphs (a) and (b) of this subsection;

14 (d) The Commonwealth, through the Kentucky Department of Education, shall
15 make the employer's contribution to the retirement system in which the
16 teacher or employee is a member during the period that the district makes
17 payments under paragraphs (a) and (b) of this subsection; and

18 (e) Payments to a teacher or employee under paragraphs (a) and (b) of this
19 subsection shall be coordinated with workers' compensation benefits under
20 KRS Chapter 342, disability retirement benefits for teachers under KRS
21 161.661 to 161.663, and disability retirement benefits for employees under
22 KRS 61.600 to 61.621 and 78.545 so that the teacher or employee receives
23 income equivalent to his or her full contracted salary, but in no event shall the

26 (4) Days of sick leave not taken by an employee or a teacher during any school year
27 shall accumulate without limitation and be credited to that employee or teacher.

1 Accumulated sick leave may be taken in any school year. Any district board of
2 education may, in its discretion, allow employees or teachers in its common school
3 system sick leave in excess of the number of days prescribed in this section and may
4 allow school district employees and teachers to use up to three (3) days' sick leave
5 per school year for emergency leave pursuant to KRS 161.152(3). Any accumulated
6 sick leave days credited to an employee or a teacher shall remain so credited in the
7 event he or she transfers his or her place of employment from one (1) school district
8 to another within the state or to the Kentucky Department of Education or transfers

10 (5) Accumulated days of sick leave shall be granted to a teacher or employee if, prior to

19 (7) A district board of education may adopt a plan for a sick leave bank. The plan may
20 include limitations upon the number of days a teacher or employee may annually
21 contribute to the bank and limitations upon the number of days a teacher or
22 employee may annually draw from the bank. Only those teachers or employees who
23 contribute to the bank may draw upon the bank. Days contributed will be deducted
24 from the days available to the contributing teacher or employee. The sick leave bank
25 shall be administered in accordance with a policy adopted by the board of

27 (8) (a) A district board of education shall establish a sick leave donation program to

1 permit teachers or employees to voluntarily contribute sick leave to teachers
2 or employees in the same school district who are in need of an extended
3 absence from school. A teacher or employee who has accrued more than
4 fifteen (15) days' sick leave may request the board of education to transfer a
5 designated amount of sick leave to another teacher or employee who is
6 authorized to receive the sick leave donated. A teacher or employee may not
7 request an amount of sick leave be donated that reduces his or her sick leave

9 (b) A teacher or employee may receive donations of sick leave if:

- 10 1. a. The teacher or employee or a member of his or her immediate
11 family suffers from a medically certified illness, injury,

14 (10) days; or
- 15 b. The teacher or employee suffers from a catastrophic loss to his or
16 her personal or real property, due to either a natural disaster or fire,

18 absent for at least ten (10) consecutive working days;
- 19 2. The teacher's or employee's need for the absence and use of leave are
20 certified by a licensed physician for leave requested under subparagraph

- 22 3. The teacher or employee has exhausted his or her accumulated sick
23 leave, personal leave, and any other leave granted by the school district;
24 and
- 25 4. The teacher or employee has complied with the school district's policies
26 governing the use of sick leave.

27 (c) While a teacher or employee is on sick leave provided by this section, he or

1 she shall be considered a school district employee, and his or her salary,
2 wages, and other employee benefits shall not be affected.

3 (d) Any sick leave that remains unused, is not needed by a teacher or employee,
4 and will not be needed in the future shall be returned to the teacher or
5 employee donating the sick leave.

6 (e) The board of education shall adopt policies and procedures necessary to
7 implement the sick leave donation program.

8 (9) A teacher or employee may use up to thirty (30) days of sick leave following the
9 birth or adoption of a child or children. Additional days may be used when the need
10 is verified by a physician's statement.

11 (10) (a) After July 1, 1982, **and except as otherwise provided by this subsection,** a
12 district board of education may compensate, at the time of retirement or upon
13 the death of a member in active contributing status at the time of death who
14 was eligible to retire by reason of service, an employee or a teacher, or the
15 estate of an employee or teacher, for each unused sick leave day. The rate of
16 compensation for each unused sick leave day shall be based on a percentage of
17 the daily salary rate calculated from the employee's or teacher's last annual

14 As used in KRS 161.220 to 161.716 and 161.990:

11 savings fund contributions for each year of subsequent service prior to date of
12 membership, with interest at the rate of eight percent (8%) compounded annually to
13 the date of deposit.

14 (5) Membership in the retirement system shall be terminated:

15 (a) By retirement for service;

16 (b) By death;

17 (c) By withdrawal of the member's accumulated *account balance*~~[contributions]~~;

18 (d) When a member, having less than five (5) years of Kentucky service is absent
19 from service for more than three (3) consecutive years; or

20 (e) For persons hired on or after August 1, 2000, when a member is convicted, in
21 any state or federal court of competent jurisdiction, of a felony related to his
22 employment as provided in subparagraphs 1. and 2. of this paragraph.

23 1. Notwithstanding any provision of law to the contrary, a member hired
24 on or after August 1, 2000, who is convicted, in any state or federal
25 court of competent jurisdiction, of a felony related to his employment
26 shall forfeit rights and benefits earned under the retirement system,
27 except for the return of his accumulated contributions and interest

1 credited on those contributions.

2 2. The payment of retirement benefits ordered forfeited shall be stayed
3 pending any appeal of the conviction. If the conviction is reversed on
4 final judgment, no retirement benefits shall be forfeited.

5 Except for paragraph (e) of this subsection, upon termination of member accounts
6 under this subsection, funds in the account shall be transferred to the guarantee
7 fund. Inactive members may apply for refunds of these funds at any time. The
8 terminated service shall be reinstated, if not withdrawn by the member, in the event
9 that the member returns to active contributing service.

10 (6) In case of withdrawal from service prior to eligibility for retirement, the board of
11 trustees shall on request of the member return all of his accumulated **account**
12 **balance**~~[contributions with regular interest]~~, including any payments made by the
13 member to the state accumulation fund, but the member shall have no claim on any
14 contributions made by the state **or employer** with a view to his retirement, **except as**
15 **provided by Section 43 of this Act,** or to contributions made to the medical
16 insurance fund. If the member is eligible for an immediate service retirement
17 allowance as provided in KRS 161.600, no withdrawal and refund shall be
18 permitted, unless the allowance would prohibit the member from qualifying for
19 Social Security benefits or the member elects to withdraw part or all of his service
20 for the purpose of obtaining credit in another retirement plan. Requests for refund of
21 contributions by the member must be filed on forms prescribed by the Teachers'
22 Retirement System and the employer shall be financially responsible for all
23 information that is certified on the prescribed form. A member may not withdraw
24 any part of his or her **accumulated account balance in**~~[contributions to]~~ the
25 retirement system except as provided by this subsection.

26 (7) Except as provided in KRS 161.520 and 161.525, in case of death prior to
27 retirement, the board of trustees shall pay to the estate of the deceased member,

1 unless a beneficiary was otherwise applicably designated by the deceased member,
2 then to the beneficiary, all of his accumulated account balance~~[contributions, with~~
3 ~~regular interest]~~, including any payments made by the member to the state
4 accumulation fund, but the estate or beneficiary shall have no claim on any
5 contributions made by the state or employer with a view to the retirement of the
6 member, except as provided by Section 43 of this Act, or to contributions made to
7 the medical insurance fund.

8 (8) Any active contributing member of the Kentucky Employees Retirement System,
9 the County Employees Retirement System, the State Police Retirement System, or
10 the Judicial Retirement System may use service, under that retirement system for
11 the purpose of meeting the service requirement of subsections (3) and (4) of this
12 section.

13 ➔Section 50. KRS 161.480 is amended to read as follows:

14 Each person, upon becoming a member of the retirement system, shall file a detailed
15 statement as required by the board of trustees and shall designate a primary beneficiary or
16 two (2) or more cobeneficiaries to receive any benefits accruing from the death of the
17 member. A contingent beneficiary may be designated in addition to the primary
18 beneficiary or cobeneficiaries. The member may name more than one (1) contingent
19 beneficiary. Any beneficiary designation made by the member, including the estate should
20 the estate become the beneficiary by default, shall remain in effect until changed by the
21 member on forms prescribed by the Kentucky Teachers' Retirement System, except in the
22 event of subsequent marriage or divorce. Subsequent marriage by the member shall void
23 the primary beneficiary and any cobeneficiary designation, even that of a trust, and the
24 spouse of the member at death shall be considered as the primary beneficiary, unless the
25 member subsequent to marriage designates another beneficiary. A final divorce decree
26 shall terminate an ex-spouse's status as either primary beneficiary, cobeneficiary, or
27 contingent beneficiary, unless subsequent to divorce the member redesignates the former

1 spouse as primary beneficiary, cobeneficiary, or contingent beneficiary. To the extent
2 permitted by the Internal Revenue Code, a trust may be designated as beneficiary for
3 receipt of a member's **accumulated account balance in**~~[contributions to]~~ the retirement
4 system as provided under KRS 161.470(7). A final divorce decree shall not terminate the
5 designation of a trust as beneficiary regardless of who is designated as beneficiary of the
6 trust. In the event that a member fails to designate a beneficiary, or all designated
7 beneficiaries predecease the member, the member's estate shall be deemed to be the
8 beneficiary. Members may designate as beneficiaries only presently identifiable and
9 existing individuals, or trusts where otherwise permitted, without contingency
10 instructions, on forms prescribed by the retirement system. The provisions of this section
11 shall be retroactive as they relate to election of beneficiaries by members still in active
12 status on the effective date of this section. The provisions of this section shall not apply to
13 any account from which a member is drawing a retirement allowance or to the life
14 insurance benefit available under KRS 161.655.

15 ➔Section 51. KRS 161.500 is amended to read as follows:

16 (1) At the close of each fiscal year, the retirement system shall add service credit to the
17 account of each member who made contributions to his or her account during the
18 year. Members shall be entitled to a full year of service credit if their total paid days
19 were not less than one hundred eighty (180) days of a one hundred eighty-five (185)
20 day contract for a regular school or fiscal year. In the event **an individual who**
21 **became** a member **prior to January 1, 2019,** is paid for less than one hundred
22 eighty (180) days, the member may purchase credit according to administrative
23 regulations established by the board of trustees. In no case shall more than one (1)
24 year of service be credited for all service performed in one (1) fiscal year. Members
25 who complete their employment contract prior to the close of a fiscal year and elect
26 to retire prior to the close of a fiscal year shall have their service credit reduced by
27 eight percent (8%) for each calendar month that the retirement becomes effective

1 prior to July 1.

2 (2) Members who are employed and paid for less than the number of days required in
3 their normal employment year shall be entitled to pro rata service credit for the
4 fractional service. Such credit shall be based upon the number of days employed
5 and the number of days in the member's annual employment agreement or normal
6 employment year.

7 (3) Service credit may not exceed the ratio between the school or fiscal year and the
8 number of months or fraction of a month the member is employed during that year.

9 (4) No service credit shall be granted in the Teachers' Retirement System for service
10 that has been or will be used in qualifying for annuity benefit payments from
11 another retirement system financed wholly or in part by public funds.

12 ➔Section 52. KRS 161.507 is amended to read as follows:

13 (1) An active contributing member of the Teachers' Retirement System may receive
14 service credit for active service rendered in the uniformed services of the Armed
15 Forces of the United States, including the commissioned corps of the Public Health
16 Service, subject to the provisions of the Uniformed Services Employment and
17 Reemployment Rights Act of 1994, the provisions of this section as applicable,
18 and ~~the~~ administrative regulations promulgated by the board of trustees. Military
19 service includes service in the uniformed services that occurs before the
20 employment of a member in a position covered by the retirement system or where a
21 member leaves covered employment without giving advance written or verbal
22 notice of performing duty in the uniformed services. Service in the uniformed
23 services also includes uniformed service that occurs after employment in a position
24 covered by the retirement system where the member has given advance written or
25 verbal notice of performing duty in the uniformed services and the member returns
26 directly from uniformed services to covered employment. Military service may be
27 credited only if discharge was honorable or was not terminated upon the occurrence

1 of any of the events listed in 38 U.S.C. sec. 4304. Service shall be considered as
2 Kentucky teaching service, except that service may not be used for meeting the
3 service requirements set forth in KRS 161.600(1)(a) or 161.661(1) unless the
4 service occurred after the member gave written or verbal notice of performing duty
5 in the uniformed services and the member returned directly from uniformed services
6 to covered employment. A maximum of six (6) years of military service may be
7 credited, but in no case a greater number of years than the actual years of
8 contributing service in Kentucky.

9 (2) No credit shall be granted for military service which has been or will be used in
10 qualifying for annuity benefit payments from another retirement system financed
11 wholly or in part by public funds.

12 (3) A member having twenty (20) years or more of active duty in the military service,
13 and who is qualified for regular federal retirement benefits based on this military
14 service, may not receive credit for any military service in the Teachers' Retirement
15 System. This subsection shall apply to service presented for credit on July 1, 1975,
16 and after this date.

17 (4) (a) *An individual who became* a member *prior to January 1, 2019, who desires*
18 *to receive*~~receiving~~ retirement credit for active duty in the armed services of
19 the United States prior to employment in a position covered by the retirement
20 system or where the member leaves covered employment without giving
21 advance written or verbal notice of performing duty in the uniformed services
22 shall pay to the retirement system the full actuarial cost of the service credit
23 purchased as provided under KRS 161.220(22). These contributions shall not
24 be picked up, as described in KRS 161.540(2). In purchasing retirement credit
25 for active duty in the armed services, the latest years of service shall be
26 considered first in allowing credit toward retirement. The board of trustees
27 shall adopt a table of actuarial factors to be used in calculating the amount of

1 contribution required for crediting this service.

2 (b) If military service occurred after the member gave written or verbal notice of
3 performing duty in the uniformed services and the member returns directly
4 from uniformed services to covered employment, the member shall contribute
5 the regular member contribution required by KRS 161.540. The member may
6 make the payment of delayed contributions in a lump sum payment or in
7 installments not to exceed five (5) years beginning with the member's date of
8 reemployment. Interest at the rate of eight percent (8%) per annum shall be
9 charged for delayed contributions beginning with the member's date of
10 reemployment until paid. Members participating in the hybrid cash balance
11 plan as provided by Section 43 of this Act who make the regular member
12 contribution required by this paragraph, shall receive employer credits for
13 the period of service purchased.

14 (5) An active contributing member of the Teachers' Retirement System who became a
15 member of the system prior to January 1, 2019, may receive service credit for
16 service in the military reserves of the United States or the National Guard. The
17 member may purchase one (1) month of service for each six (6) months of service
18 in the reserves or the National Guard. Notwithstanding any other statute, regulation,
19 or policy to the contrary, the system shall provide a member, upon request, the
20 estimated actuarial cost of the National Guard or military reserves service purchase
21 based upon the information available at the time of the request. The member shall
22 be entitled to enter into a contract with the system at the time of the request to
23 purchase the National Guard or military reserve service by paying to the system the
24 estimated actuarial cost, either by installments or in lump sum. The member shall
25 pay the full actuarial cost of this service in the military reserves or the National
26 Guard as provided in KRS 161.220(22). Service in the military reserves or the
27 National Guard shall be treated as service earned prior to participation in the system

1 and shall not be used for meeting the service requirements set forth in KRS
2 161.600(1)(a) or 161.661(1). The payment shall not be picked up by the employer,
3 as described in KRS 161.540(2).

4 ➔Section 53. KRS 161.515 is amended to read as follows:

5 (1) For the purposes of this section, "out-of-state service" shall mean service in any
6 state in a comparable position on a full-time basis, which would be covered if in
7 Kentucky.

8 (2) (a) An active contributing member who has been a contributing member of the
9 retirement system for at least one (1) full scholastic year subsequent to the
10 latest out-of-state service, may present for credit service rendered out of state,
11 not to exceed ten (10) years actually taught as a certified or licensed teacher.
12 All members who elect to purchase this service shall pay to the retirement
13 system the full actuarial cost as provided under KRS 161.220(22). For each
14 year of which the retirement system shall accept payment, one (1) year of
15 service credit shall be given. For members who purchased this service under
16 the cost formula as it existed under this subsection on June 30, 2005, this
17 credit may not be used to meet the service requirements of KRS 161.525,
18 161.600, or 161.661, except as provided in subsection (2)(c) of this section.
19 No credit shall be granted for service which has been or will be used in
20 qualifying for annuity benefit payments from another retirement system
21 financed wholly or in part by public funds.

22 (b) A member of the retirement system having teaching service in the elementary
23 or secondary schools operated by the United States overseas or in this country,
24 or in a public college or university in Kentucky, not included in the Teachers'
25 Retirement System of the State of Kentucky, may present this service for
26 credit in the retirement system on the same basis as provided above for out-of-
27 state service credit; however, no service may be presented which shall be used

1 as a basis for retirement benefits in any program supported wholly or in part
2 by a public institution or governmental agency. This service when added to
3 service credited under subsection (2)(a) of this section shall not exceed a total
4 of ten (10) years' service credit.

5 (c) A member having service referred to in subsection (2)(a) or (2)(b) of this
6 section who purchased this service under the cost formula as it existed under
7 those subsections on June 30, 2005, may elect to use this service for meeting
8 the requirements of KRS 161.600(1)(c) by making an additional contribution
9 to the state accumulation fund equal to a member contribution rate of eight
10 percent (8%) for each year so used. These payments shall not be picked up as
11 described in KRS 161.540(2). The salary base to be used in determining this
12 additional contribution shall be the final average salary which is used in
13 calculating the member's regular retirement annuity.

14 (3) Members entering the Teachers' Retirement System for the first time, July 1, 1976,
15 and after this date, shall not receive credit for service defined in subsections (2)(a)
16 or (2)(b) of this section in excess of one (1) year of credit for each two (2) years of
17 Kentucky service in a covered position or ten (10) years, whichever is the lesser
18 number.

19 (4) A member, having completed service as a volunteer in the Kentucky Peace Corps
20 created by KRS 154.1-720, may purchase service credit for the time served in the
21 corps on the same basis as provided in this section for the purchase of out-of-state
22 service credit. A member, having completed service as a federal Peace Corps
23 volunteer, may purchase up to two (2) years of service credit for time served in the
24 Peace Corps on the same basis as provided in this section for the purchase of out-of-
25 state service credit.

26 (5) Service purchased under this section by members who at the time of purchase are
27 employed by employers other than those described in KRS 161.220(4)(b) or (n)

1 shall be credited, as described in KRS 161.620(1)(a) and (b), with a retirement
2 factor of two and one-half percent (2.5%) for each year of service that was
3 originally performed on or after July 1, 1983, and two percent (2.0%) for each year
4 of service performed before July 1, 1983. Service purchased under this section by
5 members who at the time of purchase are employed by employers described in KRS
6 161.220(4)(b) or (n) shall be credited, as described in KRS 161.620(1)(a), with a
7 retirement factor of two percent (2.0%) for each year of service, regardless of when
8 the service was performed.

9 **(6) Effective January 1, 2019, this section does not apply to individuals who become**
10 **members on or after January 1, 2019.**

11 ➔Section 54. KRS 161.520 is amended to read as follows:

12 Upon the death of an active contributing member or upon the death of a member retired
13 for disability, except as provided in KRS 161.661(6), the survivors of the deceased
14 member in the following named order, may elect to receive a survivor's benefit payable as
15 follows:

16 (1) Where there is a surviving widow or widower who is named as the primary
17 beneficiary of the member's retirement account, the benefit shall be:

18 (a) One hundred eighty dollars (\$180) per month with no restriction on other
19 income;

20 (b) Two hundred forty dollars (\$240) per month when the surviving widow or
21 widower's total income from all sources does not exceed six thousand six
22 hundred dollars (\$6,600) per year or five hundred fifty dollars (\$550) per
23 month; or

24 (c) If the deceased member has a minimum of ten (10) years of service credit with
25 the Teachers' Retirement System, the surviving widow or widower may apply
26 for an annuity actuarially equivalent to the annuity that would have been paid
27 to the deceased member when eligibility conditions were met. Eligibility for

1 payments would begin at the time the age of the deceased member would have
2 met the requirements of KRS 161.600(1) or subsection (6) of Section 43 of
3 this Act, as applicable. In exercising this right, the surviving widow or
4 widower shall be entitled to receive an annuity for life, except as provided in
5 subsection (6) of this section. This subsection applies to surviving spouses of
6 members who die on or after July 1, 1978. A surviving widow or widower of
7 a member who dies after July 1, 1978, shall be eligible for benefit payments
8 provided under paragraphs (a) and (b) of this subsection until they begin
9 receiving payments under this provision;

10 (2) (a) Where there are surviving unmarried children under age eighteen (18) or
11 under age nineteen (19) if a full-time student in high school, the benefit shall
12 be two hundred dollars (\$200) per month in the case of one (1) child, three
13 hundred forty dollars (\$340) per month in the case of two (2) children, four
14 hundred dollars (\$400) per month in the case of three (3) children, and four
15 hundred forty dollars (\$440) per month in the case of four (4) or more
16 children. Benefits under this subsection shall apply in addition to benefits
17 which may be payable under subsections (1) and (3) of this section.

18 (b) Notwithstanding any provision of law to the contrary, the surviving spouse
19 may elect to receive a lump-sum refund of the member's accumulated account
20 balance in lieu of the survivorship benefits payable under this subsection and
21 subsection (1) of this section only if the surviving spouse is designated as the
22 primary beneficiary and:

- 23 1. Is a biological or adoptive parent of all children eligible for a benefit
24 under this subsection and has not had his or her parental rights
25 terminated; or
- 26 2. Has been appointed as legal guardian of all of the children eligible under
27 paragraph (a) of this subsection.

1 (c) To elect a lump-sum refund of the member's accumulated account balance
2 under paragraph (b) of this subsection, the surviving spouse who is designated
3 as the primary beneficiary must sign a waiver on forms prescribed by the
4 retirement system of his or her rights and the member's children's rights to the
5 survivorship benefits payable under this subsection and subsection (1) of this
6 section. The surviving spouse shall not waive the survivorship benefits
7 available under this subsection or subsections (1) and (6) of this section if any
8 of the member's children have attained age eighteen (18) or older unless all of
9 those children consent in writing on forms prescribed by the retirement system
10 to waive their survivorship benefits available under this subsection;

11 (3) (a) Where the survivor is a child age eighteen (18) or older whose mental or
12 physical condition is sufficient to cause his dependency on the deceased
13 member at the time of the member's death, the benefit shall be two hundred
14 dollars (\$200) per month, payable for the life of the child or until the time as
15 the mental or physical condition creating the dependency no longer exists or
16 the child marries. The mental or physical condition of the adult child shall be
17 revealed by a competent examination by a licensed physician and shall be
18 approved by a majority of a medical review committee as defined in KRS
19 161.661(14). Benefits under this subsection shall apply in addition to benefits
20 which may be payable under subsections (1) and (2) of this section.

21 (b) Notwithstanding any provision of law to the contrary, the surviving spouse
22 shall not elect to receive a lump-sum refund of the member's accumulated
23 account balance in lieu of the survivorship benefits payable under this
24 subsection and subsection (1) of this section unless:

- 25 1. The surviving spouse is designated as the primary beneficiary;
- 26 2. The surviving spouse has been appointed by the court as guardian,
27 conservator, or other fiduciary with sufficient general or specific

- 1 authority to waive the survivorship benefits available under this
2 subsection for any child or children age eighteen (18) or older who have
3 been adjudicated incompetent to make decisions on their own behalf by
4 a court of law; and
- 5 3. Any child or children age eighteen (18) or older who are mentally
6 competent to make decisions on their own behalf as attested to by two
7 (2) physicians' statements consent in writing on forms prescribed by the
8 retirement system to waive their survivorship benefits available under
9 this subsection.
- 10 (c) If eligible to elect a lump-sum refund of the member's accumulated account
11 balance, the surviving spouse shall sign a waiver on forms prescribed by the
12 retirement system of his or her rights and the member's children's rights to the
13 survivorship benefits payable under this subsection and subsections (1) and
14 (2) of this section;
- 15 (4) Where the sole eligible survivors are dependent parents aged sixty-five (65) or over,
16 the benefit shall be two hundred dollars (\$200) per month for one (1) parent or two
17 hundred ninety dollars (\$290) per month for two (2) parents. Dependency of a
18 parent shall be established as of the date of the death of the member;
- 19 (5) Where the sole eligible survivor is a dependent brother or sister, the benefit shall be
20 one hundred sixty five dollars (\$165) per month. In order to qualify the brother or
21 sister must have been a resident of the deceased member's household for at least one
22 (1) full year prior to the member's death or must have been receiving care in a
23 hospital, nursing home, or other institution at the member's expense for same
24 period;
- 25 (6) The benefit to a child as defined in subsection (2) of this section shall terminate
26 upon the attainment of age eighteen (18) or upon reaching age nineteen (19), if a
27 full-time student in high school, or upon marriage, except that benefits shall

- 1 continue until the attainment of age twenty-three (23) for an unmarried child who is
2 a full-time student in a recognized educational program beyond the high school
3 level. The benefit to a widow, widower, dependent parent, or dependent brother or
4 sister or dependent child age eighteen (18) or older shall terminate upon marriage,
5 or upon termination of the condition creating the dependency;
- 6 (7) The board of trustees shall be the sole judge of eligibility or dependency of any
7 beneficiary, and may require formal application or information relating to eligibility
8 or dependency, including proof of annual income satisfactory to the board. The
9 board of trustees may subpoena records and individuals whenever it deems this
10 action necessary;
- 11 (8) No payment of benefits shall be made unless the board of trustees authorizes the
12 payment. The board shall promulgate administrative regulations for the
13 administration of the provisions in this section and in every case the decision of the
14 board of trustees shall be final as to eligibility, dependency, or disability, and the
15 amount of benefits payable;
- 16 (9) In the event that there are no eligible survivors as defined in subsections (1) to (5)
17 of this section, or in the event that the surviving spouse elects not to receive
18 survivorship benefits on his or her own behalf or on behalf of any of the member's
19 children as permitted under subsections (2) and (3) of this section, the board of
20 trustees shall pay to the estate or the designated beneficiaries of the deceased
21 member a refund of his accumulated account balance~~[contributions]~~ as provided in
22 KRS 161.470(7). If the benefits paid or payable under subsections (1) to (5) of this
23 section and KRS 161.661 shall amount to a sum less than the member's
24 accumulated account balance~~[contributions]~~ at the time of death, the board of
25 trustees shall pay to the estate or designated beneficiaries of the deceased member
26 the balance of the accumulated account balance~~[contributions]~~;
- 27 (10) Any person who is receiving benefits and becomes disqualified from receiving

1 those benefits under this section shall immediately notify the Teachers' Retirement
2 System of this disqualification in writing and shall return all benefits paid after the
3 date of disqualification. Failure to comply with these provisions shall create an
4 indebtedness of that person to the Teachers' Retirement System. Interest at the rate
5 of eight percent (8%) per annum shall be charged if the debt is not repaid within
6 sixty (60) days after the date of disqualification. Failure to repay this debt creates a
7 lien in favor of the Teachers' Retirement System upon all property of the person
8 who improperly receives benefits and does not repay those benefits; and

9 (11) Benefits under subsections (2) and (3) of this section shall apply to a child who is a
10 legally adopted survivor at the time of the death of the member. This provision shall
11 be retroactive to include a child who was born after January 1, 1990, and is a legally
12 adopted survivor of a member whose death occurred prior to July 15, 2008.

13 ➔Section 55. KRS 161.522 is amended to read as follows:

14 Upon the death of a member retired for disability who had a minimum of twenty-seven
15 (27) years of service at the time of death, except as provided in KRS 161.661(6), the
16 spouse, if named as the primary beneficiary of the member's account, shall be entitled to
17 elect, in lieu of a refund of the member's account, an annuity actuarially equivalent to the
18 annuity that would have been paid to the deceased member had retirement for service
19 been effective on the day immediately preceding the member's death. This option shall be
20 available only during the entitlement period described under KRS 161.661(3) and (4)
21 prior to the recalculation of the member's disability allowance under KRS 161.661(5). In
22 selecting this right, the spouse shall be limited to selecting an option providing a straight
23 life annuity with refundable balance or a term certain option. There shall be a monthly
24 minimum allowance of three hundred dollars (\$300) as the basic straight life annuity.
25 This section applies to surviving spouses of members who were receiving benefit
26 payments under KRS 161.520 as of June 30, 1988, and to surviving spouses of members
27 who die on or after July 1, 1984, except that the member shall have been retired for

1 disability with a minimum of thirty (30) years of service if either of these two (2)
2 conditions were met prior to July 1, 1990. **This section does not apply to individuals who**
3 **become members on or after January 1, 2019.**

4 →Section 56. KRS 161.525 is amended to read as follows:

5 (1) Upon death of a member in active contributing status at the time of death, who was
6 eligible to retire by reason of service, the spouse, if named as the primary
7 beneficiary of the member's retirement account, or in the absence of an eligible

12 retirement plan within thirty (30) days after their employment date. This election
13 shall be irrevocable except as otherwise provided in this subsection. No member of
14 the Kentucky Teachers' Retirement System who terminates employment and is
15 subsequently reemployed by the same or another public postsecondary education
16 institution which participates in the Kentucky Teachers' Retirement System may be
17 eligible to elect to participate in the optional retirement plan unless the date of
18 reemployment is at least six (6) months after the date of termination. All elections
19 made under this subsection shall be in writing and shall be filed with the
20 appropriate officer of the employer institution. Persons who originally elected to
21 participate in the optional retirement plan may later change their elections only as
22 follows:

23 (a) Any person otherwise eligible for membership in the Kentucky Teachers'
24 Retirement System may irrevocably elect one (1) time during his or her
25 lifetime to change his or her election and to prospectively participate in the
26 Kentucky Teachers' Retirement System. This election to change from the
27 optional retirement plan to Kentucky Teachers' Retirement System shall be

1 effective beginning on the first day of the first month immediately following
2 the date that written application for the election is received in the retirement
3 system's office on forms prescribed by the system. Any person exercising this
4 election shall not be entitled to purchase as service credit in the Kentucky
5 Teachers' Retirement System any prior service with his or her postsecondary
6 education institution employer;

7 (b) Any person otherwise eligible for membership in the Kentucky Teachers'
8 Retirement System who previously elected to participate in the optional
9 retirement plan may irrevocably elect one (1) time within his or her first six
10 (6) years and six (6) months of continuous service in any one (1) or more of
11 the institutions identified in KRS 161.220(4)(b), to change his or her election
12 and to prospectively participate in the Kentucky Teachers' Retirement System
13 and also become eligible to purchase as service credit his or her prior service
14 with his or her postsecondary education employer. This election to change
15 from the optional retirement plan to the Kentucky Teachers' Retirement
16 System shall be effective beginning on the first day of the first month
17 immediately following the date that written application for the election is
18 received in the retirement system's office on forms prescribed by the
19 retirement system. Persons electing to change from the optional retirement
20 plan to the Kentucky Teachers' Retirement System may purchase service
21 credit only for their prior years of service for a postsecondary education
22 institution identified in KRS 161.220(4)(b) during which they participated in
23 the optional retirement plan. The election to purchase prior service as service
24 credit shall be received in the retirement system's office on forms prescribed
25 by the retirement system within the six (6) year and six (6) month period
26 provided to make the election to begin participation in the Kentucky Teachers'
27 Retirement System. The cost of purchasing this service shall be calculated by

1 adding both the employer and member contributions that would have been
2 paid to the Kentucky Teachers' Retirement System had the individual
3 purchasing this service participated in the Kentucky Teachers' Retirement
4 System instead of the optional retirement plan, less the amount contributed to
5 the Kentucky Teachers' Retirement System by the postsecondary education
6 institution as provided by KRS 161.569(5), or KRS 161.569(5)(a)2. as it
7 existed on June 30, 2007. Interest at Kentucky Teachers' Retirement System's
8 actuarially assumed rate shall be paid on these net contributions by the person
9 electing to change to the Kentucky Teachers' Retirement System from the
10 optional retirement plan. These payments shall not be picked up as described
11 in KRS 161.540(2). Persons who elect to change from the optional retirement
12 plan to the Kentucky Teachers' Retirement System may elect to purchase as
13 service credit, beginning with the most recent years, any portion of their prior
14 years of service during which time they participated in the optional retirement
15 plan, or none of those years. Members may purchase service credit for prior
16 years of service by rolling over funds from their optional retirement plan
17 account as provided under KRS 161.5461, or by rolling over or transferring
18 other plan funds as permitted by the rules set forth in the Internal Revenue
19 Code, or by making an after-tax lump-sum cash payment. **This paragraph**
20 **does not apply to individuals who become members on or after January 1,**
21 **2019;**

- 22 (c) Effective July 1, 2008, persons otherwise eligible for membership in the
23 Kentucky Teachers' Retirement System may irrevocably elect one (1) time to
24 change their election and to prospectively participate in the Kentucky
25 Teachers' Retirement System and purchase service credit for their prior years
26 of service during which they participated in the optional retirement plan. This
27 election shall be filed in writing with the Kentucky Teachers' Retirement

1 System no later than December 31, 2008. Persons who change their election
2 prior to July 1, 2008, to prospectively participate in the Kentucky Teachers'
3 Retirement System may purchase service credit for their prior years of service
4 during which they participated in the optional retirement plan. The purchase
5 of prior years of service under this paragraph shall be subject to the same
6 conditions and purchase costs as described in paragraph (b) of this subsection,

13 participate, based upon their age and allowable service credit, in the disability,
14 survivorship, and medical insurance programs under the conditions and in the
15 degree as they exist on the date that they file their election with the retirement
16 system, but shall be subject to any changes to those programs from that date
17 forward, including any changes that may affect their eligibility for or degree of
18 participation in those programs. Prior service purchased as service credit as
19 permitted under paragraphs (b) and (c) of this subsection shall not be
20 considered for meeting eligibility requirements or determining the extent of
21 participation in these programs. Persons electing to change to the Kentucky
22 Teachers' Retirement System shall not be eligible for the survivorship or
23 disability programs based upon medical conditions that existed prior to the
24 filing of their elections.

25 (2) Elections of eligible employees hired on or after the implementation date of the
26 optional retirement plan at their employer institution shall be effective on the date
27 of their employment. If an eligible employee hired subsequent to the

1 implementation date at the employer institution fails to make the election provided

6 (4) (a) When a subpoena is served upon any employee of the Kentucky Teachers'
7 Retirement System requiring the production of any data, information, or
8 records, it is sufficient if the employee of the Kentucky Teachers' Retirement
9 System charged with the responsibility of being custodian of the original, or
10 his or her designated staff, delivers within five (5) working days by certified
11 mail or by personal delivery to the person specified in the subpoena either of

15 permitted and limited by KRS 161.470;

16 (6) The board of trustees may annually, on July 1, adjust the current daily rate of a
17 member's last annual compensation, for each full twelve (12) month period that has
18 elapsed subsequent to the member earning his or her last annual compensation, by
19 the percentage increase in the annual average of the consumer price index for all
20 urban consumers for the calendar year preceding the adjustment as published by the
21 Federal Bureau of Labor Statistics, not to exceed five percent (5%) annually. Each

17 in effect the previous month, provided the retired member had been retired for at
18 least the full twelve (12) months immediately preceding the date that the increase is
19 effective. In the event that the retired member had been retired for less than the full
20 twelve (12) months immediately preceding the date that the increase is effective,
21 then the increase shall be reduced on a pro rata basis by each month that the retired
22 member had not been retired for the full twelve (12) months immediately preceding
23 the effective date of the increase. The level of increase provided for in this
24 subsection shall be determined by the funding provided in the 2008-2010 biennium
25 budget appropriation.

26 (7) Effective July 1, 1990, monthly payments of two hundred dollars (\$200) shall be
27 payable for the benefit of an adult child of a member retired for service when the

1 child's mental or physical condition is sufficient to cause dependency on the
2 member at the time of retirement. Eligibility for this payment shall continue for the
3 life of the child or until the time the mental or physical condition creating the
4 dependency no longer exists or the child marries. Benefits under this subsection
5 shall apply to legally adopted survivors provided the proceedings for the adoption
6 were initiated at least one (1) year prior to the death of the member. The board of
7 trustees shall be the sole judge of eligibility or dependency and may require formal
8 application or information relating thereto.

9 (8) Members of the Teachers' Retirement System shall be subject to the annuity income
10 limitations imposed by Section 415 of the Internal Revenue Service Code.

11 (9) Compensation in excess of the limitations imposed by Section 401(a)(17) of the
12 Internal Revenue Code shall not be used in determining a member's retirement
13 annuity. The limitation on compensation for eligible members shall not be less than
14 the amount which was allowed to be taken into account by the retirement system in
15 effect on July 1, 1993. For this purpose, an eligible member is an individual who
16 was a member of the retirement system before the first plan year beginning after
17 December 31, 1995.

18 **(10) Effective January 1, 2019, subsections (1) to (7) of this section do not apply to**
19 **individuals who become members of the Teachers' Retirement System on or after**
20 **January 1, 2019.**

21 ➔Section 74. KRS 161.623 is amended to read as follows:

22 (1) Effective July 1, 1982, and thereafter, a district board of education or other
23 employer of members of the Teachers' Retirement System may compensate, at the
24 time of retirement for service, an active contributing member for unused sick-leave
25 days in accordance with this section.

26 (2) Upon the member's application for service retirement, the employer shall certify the
27 retiring member's unused accumulated sick-leave balance to the board of trustees of

1 the Kentucky Teachers' Retirement System. The member's sick-leave balance,
2 expressed in days, shall be divided by one hundred eighty-five (185) days to
3 determine the amount of service credit that may be considered for addition to the
4 member's retirement account for the purpose of determining the retirement
5 allowance under KRS 161.620, subject to the limitation of subsection (9)(a) of this
6 section. Notwithstanding any statute to the contrary, sick-leave credit that is
7 accredited under this section or by one (1) of the other state-administered retirement
8 systems shall not be used for the purpose of determining whether the member is
9 eligible to receive a retirement allowance from the Kentucky Teachers' Retirement
10 System.

11 (3) The board shall compute the cost to the retirement system of the sick-leave credit
12 for each retiring member and shall bill the last employer of the retiring member for
13 such cost. The employer shall pay the cost of such service credit to the retirement
14 system within fifteen (15) days after receiving notification of the cost from the
15 board.

16 (4) Retiring members who receive service credit under this section shall not be eligible
17 to receive compensation for accrued sick leave under KRS 161.155(10) or any other
18 statutory provision.

19 (5) Employer participation is optional and the employer may opt to purchase less
20 service credit than the member is eligible to receive provided the same percentage
21 of reduction is made applicable to all retiring members of the employer during a
22 school fiscal year.

23 (6) The board of trustees shall formulate and adopt necessary rules and regulations for
24 the administration of the foregoing provisions.

25 (7) Payments to the retirement system for service credit obtained under this section or
26 for compensation credit obtained under KRS 161.155(10) shall be based on the full
27 actuarial cost as defined in KRS 161.220(22).

1 (8) For an individual who becomes a member on or after July 1, 2008, the maximum
 2 amount of unused accumulated sick leave that may be considered for addition to the
 3 member's retirement account for purposes of determining the retirement allowance
 4 under KRS 161.620 shall not exceed three hundred (300) days or the amount
 5 specified by subsection (9)(a) of this section.

6 (9) Notwithstanding any other provision of KRS 161.220 to 161.716 to the contrary:

7 (a) The maximum amount of sick leave converted to additional service credit
 8 under the provisions of this section shall not exceed the service credit based
 9 upon the level of sick leave accumulated on December 31, 2018, by a
 10 member whose employer participates in the sick leave program authorized
 11 by this section; and

12 (b) On or after August 1, 2018, no employers may opt to participate in the sick
 13 leave program authorized by this section.

14 ➔Section 75. KRS 161.630 is amended to read as follows:

15 (1) (a) An individual who became a member prior to January 1, 2019, upon
 16 retirement, shall receive a retirement allowance in the form of a life annuity,
 17 with refundable balance, as provided in KRS 161.620, unless an election is
 18 made before the effective date of retirement to receive actuarially equivalent
 19 benefits under options which the board of trustees approves.

20 (b) An individual who is participating in the hybrid cash balance plan as
 21 provided by Section 43 of this Act may, before the effective date of
 22 retirement, elect to receive his or her accumulated account balance
 23 annuitized into a monthly payment under one (1) of the actuarial equivalent
 24 payment options approved by the board of trustees.

25 (c) No option shall provide for a benefit with an actuarial value at the age of
 26 retirement greater than that provided in KRS 161.620 or subsection (7)(a) of
 27 Section 43 of this Act, as applicable. This section does not apply to disability

1 allowances as provided in KRS 161.661(1).

2 (2) The retirement option chosen by a retiree at the time of service retirement shall
3 remain in force unless the retiree **became a member prior to January 1, 2019, and**
4 elects to make a change under the following conditions:

5 (a) A divorce, annulment, or marriage dissolution following retirement shall, at
6 the election of the retiree, cancel any optional plan selected at retirement that
7 provides continuing benefits to a spousal beneficiary and return the retiree to a
8 single lifetime benefit equivalent as determined by the board; or

9 (b) Following marriage or remarriage, or the death of the designated beneficiary, a
10 retiree may elect a new optional plan of payment based on the actuarial
11 equivalent of a single lifetime benefit at the time of the election, as determined
12 by the board. The plan shall become effective the first of the month following
13 receipt of an application on a form approved by the board.

14 (3) Except as otherwise provided in this section, a beneficiary designation shall not be
15 changed after the effective date of retirement except for retirees who elect the life
16 annuity with refundable balance or the predetermined years certain and life
17 thereafter option. A member may remove a beneficiary at any time, but shall not
18 designate a substitute beneficiary. If a member elects to remove a beneficiary, the
19 member's retirement allowance shall not change regardless of the retirement option
20 selected by the member, even if the removed beneficiary predeceases the member.

21 (4) A member who experiences a qualifying event under subsection (2) of this section
22 and who elects a new optional plan of payment shall make that election within sixty
23 (60) days of the qualifying event.

24 ➔Section 76. KRS 161.655 is amended to read as follows:

25 (1) Effective July 1, 2000, the Teachers' Retirement System shall **for those individuals**
26 **who became members prior to January 1, 2019:**

27 (a) Provide a life insurance benefit in a minimum amount of five thousand dollars

- 1 (\$5,000) for its members who are retired for service or disability. This life
2 insurance benefit shall be payable upon the death of a member retired for
3 service or disability to the member's estate or to a party designated by the
4 member on a form prescribed by the retirement system; and
- 5 (b) Provide a life insurance benefit in a minimum amount of two thousand dollars
6 (\$2,000) for its active contributing members. This life insurance benefit shall
7 be payable upon the death of an active contributing member to the member's
8 estate or to a party designated by the member on a form prescribed by the
9 retirement system.
- 10 (2) The member may name one (1) primary and one (1) contingent beneficiary for
11 receipt of the life insurance benefit. To the extent permitted by the Internal Revenue
12 Code, a trust may be designated as beneficiary for receipt of the life insurance
13 benefit. Members may designate as beneficiaries only presently identifiable and
14 existing individuals, or trusts where otherwise permitted, without contingency
15 instructions, on forms prescribed by the retirement system. In the event that a
16 member fails to designate a beneficiary, or all designated beneficiaries predecease
17 the member, the member's estate shall be deemed to be the beneficiary. Any
18 beneficiary designation made by the member, including the estate should the estate
19 become the beneficiary by default, shall remain in effect until changed by the
20 member on forms prescribed by the retirement system, except in the event of
21 subsequent marriage or divorce. A valid marriage license shall terminate any
22 previously designated beneficiary, even that of a trust, and establish the spouse as
23 beneficiary unless, subsequent proof of the marriage, the member or retired member
24 redesignates someone other than the new spouse as the beneficiary. A final divorce
25 decree shall terminate the beneficiary status of an ex-spouse unless, subsequent to
26 divorce, the member redesignates the former spouse as a beneficiary. A final
27 divorce decree shall not terminate the designation of a trust as beneficiary regardless

1 of who is designated as beneficiary of the trust.

2 (3) Application for payment of life insurance proceeds shall be made to the Teachers'
3 Retirement System together with acceptable evidence of death and eligibility. The
4 reciprocal provisions of KRS 61.680(2)(a) shall not apply to the coverage and
5 payment of proceeds by the life insurance benefit under this section.

6 (4) Suit or civil action shall not be required for the collection of the proceeds of the life
7 insurance benefit provided for by this section, but nothing in this section shall
8 prevent the maintenance of suit or civil action against the beneficiary or legal
9 representative receiving the proceeds of the life insurance benefit.

10 (5) Upon the death of a member of the Teachers' Retirement System, the life insurance
11 provided pursuant to subsection (1) of this section may be assigned by the
12 designated beneficiary to a bank or licensed funeral home.

13 ➔Section 77. KRS 161.661 is amended to read as follows:

14 (1) Any member who has completed five (5) or more years of accredited service in the
15 public schools of Kentucky after July 1, 1941, may retire for disability and be
16 granted a disability allowance if found to be eligible as provided in this section.
17 Application for disability benefits shall be made within one (1) year of the last
18 contributing service in Kentucky, and the disability must have occurred during the
19 most recent period of employment in a position covered by the Teachers' Retirement
20 System and subsequent to the completion of five (5) years of teaching service in
21 Kentucky. A disability occurring during the regular vacation immediately following
22 the last period of active service in Kentucky or during an official leave for which
23 the member is entitled to make regular contributions to the retirement system, shall
24 be considered as having occurred during a period of active service. The annual
25 disability allowance shall be equal to sixty percent (60%) of the member's final
26 average salary. ***Individuals who became*** members ***prior to January 1, 2019, who***
27 ***have***~~[with]~~ twenty-seven (27) or more years of service credit are eligible for service

1 retirement only. **Individuals who become members on or after January 1, 2019,**
2 **who have met the requirements of subsection (6)(b) of Section 43 of this Act shall**
3 **be eligible for service retirement only.**

4 (2) The provisions of KRS 161.520, 161.525, and subsections (3), (4), and (5) of this
5 section shall not apply to disability retirees whose benefits were calculated on the
6 service retirement formula nor to survivors of these members.

7 (3) Members shall earn one (1) year of entitlement to disability retirement, at sixty
8 percent (60%) of the member's final average salary, for each four (4) years of
9 service in a covered position, but any member meeting the service requirement for
10 disability retirement shall be credited with no less than five (5) years of eligibility.

11 (4) A member retired by reason of disability shall continue to earn service credit at the
12 rate of one (1) year for each year retired for disability. This service shall be credited
13 to the member's account at the expiration of entitlement as defined in subsection (3)
14 of this section, or when the member's eligibility for disability benefits is terminated
15 upon recommendation of a medical review committee, and this service shall be used
16 in calculating benefits as provided in subsection (5) of this section, but under no
17 circumstances shall this service be used to provide the member with more than
18 twenty-seven (27) years of total service credit **or the level of service credit needed**
19 **to meet the requirements of subsection (6)(b) of Section 43 of this Act, as**
20 **applicable.** The service credit shall be valued at the same level as service earned by
21 active members as provided under KRS 161.600, ~~and~~ 161.620, **or Section 43 of**
22 **this Act, as applicable. Members participating in the hybrid cash balance plan as**
23 **provided by Section 43 of this Act shall also be credited with employer credits and**
24 **interest credits for each year of service earned under the provisions of this**
25 **subsection based upon the salary in which the last employer credit was paid.**
26 **Payments during the entitlement period as specified by subsection (3) of this**
27 **section shall not reduce the accumulated account balance of a member**

- 1 **participating in the hybrid cash balance plan.**
- 2 (5) Any member retired by reason of disability and remaining disabled at the expiration
3 of the entitlement period shall have his disability benefits recalculated using the
4 service retirement formula with service credit **and any additional accumulated**
5 **account balance earned** as set out in subsection (4) of this section. **For persons**
6 **who became members prior to January 1, 2019,** the retirement allowance shall be
7 calculated as set forth in KRS 161.620, except that those persons less than sixty
8 (60) years of age shall be considered as sixty (60) years of age. **For persons who**
9 **become members on or after January 1, 2019, the retirement allowance or benefit**
10 **shall be calculated as set forth in Section 43 of this Act, except that those persons**
11 **less than age sixty-five (65) shall be considered as sixty-five (65) years of age.**
- 12 Members having their disability benefits recalculated under this subsection shall not
13 be entitled to a benefit based upon an average of their three (3) highest salaries as
14 set forth in KRS 161.220(9), unless approved otherwise by the board of trustees.
- 15 (6) Members who have their disability retirement allowance recalculated at the
16 expiration of the entitlement period shall continue to have coverage under the post-
17 retirement medical insurance program. Restrictions on employment shall remain in
18 effect until the member attains age seventy (70) or until the member's eligibility is
19 discontinued. KRS 161.520 and 161.525 shall not apply to survivors of disability
20 retirees whose retirement allowances have been recalculated at the expiration of the
21 entitlement period. Members who have their disability retirement allowance
22 recalculated at the expiration of their entitlement period shall be entitled to a
23 minimum monthly allowance of five hundred dollars (\$500) as the basic straight life
24 annuity. The minimum allowance shall be effective July 1, 1992, and shall apply to
25 those members who have had their allowance recalculated prior to that date and to
26 disability retirees who will have their benefit allowance recalculated on or after that
27 date.

- 1 (7) Effective July 1, 1992, members retired for disability prior to July 1, 1964, shall be
2 entitled to a minimum monthly allowance of five hundred dollars (\$500) as their
3 basic straight life annuity and their surviving spouse shall be eligible for survivor
4 benefits as provided in KRS 161.520(1)(a) and (b).
- 5 (8) Any member retired by reason of disability may voluntarily waive disability benefits
6 and return to teaching or any individual who became a member prior to January 1,
7 2019, who is age sixty (60) years or older, may elect to waive disability benefits and
8 retire for service on the basis of service credited to the member on the effective date
9 of the disability retirement, or any individual who becomes a member on or after
10 January 1, 2019, who is sixty-five (65) years of age or older, may elect to waive
11 disability benefits and retire for service on the basis of his or her accumulated
12 account balance and service credited to the member on the effective date of
13 disability retirement.
- 14 (9) In order to qualify for retirement by reason of disability a member must suffer from
15 a physical or mental condition presumed to be permanent in duration and of a nature
16 as to render the member incapable of being gainfully employed in a covered
17 position. The incapability must be revealed by a competent examination by a
18 licensed physician or physicians and must be approved by a majority of a medical
19 review committee.
- 20 (10) A member retired by reason of disability shall be required to undergo periodic
21 examinations at the discretion of the board of trustees to determine whether the
22 disability allowance shall be continued. When examination and recommendation of
23 a medical review committee indicate the disability no longer exists, the allowance
24 shall be discontinued.
- 25 (11) Eligibility for payment shall begin on the first day of the month following receipt of
26 the application in the Teachers' Retirement System office, or the first of the month
27 next following the last payment of salary or sick leave benefits by the employer,

1 whichever is the later date.

2 (12) No person who receives a disability allowance may be employed in a position that
3 entails duties or qualification requirements similar to positions subject to
4 participation in the retirement system either within or without the State of
5 Kentucky. So doing shall constitute a misdemeanor and shall result in loss of the
6 allowance from the first date of this service. A member who applies for and is
7 approved for disability retirement on or after July 1, 2002, and whose annual
8 disability benefit is less than forty thousand dollars (\$40,000) may earn income in
9 any occupation other than covered employment only to the extent that the annual
10 income from the other employment when added to the annual disability benefit does
11 not exceed forty thousand dollars (\$40,000). For any member who exceeds this
12 limit as a result of income from other employment, the Kentucky Teachers'
13 Retirement System shall reduce the member's disability benefit on a dollar-for-
14 dollar basis for each dollar that the member's combined annual disability benefit and
15 annual income from other employment exceeds forty thousand dollars (\$40,000).
16 The board of trustees may annually increase the forty thousand dollar (\$40,000)
17 limit by the percentage increase in the annual average of the consumer price index
18 for all urban consumers for the most recent calendar year as published by the
19 Federal Bureau of Labor Statistics, not to exceed five percent (5%).

20 (13) All members who applied for disability retirement before July 1, 2002, and were
21 approved as a result of that application shall be subject to the income limitations as
22 they existed on June 30, 2002, until July 1, 2006. Effective July 1, 2006, the twenty-
23 seven thousand dollar (\$27,000) limitation shall be increased to forty thousand
24 dollars (\$40,000) and may be adjusted by the board of trustees by the consumer
25 price index in the manner described in subsection (12) of this section. The recipient
26 of a disability allowance who engages in any gainful occupation other than covered
27 employment must make a report of the duties involved, compensation received, and

- 1 any other pertinent information required by the board of trustees.
- 2 (14) The board of trustees shall designate medical review committees, each consisting of
3 three (3) licensed physicians. A medical review committee shall pass upon all
4 applications for disability retirement and upon all applicant statements, medical
5 certifications, and examinations submitted in connection with disability
6 applications. The disposition of each case shall be recommended by a medical
7 review committee in writing to the retirement system. Members of a medical review
8 committee shall follow administrative regulations regarding procedures as the board
9 of trustees may enact and shall be paid reasonable fees and expenses as authorized
10 by the board of trustees in compliance with the provisions of KRS 161.330 and
11 161.340. The retirement system may secure additional medical examinations and
12 information as it deems necessary. A member may appeal any final agency decision
13 denying his or her disability retirement application pursuant to the provisions of
14 KRS 161.250(2).
- 15 (15) A disability may be presumed to be permanent if the condition creating the
16 disability may be reasonably expected to continue for one (1) year or more from the
17 date of application for disability benefits.
- 18 (16) Any member who has voluntarily waived disability benefits or whose disability
19 benefits have been discontinued on recommendation of a medical review
20 committee, may apply for reinstatement of disability benefits. The application for
21 reinstatement must be made to the retirement system within twelve (12) months of
22 the date disability benefits terminated. If the termination of benefits were voluntary,
23 the reinstatement may be made without medical examination if application is made
24 within three (3) months of the termination date. Other applications for reinstatement
25 will be processed in the same manner as new applications for benefits.
- 26 (17) No person who is receiving disability benefits under this section may be employed
27 in a position which qualifies the person for membership in a retirement system

1 financed wholly or in part with public funds. Employment in a position prohibited
2 by this subsection shall result in disqualification for those disability benefits from
3 the date of employment in the prohibited position.

4 (18) Any person who is receiving benefits and becomes disqualified from receiving
5 those benefits under this section, or becomes disqualified from receiving a portion
6 of those benefits due to income from other than covered employment, shall
7 immediately notify the Teachers' Retirement System of this disqualification in
8 writing and shall return all benefits paid after the date of disqualification. Failure to
9 comply with these provisions shall create an indebtedness of that person to the
10 Teachers' Retirement System. Interest at the rate of eight percent (8%) per annum
11 shall be charged if the debt is not repaid within sixty (60) days after the date of
12 disqualification. Failure to repay this debt creates a lien in favor of the Teachers'
13 Retirement System upon all property of the person who improperly receives benefits
14 and does not repay those benefits. The Kentucky Teachers' Retirement System may,
15 in order to collect an outstanding debt, reduce or terminate any benefit that a
16 member is otherwise entitled to receive.

17 ➔Section 78. KRS 161.650 is amended to read as follows:

18 (1) In the case of death of a member who has retired by reason of service or disability,
19 any portion of the member's accumulated contributions, including member
20 contributions to the state accumulation fund and regular interest to the date of
21 retirement, that has not, and will not be paid as an allowance or benefit shall be paid
22 to the member's beneficiary in such manner as the board of trustees elects.

23 (2) The member may designate a primary beneficiary or two (2) or more cobeneficiaries
24 to receive any remaining accumulated member contributions payable under this
25 section. A contingent beneficiary may be designated in addition to the primary
26 beneficiary or the cobeneficiaries. The member may designate two (2) or more
27 contingent beneficiaries. To the extent permitted by the Internal Revenue Code, a

1 trust may be designated as beneficiary for receipt of any remaining *funds of the*
2 *member's* accumulated [~~member~~] contributions. Members may designate as
3 beneficiaries only presently identifiable and existing individuals, or trusts where
4 otherwise permitted, without contingency instructions, on forms prescribed by the
5 retirement system. Cobeneficiaries shall be composed of a single class of
6 individuals, or trusts where permitted, who will share in equal proportions in any
7 payment that may become available under this section. Any beneficiary designation
8 made by the member shall remain in effect until changed by the member on forms
9 prescribed by the retirement system, except in the event of subsequent divorce. A
10 final divorce decree shall terminate the beneficiary status of an ex-spouse unless,
11 subsequent to divorce, the member redesignates the former spouse as a beneficiary.
12 A final divorce decree shall not terminate the designation of a trust as beneficiary
13 regardless of who is designated as beneficiary of the trust. In the event that the
14 member fails to designate a beneficiary or all designated beneficiaries predecease
15 the member, any remaining accumulated member contributions shall be payable to
16 the member's estate.

17 ➔Section 79. KRS 161.700 is amended to read as follows:

- 18 (1) Except as otherwise provided by this section and KRS 161.655(5), the right of a
19 member to a retirement allowance and to the return of contributions, any benefit or
20 right accrued or accruing to any person under KRS 161.220 to 161.716, and the
21 money in the various funds established pursuant to KRS 161.220 to 161.716 are
22 hereby exempt from any state or municipal tax, and shall not be subject to
23 execution, garnishment, attachment, or other process, and shall not be assigned.
- 24 (2) Notwithstanding subsection (1) of this section, retirement benefits accrued or
25 accruing to any person under this retirement system on or after January 1, 1998,
26 shall be subject to the tax imposed by KRS 141.020, to the extent provided in KRS
27 141.010 and 141.0215.

- 1 (3) Retirement allowance, disability allowance, accumulated account
2 balance~~[contributions]~~, or any other benefit under the retirement system shall not be
3 classified as marital property pursuant to KRS 403.190(1), except to the extent
4 permitted under KRS 403.190(4). Retirement allowance, disability allowance,
5 accumulated contributions, or any other benefit under the retirement system shall
6 not be considered as an economic circumstance during the division of marital
7 property in an action for dissolution of marriage pursuant to KRS 403.190(1)(d),
8 except to the extent permitted under KRS 403.190(4).
- 9 (4) Qualified domestic relations orders issued by a court or administrative agency shall
10 be honored by the retirement system if:
- 11 (a) The benefits payable pursuant to the order meet the requirements of a
12 qualified domestic relations order as provided by 26 U.S.C. sec. 414(p). The
13 retirement system shall follow applicable provisions of 26 U.S.C. sec. 414(p)
14 in administering qualified domestic relations orders;
- 15 (b) The order meets the requirements established by the retirement system and by
16 subsections (4) to (12) of this section. The board of trustees of the retirement
17 system shall establish the requirements, procedures, and forms necessary for
18 the administration of qualified domestic relations order by promulgation of
19 administrative regulations in accordance with KRS Chapter 13A; and
- 20 (c) The order is on the form established by the retirement system pursuant to the
21 retirement system's authority provided under paragraph (b) of this subsection.
- 22 (5) A qualified domestic relations order shall not:
- 23 (a) Require the retirement system to take any action not authorized under state or
24 federal law;
- 25 (b) Require the retirement system to provide any benefit, allowance, or other
26 payment not authorized under state or federal law;
- 27 (c) Grant or be construed to grant the alternate payee any separate right, title, or

1 interest in or to any retirement benefit other than to receive payments from the
2 participant's account in accordance with the administrative regulations
3 promulgated by the system and as provided by subsections (4) to (12) of this
4 section; or

5 (d) Grant any separate interest to any person other than the participant.

6 (6) Any qualified domestic relations order submitted to the retirement system shall
7 specify the dollar amount or percentage amount of the participant's benefit to be

23 declared by the President of the United States or the Governor of the
24 Commonwealth of Kentucky.

25 (5) (a) For employees retiring on or after January 1, 2014, but prior to July 1, 2017,
26 the last participating employer shall be required to pay for any additional
27 actuarial costs resulting from annual increases in an employee's creditable

1 compensation greater than ten percent (10%) over the employee's last five (5)
2 fiscal years of employment that are not the direct result of a bona fide
3 promotion or career advancement. The cost shall be determined by the
4 retirement systems.

5 (b) Lump-sum payments for compensatory time paid to an employee upon
6 termination of employment shall be exempt from this subsection.

7 (c) Kentucky Retirement Systems shall be required to answer inquiries from
8 participating employers regarding this subsection. Upon request of the
9 employer prior to the employee's change of position or hiring, the systems
10 shall make a determination that is binding to the systems as to whether or not
11 a change of position or hiring constitutes a bona fide promotion or career
12 advancement.

13 (d) For any additional actuarial costs charged to the employer under this
14 subsection, the systems shall allow the employer to pay the costs without
15 interest over a period of one (1) year from the date of receipt of the employer's
16 final invoice.

17 (6) The Kentucky Retirement Systems shall determine whether increases in creditable
18 compensation during the last five (5) fiscal years of employment prior to retirement
19 constitute a bona fide promotion or career advancement and may promulgate
20 administrative regulations in accordance with KRS Chapter 13A to administer this
21 section. All state-administered retirement systems shall cooperate to implement this
22 section.

23 (7) Any employer who disagrees with a determination made by the system in
24 accordance with this section regarding whether an increase in compensation
25 constitutes a bona fide promotion or career advancement for purposes of subsection
26 (5) of this section may request a hearing and appeal the decision in accordance with
27 KRS 61.645(16).

1 (8) For the fiscal year beginning July 1, 2017, and subsequent years, the Kentucky
2 Retirement Systems shall provide a means for employers to separately report the
3 specific exceptions provided in subsection (4) of this section within the reporting
4 system utilized by the employers for making employer reports under KRS 16.645,
5 61.675, and 78.545. The Kentucky Retirement Systems shall continually provide
6 communication, instructions, training, and educational opportunities for employers
7 regarding how to appropriately report exemptions established by subsection (4) of
8 this section.

9 (9) This section shall not apply to employees participating in the hybrid cash balance
10 plan as provided by KRS 16.583 and 61.597 or to service in the 401(a) money
11 purchase plan as provided by Section 12 of this Act.

12 ➔Section 86. Pursuant to the Public Pension Oversight Board's authority under
13 KRS 7A.260, the board shall establish an advisory committee to study the benefits and
14 drawbacks of separating the County Employees Retirement System from the Kentucky
15 Retirement Systems or restructuring the administration of the systems administered by the
16 Kentucky Retirement Systems. The advisory committee shall submit recommendations to
17 the Public Pension Oversight Board no later than December 1, 2019. Notwithstanding the
18 provisions of this section, the Legislative Research Commission shall have the authority
19 to alternatively assign the issues identified herein to an interim joint committee or
20 subcommittee thereof and to designate a study completion date.

21 ➔Section 87. The Kentucky Retirement Systems and Teachers' Retirement
22 System shall provide an update on the development of the system, including any issues as
23 it relates to state or federal law, to the Public Pension Oversight Board no later than
24 August 1, 2018.

25 ➔Section 88. Notwithstanding KRS 16.500 to 16.652, 61.510 to 61.705, 78.510
26 to 78.852, 161.220 to 161.716, or any provision of Sections 1 to 85 of this Act to the
27 contrary, in the month following the effective date of this section, a surviving spouse who

1 was married to the deceased member at the time of death but who was ineligible for
2 monthly benefits payable to the surviving spouse under KRS 16.601 as codified prior to
3 the effective date of this section, shall receive the monthly benefit payable to the
4 surviving spouse in Section 24 of this Act, if the member's death occurred on or after
5 January 1, 2017.

6 ➔Section 89. If any section, any subsection, or any provision of this Act is found
7 by a court of competent jurisdiction in a final, unappealable order to be invalid or
8 unconstitutional, the decision of the courts shall not affect or impair any of the remaining
9 sections, subsections, or provisions of this Act.
