

1           A RESOLUTION adjourning the Senate in honor and loving memory of Dr. Dwight  
2 L. Blackburn.

3           WHEREAS, Dr. Dwight L. Blackburn, affectionately known as "Dr. B.," was born  
4 in Newark, Ohio, on October 10, 1929, to the late William C. and Ruth Blackburn; and

5           WHEREAS, Dr. B. was a 1955 graduate of the University of Louisville School of  
6 Medicine and a proud veteran of the United States Army who served in Okinawa. Upon  
7 completion of his military service, he operated a private practice in Berea for 25 years;  
8 and

9           WHEREAS, Dr. B. served as Chief of Staff of Berea Hospital and was instrumental  
10 in the hospital's expansion as well as many other technological and service initiatives; and

11           WHEREAS, Dr. B. was a longtime member and past president of the Kentucky  
12 Medical Association, and was presented with a Lifetime Achievement Award from that  
13 honorable body; and

14           WHEREAS, Dr. B. relocated to Louisville in 1984 and began working in medical  
15 review for Anthem, retiring in 1995. He would continue consulting and working in a  
16 substance abuse facility until the age of 80; and

17           WHEREAS, Dr. B. was a pillar of the Berea community, chairing the Berea Bank  
18 Board and the Berea Country Club. A board member of KMIC and Kentucky Telco, he  
19 was honored as the Man of the Year by the Berea Chamber of Commerce; and

20           WHEREAS, Dr. Dwight L. Blackburn, esteemed physician; patriot; and beloved  
21 husband, father, stepfather, and grandfather, departed this earthly life and entered the  
22 gates of Heaven on January 12, 2018, leaving his family, friends, and all those whose  
23 lives he touched in solemn mourning; and

24           WHEREAS, Dr. B. was preceded in death by his parents; sisters, Rose Wheeler and  
25 Dorothy Golden; and brothers, David, William, and Virgil Blackburn. He is survived by  
26 his wife, Paula Blackburn; sons, Donald Blackburn and his wife, Marylynn, Dennis  
27 Blackburn and his wife, Leona, and Douglas Blackburn and his wife, Alexis; daughter,

1 Deena Jones and her husband, Jeff; stepdaughter, Stacey Fields; 12 grandchildren; 13  
2 great-grandchildren; former wife and mother of his children, Dorothy Blackburn; and a  
3 host of other family members, friends, and loved ones who will dearly miss his presence  
4 in their lives;

7 *Kentucky:*
