

1 A RESOLUTION adjourning the Senate in honor and loving memory of Terry Allen
2 "T.A." Green.

3 WHEREAS, Terry Allen "T.A." Green was born on March 19, 1947, to the late W.
4 Allen and Maxine C. Green; and

5 WHEREAS, Terry Green enjoyed an illustrious 20-year career as a naval pilot,
6 flying helicopters and fixed-wing aircrafts in Alaska, California, Kentucky, New York, and
7 Antarctica. He was awarded the Navy Commendation Medal, Navy Achievement Medal,
8 Meritorious Unit Commendation, Antarctica Service Medal, National Defense Medal, Sea
9 Service Ribbon, Recruiting Service Ribbon, Overseas Service Ribbon, Rifle and Expert
10 Pistol Medal, a Congressional Commendation, two Search and Rescue Awards, and 15
11 Gold Wreath Awards. In 2016, Mr. Green was awarded the New Zealand Special Service
12 Medal for his heroic onsite assistance in that government's Operation Overdue, following
13 the crash of an Air New Zealand flight on Mount Erebus in Antarctica; and

14 WHEREAS, after his retirement, Terry Green worked with Larry Burkett's Christian
15 Financial Concepts Ministry and, upon return to Harrodsburg, he owned the McGee
16 House, which is on the National Register of Historic Homes. He was an active member of
17 the Harrodsburg Rotary Club, a co-founder and board member of Central Kentucky
18 Christian School, and owner of Green Integrity Services. Mr. Green served as a Mercer
19 County Constable and was very active in local policy making. He acted in several plays in
20 the Ragged Edge Community Theater and Old Fort Harrod outdoor theater and drama
21 production, bringing joy to all those who attended; and

22 WHEREAS, Terry Green was a faithful member and elder of the New Providence
23 Presbyterian Church for 18 years, teaching Sunday school and leading the Harrodsburg
24 Men's Interdenominational Bible Study Group; and

25 WHEREAS, Terry Green departed this earthly life and entered into the kingdom of
26 Heaven on July 7, 2017. He is survived by his wife, Marybeth G. Green; four daughters,
27 Larissa Green, Anneke E. Green and her husband, Thomas Becket Adams, Susannah

1 Vandyke and her husband, Lukas, Lianna Green and her fiancé, Jaymes Awbrey; one son,
2 Travis Green and his wife, Rosalie; three grandchildren, Wilder Freedom and Cedar
3 Ransom Vandyke, and Gwendalyn Sydney Green; one sister, Cheryl Green Cottingham;
4 two brothers, Steve Green and Rick Green and his wife, Lynette; and many other family
5 and friends;
