

1 A RESOLUTION adjourning the Senate in honor and loving memory of Georganne
2 "Jan" Brown Taylor.

3 WHEREAS, Georganne "Jan" Brown Taylor was born on June 12, 1963, the
4 cherished daughter of the late George C. Brown and Bertha Mae Cooksey Brown of
5 Prestonsburg, Kentucky; and

6 WHEREAS, a 1981 graduate of Prestonsburg High School, a 1985 graduate of
7 Transylvania University, and a 1989 graduate of the Salmon P. Chase College of Law at
8 Northern Kentucky University, Georganne "Jan" Brown Taylor was admitted to practice
9 law in Kentucky on May 11, 1990, and was later licensed to practice law in Tennessee on
10 October 24, 2008; and

11 WHEREAS, Georganne "Jan" Brown Taylor proudly served as an Assistant Floyd
12 County Attorney in Prestonsburg. She also served as Vice President and Corporate
13 Counsel for the First Commonwealth Bank of Prestonsburg. After moving to Johnson
14 City, Tennessee, she volunteered legal services for Court Appointed Special Advocates
15 (CASA) of North East Tennessee. During her one and one-half years volunteering with
16 CASA, she advocated for more than 25 children to make sure they were safe; and

17 WHEREAS, Georganne "Jan" Brown Taylor was a dedicated member of
18 Philanthropic Education Organization, which provides educational and professional
19 opportunities for other women; and

20 WHEREAS, Georganne "Jan" Brown Taylor loved shelter animals and enjoyed
21 taking many into her home when they lived on Cow Creek and Rice Branch in Floyd
22 County, Kentucky, and in Johnson City, Tennessee. She enjoyed following in her
23 mother's footsteps when learning how to fly. Most of all, she loved her family, friends,
24 and living on Rice Branch; and

25 WHEREAS, on March 2, 2018, Georganne "Jan" Brown Taylor departed this
26 earthly life, leaving those whose lives she touched in solemn and resolute mourning; and

27 WHEREAS, Georganne "Jan" Brown Taylor is survived by her husband, Donald

1 Wayne Taylor, Jr.; her twin brothers, State Representative Larry D. Brown and Dr. Gary
2 D. Brown; her nephews, Jordan Chase Brown, Andrew Tyler Brown, and Garrett
3 Woodson McGuire Brown; her niece, Lindsey Michelle Brown; and a host of other
4 family, friends, and loved ones who will dearly miss her presence in their lives;
