1 AN ACT relating to dialysate solutions and devices.

2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

Section 1. KRS 315.0351 is amended to read as follows:

4 (1) Except as provided in subsection (2) of this section:

5 Every person or pharmacy located outside this Commonwealth which $(a)^{[(1)]}$ 6 does business, physically or by means of the Internet, facsimile, phone, mail, 7 or any other means, inside this Commonwealth within the meaning of KRS 8 Chapter 315, shall hold a current pharmacy permit as provided in KRS 9 315.035(1) and (4) issued by the Kentucky Board of Pharmacy. The pharmacy 10 shall be designated an "out-of-state pharmacy" and the permit shall be designated an "out-of-state pharmacy permit." The fee for the permit shall not 11 12 exceed the current in-state pharmacy permit fee as provided under KRS 315.035;[.] 13

14(b)[(2)]Every out-of-state pharmacy granted an out-of-state pharmacy permit by15the board shall disclose to the board the location, names, and titles of all16principal corporate officers and all pharmacists who are dispensing17prescription drugs to residents of the Commonwealth. A report containing this18information shall be made to the board on an annual basis and within thirty19(30) days after any change of office, corporate officer, or pharmacist:

20 Every out-of-state pharmacy granted an out-of-state pharmacy permit (c)[(3)] 21 shall comply with all statutorily-authorized directions and requests for 22 information from any regulatory agency of the Commonwealth and from the board in accordance with the provisions of this section. The out-of-state 23 24 pharmacy shall maintain at all times a valid unexpired permit, license, or 25 registration to conduct the pharmacy in compliance with the laws of the 26 jurisdiction in which it is a resident. As a prerequisite to seeking a permit from 27 the Kentucky Board of Pharmacy, the out-of-state pharmacy shall submit a

1 copy of the most recent inspection report resulting from an inspection 2 conducted by the regulatory or licensing agency of the jurisdiction in which it 3 is located. Thereafter, the out-of-state pharmacy granted a permit shall submit 4 to the Kentucky Board of Pharmacy a copy of any subsequent inspection 5 report on the pharmacy conducted by the regulatory or licensing body of the 6 jurisdiction in which it is located;[.] 7 Every out-of-state pharmacy granted an out-of-state pharmacy permit by (d)[(4)] 8 the board shall maintain records of any controlled substances or dangerous 9 drugs or devices dispensed to patients in the Commonwealth so that the 10 records are readily retrievable from the records of other drugs dispensed; [.] 11 Records for all prescriptions delivered into Kentucky shall be readily (e)[(5)] 12 retrievable from the other prescription records of the out-of-state pharmacy; [...] 13 $(f)^{[(6)]}$ Each out-of-state pharmacy shall, during its regular hours of operation, 14 but not less than six (6) days per week and for a minimum of forty (40) hours 15 per week, provide a toll-free telephone service directly to the pharmacist in 16 charge of the out-of-state pharmacy and available to both the patient and each 17 licensed and practicing in-state pharmacist for the purpose of facilitating 18 communication between the patient and the Kentucky pharmacist with access 19 to the patient's prescription records. A toll-free number shall be placed on a 20 label affixed to each container of drugs dispensed to patients within the 21 Commonwealth;[.] 22 <u>(g)</u>[(7)] Each out-of-state pharmacy shall have a pharmacist in charge who is 23 licensed to engage in the practice of pharmacy by the Commonwealth that 24 shall be responsible for compliance by the pharmacy with the provisions of 25 this section and for the distribution and sale of dialysate solutions and 26 devices pursuant to subsection (2) of this section; [.]27 Each out-of-state pharmacy shall comply with KRS 218A.202; $(h)^{(8)}$

1	(i) [(9)] Any out-of-state pharmacy that dispenses more than twenty-five percent
2	(25%) of its total prescription volume as a result of an original prescription
3	order received or solicited by use of the Internet, including but not limited to
4	electronic mail, shall receive and display in every medium in which it
5	advertises itself a seal of approval for the National Association of Boards of
6	Pharmacy certifying that it is a Verified Internet Pharmacy Practice Site
7	(VIPPS) or a seal certifying approval of a substantially similar program
8	approved by the Kentucky Board of Pharmacy. VIPPS, or any other
9	substantially similar accreditation, shall be maintained and remain current;[.]
10	(\underline{i}) [(10)] Any out-of-state pharmacy doing business in the Commonwealth of
11	Kentucky shall certify the percentage of its annual business conducted via the
12	Internet and electronic mail and submit such supporting documentation as
13	requested by the board, and in a form or application required by the board,
14	when it applies for permit or renewal: [.]
15	(\underline{k}) [(11)] Any pharmacy doing business within the Commonwealth of Kentucky
16	shall use the address on file with the Kentucky Board of Pharmacy as the
17	return address on the labels of any package shipped into or within the
18	Commonwealth. The return address shall be placed on the package in a clear
19	and prominent manner; and[.]
20	(\underline{I}) [(12)] The Kentucky Board of Pharmacy may waive the permit requirements of
21	this chapter for an out-of-state pharmacy that only does business within the
22	Commonwealth of Kentucky in limited transactions.
23	(2) (a) Only subsection (1)(g) of this section shall apply to the sale or distribution
24	of dialysate solutions or devices necessary to perform home peritoneal
25	kidney dialysis to patients with end-stage renal disease, if:
26	1. The dialysate solutions or devices are approved or cleared by the
27	federal Food and Drug Administration, as required by federal law;

1	2. The dialysate solutions or devices are lawfully held by a manufacturer
2	or manufacturer's agent that is properly registered with or licensed by
3	the board as a manufacturer, wholesale distributer, or third-party
4	logistics provider under this chapter;
5	3. The dialysate solutions or devices are held and delivered in their
6	original, sealed packaging from an Food and Drug Administration
7	approved manufacturing facility;
8	4. The dialysate solutions or devices are only delivered upon receipt of a
9	physician's prescription by a Kentucky licensed pharmacy and the
10	transmittal of an order from the Kentucky licensed pharmacy to the
11	manufacturer or manufacturer's agent; and
12	5. The manufacturer or manufacturer's agent delivers the dialysate
13	solutions or devices directly to:
14	a. A patient with end-stage renal disease or the patient's designee
15	for the patient's self-administration of dialysis therapy; or
16	b. A health care provider or institution for administration or
17	delivery of dialysis therapy to a patient with end-stage renal
18	<u>disease.</u>
19	(b) 1. A manufacturer or manufacturer's agent who sells or distributes
20	dialysate solutions or devices under this subsection shall employ or
21	contract with a pharmacist who is licensed to engage in the practice of
22	pharmacy by the Commonwealth to conduct a retrospective audit on
23	ten percent (10%) of the orders processed by that manufacturer or
24	manufacturer's agent each month.
25	2. On or before February 1 of each year, an annual summary of the
26	monthly audits shall be prepared and submitted to the board, in the
27	form prescribed by the board.

1		3. On or before June 1 of each year, the board shall compile the
2		summaries of monthly audits into a single report and submit that
3		report to the Interim Joint Committee on Health and Welfare and
4		Family Services.
5		(c) Prescriptions and records of delivery for dialysate solutions or devices sold
6		or distributed under this subsection shall be maintained by the
7		manufacturer or manufacturer's agent for a minimum of two (2) years and
8		shall be made available to the board upon request.
9		(d) As used in this subsection, "dialysate solutions" means dextrose or
10		icodextrin when used to perform home peritoneal kidney dialysis.
11		(e) The Kentucky Board of Pharmacy will retain oversight of the distribution of
12		dialysate solutions and devices under this section.
13		Section 2. KRS 315.040 is amended to read as follows:
14	(1)	Nothing in this chapter shall be construed to prevent, restrict, or otherwise interfere
15		with the sale of nonprescription drugs in their original packages by any retailer. No
16		rule or regulation shall be adopted by the Board of Pharmacy under this chapter
17		which shall require the sale of nonprescription drugs by a licensed pharmacist or
18		under the supervision of a licensed pharmacist.
19	(2)	Nothing in this chapter shall interfere with the professional activities of any licensed
20		practicing physician, or prevent the physician from keeping any drug or medicine
21		that he or she may need in his or her practice, from compounding the physician's
22		own medications, or from dispensing or supplying to patients any article that seems
23		proper to the physician.
24	(3)	Nothing in this chapter pertaining to the use of collaborative care agreements shall
25		apply in any hospital or other health facility operated by a hospital without the
26		express written permission of the hospital's governing body. Collaborative care
27		agreements may be restricted by the policies and procedures of the facility.

- 1 Nothing in this chapter shall interfere with the activities of a physician assistant as (4)2 authorized in KRS Chapter 311.
- 3 Nothing in this chapter shall interfere with the activities of an advanced practice (5) 4 registered nurse as authorized in KRS Chapter 314.
- 5 Nothing in this chapter shall be construed to prevent, restrict, or otherwise **(6)**
- 6 interfere with the sale or distribution of dialysate solutions as defined in Section 1
- 7 of this Act or devices necessary to perform home peritoneal dialysis to patients
- with end-stage renal disease, provided that the requirements established in 8
- 9 subsection (2) of Section 1 of this Act are satisfied. No rule or administrative
- 10 regulation shall be adopted or promulgated by the board under this chapter that
- 11 requires the sale or distribution of dialysate solutions as defined in Section 1 of

- Section 3. KRS 315.400 is amended to read as follows: 14
- 15 As used in KRS 315.400 to 315.412:
- "Authorized distributor of record" means a wholesale distributor that: 16 (1)
- 17 Has established an ongoing relationship with a manufacturer to distribute the (a) manufacturer's prescription drug. An ongoing relationship exists between a 18 19 wholesale distributor and a manufacturer if the wholesale distributor, 20 including any affiliated group of the wholesale distributor as defined in Section 1504 of the Internal Revenue Code, has a written agreement for 21 22 distribution in effect; and
- 23 (b)
 - Is listed on the manufacturer's current list of authorized distributors of record;
- 24 (2)"Co-licensed product" means a prescription drug manufactured by two (2) or more 25 co-licensed partners;
- "Counterfeit prescription drug" means a drug which, or the container or labeling of 26 (3) 27 which, without authorization, bears the trademark, trade name, or other identifying

mark, imprint, or device, or any likeness thereof, of a drug manufacturer, processor,
packer, or distributor other than the person or persons who in fact manufactured,
processed, packed, or distributed the drug and which thereby falsely purports or is

drug manufacturer, processor, packer, or distributor;

6 (4) "Dispenser" means:

- (a) A retail pharmacy, hospital pharmacy, a group of chain pharmacies under
 common ownership and control that do not act as a wholesale distributor, or
 any other person authorized by law to dispense or administer prescription
 drugs, and the affiliated warehouse distribution centers of such entities under
 common ownership and control that do not act as a wholesale distributor; but
- 12 (b) Does not include a person who dispenses only products to be used in animals
 13 in accordance with 21 U.S.C. sec. 360b(a)(4) and (5);
- 14 (5) "Distribution" or "distribute" means the sale, purchase, trade, delivery, handling,

 18 under Section 512(b) of the federal Drug Quality and Security Act;
- 19 (6) "Drop shipment" means a product not physically handled or stored by a wholesale 20 distributor and that is exempt from Section 582 of the federal Drug Quality and 21 Security Act, except the notification requirements under clauses (ii), (iii), and (iv) of 22 subsection (c)(4)(B) of Section 582 of the federal Drug Quality and Security Act, 23 provided that the manufacturer, repackager, or other wholesale distributor that 24 distributes the product to the dispenser by means of a drop shipment for the 25 wholesale distributor includes on the transaction information and transaction history 26 to the dispenser the contact information of the wholesale distributor and provides 27 the transaction information, transaction history, and transaction statement directly to

A third-party logistics provider shall be 25 considered as part of the normal distribution channel; 26 (19) "Transaction" means the transfer of product between persons in which a change of 27 ownership occurs, with the following exemptions:
