

1 AN ACT relating to cities.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 24A.140 is amended to read as follows:

4 (1) When sessions of District Court are held in:

5 (a) The county courthouse or other county-owned facility;

6 (b) Urban-county facilities;

7 (c) State-owned, leased, or controlled facilities;

8 (d) Special district facilities; or

9 (e) Private facilities;

10 the sheriff shall be responsible for attending court, keeping order, and providing the
11 same services to District Court as are provided to the Circuit Court.

12 (2) The sheriff shall be compensated for these services in the same manner and at the
13 same rates as for similar services rendered to the Circuit Court.

14 (3) When sessions of District Court are held in city facilities the city police~~[or city~~
15 ~~marshal, as appropriate,]~~ shall be responsible for attending court, keeping order, and
16 providing the same services to District Court as are provided by the sheriff to
17 Circuit Court. Compensation for these services shall be the same as allowed to the
18 sheriff as provided in subsection (2) of this section.

19 (4) If the Administrative Office of the Courts determines that the provision of services
20 by any law enforcement officer or agency named herein would place an undue
21 burden on such officer or agency the Administrative Office of the Courts may
22 arrange with any other law enforcement officer or agency in the Commonwealth to
23 provide such services. Compensation shall be as provided in subsection (2) of this
24 section.

25 ➔Section 2. KRS 29A.180 is amended to read as follows:

26 (1) The sheriff or~~[,]~~ city police, ~~[or city marshal,]~~ as appropriate, shall be responsible
27 for meals, housing, and other incidental needs of grand jurors and petit jurors in

1 Circuit Court and in District Court when the jurors are kept overnight or otherwise
2 sequestered when ordered to do so by the judge of the court for which the jurors
3 were summoned. The expenses for these services shall be borne by the Finance and
4 Administration Cabinet and the officer shall be reimbursed in accordance with
5 administrative regulations issued by the Finance and Administration Cabinet,
6 pursuant to KRS Chapter 13A.

7 (2) The sheriff ~~or~~ city police, ~~for city marshal,~~ as appropriate, shall be responsible
8 for the transportation of jurors and other authorized persons to views of the scene or
9 other locations authorized by the court pursuant to KRS 29A.310. In criminal cases
10 the expenses for these services shall be borne by the Finance and Administration
11 Cabinet, and the sheriff shall be reimbursed in accordance with administrative
12 regulations issued by the Finance and Administration Cabinet, pursuant to KRS
13 Chapter 13A. Excepting views conducted under the Eminent Domain Act of
14 Kentucky, in civil cases these expenses shall be paid by the party requesting the
15 viewing.

16 (3) The sheriff ~~or~~ city police, ~~for city marshal,~~ as appropriate, shall be responsible
17 for providing any specialized security personnel, equipment, and services which the
18 judge, with the consent of the Chief Justice, shall deem necessary for the conduct of
19 a trial in which the judge believes that special security precautions are necessary or
20 desirable. The expenses for these services shall be borne by the Finance and
21 Administration Cabinet, and the officer shall be reimbursed in accordance with
22 administrative regulations issued by the Finance and Administration Cabinet,
23 pursuant to KRS Chapter 13A. In such cases, the judge may also request the Chief
24 Justice to provide the services of the Department of Kentucky State Police to ensure
25 proper security precautions relating to the case.

26 ➔Section 3. KRS 61.900 is amended to read as follows:

27 As used in KRS 61.902 to 61.930:

- 1 (1) "Commission" means a commission issued to an individual by the secretary of
2 justice and public safety, entitling the individual to perform special law enforcement
3 duties on public property;
- 4 (2) "Council" means the Kentucky Law Enforcement Council;
- 5 (3) "Cabinet" means the Justice and Public Safety Cabinet;
- 6 (4) "Public property" means property currently owned or used by any organizational
7 unit or agency of state, county, city, metropolitan government, or a combination of
8 these. The term shall include property currently owned or used by public airport
9 authorities;
- 10 (5) "Secretary" means the secretary of the Justice and Public Safety Cabinet;
- 11 (6) "Special law enforcement officer":
- 12 (a) Means one whose duties include the protection of specific public property
13 from intrusion, entry, larceny, vandalism, abuse, intermeddling, or trespass;
- 14 (b) Means one whose duties include the prevention, observation, or detection of,
15 or apprehension for, any unlawful activity on specific public property;
- 16 (c) Means one whose special duties include the control of the operation, speed,
17 and parking of motor vehicles, bicycles, and other vehicles, and the movement
18 of pedestrian traffic on specific public property;
- 19 (d) Means one whose duties include the answering of any intrusion alarm on
20 specific public property;
- 21 (e) Shall include the Capitol police, the Capital Plaza police, public school
22 district security officers, public airport authority security officers, and the
23 officers of the other public security forces established for the purpose of
24 protecting specific public property; and
- 25 (f) Shall not include members of a lawfully organized police unit or police force
26 of state, county, city, or metropolitan government, or a combination of these,
27 who are responsible for the detection of crime and the enforcement of the

1 general criminal law enforcement of the state; it shall not include any of the
2 following officials or officers:

- 3 1. Sheriffs, sworn deputy sheriffs, ~~{city marshals,}~~ constables, sworn
4 deputy constables, and coroners;
- 5 2. Auxiliary and reserve police appointed under KRS 95.160 or 95.445, or
6 citation and safety officers authorized by KRS 83A.087 and 83A.088;
- 7 3. State park rangers and officers of the Division of Law Enforcement
8 within the Department of Fish and Wildlife Resources;
- 9 4. Officers of the Transportation Cabinet responsible for law enforcement;
- 10 5. Officers of the Department of Corrections responsible for law
11 enforcement;
- 12 6. Fire marshals and deputy fire marshals;
- 13 7. Other officers not mentioned above who are employed directly by state
14 government and are responsible for law enforcement;
- 15 8. Federal peace officers;
- 16 9. Those campus security officers who are commissioned under KRS
17 164.950;
- 18 10. Private security guards, private security patrolmen, and investigators
19 licensed pursuant to state statute; and
- 20 11. Railroad policemen covered by KRS 277.270 and 277.280; and

21 (7) "Sworn public peace officer" means one who derives plenary or special law
22 enforcement powers from, and is a full-time employee of, the federal government,
23 the Commonwealth, or any political subdivision, agency, department, branch, or
24 service of either, or of any municipality.

25 ➔Section 4. KRS 65.710 is amended to read as follows:

26 In order to enable cities and counties to fulfill their obligations regarding the public
27 health, safety, and welfare, the General Assembly does hereby allow cities and counties to

1 contract with private persons, partnerships, or corporations for providing ambulance
2 service to the residents of such cities and counties subject to the following conditions:

- 3 (1) These contracts must be in writing and must be approved by the *legislative body of*
4 *the city* [~~council or board of aldermen~~] if a city is party thereto, or by the fiscal court
5 in case a county is party thereto.
- 6 (2) No contract shall be made with an ambulance service or other organization or
7 person unless the contract shall stipulate that at least one (1) person on each
8 ambulance run shall possess currently valid emergency medical technician
9 certification.
- 10 (3) All contracts made with any ambulance service or other organization or person shall
11 stipulate that all vehicles used for operation of the service comply with vehicle and
12 equipment administrative regulations issued by the Cabinet for Health and Family
13 Services.
- 14 (4) All contracts shall include the stipulation that at least two (2) trained persons, one
15 (1) driver and one (1) attendant, shall be carried on each ambulance for each
16 ambulance call which is covered by the contract.
- 17 (5) No contract shall be made for a period of time greater than one (1) year.
- 18 (6) The vehicle, equipment, training, and personnel requirements of subsections (2),
19 (3), and (4) of this section shall also apply to the operation of an ambulance service
20 by a city or a county or by a city and a county jointly.
- 21 (7) No provisions of this section shall be construed as to limit the power of any city or
22 county to contract for or operate ambulance services under requirements which are
23 stricter than those of this section, or to require insurance, or bonding of contractors,
24 provided these provisions are not in conflict with the requirements of this section.

25 ➔Section 5. KRS 65.805 is amended to read as follows:

26 As used in KRS 65.810 to 65.830, unless the context otherwise requires, the word
27 "district" shall mean, and the provisions of KRS 65.810 to 65.830 shall apply to, any

1 special district governed by the following statutes: KRS ~~[66.610 to 66.650,]~~74.010 to
2 74.415, 108.010 to 108.070, 184.010 to 184.300, and 267.010 to 267.990.

3 ➔Section 6. KRS 67.750 is amended to read as follows:

4 As used in KRS 67.750 to 67.790, unless the context requires otherwise:

- 5 (1) "Business entity" means each separate corporation, limited liability company,
6 business development corporation, partnership, limited partnership, sole
7 proprietorship, association, joint stock company, receivership, trust, professional
8 service organization, or other legal entity through which business is conducted;
- 9 (2) "Compensation" means wages, salaries, commissions, or any other form of
10 remuneration paid or payable by an employer for services performed by an
11 employee, which are required to be reported for federal income tax purposes and
12 adjusted as follows:
- 13 (a) Include any amounts contributed by an employee to any retirement, profit
14 sharing, or deferred compensation plan, which are deferred for federal income
15 tax purposes under a salary reduction agreement or similar arrangement,
16 including but not limited to salary reduction arrangements under Section
17 401(a), 401(k), 402(e), 403(a), 403(b), 408, 414(h), or 457 of the Internal
18 Revenue Code; and
- 19 (b) Include any amounts contributed by an employee to any welfare benefit, fringe
20 benefit, or other benefit plan made by salary reduction or other payment
21 method which permits employees to elect to reduce federal taxable
22 compensation under the Internal Revenue Code, including but not limited to
23 Sections 125 and 132 of the Internal Revenue Code;
- 24 (3) "Fiscal year" means "fiscal year" as defined in Section 7701(a)(24) of the Internal
25 Revenue Code;
- 26 (4) "Employee" means any person who renders services to another person or business
27 entity for compensation, including an officer of a corporation and any officer,

- 1 employee, or elected official of the United States, a state, or any political
2 subdivision of a state, or any agency or instrumentality of any one (1) or more of the
3 above. A person classified as an independent contractor under the Internal Revenue
4 Code shall not be considered an employee;
- 5 (5) "Employer" means "employer" as defined in Section 3401(d) of the Internal
6 Revenue Code;
- 7 (6) "Gross receipts" means all revenues or proceeds derived from the sale, lease, or
8 rental of goods, services, or property by a business entity reduced by the following:
- 9 (a) Sales and excise taxes paid; and
10 (b) Returns and allowances;
- 11 (7) "Internal Revenue Code" means the Internal Revenue Code in effect on December
12 31, 2008, as amended;
- 13 (8) "Net profit" means gross income as defined in Section 61 of the Internal Revenue
14 Code minus all the deductions from gross income allowed by Chapter 1 of the
15 Internal Revenue Code, and adjusted as follows:
- 16 (a) Include any amount claimed as a deduction for state tax or local tax which is
17 computed, in whole or in part, by reference to gross or net income and which
18 is paid or accrued to any state of the United States, local taxing authority in a
19 state, the District of Columbia, the Commonwealth of Puerto Rico, any
20 territory or possession of the United States, or any foreign country or political
21 subdivision thereof;
- 22 (b) Include any amount claimed as a deduction that directly or indirectly is
23 allocable to income which is either exempt from taxation or otherwise not
24 taxed;
- 25 (c) Include any amount claimed as a net operating loss carryback or carryforward
26 allowed under Section 172 of the Internal Revenue Code;
- 27 (d) Include any amount of income and expenses passed through separately as

- 1 required by the Internal Revenue Code to an owner of a business entity that is
2 a pass-through entity for federal tax purposes; and
- 3 (e) Exclude any amount of income that is exempt from state taxation by the
4 Kentucky Constitution or the Constitution and statutory laws of the United
5 States;
- 6 (9) "Sales revenue" means receipts from the sale, lease, or rental of goods, services, or
7 property;
- 8 (10) "Tax district" means a city, county, urban-county, charter county, consolidated local
9 government, school district, special taxing district, or any other statutorily created
10 entity with the authority to levy net profits, gross receipts, or occupational license
11 taxes;
- 12 (11) "Taxable gross receipts," in case of a business entity having payroll or sales
13 revenues both within and without a tax district, means gross receipts as defined in
14 subsection (6) of this section, as apportioned under KRS 67.753;
- 15 (12) "Taxable gross receipts," in case of a business entity having payroll or sales revenue
16 only in one (1) tax district, means gross receipts as defined in subsection (6) of this
17 section;
- 18 (13) "Taxable net profit," in case of a business entity having payroll or sales revenue
19 only in one (1) tax district, means net profit as defined in subsection (8) of this
20 section;
- 21 (14) "Taxable net profit," in case of a business entity having payroll or sales revenue
22 both within and without a tax district, means net profit as defined in subsection (8)
23 of this section, as apportioned under KRS 67.753; and
- 24 (15) "Taxable year" means the calendar year or fiscal year ending during the calendar
25 year, upon the basis of which net income or gross receipts is computed; ~~and~~
- 26 ~~(16) "City" means a city with a population equal to or greater than one thousand (1,000)~~
27 ~~based on the most recent federal decennial census and any city with a population of~~

1 ~~less than one thousand (1,000) based on the most recent federal decennial census~~
 2 ~~that, prior to January 1, 2014, imposed a license fee at a percentage rate on salaries,~~
 3 ~~wages, commission, or other compensation for work done or services performed~~

6 ➔Section 7. KRS 67.850 is amended to read as follows:

7 (1) Charter county governments may exercise the constitutional and statutory rights,
 8 powers, privileges, immunities, and responsibilities of counties and cities of the
 9 **home rule**~~[highest]~~ class within the county:

10 (a) In effect on the date the charter county government becomes effective;

11 (b) That may subsequently be authorized for or imposed upon counties and cities
 12 of that class; and

13 (c) That may be authorized for or imposed upon charter counties.

14 (2) Rights, powers, privileges and immunities exercised by charter county governments
 15 pursuant to subsection (1)(a) and (b) of this section shall continue to be authorized
 16 for charter county governments notwithstanding repeal or amendment of the statutes
 17 upon which they are based unless expressly repealed or amended for charter county
 18 governments.

19 ➔Section 8. KRS 67.922 is amended to read as follows:

20 (1) A unified local government may exercise the constitutional and statutory rights,
 21 powers, privileges, immunities, and responsibilities of counties and of cities of the
 22 **first class or home rule** ~~[highest]~~ class within the unified local government:

23 (a) In effect on the date the unified local government becomes effective;

24 (b) Which may subsequently be authorized for or imposed upon counties and
 25 cities of that class; and

26 (c) Which may be authorized for or imposed upon unified local governments.

27 (2) **If a city of the first class exists within the county on the date that the unified local**

1 government becomes effective and that city is part of the unified local
 2 government, the unified local government may also exercise the constitutional
 3 and statutory rights, powers, privileges, immunities, and responsibilities of a city
 4 of the first class in addition to its authority to exercise the rights, powers,
 5 privileges, immunities, and responsibilities granted under subsection (1) of this
 6 section.

7 **(3)** A unified local government shall be accorded the same sovereign immunity granted
 8 counties, their agencies, officers, and employees.

9 ~~**(4)**~~~~**(3)**~~ All ordinances of a unified local government shall be enacted and enforced
 10 pursuant to KRS 83A.060 and 83A.065.

11 ➔Section 9. KRS 80.010 is amended to read as follows:

12 As used in this chapter, unless the context otherwise requires:

13 (1) "Housing" means a building or buildings containing rooms to be provided as living
 14 quarters, together with shops, stores, garages, laundries, doctors' and dentists'
 15 offices, and other facilities and appurtenances deemed reasonably necessary by the
 16 housing authority to the successful and economical operation of the project. It also
 17 means any work or undertaking of a housing authority or of the federal government
 18 to:

19 (a) Demolish, clear, or remove a building or buildings from any slum area,
 20 including the adaptation of such area to recreational, community, or other
 21 public purposes;

22 (b) Provide decent, safe, and sanitary living accommodations for persons who
 23 lack the amount of income that is necessary, as determined by the authority
 24 undertaking the project, to enable them, without financial assistance, to obtain
 25 such accommodations; such work or undertaking may include buildings, land
 26 equipment, facilities, and other real or personal property for necessary,
 27 convenient, or desirable appurtenances, streets, sewers, water service, parks,

- 1 site preparation, gardening, administrative, community, health, recreational,
2 welfare, or other purposes;
- 3 (c) Accomplish a combination of the foregoing and any purposes and objectives
4 permitted of public housing authorities authorized by the United States
5 Housing Act of 1937, 42 U.S.C., sec. 1401, as amended from time to time.
- 6 (2) "Housing authority" or "authority" means any housing authority created pursuant to
7 this chapter.
- 8 (3) "Public body" means any city, ~~village,~~ county, commission, district, authority, or
9 other public body or political subdivision of the Commonwealth.
- 10 (4) "Federal government" includes the United States of America, the United States
11 housing authority and its successor agencies, and any other agency or
12 instrumentality of the United States of America.
- 13 (5) "Bonds" means any bonds, notes, interim certificates, debentures, or other
14 obligations.
- 15 (6) "Clerk" means the clerk of the city or the clerk of the county, as the case may be, or
16 the officer charged with the duties customarily imposed on such clerk.
- 17 (7) "Governing body" means, in the case of a city, the city council, the commission,
18 board of commissioners, board of alderman,~~the board of trustees~~ or other
19 legislative body of the city, and in the case of a county, the fiscal court.
- 20 (8) "Mayor" means the mayor of the city or the officer thereof charged with the duties
21 customarily imposed on the mayor or executive head of the city.
- 22 (9) "Obligee of the authority" or "obligee" shall include any bondholder, trustee or
23 trustees for any bondholders, or lessor demising to the authority property used in
24 connection with a housing project, or any assignee or assignees of such lessor's
25 interest or any part thereof, and the federal government when it is a party to any
26 contract with the authority.
- 27 (10) "Persons of low income" means persons or families who lack the amount of income

1 which is necessary, as determined by the housing authority undertaking the housing
2 development, to enable them, without financial assistance, to live in decent, safe,
3 and sanitary dwellings, without overcrowding.

4 (11) "Real property" includes all lands, including improvements and fixtures thereon,
5 and property of any nature appurtenant thereto, or used in connection therewith, and
6 every estate, interest and right, legal or equitable, therein, including terms for years
7 and liens by way of judgment, mortgage, or otherwise and the indebtedness secured
8 by such liens.

9 (12) "Slum" means any area where dwellings predominate which, by reason of
10 dilapidation, overcrowding, lack of ventilation, light, or sanitary facilities, or any
11 combination of these factors are detrimental to safety, health and morals.

12 (13) "Low income" and "moderate income" shall have those meanings as from time to
13 time are promulgated by federal and state governmental agencies providing funding
14 for the then applicable housing program.

15 ➔Section 10. KRS 81.005 is amended to read as follows:

16 (1) Cities shall be organized into two (2) classes based on the form of their respective
17 government. The two (2) classes of cities shall be:

18 (a) First class, which shall include cities organized and operating under the
19 mayor-alderman plan of government in accordance with KRS Chapter 83; and

20 (b) Home rule class, which shall include any city government organized and
21 operating under the following forms~~[classes]~~ of government:

- 22 1. City manager plan of government in accordance with KRS 83A.150;
- 23 2. Mayor-council plan of government in accordance with KRS 83A.130; or
- 24 3. Commission plan of government in accordance with KRS 83A.140.

25 (2) Cities incorporated before January 1, 2015, shall be classified in accordance with
26 the classes set out in subsection (1) of this section on January 1, 2015.

27 (3) When a city is incorporated on or after January 1, 2015, that city's initial

1 classification shall be the form of government designated by the court upon
2 incorporation in accordance with KRS 81.060.

3 (4) A city shall be deemed to be reclassified to the class designated under subsection
4 (2) of this section upon the effective date of a change in the form of government
5 pursuant to KRS 83A.160.

6 (5) When a city changes class, it shall thereafter be governed by the laws relating to the
7 class to which it is assigned, but the change from one (1) class to another shall not
8 affect any ordinance previously enacted by the city, except that any ordinance in
9 conflict with the laws relating to cities of the class to which the city is assigned shall
10 be repealed to the extent the ordinance so conflicts.

11 (6) A city that is reclassified shall provide the Secretary of State written notice of the
12 reclassification, including the effective date of the reclassification no later than
13 thirty (30) days after the effective date of the reclassification pursuant to KRS
14 83A.160.

15 (7) In order to update the record of incorporation of cities in the Secretary of State's
16 office, every city operating as a public corporation and a unit of local government
17 shall file with the Secretary of State before January 1, 2015, a document listing the
18 name of the city, the year of its incorporation, form of government, and the
19 classification assigned the city by this section. If a city fails to comply with this
20 subsection, it shall be barred from receiving state moneys until such time as the city
21 complies.

22 ➔Section 11. KRS 82.082 is amended to read as follows:

23 (1) A city may exercise any power and perform any function within its boundaries,
24 including the power of eminent domain in accordance with the provisions of the
25 Eminent Domain Act of Kentucky, that is in furtherance of a public purpose of the
26 city and not in conflict with a constitutional provision or statute.

27 (2) A power or function is in conflict with a statute if it is expressly prohibited by a

1 statute or there is a comprehensive scheme of legislation on the same general
2 subject embodied in the Kentucky Revised Statutes~~[including, but not limited to,~~
3 ~~the provisions of KRS Chapters 95 and 96].~~

4 ➔Section 12. KRS 92.281 is amended to read as follows:

5 (1) Cities of all classes are authorized to levy and collect any and all taxes provided for
6 in Section 181 of the Constitution of the Commonwealth of Kentucky, and to use
7 the revenue therefrom for such purposes as may be provided by the legislative body
8 of the city.

9 (2) Nothing in this section shall be construed to repeal, amend, or affect in any way the
10 provisions of KRS 243.070.

11 (3) This section shall not in any wise repeal, amend, affect, or apply to any existing
12 statute exempting property from local taxation or fixing a special rate on proper
13 classification or imposing a state tax which is declared to be in lieu of all local
14 taxation, nor shall it be construed to authorize a city to require any company that
15 pays both an ad valorem tax and a franchise tax to pay a license tax.

16 (4) This section shall also be subject to the provisions of KRS 91.200 in cities of the
17 first class having a sinking fund and commissioners of a sinking fund.

18 (5) ~~{(a) License fees on businesses, trades, occupations, or professions may not be~~
19 ~~imposed by a city with a population of less than one thousand (1,000) based~~
20 ~~upon the most recent federal decennial census at a percentage rate on salaries,~~
21 ~~wages, commissions, or other compensation earned by persons for work done~~
22 ~~or services performed within that city nor the net profits of businesses,~~
23 ~~professions, or occupations from activities conducted in that city.~~

24 ~~(b) Notwithstanding paragraph (a) of this subsection, a city with a population of~~
25 ~~less than one thousand (1,000) based upon the most recent federal decennial~~
26 ~~census that, prior to January 1, 2014, imposed a license fee at a percentage~~
27 ~~rate on salaries, wages, commissions, or other compensation for work done or~~

1 ~~services performed within the city or on the net profits or gross receipts of~~
2 ~~businesses, professions, and occupations from activities conducted within the~~
3 ~~city may continue to impose that fee on a percentage rate.~~

4 ~~(6)~~ License fees or occupational taxes may not be imposed against or collected on
5 income received by precinct workers for election training or work at election booths
6 in state, county, and local primary, regular, or special elections.

7 ~~(6)~~~~(7)~~ License fees or occupational taxes may not be imposed against or collected on
8 any profits, earnings, or distributions of an investment fund which would qualify
9 under KRS 154.20-250 to 154.20-284 to the extent any profits, earnings, or
10 distributions would not be taxable to an individual investor.

11 ~~(7)~~~~(8)~~ (a) It is the intent of the General Assembly to continue the exemption from
12 local license fees and occupational taxes that existed on January 1, 2006, for
13 providers of multichannel video programming services or communications
14 services as defined in KRS 136.602 that were taxed under KRS 136.120 prior
15 to January 1, 2006.

16 (b) To further this intent, license fees or occupational taxes may not be imposed
17 against any company providing multichannel video programming services or
18 communications services as defined in KRS 136.602. If only a portion of an
19 entity's business is providing multichannel video programming services or
20 communications services including products or services that are related to and
21 provided in support of the multichannel video programming services or
22 communications services, this exclusion applies only to that portion of the
23 business that provides multichannel video programming services or
24 communications services including products or services that are related to and
25 provided in support of the multichannel video programming services or
26 communications services.

27 ➔Section 13. KRS 95.761 is amended to read as follows:

- 1 (1) Any city with a population equal to or greater than one thousand (1,000) but less
2 than eight thousand (8,000) based upon the most recent federal decennial census
3 which has now, or in which there may be hereafter established a regular police or
4 fire department in the future, may by ordinance create a civil service commission,
5 whose duties shall be to hold examinations as to the qualifications of applicants for
6 employment within the police or fire departments. If a city elects to establish a civil
7 service system for its police and fire employees under this section, then it may adopt
8 either the provisions of this section, or KRS 95.762 ~~to~~, ~~95.763, 95.764, 95.765,~~
9 ~~and~~ 95.766, or it may adopt the provisions of KRS 90.300 to 90.420. A city
10 meeting the population criteria of this subsection may adopt the provisions of KRS
11 90.300 to 90.420 for municipal employees who are not police or fire personnel.
- 12 (2) Any city meeting the criteria of subsection (6) of this section may provide a
13 retirement system for any of its employees, including police and firefighters,
14 pursuant to KRS 90.400 or 90.410. If a city creates a retirement system for its police
15 and firefighters pursuant to KRS 90.400 or 90.410, it shall establish a board of
16 trustees for that system. The provisions of KRS 90.400 and 90.410 notwithstanding,
17 a majority of the board shall be members of the retirement system elected by the
18 members of the retirement system, except that if there are fewer than six (6) active
19 and retired members of the fund, the board of trustees shall be composed of the
20 mayor, city treasurer or chief financial officer, and two (2) employees appointed by
21 the mayor, one (1) from the city police department and one (1) from the city fire
22 department, who shall serve for one (1) year and until their respective successors are
23 appointed and qualified. If all of the members of the pension fund are from one (1)
24 department, no appointment shall be made from the other department. The board of
25 trustees shall control and manage the retirement fund, for the exclusive purposes of
26 providing benefits to members and their beneficiaries and defraying reasonable
27 expenses of administering the plan. The board may contract with investment

1 advisors or managers to perform investment services as deemed necessary and
2 prudent by the board.

3 (3) A city meeting the criteria of subsection (6) of this section may adopt the provisions
4 of KRS 79.080 or 78.510 to 78.852 for any of its employees, or either KRS 95.520
5 to 95.620 or KRS 95.767 to 95.784 for its police and firefighters. After adoption of
6 the provisions of any of the statutes listed in this section, the city may not revoke,
7 rescind or repeal these adoptions for any employee covered thereby.

8 (4) (a) Any of the following offices, positions, and places of employment, in the
9 police and fire departments, may be excluded from the classified service: The
10 chief of police, assistant chief of police, chief of firefighters and assistant
11 chief of firefighters.

12 (b) Any classified employee in either department who shall accept an appointment
13 and qualify as chief of police, assistant chief of police, chief of firefighters, or
14 assistant chief of firefighters, shall be deemed to have received a leave of
15 absence from the classified service for, and during the incumbency of, any of
16 said respective positions. Should any such chief or assistant chief, cease to
17 serve as such, the same classification and rank which he had prior to said
18 appointment shall be restored to him.

19 (5) After August 1, 1988, no city shall create a new pension fund pursuant to this
20 section other than by adopting KRS 78.510 to 78.852, or by adopting a deferred
21 compensation program pursuant to KRS 18A.270 or a defined contribution or
22 money purchase plan qualified under Section 401(a) of the Internal Revenue Code
23 of 1954 as amended. Any city which adopted a pension system pursuant to this
24 section on or prior to August 1, 1988, shall participate in the County Employees
25 Retirement System effective August 1, 1988.

26 (6) As used in subsections (2) and (3) of this section, "city" means only those cities that
27 were previously classified as cities of the fourth and fifth class under the

1 classification system that was in effect before August 1, 1988.

2 (7) Notwithstanding subsection (1) of this section, no city shall adopt any~~[a]~~ civil
3 service system for any of its employees ~~[under KRS 90.300 to 90.420 or under KRS~~
4 ~~95.761, 95.762, 95.763, 95.764, 95.765, and 95.766]~~ during the months of
5 November or December in any even-numbered year.

6 (8) Any city that creates a civil service commission pursuant to this section may repeal
7 or amend the ordinance at the discretion of the city legislative body. The city
8 legislative body shall not repeal any provisions of the ordinance governing the
9 maintenance of a pension fund.

10 ➔Section 14. KRS 96.045 is amended to read as follows:

11 (1) No municipality, in which there is located an existing electric, water or gas public
12 utility plant or facility shall construct or cause to be constructed any similar utility
13 plant or any similar public utility facility duplicating such existing plant or facility
14 or to obtain or acquire any similar public utility plant or facility other than by the
15 purchase of the existing plant or facility or by the acquisition of such existing plant
16 or facility by the exercise of the power of eminent domain.

17 (2) "Municipality" means any county, city, and~~[town, village and]~~ municipal
18 corporation ~~[of any and every class]~~ in the Commonwealth of Kentucky, and any
19 board, commission or agency thereof.

20 (3) All laws and parts of laws in conflict herewith to the extent of such conflict are
21 repealed.

22 ➔Section 15. KRS 96.120 is amended to read as follows:

23 (1) Any city *that owns and operates its own water or light plant* may acquire a
24 franchise to furnish water and light to any other city, in the same manner that any
25 private corporation or individual may acquire such a franchise.

26 (2) *Any city that owns and operates its own water or light plant may contract with*
27 *any other city to furnish water and light to that other city. Those contracts may be*

1 entered into by the legislative bodies of the cities, and the legislative bodies are
 2 given full power to so contract in regard to the furnishing of water or light. Each
 3 contract shall be specific in its terms. Any city may pay to any other city a rental
 4 for water and light from year to year, or for a term of years.

5 (3) Any city may construct, lay, or maintain mains, pipes, lines, or other necessary
 6 apparatus to convey water or light from any city that owns and operates its own
 7 water or light plant, or may contract with the other city to do these things, and the
 8 other city shall have the same power. For this purpose, any city may acquire
 9 rights and rights-of-way in the same manner that private corporations or
 10 individuals may acquire rights and rights-of-way, and may do any other things in
 11 carrying into effect the provisions of this section that any individual or
 12 corporation may do.

13 ➔Section 16. KRS 96.189 is amended to read as follows:

14 (1) Any city ~~[with a population equal to or greater than eight thousand (8,000) based~~
 15 ~~upon the most recent federal decennial census]~~may, pursuant to an ordinance so
 16 providing, acquire any streetcar system existing in the city, with all its appliances,
 17 or may establish and install a streetcar system, and may operate within and not more
 18 than ten (10) air miles beyond the corporate limits of the city, improve and extend a
 19 system so acquired or installed upon the terms and conditions as may be provided
 20 by ordinance and by the terms of the contract by which the system is acquired or
 21 installed. Any city ~~[meeting the population requirements of this section]~~may
 22 acquire, establish, and install a street omnibus or taxicab system, and operate it
 23 upon the terms and conditions as are prescribed by ordinance.

24 (2) To provide for the financing of the streetcar system or street omnibus or taxicab
 25 line, the city may issue bonds at not less than par and accrued interest, to bear
 26 interest at a rate or rates or method of determining rates as the city determines,
 27 payable at least annually, and to mature at any time not exceeding twenty (20) years

1 after their date, and may provide for a sinking fund to meet the bonds at their
2 maturity. No bonds shall be issued except in compliance with the general law in
3 reference to the amount of indebtedness that may be incurred by the city, nor until
4 after a vote is taken as required by law to authorize the incurring of indebtedness.

5 ➔Section 17. KRS 96.200 is amended to read as follows:

6 Except as otherwise provided in KRS ~~96.330 or~~ 96.550 to 96.900, ~~for,~~ the legislative
7 body of any city may, by ordinance, provide in what manner and for what purpose any
8 profits, earnings or surplus funds arising from the operation of any public utility owned or
9 operated by the city may be used and expended. The ordinance may be amended or
10 repealed from time to time. Until such an ordinance is enacted any surplus earnings shall
11 be paid into the city treasury, to be expended for the general purposes of government in
12 the city.

13 ➔Section 18. KRS 107.020 is amended to read as follows:

14 (1) The term "governing body," as used in this chapter, means and includes the
15 legislative body of any city, whether the same be designated by applicable statutes
16 as a general council, a common council, a city council, a board of commissioners,
17 or otherwise. The term "governing body," as used in KRS 107.010 to 107.220 shall
18 include the legislative body of any county unless the context requires otherwise. The
19 terms "municipality" and "city" as used in KRS 107.010 to 107.220 shall include
20 county within their meaning unless the context requires otherwise.

21 (2) The term "ordinance" means and includes any ordinance enacted in accordance with
22 the general laws applicable to ordinances of the class of city in question, and the
23 form of government thereof, and in accordance with the provisions of this chapter.

24 (3) The term "public way" means and includes streets, boulevards, avenues, roads,
25 lanes, alleys, parkways, courts, terraces, and other courses of travel open to the
26 general public by whatsoever name designated.

27 (4) The terms "improvement" and "project" mean and include:

- 1 (a) The construction of public ways or the substantial reconstruction or widening
2 thereof;
- 3 (b) The construction, installation, or substantial reconstruction of sanitary, storm,
4 or combined sewers and appurtenances;
- 5 (c) The construction, enlargement or substantial reconstruction of sewage
6 treatment plants for rendering sewage less hazardous to public health, safety,
7 and general welfare;
- 8 (d) The construction, installation, or substantial replacement of fire hydrants
9 and~~[in cities with populations of less than twenty thousand (20,000) based~~
10 ~~upon the most recent federal decennial census,]~~ necessary water mains and
11 appurtenances in any city~~[in a city in a county containing a city of the first~~
12 ~~class or a city with a population equal to or greater than twenty thousand~~
13 ~~(20,000) based upon the most recent federal decennial census];~~ or
- 14 (e) Any combination of the same. Bonds for improvements defined in paragraphs
15 (b), (c) and (d) of this subsection may be caused to mature as to principal in
16 term or serial maturities not to exceed thirty (30) years from date of issue.
- 17 (5) The term "costs" as applied to any project undertaken under this chapter includes
18 the cost of labor, materials, and equipment necessary to complete the project in a
19 satisfactory manner, cost of land acquired, and every expense connected with the
20 project, including preliminary and other surveys, inspections of the work, engineers'
21 fees and costs, attorneys' fees, preparation of plans and specifications, publication of
22 ordinances and notices, interest which will accrue on the bonds until the due date of
23 the first annual improvement assessment levied in connection therewith, a sum
24 equal to any discount in the sale of the bonds (if discount bids are authorized and
25 permitted by the governing body), a reasonable allowance for unforeseen
26 contingencies, the printing of bonds, and other costs of financing which may
27 include the payment of a fee to a fiscal agent for advice and assistance in the

- 1 preparation and marketing of the bonds. As applied to wastewater collection
2 projects undertaken by metropolitan sewer districts "costs" also include:
- 3 (a) The cost of inspections of work as construction progresses;
 - 4 (b) Interest which will accrue on the bonds until the due date of the first annual
5 improvement assessment if a lump sum is not paid;
 - 6 (c) Capitalized interest on the bonds for a period not to exceed three (3) years;
 - 7 (d) All or any portion of the debt service reserve requirement, if determination is
8 made to finance same from bond proceeds;
 - 9 (e) Payment of attorneys' fees, underwriting and fiscal agency fees, trustees' fees,
10 rating service fees if approved by the fiscal court; and
 - 11 (f) Other costs of issuance of bonds.
- 12 (6) The term "assessed value basis" means the plan for the levying of annual
13 improvement benefit assessments on the basis of the assessed values of the
14 benefited properties, as authorized by this chapter. As applied to wastewater
15 collection projects undertaken by metropolitan sewer districts, "assessed value
16 basis" means the plan for the levying of annual improvement benefit assessments
17 upon benefited property for the benefits conferred by the construction of projects on
18 the basis of the ad valorem assessed values (land only) of the benefited property,
19 whether the owners pay such levies in full or on an annual basis to amortize bonds.
20 Identical annual improvement benefit assessments upon classified zones of
21 benefited property may also be included in this plan where determination is made by
22 order of a metropolitan sewer district, as provided in KRS 107.030, that benefits
23 conferred by construction of a project are substantially equal and that the assessed
24 value (land only) of all benefited property or designated zones thereof shall
25 therefore be deemed equal in respect of a given wastewater collection project.
- 26 (7) The term "front-foot basis" refers to the plan for financing improvements by
27 apportioning the cost among benefited properties upon the basis of the number of

1 linear feet thereof abutting upon the improvement project, as otherwise provided by
2 law.

3 (8) The terms "property to be benefited," "properties to be benefited," "benefited
4 property" and "benefited properties" all mean and refer to the property or properties
5 defined in KRS 107.140. As applied to wastewater collection projects undertaken
6 by metropolitan sewer districts, "benefited property" and "property to be benefited"
7 mean the property (land only) proposed to be benefited by construction of a
8 wastewater collection project instituted by a metropolitan sewer district and against
9 which lump-sum or annual improvement benefit assessments are to be levied.

10 (9) "Construction" means the following services and facilities provided by a
11 metropolitan sewer district:

12 (a) Preliminary planning to determine the economic and engineering feasibility of
13 construction of wastewater collection projects, and any engineering,
14 architectural, legal, fiscal, and economic investigations and studies necessary.
15 Also included are all necessary surveys, designs, plans, working drawings,
16 specifications, procedures, and other required actions incident to the
17 construction of wastewater collection projects;

18 (b) The building, acquisition, installation, erection, alteration, remodeling,
19 improvement, expansion, or extension of wastewater collection projects and
20 any other physical devices reasonably associated with such projects;

21 (c) The provision of sewer collection services and facilities to benefited property
22 although not directly financed by the issuance of bonds; and

23 (d) Inspection and supervision incident to the acquisition, construction, and
24 installation of wastewater collection projects.

25 (10) "Debt service reserve requirement" means with respect to any particular issue of
26 bonds for a wastewater collection project of a metropolitan sewer district, the
27 maximum annual requirements for payment of principal of and interest on such

1 bond issue funded either in whole or in part by application of bond proceeds or
2 accrued by the levying of improvement benefit assessments as provided in KRS
3 Chapters 76 and 107.

4 (11) "Metropolitan sewer district" means a joint metropolitan sewer district which has
5 been duly created under KRS 76.005 to 76.210.

6 (12) "Order" means a formal and binding enactment of the board of a metropolitan sewer
7 district entered in connection with the financing by such district of a wastewater
8 collection project.

9 (13) "Wastewater" means any water or liquid substance containing sewage, industrial
10 waste, or other pollutants or contaminants.

11 (14) "Wastewater collection project" means treatment plants and all or part of any
12 facilities and systems of a metropolitan sewer district used in the collection,
13 holding, or transmission of wastewater from a benefited property to wastewater
14 treatment plants or other similar facilities for final disposition. These terms shall
15 include, without being limited to, sanitary sewage collection lines, intercepting
16 sewers, outfall sewers, sewer laterals, power stations and pumping stations, and
17 other equipment and their appurtenances necessary to enable the project to fulfill its
18 function, including land acquisition, if required, whether such project facilities are
19 provided by funds derived from issuance of bonds or otherwise provided by a
20 district in any manner.

21 (15) "Classified zone" means any portion of any construction phase of a wastewater
22 collection project designated by a metropolitan sewer district after a determination
23 that all property located in such zone is benefited substantially equal by such
24 construction.

25 ➔Section 19. KRS 107.030 is amended to read as follows:

26 If a municipality desires to authorize, construct, and finance an improvement pursuant to
27 this chapter, its governing body shall initiate the proceedings by adopting an ordinance,

1 herein called the "First Ordinance," in which announcement shall be made of the public
2 way or ways (which need not be contiguous) proposed to be improved and the
3 geographical limits of the proposed improvement in such manner as to identify the
4 benefited properties or the identity of the property or properties to be benefited by the fire
5 hydrant in a city~~[cities with a population of less than twenty thousand (20,000) based~~
6 ~~upon the most recent federal decennial census]~~ or by the sewer installations (which may
7 include a sewage treatment plant) which properties may be identified by naming the
8 public way or ways upon which they abut, if any, or by geographical location, or both. In
9 either case the ordinance shall recite the nature and scope of the improvement, a
10 preliminary estimate of the costs thereof, as submitted in writing by an engineer, or firm
11 of engineers, holding a license from the Commonwealth of Kentucky, and the amount, if
12 any, which the city proposes to appropriate from available city funds toward the estimated
13 cost. Any metropolitan sewer district desiring to initiate a wastewater collection project
14 pursuant to this chapter shall, by order of its board cause a written preliminary
15 engineering and financing report to be prepared by one (1) or more engineers, or one (1)
16 or more firms of engineers, licensed to do business in the Commonwealth of Kentucky, or
17 alternatively, by district personnel, for submission to the district. The preliminary
18 engineering and financing report shall designate a geographical area in which a
19 wastewater collection project is recommended for construction. The report shall contain a
20 reasonable description of the project facilities proposed to be constructed, a statement as
21 to benefits to be conferred by the proposed project, the distribution of the benefits and an
22 estimate of the cost of the proposed project. The board of the district shall receive the
23 preliminary engineering and financing report at a regular meeting. The board shall study
24 and evaluate it, and by duly entered order either approve, disapprove the report as
25 submitted, or amend and approve the report. Following approval of the preliminary
26 engineering and financing report by the board of the metropolitan sewer district, the board
27 shall formally initiate proceedings for the construction and financing of the proposed

1 wastewater collection project. This announcement shall identify all benefited properties
2 by naming the public way upon which such benefited properties abut, if any, or by
3 geographical location, or by other appropriate description. The first ordinance shall
4 describe the nature, scope and preliminary cost estimate of the wastewater collection
5 project being proposed. The ordinance shall determine that each parcel of land identified
6 as benefited property shall be afforded benefits by the projects unless specifically
7 excluded. A public hearing shall be held in respect of the proposed wastewater collection
8 project. In all succeeding proceedings, the city shall be bound and limited by the
9 preliminary report of the engineer, or engineers, with regard to the nature, scope, and
10 extent of the proposed improvement project (unless the first ordinance be amended, as
11 hereinafter provided); but shall not be bound by, or limited to, the preliminary estimate of
12 costs. The costs shall be determined upon the basis of construction bids publicly solicited
13 as hereinafter provided, and shall be binding upon the city, and upon the owners of
14 property to be benefited by the proposed improvement project, whether the same turn out
15 to be equal to, below, or above such preliminary estimate. Architects, attorneys,
16 consultants, engineers, and fiscal agents shall be employed after reasonable advertisement
17 of the need for their services and with such competition as is permitted by law. In a first
18 ordinance for a wastewater collection project, the board of a metropolitan sewer district
19 shall make findings of fact regarding the degree and nature of the benefit which will
20 accrue to benefited properties by the installation of the project. If the board determines as
21 a fact that groups of or all of the benefited properties will be affected and benefited in
22 substantially the same manner and to substantially the same degree, the board may
23 classify such benefited properties into one (1) or more assessment zones based upon the
24 similarity of benefits to be derived. In such case, the board may deem all benefited
25 properties within a particular assessment zone to be equally benefited and therefore
26 equally treated for purposes of levying improvement benefit assessments for amortization
27 of bonds issued to provide funds to pay the costs of the project. It is the intent of KRS

1 Chapters 76 and 107 to vest in the board of any metropolitan sewer district undertaking a
2 project authority to make findings of fact in order to classify properties according to
3 benefits conferred from the construction of projects. The board may, by appropriate order,
4 determine that identified groups of benefited properties will be benefited in substantially
5 the same manner by a project and these properties shall be treated equally for purposes of
6 annual improvement benefit assessment of such benefited properties. The board may rely
7 upon any pertinent data in making such findings of fact, including the size and diameter
8 of sanitary sewer service connections to be made available. If the board of the district
9 determines that all properties situated within a particularly described geographic area will
10 not receive substantially equal benefits from the project, the board shall determine in the
11 first ordinance that such properties shall be annually assessed for benefits conferred based
12 upon the relative assessed land valuation of each benefited property as it relates to the
13 aggregated assessed land valuation of all benefited properties within such particularly
14 described geographic area. Whichever basis of assessment is selected, it shall be used
15 both initially, when land owners may pay improvement benefit assessments in a lump
16 sum, and subsequently during each annual period in which project bonds are outstanding
17 if a lump-sum payment is not paid. The first ordinance shall provide for a public hearing
18 at a time and place specified therein (not less than one (1) week after publication) and
19 shall give notice that at the hearing any owner of property to be benefited may appear and
20 be heard as to:

- 21 (1) Whether the proposed project should be undertaken or abandoned;
- 22 (2) Whether the nature and scope of the project shall be altered;
- 23 (3) Whether the project shall be financed through the issuance of bonds according to
24 the "assessed value basis," authorized by this chapter; or
- 25 (4) Whether the project shall be financed through assessments made and apportioned
26 on a front-foot basis, as may otherwise be authorized by law. The first ordinance
27 shall be published pursuant to KRS Chapter 424. The first ordinance may designate

1 a person, who may be the mayor, a member of the governing body, or any city
2 official, to preside at and conduct such public hearing. In the absence of a
3 designation in the ordinance, the mayor or a person designated by the mayor shall
4 preside. Notwithstanding the foregoing, the public hearing shall not be deemed
5 irregular or improper if it is in fact presided over and conducted at the designated
6 time and place by any elected city officer or member of the governing body.

7 ➔Section 20. KRS 107.140 is amended to read as follows:

8 (1) (a) In the case of improvements of public ways, the benefited property shall
9 consist of all real property abutting upon both sides of the improvement
10 project, and the cost of improving intersections shall be included in the total
11 costs to be assessed and apportioned, unless and to the extent the city shall
12 appropriate, within constitutional limitations, from available funds, a definite
13 and specified sum as a contribution thereto, or a portion of the aggregate cost,
14 or the cost of specified portions of the improvement; provided, however, that
15 if provisions shall be made for sidewalk improvements, as an integral part of
16 the improvement of a "public way," as defined in subsection (3) of KRS
17 107.020, upon only one side of the project, the costs of the sidewalk
18 improvement shall be ascertained and assessed separately against the property
19 abutting upon that side only, but the governing body may provide that such
20 assessment shall include a fair share of the over-all costs as herein defined,
21 other than the amounts of the actual construction contracts.

22 (b) In the case of improvements for draining sewage, storm water, or a
23 combination thereof, the benefited properties shall consist of all properties
24 which are thereby afforded a means of drainage, including not only the
25 properties which may be contiguous to the improvements, but also adjacent
26 properties within a reasonable distance therefrom as the governing body may
27 in the proceedings set forth.

- 1 (c) In the case of an improvement project consisting in whole or in part of a
2 sewage treatment plant, or enlargement or substantial reconstruction of an
3 existing sewage treatment plant, the benefited properties shall be all those
4 properties the sewage from which is treated in such plant, including properties
5 already provided with sewer drainage facilities as well as those properties
6 which the improvement project will provide with such drainage facilities, but
7 the governing body may classify properties according to the extent of benefits
8 to be afforded to them, and may establish one (1) rate of assessment
9 applicable to all properties participating in the benefits of the sewage
10 treatment installations, and an additional rate of assessment applicable to
11 properties for which the improvement project will also provide sewer drainage
12 facilities. In relation to wastewater collection projects constructed by
13 metropolitan sewer districts, benefited property shall consist of all property
14 whether improved or unimproved to which the project affords a means of
15 discharging wastewater.
- 16 (d) The governing body may, either in the proceedings initiating an improvement
17 project, or in subsequent proceedings, recognize the necessity or desirability in
18 the interest of the public health, safety and general welfare, that properties
19 other than the properties originally benefited by an improvement under
20 paragraphs (b) or (c) of this subsection, be permitted to connect to such sewer
21 drainage and/or treatment facilities, and may make equitable provisions which
22 may be adjustable from year to year as bonds are retired, whereby the owners
23 of such later-connecting properties, may, by paying charges for the privilege
24 of connecting, and/or by assuming a share of improvement assessments, or
25 otherwise, be placed as nearly as practicable on a basis of financial equity with
26 the owners of properties initially provided to be assessed.
- 27 (e) The governing body may, either in the proceedings initiating an improvement

1 project, or in subsequent proceedings, recognize the necessity or desirability in
2 the interest of the public health, safety and general welfare that residential
3 properties within one thousand feet (1000'), measured along paved roads, of a
4 fire hydrant in a city~~[cities with a population of less than twenty thousand~~
5 ~~(20,000) based upon the most recent federal decennial census]~~ may be
6 assessed on the same basis as property abutting upon a street where a fire
7 hydrant is to be installed.

8 (2) (a) Benefited property owned by the city or county, or owned by the United States
9 government or any of its agencies, if such property is subject to assessment by
10 Act of Congress, shall be assessed annually the same as private property, and
11 the amount of the annual assessment shall be paid by the city, county, or
12 United States government, as the case may be. The same right of action shall

14 (b) Benefited property owned by the state, except property the title to which is
15 vested in the Commonwealth for the benefit of a district board of education
16 pursuant to KRS 162.010, shall be assessed as follows: Before assessing the
17 state, the governing body shall serve written notice on the secretary of the
18 Finance and Administration Cabinet setting forth specific details including the
19 estimated total amount of any improvement assessment proposed to be levied
20 against any state property relative to any proposed improvement project. Said
21 written notice shall be served prior to the next even-numbered-year regular
22 session of the General Assembly so that the amount of any specific
23 improvement assessment may be included in the biennial executive branch
24 budget recommendation to be submitted to the General Assembly. Payment of

4 enforcement of its laws relating to motor vehicles and boats or boating, now existing or

16 This material shall be receipted for by the person withdrawing it, and returned

19 (1) Except as provided in KRS 353.500 to 353.720, no permits shall be issued for the
20 drilling, deepening, or reopening of any shallow well for the production of oil,
21 unless the proposed location of the well shall be at least three hundred thirty (330)
22 feet from the nearest mineral boundary of the premises upon which the well is to be
23 drilled, deepened or reopened; and, the proposed location must be at least six
24 hundred sixty (660) feet from the nearest oil producing well. This subsection shall
25 not be construed to regulate the distance between wells which do not produce oil
26 from the same pool.

27 (2) Except as provided in KRS 353.500 to 353.720, no permit shall be issued for the

1 drilling, deepening or reopening of any shallow well for the production of gas

3 from the nearest mineral boundary of the premises upon which such well is to be
4 drilled, deepened or reopened; and, the proposed location must be at least one
5 thousand (1,000) feet from the nearest gas producing well. This subsection shall not

14 already established on all premises which will be offset and affected by the

18 (d) To premises within the limits of any incorporated city~~, town or village~~ which
19 has enacted or enacts hereafter an ordinance regulating the location or spacing

21 distances prescribed in this section.

22 (e) To wells for the production of oil to be drilled, deepened, or reopened and
23 completed at a depth of less than two thousand (2,000) feet where there are no

27 production of oil coming within this exception shall be at least two hundred

6 through suitable competitive examinations for positions or classes of
7 positions;
- 8 (c) "Fire department" means and includes all officers, firefighters, and clerical or
9 maintenance employees of the fire department;
- 10 (d) "Police department" means and includes all officers, policemen, and clerical
11 or maintenance employees of the police department;
- 12 (e) "Member" means any and all officers, firefighters, policemen, clerical or
13 maintenance employees in the police or fire department, except as used in
14 subsections (1) and (3) of KRS 95.440, and KRS 95.450, 95.460, 95.470,
15 95.550, 95.560, 95.565, 95.570 and 95.580; it shall not include the chief of
16 police in an urban-county government;
- 17 (f) "Police force" means and includes all officers and policemen in the police
18 department;
- 19 (g) "Policeman" means a member of the police department below the rank of
20 officer, other than a clerical or maintenance employee;
- 21 (h) "Firefighter" means a member of the fire department below the rank of officer,
22 other than a clerical or maintenance employee;
- 23 (i) "Salary" means any compensation received for services;
- 24 (j) "Suspension" means the separation of an employee from the service for a
25 temporary or fixed period of time, by his appointing authority, as a
26 disciplinary measure; and
- 27 (k) "Pension fund" shall mean the moneys derived from the members of the

1 police and fire departments' salary or salaries and appropriations by the
2 legislative body, or any other means derived from whatever source by gift or
3 otherwise to be used for the retirement of members of the police and fire
4 departments after the prescribed number of years of service, and for the
5 benefit of disabled members of police and fire departments, and for the benefit
6 of surviving spouses and dependent children or dependent fathers or mothers
7 in the case of death of any member of the police or fire department within the
8 scope of his employment.

9 (3) As used in KRS 95.761 to 95.784, the following words and terms shall have the
10 following meaning:

11 (a) "Regular police department." For the purpose of KRS 95.761 to 95.784, a
12 "regular police department" is defined as one having a fixed headquarters,
13 where police equipment is maintained and where a policeman or policemen
14 are in constant and uninterrupted attendance to receive and answer police
15 calls, and execute regular police patrol duties;

16 (b) "Regular fire department." For the purpose of KRS 95.761 to 95.784, a
17 "regular fire department" is defined as one having a fixed headquarters where
18 firefighting apparatus and equipment are maintained, and where firefighters
19 are in constant and uninterrupted attendance to receive and answer fire alarms;

20 (c) "Legislative body." Wherever in KRS 95.761 to 95.784 the term "body" or
21 "legislative body" is employed, it shall be construed to mean the legislative
22 branch of the city government or urban-county government;

23 (d) "Commission." The word "commission" shall mean the board of civil service
24 commissioners, as established under the terms of KRS 95.761 to 95.784;

25 (e) "Trustees." The word "trustees" shall mean the board of pension fund trustees,
26 as established under the terms of KRS 95.761 to 95.784; and

27 (f) "Pension fund." The term "pension fund" shall mean the moneys derived from

1 the policeman or policemen and firefighter or firefighters salary or salaries,
2 and appropriations by the legislative body, or any other sums derived from
3 whatever source by gifts or otherwise to be used for the retirement of
4 policeman or policemen and firefighter or firefighters after the prescribed
5 number of years of service and for the benefit of disabled policeman or
6 policemen and firefighter or firefighters, and for the benefit of surviving
7 spouses and dependent children or dependent fathers or mothers in the case of
8 death of a policeman or firefighter within the scope of his employment,
9 according to the terms of KRS 95.761 to 95.784.
