

1 AN ACT relating to emergency medical services.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 311A.010 is amended to read as follows:

4 As used in this chapter, unless the context otherwise requires:

- 5 (1) **"Advanced emergency medical technician" or "AEMT" means a person certified**  
 6 **by the board under this chapter as an advanced emergency medical technician;**
- 7 (2) **"Advanced practice paramedic" or "APP" means a paramedic licensed by the**  
 8 **board under this chapter as a paramedic and certified by the board under this**  
 9 **chapter in at least one (1) emergency medical services subspecialty, including**  
 10 **community paramedic, critical care paramedic, wilderness paramedic, tactical**  
 11 **paramedic, or flight paramedic;**
- 12 (3) "Ambulance" means a vehicle which has been inspected and approved by the board,  
 13 including a helicopter or fixed-wing aircraft, except vehicles or aircraft operated by  
 14 the United States government, that are specially designed, constructed, or have been  
 15 modified or equipped with the intent of using the same, for the purpose of  
 16 transporting any individual who is sick, injured, or otherwise incapacitated who  
 17 may require immediate stabilization or continued medical response and intervention  
 18 during transit or upon arrival at the patient's destination to safeguard the patient's  
 19 life or physical well-being;
- 20 (4)~~(2)~~ "Ambulance provider" means any individual or private or public organization,  
 21 except the United States government, who is licensed by the board to provide  
 22 medical ~~transportation~~ services **that may include transport** at either basic life  
 23 support level or advanced life support level and who may have a vehicle or vehicles,  
 24 including ground vehicles, helicopters, or fixed-wing aircraft to provide such  
 25 transportation. An ambulance provider may be licensed as **a Class I, II, III, or IV**  
 26 **ground ambulance provider, a Class VI medical first response provider, a Class**  
 27 **VII air ambulance provider, or a Class VIII event medicine provider**~~an air~~

2 ~~ambulance provider, or as a Class III ground ambulance provider];~~

3 ~~(5)~~~~(3)~~ "Board" means the Kentucky Board of Emergency Medical Services;

4 **(6) "Community paramedic" or "CP" means an advanced practice paramedic**  
5 **certified under this chapter as a CP;**

6 ~~(7)~~~~(4)~~ "Emergency medical facility" means a hospital or any other institution  
7 licensed by the Cabinet for Health and Family Services that furnishes emergency  
8 medical services;

9 **(8) "Emergency medical responder" or "EMR" means a person certified under this**  
10 **chapter as an EMR or EMR instructor;**

11 ~~(9)~~~~(5)~~ "Emergency medical services" **or "EMS"** means the services utilized in  
12 providing care for the perceived individual need for immediate medical care to  
13 protect against loss of life, or aggravation of physiological or psychological illness  
14 or injury;

15 **(10) "Emergency medical services educator" or "EMS educator" means a person**  
16 **who is certified and licensed by the board under this chapter as a Level I, II, or**  
17 **III EMS educator to provide emergency medical services education and training**  
18 **with the scope of practice established by the board through administrative**  
19 **regulations;**

20 ~~(11)~~~~(6)~~ "Emergency Medical Services for Children Program" or "EMSC Program"  
21 means the program established under this chapter;

22 **(12) "Emergency medical services medical director" means a physician licensed in**  
23 **Kentucky and certified by the board under this chapter who is employed by, under**  
24 **contract to, or has volunteered to provide supervision for a paramedic or an**  
25 **ambulance service, or both;**

27 **(a)** Persons~~[, certified or licensed, and]~~ trained to provide emergency medical

1 services and certified or licensed by the board under this chapter as an

 8 care delivery that responds to the needs of acutely sick and injured adults and  
 9 children, and includes community education and prevention programs, mobile  
 10 integrated healthcare programs, centralized access and emergency medical  
 11 dispatch, communications networks, trained emergency medical services personnel,  
 12 medical first response, ground and air ambulance services, trauma care systems,  
 13 mass casualty management, medical direction, and quality control and system  
 14 evaluation procedures;

 16 ~~[person or ]~~organization licensed by the board under this chapter to provide~~[which~~

 19 training in-house for its own employees or volunteers;

23 **(17) "Executive director" means the executive director of the Kentucky Board of**  
 24 **Emergency Medical Services;**

25 ~~[(11) "First responder" means a person certified under this chapter as a first responder or~~  
 26 ~~first responder instructor;~~

27 ~~(12) "Emergency medical services medical director" means a physician licensed in~~

1 Kentucky who is employed by, under contract to, or has volunteered to provide  
 2 supervision for a paramedic or an ambulance service, or both;]

3 (18) "Mobile integrated healthcare" or "MIH" means a program licensed by the  
 4 board under this chapter to provide services including evaluation, advice, and  
 5 medical care for the purpose of preventing or improving a particular medical  
 6 condition outside of a hospital setting to eligible patients who do not require or  
 7 request emergency medical transportation;

8 (19) "Mobile integrated healthcare program medical director" or "MIH program  
 9 medical director" means a physician licensed in Kentucky and certified by the  
 10 board under this chapter who is employed by, under contract to, or has  
 11 volunteered to provide supervision for a licensed MIH program;

12 (20)~~[(13)]~~ "Paramedic" means a person who is involved in the delivery of medical  
 13 services and is licensed under this chapter;

14 ~~[(14) "Paramedic course coordinator" means a person certified under this chapter to~~  
 15 ~~coordinate a paramedic course. A paramedic course coordinator shall not practice as~~  
 16 ~~a paramedic unless they are also licensed as a paramedic;]~~

17 (21)~~[(15)]~~ "Paramedic preceptor" means a licensed paramedic who supervises a  
 18 paramedic student during the field portion of the student's training;

19 (22)~~[(16)]~~ "Prehospital care" means the provision of emergency medical services, **mobile**  
 20 **integrated healthcare,** or transportation by trained and certified or licensed  
 21 emergency medical services personnel at the scene or while transporting sick or  
 22 injured persons to a hospital or other emergency medical facility; and

23 (23)~~[(17)]~~ "Trauma" means a single or multisystem life-threatening or limb-threatening  
 24 injury requiring immediate medical or surgical intervention or treatment to prevent  
 25 death or permanent disability.

26 ➔Section 2. KRS 311A.015 is amended to read as follows:

27 (1) The Kentucky Board of Emergency Medical Services is created and shall be

1 attached to the Kentucky Community and Technical College System.

2 (2) The board shall consist of eighteen (18) members who are residents of Kentucky  
3 **and** appointed by the Governor in conjunction with recognized state emergency  
4 medical services related organizations. Membership shall be made up of the  
5 following:

6 (a) One (1) paramedic who works for a government agency but is not serving in  
7 an educational, management, or supervisory capacity;

8 (b) One (1) emergency medical technician~~[basic]~~ **or advanced emergency**  
9 **medical technician** who works for a government agency but is not serving in  
10 an educational, management, or supervisory capacity;

11 (c) One (1) **emergency medical**~~[first]~~ responder who is not serving in an  
12 educational, management, or supervisory capacity;

13 (d) One (1) physician licensed in Kentucky having a primary practice in the  
14 delivery of emergency medical care selected from a list of three (3) physicians  
15 submitted by the Kentucky Medical Association;

16 (e) One (1) physician licensed in Kentucky serving as medical director of an  
17 advanced life support ambulance service selected from a list of three (3)  
18 physicians submitted by the Kentucky Medical Association;

19 (f) One (1) physician licensed in Kentucky who routinely is involved in the  
20 emergency care of ill and injured children selected from a list of three (3)  
21 physicians submitted by the Kentucky Medical Association;

22 (g) One (1) trauma surgeon licensed in Kentucky selected from a list of three (3)  
23 physicians submitted by the Kentucky Medical Association;

24 (h) One (1) citizen having no involvement in the delivery of medical or  
25 emergency services;

26 (i) One (1) emergency medical services educator certified by the board;

27 (j) One (1) mayor of a city that operates, either directly or through contract

- 1 services, a licensed Class I ground ambulance service;
- 2 (k) One (1) county judge/executive from a county that operates, whether directly  
3 or through contract services, a licensed Class I ground ambulance service;
- 4 (l) One (1) volunteer-staffed, licensed Class I ground ambulance service  
5 administrator who is a certified emergency medical technician or a licensed  
6 paramedic;
- 7 (m) One (1) fire-service-based, licensed Class I ground ambulance service  
8 administrator who is a certified emergency medical technician or a licensed  
9 paramedic;
- 10 (n) One (1) licensed air ambulance service administrator or paramedic for a  
11 licensed air ambulance service headquartered in Kentucky;
- 12 (o) One (1) private licensed Class ~~I+I~~ ground ambulance service administrator  
13 who is a certified emergency medical technician or a licensed paramedic who  
14 is a resident of Kentucky;
- 15 (p) One (1) hospital administrator selected from a list of five (5) nominees  
16 submitted by the Kentucky Hospital Association;
- 17 (q) One (1) basic life support, licensed Class I government-operated ground  
18 ambulance service administrator who is a certified emergency medical  
19 technician or a licensed paramedic; and
- 20 (r) One (1) advanced life support, government-operated ambulance service  
21 administrator who is a certified emergency medical technician or a licensed  
22 paramedic.
- 23 (3) **Members shall serve for a term of four (4) years, may be reappointed, and**~~no~~  
24 ~~board member~~ shall serve **no** more than two (2) consecutive terms. A member  
25 appointed to a partial term vacancy exceeding two (2) years shall be deemed to have  
26 served a full term. A former member may be reappointed following an absence of **at**  
27 **least** one (1) term.

- 1 (4) The board shall ~~annually~~:
- 2 (a) Meet at least six (6) times a year; **and**
- 3 (b) At the first meeting of the board after September 1 **of each year**, elect a chair
- 4 and vice chair by majority vote of the members present~~;~~ and~~;~~
- 5 ~~(c)~~ set a schedule of six (6) regular meetings for the next twelve (12) month
- 6 period.
- 7 (5) The board shall adopt a quorum and rules of procedure by administrative regulation.
- 8 (6) (a) A member of the board who misses three (3) regular meetings in **a twelve (12)**
- 9 **month period**~~one (1) year~~ shall be deemed to have resigned from the board
- 10 and his or her position shall be deemed vacant.
- 11 (b) The failure of a board member to attend a special or emergency meeting shall
- 12 not result in any penalty.

- 14 ~~and end three hundred sixty five (365) days later or with the third meeting~~
- 15 ~~missed, whichever occurs earlier.~~
- 16 ~~(d)~~ The Governor shall appoint a person of the same class to fill the vacancy
- 17 within ninety (90) days.
- 18 **(d)**~~(e)~~ The person removed under this subsection shall not be reappointed to
- 19 the board for **at least** ten (10) years.
- 20 (7) Members of the board shall be entitled to reimbursement for actual and necessary
- 21 expenses when carrying out official duties of the board in accordance with state
- 22 administrative regulations relating to travel reimbursement.~~[The board shall meet at~~
- 23 ~~least six (6) times each year.]~~
- 24 (8) Annual reports and recommendations from the board shall be sent by September 1
- 25 each year to the Governor, the president of the Kentucky Community and Technical
- 26 College System, and the General Assembly.
- 27 ➔Section 3. KRS 311A.020 is amended to read as follows:

1 (1) The board shall:

2 (a) Exercise all of the administrative functions of the state not regulated by the  
3 Board of Medical Licensure or Cabinet for Health and Family Services in the  
4 regulation of the emergency medical services system and the practice of  
5 emergency medical services~~[first responders, emergency medical technicians,~~  
6 ~~paramedics, ambulance services]~~, and emergency medical services training  
7 institutions, with the exception of employment of personnel as described in  
8 subsections (5) and (6) of this section;

9 (b) Issue any licenses or certifications authorized by this chapter;

10 (c) Oversee the operations and establish the organizational structure of the Office  
11 of the Kentucky Board of Emergency Medical Services, which is created and  
12 shall be attached to the board for administrative purposes. The office shall be  
13 headed by the executive director appointed under paragraph (d) of this  
14 subsection and shall be responsible for:

- 15 1. Personnel and budget matters affecting the board;
- 16 2. Fiscal activities of the board, including grant writing and disbursement  
17 of funds;
- 18 3. Information technology, including the design and maintenance of  
19 databases;
- 20 4. Certification and recertification of emergency medical~~[first]~~ responders;

- 27 9. Certification and recertification of EMS educators~~[paramedic course~~

6 (d) Employ an executive director and deputy executive director and fix the  
7 compensation. The executive director and deputy executive director shall  
8 serve at the pleasure of the board, administer the day-to-day operations of the  
9 Office of the Kentucky Board of Emergency Medical Services, and supervise  
10 all directives of the board. The director and deputy executive director shall  
11 possess a baccalaureate degree and shall have no less than five (5) years of  
12 experience in public administration or in the administration of an emergency  
13 medical services program;

14 (e) Employ or contract with a physician licensed in Kentucky who is board  
15 certified in emergency medicine and fix the compensation. The physician shall  
16 serve at the pleasure of the board and as the medical advisor to the Kentucky  
17 Board of Emergency Medical Services and the staff of the board;

18 (f) Employ or contract with an attorney licensed to practice law in Kentucky and  
19 fix the compensation. The attorney shall serve at the pleasure of the board and  
20 have primary assignment to the board;

21 (g) Employ personnel sufficient to carry out the statutory responsibilities of the  
22 board.

23 1. Personnel assigned to investigate an emergency medical~~[a first]~~  
24 responder program complaint or regulate the emergency medical~~[first]~~  
25 responder programs shall be certified emergency medical~~[first]~~  
26 responders, emergency medical technicians, advanced emergency  
27 medical technicians, or licensed paramedics.

- 1           2. Personnel assigned to investigate an emergency medical technician  
2           program complaint or regulate the emergency medical technician  
3           program shall be certified emergency medical technicians, *advanced*  
4           *emergency medical technicians*, or paramedics.
- 5           3. *Personnel assigned to investigate an advanced emergency medical*  
6           *technician program complaint or regulate the advanced emergency*  
7           *medical technician program shall be certified advanced emergency*  
8           *medical technicians or paramedics*.
- 9           4. Personnel assigned to investigate a paramedic program complaint or  
10           regulate the paramedic program shall be licensed paramedics.
- 11           ~~5.~~<sup>4.</sup> A person who is employed by the board who is licensed or certified by  
12           the board shall retain his or her license or certification if he or she meets  
13           the in-service training requirements and pays the fees specified by  
14           administrative regulation.
- 15           ~~6.~~<sup>5.</sup> A person who is employed by the board may instruct in emergency  
16           medical subjects in which he or she is qualified, with the permission of  
17           the board. All instruction shall be rendered without remuneration other  
18           than his or her state salary and the employee shall be considered as on  
19           state duty when teaching.
- 20           ~~7.~~<sup>6.</sup> A person who is employed by the board may render services for which  
21           the person is qualified at a declared disaster or emergency or in a  
22           situation where trained personnel are not available until those personnel  
23           arrive to take over the patient, or where insufficient trained personnel are  
24           available to handle a specific emergency medical incident. All aid shall  
25           be rendered without remuneration other than the employee's state salary  
26           and the employee shall be considered as on state duty when rendering  
27           aid. In cases specified in this paragraph, the state medical advisor shall

1                   serve as the emergency medical services medical director for the  
2                   employee;

3           (h) Establish committees and subcommittees and the membership thereof.  
4           Members of committees and subcommittees do not need to be members of the  
5           board;

6           (i) Enter into contracts, apply for grants and federal funds, and disburse funds to  
7           local units of government as approved by the General Assembly. All funds  
8           received by the board shall be placed in a trust and agency account in the State  
9           Treasury subject to expenditure by the board;

10          (j) Administer the Emergency Medical Services for Children Program; and

11          (k) Establish minimum curriculum and standards for emergency medical services  
12          training.

13       (2) The board may utilize materials, services, or facilities as may be made available to it  
14       by other state agencies or may contract for materials, services, or facilities.

15       (3) The board may delegate to the executive director, by written order, any function  
16       other than promulgation of an administrative regulation specified in this chapter.

17       (4) Except for securing funding for trauma centers ~~and the implementation of KRS~~  
18       ~~311A.170~~, the board shall not serve as the lead agency relating to the development  
19       or regulation of trauma systems, but shall be a partner with other state agencies in

21       (5) (a) The Kentucky Community and Technical College System shall employ  
22       personnel for the work of the board, and the personnel in the positions  
23       described in this section and all other persons in administrative and  
24       professional positions shall be transferred to the personnel system of the  
25       Kentucky Community and Technical College System on July 12, 2006, in the  
26       appropriate classification to carry out the mission of the board. All employees  
27       transferred under this paragraph shall have all employment records and

9 (b) New employees hired or contracted after July 12, 2006, shall be employed or

11 (6) The board shall appoint a personnel committee consisting of the chair of the board,  
12 one (1) physician member of the board, one (1) ambulance service provider member  
13 of the board, one (1) additional member of the board selected by the chair of the  
14 board, and one (1) representative of the Kentucky Community and Technical  
15 College System administration. The personnel committee shall conduct an annual  
16 job performance review of the executive director, the medical advisor, and the  
17 board attorney that conforms with the personnel standards of the Kentucky  
18 Community and Technical College System and includes a recommendation for or  
19 against continued employment to be presented to the personnel office of the  
20 Kentucky Community and Technical College System.

21 (7) All state general fund moneys appropriated to the board, all federal funds, all  
22 moneys collected by the board, and all equipment owned by the board shall be  
23 transferred to the Kentucky Community and Technical College System on July 1,  
24 2006.

25 (8) The board shall develop a proposed biennial budget for all administrative and  
26 operational functions and duties in conjunction with the Kentucky Community and  
27 Technical College System budget submission process. The Kentucky Community

1 and Technical College System shall not make changes to the budget proposal  
 2 submitted by the board, but may submit written comments on the board's budget  
 3 proposal to the board and other agencies in the budget submission process.

4 ➔Section 4. KRS 311A.025 is amended to read as follows:

5 (1) The board shall, subject to the provisions of this chapter, create levels of  
 6 certification or licensure, as appropriate for individuals providing services under  
 7 this chapter. These may consist of but not be limited to:

8 (a) **Emergency medical services educator, Level I, II, and III**~~First responder~~  
 9 ~~and first responder instructor~~;

10 (b) **Emergency medical responder**;

11 (c) Emergency medical technician **and advanced emergency medical**  
 12 **technician**~~basic, emergency medical technician basic instructor, and~~  
 13 ~~emergency medical technician basic instructor trainer~~;

14 (d)~~(c)~~ Paramedic, **advanced practice** paramedic~~—course coordinator,~~  
 15 ~~paramedic instructor~~, and paramedic preceptor;

 17 or organization licensed or certified by the board;

18 (f) **Mobile integrated healthcare program medical director who supervises a**

22 (i)~~(g)~~ Ground ambulance service, including categories thereof;

3       (2) The board shall promulgate administrative regulations for any certification or  
4       license the board may create. The administrative regulations shall, at a minimum,  
5       address:

6           (a) Requirements for students, if appropriate;

7           (b) Requirements for training;

8           (c) Eligibility for certification or licensure; and

9           (d) Renewal, recertification, and relicensure requirements.

10       (3) The board may authorize a physician licensed to practice in Kentucky to serve as an  
11       emergency medical services medical director if that physician meets the  
12       requirements specified by the board by administrative regulation.

13       ➔Section 5. KRS 311A.030 is amended to read as follows:

14       The board shall promulgate administrative regulations in accordance with KRS Chapter  
15       13A to carry out the functions of this chapter, including but not limited to:

16       (1) Licensing, inspecting, and regulating of ambulance services, mobile integrated  
17       healthcare programs, and medical first-response providers. The administrative  
18       regulations shall address specific requirements for:

19           (a) ~~[Air ambulance providers, which provide basic or advanced life support~~  
20           ~~services;~~

21           ~~(b)~~ Class I ground ambulance providers, which provide basic life support or  
22           advanced life support services to all patients for emergencies or scheduled  
23           ambulance transportation which is medically necessary;

24           ~~(b)~~~~(e)~~ Class II ground ambulance providers, which provide only basic life  
25           support services but do not provide initial response to the general population  
26           with medical emergencies and which are limited to providing scheduled  
27           ambulance transportation which is medically necessary;

1 ~~(c)~~~~(d)~~ Class III ground ambulance providers, which provide mobile intensive  
 2 care services at or above the level of advanced life support to patients with  
 3 critical illnesses or injuries who must be transported between hospitals in  
 4 vehicles with specialized equipment as an extension of hospital-level care;~~f~~

6 (d) Class IV ground ambulance providers, which provide basic life support or  
 7 advanced life support services and transportation for restricted locations  
 8 such as industrial sites and other sites that do not provide services outside a  
 9 designated site;

10 (e) Class V mobile integrated healthcare programs, which do not transport  
 11 patients as a function of the program and which must be operated by or in  
 12 affiliation with a Class I ambulance provider that provides emergency  
 13 medical response in the geographic area~~[Medical first response providers,~~  
 14 ~~which provide prehospital or advanced life support services, but do not~~  
 15 ~~transport patients];~~

16 (f) Class VI medical first response providers, which provide basic or advanced  
 17 life support services, but do not transport patients;

18 (g) Class VII air ambulance providers, which provide basic or advanced life  
 19 support services; and

20 (h) Class VIII event medicine providers, which provide basic or advanced life  
 21 support services, but do not transport patients; and

22 (2) Licensing, inspecting, and regulating of emergency medical services training  
 23 institutions.

24 Nothing in this section shall be construed to change or alter the issuance of certificates of  
 25 need for emergency medical services providers.

26 ➔Section 6. KRS 311A.040 is amended to read as follows:

27 (1) The board may, on petition by an interested party, issue an advisory opinion relating

1 to the applicability to any person, property, or state of facts of a statute in this  
 2 chapter, administrative regulation promulgated by the board, decision, order, or

- 2 (2) (a) Except as provided in subsection (3) of this section, the Commission on Fire  
3 Protection Personnel Standards and Education shall allot on an annual basis a  
4 share of the funds accruing to and appropriated for volunteer fire department  
5 aid to volunteer fire departments in cities of all classes, fire protection districts  
6 organized pursuant to KRS Chapter 75, county districts established under  
7 authority of KRS 67.083, and volunteer fire departments created as nonprofit  
8 corporations pursuant to KRS Chapter 273.
- 9 (b) The commission shall allot eight thousand two hundred fifty dollars (\$8,250),  
10 and beginning on July 1, 2018, the commission shall allot eleven thousand  
11 dollars (\$11,000) annually to each qualifying department.
- 12 (c) Any qualifying department which fails to participate satisfactorily in the  
13 Kentucky fire incident reporting system as described in KRS 304.13-380 shall  
14 forfeit annually five hundred dollars (\$500) of its allotment.
- 15 (d) If two (2) or more qualified volunteer fire departments, as defined in KRS  
16 95A.500 to 95A.560, merge after January 1, 2000, then the allotment shall be  
17 in accordance with the provisions of KRS 95A.500 to 95A.560.
- 18 (e) Administrative regulations for determining qualifications shall be based on the  
19 number of both paid firefighters and volunteer firemen within a volunteer fire  
20 department, the amount of equipment, housing facilities available, and any  
21 other matters or standards that will best effect the purposes of the volunteer  
22 fire department aid law. A qualifying department shall:
- 23 1. Include at least twelve (12) firefighters;
  - 24 2. Have a chief;
  - 25 3. Have at least one (1) operational fire apparatus or one (1) on order; and
  - 26 4. Have at least fifty percent (50%) of its firefighters who have completed  
27 at least one-half (1/2) of one hundred fifty (150) training hours, or as

1 otherwise established by the commission under KRS 95A.240(6),  
2 toward certification within the first six (6) months of the first year of the  
3 department's application for certification, and there shall be a plan to  
4 complete the one hundred fifty (150) training hours, or as otherwise  
5 established by the commission by KRS 95A.240(6), within the second  
6 year.

7 These personnel, equipment, and training requirements shall not be made  
8 more stringent by the promulgation of administrative regulations.

9 (f) No allotment shall exceed the total value of the funds, equipment, lands, and  
10 buildings made available to the local fire units from any source whatever for  
11 the year in which the allotment is made.

12 (g) A portion of the funds provided for above may be used to purchase group or  
13 blanket health insurance and shall be used to purchase workers' compensation  
14 insurance, and the remaining funds shall be distributed as provided in this  
15 section.

16 (3) There shall be allotted two hundred thousand dollars (\$200,000) of the insurance  
17 premium surcharge proceeds accruing to the Firefighters Foundation Program fund  
18 that shall be allocated each fiscal year of the biennium to the firefighters training  
19 center fund, which is hereby created and established, for the purposes of  
20 constructing new or upgrading existing training centers for firefighters. If any  
21 moneys in the training center fund remain uncommitted, unobligated, or  
22 unexpended at the close of the first fiscal year of the biennium, then such moneys  
23 shall be carried forward to the second fiscal year of the biennium, and shall be  
24 reallocated to and for the use of the training center fund, in addition to the second  
25 fiscal year's allocation of two hundred thousand dollars (\$200,000). Prior to funding  
26 any project pursuant to this subsection, a proposed project shall be approved by the  
27 Commission on Fire Protection Personnel Standards and Education as provided in

1 subsection (4) of this section and shall comply with state laws applicable to capital  
2 construction projects.

3 (4) Applications for funding low-interest loans and firefighters' training centers shall be  
4 submitted to the Commission on Fire Protection Personnel Standards and Education  
5 for their recommendation, approval, disapproval, or modification. The commission  
6 shall review applications periodically, and shall, subject to funds available,  
7 recommend which applications shall be funded and at what levels, together with any  
8 terms and conditions the commission deems necessary.

9 (5) Any department or entity eligible for and receiving funding pursuant to this section  
10 shall have a minimum of fifty percent (50%) of its personnel certified as recognized  
11 by the Commission on Fire Protection Personnel Standards and Education.

12 (6) Upon the written request of any department, the Commission on Fire Protection  
13 Personnel Standards and Education shall make available a certified training  
14 program in a county of which such department is located.

15 (7) The amount of reimbursement for any given year for costs incurred by the Kentucky  
16 Community and Technical College System for administering these funds, including  
17 but not limited to the expenses and costs of commission operations, shall be  
18 determined by the commission and shall not exceed five percent (5%) of the total  
19 amount of moneys accruing to the Firefighters Foundation Program fund which are  
20 allotted for the purposes specified in this section during any fiscal year.

21 (8) The commission shall withhold from the general distribution of funds under  
22 subsection (2) of this section an amount which it deems sufficient to reimburse  
23 volunteer fire departments for equipment lost or damaged beyond repair due to  
24 hazardous material incidents.

25 (9) Moneys withheld pursuant to subsection (8) of this section shall be distributed only  
26 under the following terms and conditions:

27 (a) A volunteer fire department has lost or damaged beyond repair items of

- 1 personal protective clothing or equipment due to that equipment having been  
2 lost or damaged as a result of an incident in which a hazardous material (as  
3 defined in any state or federal statute or regulation) was the causative agent of  
4 the loss;
- 5 (b) The volunteer fire department has made application in writing to the  
6 commission for reimbursement in a manner approved by the commission and  
7 the loss and the circumstances thereof have been verified by the commission;
- 8 (c) The loss of or damage to the equipment has not been reimbursed by the person  
9 responsible for the hazardous materials incident or by any other person;
- 10 (d) The commission has determined that the volunteer fire department does not  
11 have the fiscal resources to replace the equipment;
- 12 (e) The commission has determined that the equipment sought to be replaced is  
13 immediately necessary to protect the lives of the volunteer firefighters of the  
14 fire department;
- 15 (f) The fire department has agreed in writing to subrogate all claims for and rights  
16 to reimbursement for the lost or damaged equipment to the Commonwealth to  
17 the extent that the Commonwealth provides reimbursement to the department;  
18 and
- 19 (g) The department has shown to the satisfaction of the commission that it has  
20 made reasonable attempts to secure reimbursement for its losses from the  
21 person responsible for the hazardous materials incident and has been  
22 unsuccessful in the effort.
- 23 (10) If a volunteer fire department has met all of the requirements of subsection (9) of  
24 this section, the commission may authorize a reimbursement of equipment losses  
25 not exceeding ten thousand dollars (\$10,000) or the actual amount of the loss,  
26 whichever is less.
- 27 (11) Moneys which have been withheld during any fiscal year which remain unexpended



1 at the end of the fiscal year shall be distributed in the normal manner required by  
2 subsection (2) of this section during the following fiscal year.

3 (12) No volunteer fire department may receive funding for equipment losses more than  
4 once during any fiscal year.

5 (13) The commission shall make reasonable efforts to secure reimbursement from the  
6 responsible party for any moneys awarded to a fire department pursuant to this  
7 section.

8 (14) There shall be allotted each year of the 1992-93 biennium one million dollars  
9 (\$1,000,000), and each year of the 1994-95, 1996-97, 1998-99, and 2000-01  
10 bienniums one million dollars (\$1,000,000) of the insurance premium surcharge  
11 proceeds accruing to the Firefighters Foundation Program fund for the purpose of  
12 creating a revolving low-interest loan fund, which shall thereafter be self-sufficient  
13 and derive its operating revenues from principal and interest payments. The  
14 commission, in accordance with the procedures in subsection (4) of this section,  
15 may make low-interest loans, and the interest thereon shall not exceed three percent  
16 (3%) annually or the amount needed to sustain operating expenses of the loan fund,  
17 whichever is less, to volunteer fire departments for the purposes of major equipment  
18 purchases and facility construction. Loans shall be made to departments which  
19 achieve the training standards necessary to qualify for volunteer fire department aid  
20 allotted pursuant to subsection (2) of this section, and which do not have other  
21 sources of funds at rates which are favorable given their financial resources. The  
22 proceeds of loan payments shall be returned to the loan fund for the purpose of  
23 providing future loans. If a department does not make scheduled loan payments, the  
24 commission may withhold any grants payable to the department pursuant to  
25 subsection (2) of this section until the department is current on its payments. Money  
26 in the low-interest loan fund shall be used only for the purposes specified in this  
27 subsection. Any funds remaining in the fund at the end of a fiscal year shall be

1 carried forward to the next fiscal year for the purposes of the fund.

2 (15) For fiscal year 2004-2005 and each fiscal year thereafter, there is allotted one  
3 million dollars (\$1,000,000) from the fund established in KRS 95A.220 to be used  
4 by the commission to conduct training-related activities.

5 (16) If funding is available from the fund established in KRS 95A.220, the Commission  
6 on Fire Protection Personnel Standards and Education may implement the  
7 following:

8 (a) A program to prepare emergency service personnel for handling potential  
9 man-made and non-man-made threats. The commission shall work in  
10 conjunction with the state fire marshal and other appropriate agencies and  
11 associations to identify and make maps of gas transmission and hazardous  
12 liquids pipelines in the state;

13 (b) A program to provide and maintain a mobile test facility in each training  
14 region established by the Commission on Fire Protection Personnel Standards  
15 and Education with equipment to administer Comprehensive Physical  
16 Aptitude Tests (CPAT) to ascertain a firefighter's ability to perform the  
17 physical requirements necessary to be an effective and safe firefighter;

18 (c) A program to provide defensive driving training tactics to firefighters. The  
19 commission shall purchase, instruct in the use of, and maintain mobile  
20 equipment in each of the training regions, and fund expenses related to  
21 equipment replacement;

22 (d) A program to annually evaluate equipment adequacy and to provide for annual  
23 physical examinations for instructors, adequate protective clothing and  
24 personal equipment to meet NFPA guidelines, and to establish procedures for  
25 replacing this equipment as needed;

26 (e) A program to establish a rotational expansion and replacement program for  
27 mobile fleet equipment currently used for training and recertification of fire

1 departments;

2 (f) A program to expand and update current emergency medical services~~[EMS]~~,  
3 emergency medical~~[first]~~ responder, emergency medical technician~~[EMT]~~,  
4 advanced emergency medical technician, and paramedic training and  
5 certification instruction; and

6 (g) A program to purchase thermal vision devices to comply with the provisions  
7 of KRS 95A.400 to 95A.440.

22 reregistration of the licensee;
