11			5.	Natural gas processing, fractionation, stabilization, and compressor				
12				station facilities, as well as above-ground pipelines and related facilities;				
13			6.	Railroad yards and railroad tunnel portals;				
14			7.	A drinking water collection, treatment, or storage facility;				
15			8.	A facility used for research, development, design, production, delivery,

3		(b)	"Unmanned aircraft system" means an aircraft that is operated without the		
4			possibility of direct human interaction from within or on the aircraft and		
5			includes everything that is on board or otherwise attached to the aircraft and		
6			all associated elements, including communication links and the components		
7			that control the small unmanned aircraft, that are required for the safe and		
8			efficient operation of the unmanned aircraft in the national airspace system.

10			degree when: [commits the offense of trespass upon key infrastructure assets

12		<u>(a)</u>	He or she knowingly enters or remains unlawfully in or upon real property on		
13			which key infrastructure assets are located [.]; or		
14		(b)	[A person commits the offense of trespass upon key infrastructure assets if		
15			He or she knowingly uses, or retains or authorizes a person to use, an		
16			unmanned aircraft system to fly above real property on which key		
17			infrastructure assets are located with the intent to cause harm or damage to or		
18			conduct surveillance of the key infrastructure asset without the prior consent		
19			of the owner, tenant, or lessee of the real property.

1	(a)	An unmanned aircraft system used by the federal government or by the	
2		Commonwealth, or by a person acting pursuant to a contract with the federal	
3		government or the Commonwealth;	
4	(b)	An unmanned aircraft system used by:	
5		1. The owner of the real property or key infrastructure asset;	
6		2. A person under a valid lease, servitude, right-of-way, right of use,	
7		permit, license, or other right granted by the owner of the real property	
8		or key infrastructure asset; or	
9		3. A third party who is retained or authorized by a person specified in	
10		subparagraph 1. or 2. of this paragraph;	
11	(c)	An unmanned aircraft system used by a law enforcement agency, emergency	
12		medical service agency, hazardous material response team, disaster	
13		management agency, or other emergency management agency for the purpose	
14		of incident command, area reconnaissance, personnel and equipment	
15		deployment monitoring, training, or a related purpose;	
16	(d)	Operation of an unmanned aircraft system by a person or entity for a	
17		commercial purpose in compliance with applicable Federal Aviation	
18		Administration authorization, regulations, or exemptions;

20	(f)	An unmanned aircraft system used by an insurance company or a person	
21		acting on behalf of an insurance company for purposes of underwriting an
