

1 AN ACT relating to the Department for Local Government.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. The following KRS section is repealed:

4 147A.023 Legislative findings -- Department for Local Government to encourage  
5 growth of broadband and information technology in state.

6 ➔Section 2. KRS 147A.021 is amended to read as follows:

- 7 (1) The Department for Local Government shall have the following powers and duties:
- 8 (a) To require any reports from local governments that will enable it adequately to  
9 provide the technical and advisory assistance authorized by this section;
- 10 (b) To encourage, conduct, or participate in training courses in procedures and  
11 practices for the benefit of local officials, and in connection therewith, to  
12 cooperate with associations of public officials, business and professional  
13 organizations, university faculties, or other specialists;
- 14 (c) To request assistance and information, which shall be provided by all  
15 departments, divisions, boards, bureaus, commissions, and other agencies of  
16 state government to enable the Department for Local Government to carry out  
17 its duties under this section;
- 18 (d) At its discretion, to compile and publish annually a report on local  
19 government; and
- 20 (e) To administer the provisions of KRS 65A.010 to 65A.090.
- 21 (2) The Department for Local Government shall coordinate for the Governor the state's  
22 responsibility for, and shall be responsible for liaison with the appropriate state and  
23 federal agencies with respect to, the following programs:
- 24 (a) Demonstration cities and metropolitan development act as amended with the  
25 exception of Title I of the Housing and Community Development Act of 1974  
26 as amended through 1981;
- 27 (b) Farmers Home Administration;

- 1 (c) Veterans Administration Act as amended, as it pertains to housing.
- 2 (3) The Department for Local Government shall provide technical assistance and  
3 information to units of local government, including but not limited to:
- 4 (a) Personnel administration;
- 5 (b) Ordinances and codes;
- 6 (c) Community development;
- 7 (d) Appalachian Regional Development Program;
- 8 (e) Economic Development Administration Program;
- 9 (f) Intergovernmental Personnel Act Program;
- 10 (g) Land and Water Conservation Fund Program;
- 11 (h) Area Development Fund Program;
- 12 (i) Joint Funding Administration Program;
- 13 (j) State clearinghouse for A-95 review;
- 14 (k) The memorandums of agreement with the area development districts to  
15 provide management assistance to local governments; and
- 16 (l) The urban development office.
- 17 (4) The Department for Local Government shall exercise all of the functions of the state  
18 local finance officer provided in KRS Chapters 66, 68, and 131 relating to the  
19 control of funds of counties, cities, and other units of local government.
- 20 (5) Upon request of the Administrative Office of the Courts, the Department for Local  
21 Government shall evaluate the financial condition of any local unit of government  
22 selected to participate in a court facilities construction or renovation project under  
23 KRS 26A.160 and shall certify to the Administrative Office of the Courts the local  
24 unit of government's ability to participate in the project.
