

1 AN ACT relating to county detectives.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 69.360 is amended to read as follows:

4 (1) A county attorney may, as funding allows, employ one (1) or more county  
5 detectives. County detectives ~~in counties containing a consolidated local~~  
6 ~~government]~~ shall have the power of arrest in the county and the right to execute  
7 process statewide. They shall assist the county attorney in all matters pertaining to  
8 his office in the manner he designates and shall assist him in the preparation of all  
9 criminal cases in District Court by investigating the evidence and facts connected  
10 with such cases.

11 (2) A county detective ~~in a county containing a consolidated local government who has~~  
12 ~~the power of arrest in the county and right to execute process statewide, as set out in~~  
13 ~~subsection (1) of this section,]~~ shall be certified in accordance with KRS 15.380 to  
14 KRS 15.404.

15 ~~[(3) A county detective certified in accordance with KRS 15.380 to 15.404 shall have~~  
16 ~~the right to execute civil process statewide.~~

17 ~~(4) A county detective who is not certified in accordance with KRS 15.380 to 15.404~~  
18 ~~shall have the right to serve civil process only in the county in which the county~~  
19 ~~attorney is elected.~~

20 ~~(5) The provisions of subsections (3) and (4) of this section shall not apply to a county~~  
21 ~~detective appointed pursuant to subsections (1) and (2) of this section.]~~

22 ➔Section 2. KRS 15.380 is amended to read as follows:

23 (1) The following officers employed or appointed as full-time, part-time, or auxiliary  
24 officers, whether paid or unpaid, shall be certified:

25 (a) Department of Kentucky State Police officers, but for the commissioner of the  
26 Department of Kentucky State Police;

27 (b) City, county, and urban-county police officers;

- 1 (c) Court security officers and deputy sheriffs, except those identified in KRS  
2 70.045 and 70.263(3);
- 3 (d) State or public university police officers appointed pursuant to KRS 164.950;
- 4 (e) School security officers employed by local boards of education who are  
5 special law enforcement officers appointed under KRS 61.902;
- 6 (f) Airport safety and security officers appointed under KRS 183.880;
- 7 (g) Department of Alcoholic Beverage Control investigators appointed under  
8 KRS 241.090;
- 9 (h) Division of Insurance Fraud Investigation investigators appointed under KRS  
10 304.47-040;
- 11 (i) Fire investigators appointed or employed under KRS 95A.100 or 227.220; and
- 12 (j) County detectives appointed~~[ in a county containing a consolidated local  
13 government with the power of arrest in the county and the right to execute  
14 process statewide]~~ in accordance with KRS 69.360.
- 15 (2) The requirements of KRS 15.380 to 15.404 for certification may apply to all state  
16 peace officers employed pursuant to KRS Chapter 18A and shall, if adopted, be  
17 incorporated by the Personnel Cabinet for job specifications.
- 18 (3) Additional training in excess of the standards set forth in KRS 15.380 to 15.404 for  
19 all peace officers possessing arrest powers who have specialized law enforcement  
20 responsibilities shall be the responsibility of the employing agency.
- 21 (4) The following officers may, upon request of the employing agency, be certified by  
22 the council:
- 23 (a) Deputy coroners;
- 24 (b) Deputy constables;
- 25 (c) Deputy jailers;
- 26 (d) Deputy sheriffs under KRS 70.045 and 70.263(3);
- 27 (e) Officers appointed under KRS 61.360;

- 1 (f) Officers appointed under KRS 61.902, except those who are school security  
2 officers employed by local boards of education;
- 3 (g) Private security officers;
- 4 (h) Employees of a correctional services division created pursuant to KRS  
5 67A.028 and employees of a metropolitan correctional services department  
6 created pursuant to KRS 67B.010 to 67B.080; and
- 7 (i) Investigators employed by the Department of Charitable Gaming in  
8 accordance with KRS 238.510; and
- 9 (j) Commonwealth detectives employed under KRS 69.110 ~~and county~~  
10 ~~detectives employed under KRS 69.360~~.
- 11 (5) The following officers shall be exempted from the certification requirements but  
12 may upon their request be certified by the council:
- 13 (a) Sheriffs;
- 14 (b) Coroners;
- 15 (c) Constables;
- 16 (d) Jailers;
- 17 (e) Kentucky Horse Racing Commission security officers employed under KRS  
18 230.240; and
- 19 (f) Commissioner of the State Police.
- 20 (6) Federal peace officers cannot be certified under KRS 15.380 to 15.404.
