- 3 → Section 1. KRS 160.352 is amended to read as follows:
- 4 (1) For purposes of this section the term "minority" means American Indian; Alaskan
- 5 native; African-American; Hispanic, including persons of Mexican, Puerto Rican,
- 6 Cuban, and Central or South American origin; Pacific islander; or other ethnic
- 7 group underrepresented in a local school district.
- 8 (2) Each board of education shall appoint a superintendent of schools after receiving
- 9 the recommendations of a screening committee. A screening committee shall be
- established within thirty (30) days of a determination by a board of education that a
- vacancy has occurred or will occur in the office of superintendent, except that when
- the board determines a vacancy will not occur before six (6) months from the date
- of determination, the board shall establish a screening committee at least ninety (90)
- days before the first date on which the position may be filled.
- 15 (3) Except as provide in Subsection 4 of this Section, a screening committee shall be
- composed of:
- 17 (a) Two (2) teachers, elected by the teachers in the district;
- 18 (b) One (1) board of education member, appointed by the board chairman;
- 19 (c) One (1) principal, elected by the principals in the district;
- 20 (d) One (1) parent, elected by the presidents of the parent-teacher organizations of
- 21 the schools in the district;
- 22 (e) One (1) classified employee, elected by the classified employees in the
- 23 district; and
- 24 (f) If a minority member is not elected or appointed to a screening committee in
- districts with a minority <u>student</u> population of eight percent (8%) or more, as
- determined by the enrollment on the preceding October 1, the committee

1		minority parent member shall be elected by the parents in an election
2		conducted by the local school board. Parents in the district shall be given
3		adequate notice of the date, time, place, and purpose of the election.
4	(4)	For a school district with a student minority population of fifty percent (50%) or
5		greater, a screening committee shall be composed of:
6		(a) Three (3) teachers, at least one (1) of whom shall be a member of a minority
7		group, elected by the teachers employed in the district;
8		(b) One (1) board of education member, appointed by the board chairman;
9		(c) Two (2) principals, at least one (1) of whom shall be a member of a minority
10		group, elected by the principals of schools in the district;
11		(d) Two (2) parents, at least one (1) of whom shall be a member of a minority
12		group, elected by the presidents of the parent-teacher organizations of the
13		schools in the district; and
14		(e) Two (2) classified employees, at least one (1) of whom shall be a member of
15		a minority group, elected by the classified employees in the district.
16	<u>(5)</u>	Prior to appointing a superintendent of schools, the board of education shall
17		consider the recommendations of the screening committee, but the board shall not
18		be required to appoint a superintendent from the committee's recommendations.
