

1 AN ACT relating to the contracting or reemployment of retired state and local  
2 employees.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 61.590 is amended to read as follows:

5 (1) **(a)** A member or beneficiary eligible to receive retirement benefits under any of  
6 the provisions of KRS 61.510 to 61.705, 78.510 to 78.852, and 16.510 to  
7 16.652 shall have on file at the retirement office on the form prescribed by the  
8 board, a correctly completed notification of retirement, giving his ***or her***  
9 name, address, Social Security number or Kentucky Retirement Systems  
10 member identification number, last day of employment, and other information  
11 the system may require. The form entitled "Notification of Retirement" shall  
12 not be filed more than six (6) months before the member's effective retirement  
13 date; **and**[-]

14 **(b) A member eligible to receive retirement benefits under any of the provisions of**  
15 **KRS 61.510 to 61.705, 78.510 to 78.852, and 16.510 to 16.652 shall certify**  
16 **in writing on the "Notification of Retirement" form or another form**  
17 **prescribed by the board that no prearranged agreement existed prior to the**  
18 **member's retirement between the member and any participating agency in**  
19 **the systems administered by the Kentucky Retirement Systems for the**  
20 **member to return to employment with the participating agency. No**  
21 **retirement benefits shall be paid to the member until the member completes**  
22 **the certification required by this paragraph.**

23 (2) After receipt of the correctly completed form entitled "Notification of Retirement",  
24 the system shall cause to be prepared an estimate of the amounts the member or  
25 beneficiary may expect to receive under the various plans available to the member  
26 or beneficiary. This information shall be recorded on a form entitled "Estimated  
27 Retirement Allowance" and forwarded to the member or beneficiary.

- 1 (3) The member or beneficiary shall file at the retirement office the form entitled  
2 "Estimated Retirement Allowance" after he has checked one (1) payment option of  
3 his choice, signed the document, and had his signature witnessed. A member shall  
4 not have the right to select a different payment option on or after the first day of the  
5 month in which the member receives his or her first retirement allowance or after  
6 the effective date of a deferred retirement option as provided by subsection (6) of  
7 this section. A beneficiary shall not have the right to select a different payment  
8 option after the effective date of the beneficiary's retirement allowance as provided  
9 in subsection (7) of this section.
- 10 (4) A member or beneficiary choosing a monthly payment option shall have on file at  
11 the retirement office his birth certificate or other acceptable evidence of date of  
12 birth. If a survivorship option is chosen, proof of dates of birth of the beneficiary  
13 and member shall be on file at the retirement office.
- 14 (5) (a) The effective date of normal retirement shall be the first month following the  
15 month in which employment from all employers participating in any of the  
16 systems administered by Kentucky Retirement Systems was terminated.
- 17 (b) The effective date of disability retirement shall be the first month following  
18 the month in which the member's last day of paid employment in a regular  
19 full-time position occurred, provided the member files the form entitled  
20 "Estimated Retirement Allowance" no later than six (6) months following the  
21 date the notification of approval for disability retirement benefits is mailed. If  
22 the member fails to file the form entitled "Estimated Retirement Allowance"  
23 within six (6) months of the date the notification of approval for disability  
24 retirement benefits is mailed, then the member's form entitled "Notification of  
25 Retirement" shall be void. The member shall be required to submit a new  
26 form entitled "Notification of Retirement" to apply for disability retirement  
27 and reestablish eligibility for disability retirement benefits.

1 (c) The effective date of early retirement shall be the first month following the  
2 month a correctly completed form entitled "Notification of Retirement" is  
3 filed at the retirement office or a future month designated by the member, if  
4 employment from all employers participating in any of the systems  
5 administered by Kentucky Retirement Systems has been terminated and if the  
6 member files the form entitled "Estimated Retirement Allowance" no later  
7 than six (6) months following termination. If the member fails to file the form  
8 entitled "Estimated Retirement Allowance" within six (6) months following  
9 the effective retirement date of the member, then the member's form entitled  
10 "Notification of Retirement" shall be void and the member shall be required to  
11 submit a new form entitled "Notification of Retirement" to apply for early  
12 retirement.

13 (6) The effective date of a deferred retirement option as provided under KRS 16.576(5)  
14 shall be the month following age sixty-five (65), or the month following written  
15 notification from the member that he wishes to begin receiving retirement  
16 payments. In the event of the death of a member who has deferred his retirement  
17 allowance, the effective date of retirement shall be the month following the  
18 member's death.

19 (7) Notwithstanding the provisions of KRS 16.578 or 61.640, the effective date of a  
20 beneficiary's retirement allowance under normal, early, or disability retirement shall  
21 be as prescribed in subsection (5) or (6) of this section if the member dies before the  
22 first day of the month in which the member would have received his or her first  
23 retirement allowance and his beneficiary becomes eligible for payments under KRS  
24 16.578 or 61.640.

25 ➔Section 2. KRS 61.637 is amended to read as follows:

26 (1) A retired member who is receiving monthly retirement payments under any of the  
27 provisions of KRS 61.510 to 61.705 and 78.510 to 78.852 and who is reemployed

1 as an employee by a participating agency prior to August 1, 1998, shall have his  
2 retirement payments suspended for the duration of reemployment. Monthly  
3 payments shall not be suspended for a retired member who is reemployed if he  
4 anticipates that he will receive less than the maximum permissible earnings as  
5 provided by the Federal Social Security Act in compensation as a result of  
6 reemployment during the calendar year. The payments shall be suspended at the  
7 beginning of the month in which the reemployment occurs.

8 (2) Employer and employee contributions shall be made as provided in KRS 61.510 to  
9 61.705 and 78.510 to 78.852 on the compensation paid during reemployment,  
10 except where monthly payments were not suspended as provided in subsection (1)  
11 of this section or would not increase the retired member's last monthly retirement  
12 allowance by at least one dollar (\$1), and the member shall be credited with  
13 additional service credit.

14 (3) In the month following the termination of reemployment, retirement allowance  
15 payments shall be reinstated under the plan under which the member was receiving  
16 payments prior to reemployment.

17 (4) (a) Notwithstanding the provisions of this section, the payments suspended in  
18 accordance with subsection (1) of this section shall be paid retroactively to the  
19 retired member, or his estate, if he does not receive more than the maximum  
20 permissible earnings as provided by the Federal Social Security Act in  
21 compensation from participating agencies during any calendar year of  
22 reemployment.

23 (b) If the retired member is paid suspended payments retroactively in accordance  
24 with this section, employee contributions deducted during his period of  
25 reemployment, if any, shall be refunded to the retired employee, and no  
26 service credit shall be earned for the period of reemployment.

27 (c) If the retired member is not eligible to be paid suspended payments for his

1 period of reemployment as an employee, his retirement allowance shall be  
2 recomputed under the plan under which the member was receiving payments  
3 prior to reemployment as follows:

- 4 1. The retired member's final compensation shall be recomputed using  
5 creditable compensation for his period of reemployment; however, the  
6 final compensation resulting from the recalculation shall not be less than  
7 that of the member when his retirement allowance was last determined;
- 8 2. If the retired member initially retired on or subsequent to his normal  
9 retirement date, his retirement allowance shall be recomputed by using  
10 the formula in KRS 61.595(1);
- 11 3. If the retired member initially retired prior to his normal retirement date,  
12 his retirement allowance shall be recomputed using the formula in KRS  
13 61.595(2), except that the member's age used in computing benefits shall  
14 be his age at the time of his initial retirement increased by the number of  
15 months of service credit earned for service performed during  
16 reemployment;
- 17 4. The retirement allowance payments resulting from the recomputation  
18 under this subsection shall be payable in the month following the  
19 termination of reemployment in lieu of payments under subparagraph 3.  
20 The member shall not receive less in benefits as a result of the  
21 recomputation than he was receiving prior to reemployment or would  
22 receive as determined under KRS 61.691; and
- 23 5. Any retired member who was reemployed prior to March 26, 1974, shall  
24 begin making contributions to the system in accordance with the  
25 provisions of this section on the first day of the month following March  
26 26, 1974.

27 (5) A retired member, or his estate, shall pay to the retirement fund the total amount of

1 payments which are not suspended in accordance with subsection (1) of this section  
2 if the member received more than the maximum permissible earnings as provided  
3 by the Federal Social Security Act in compensation from participating agencies  
4 during any calendar year of reemployment, except the retired member or his estate  
5 may repay the lesser of the total amount of payments which were not suspended or  
6 fifty cents (\$0.50) of each dollar earned over the maximum permissible earnings  
7 during reemployment if under age sixty-five (65), or one dollar (\$1) for every three  
8 dollars (\$3) earned if over age sixty-five (65).

9 (6) (a) "Reemployment" or "reinstatement" as used in this section shall not include a  
10 retired member who has been ordered reinstated by the Personnel Board under  
11 authority of KRS 18A.095.

12 (b) A retired member who has been ordered reinstated by the Personnel Board  
13 under authority of KRS 18A.095 or by court order or by order of the Human  
14 Rights Commission and accepts employment by an agency participating in the  
15 Kentucky Employees Retirement System or County Employees Retirement  
16 System shall void his retirement by reimbursing the system in the full amount  
17 of his retirement allowance payments received.

18 (7) (a) Effective August 1, 1998, the provisions of subsections (1) to (4) of this  
19 section shall no longer apply to a retired member who is reemployed in a  
20 position covered by the same retirement system from which the member  
21 retired. Reemployed retired members shall be treated as new members upon  
22 reemployment. Any retired member whose reemployment date preceded  
23 August 1, 1998, who does not elect, within sixty (60) days of notification by  
24 the retirement systems, to remain under the provisions of subsections (1) to  
25 (4) of this section shall be deemed to have elected to participate under this  
26 subsection.

27 (b) A retired member whose disability retirement was discontinued pursuant to

1 KRS 61.615 and who is reemployed in one (1) of the systems administered by  
2 the Kentucky Retirement Systems prior to his or her normal retirement date  
3 shall have his or her accounts combined upon termination for determining  
4 eligibility for benefits. If the member is eligible for retirement, the member's  
5 service and creditable compensation earned as a result of his or her  
6 reemployment shall be used in the calculation of benefits, except that the  
7 member's final compensation shall not be less than the final compensation last  
8 used in determining his or her retirement allowance. The member shall not  
9 change beneficiary or payment option designations. This provision shall apply  
10 to members reemployed on or after August 1, 1998.

11 (8) *If a retired member accepts employment or begins serving as a volunteer with an*  
12 *employer participating in the systems administered by Kentucky Retirement*  
13 *Systems within twelve (12) months of his or her retirement date, the*~~[A] retired~~  
14 ~~member [or his employer] shall notify the retirement system [if he has accepted~~  
15 ~~employment or is serving as a volunteer with an employer that participates in the~~  
16 ~~retirement system from which the member retired. The retired member]~~ and the  
17 participating employer shall submit the information required or requested by the  
18 systems to confirm the individual's employment or volunteer status. *The retired*  
19 *member shall not be required to notify the retirement systems regarding any*  
20 *employment or volunteer service with a participating agency that is accepted after*  
21 *twelve (12) months following his or her retirement date.*

22 (9) If the retired member is under a contract *to provide services as an independent*  
23 *contractor or leased employee to an employer participating in the systems*  
24 *administered by Kentucky Retirement Systems within twelve (12) months of his or*  
25 *her retirement date,* the member shall submit a copy of that contract to the  
26 retirement system, and the retirement system shall determine if the member is an  
27 independent contractor *or leased employee* for purposes of retirement benefits. The

1 retired member and the participating employer shall submit the information required  
2 or requested by the systems to confirm the individual's ~~employment or volunteer~~  
3 status **as an independent contractor or leased employee. The retired member shall**  
4 **not be required to notify the retirement systems regarding any services entered**  
5 **into as an independent contractor or leased employee with a participating agency**  
6 **that the employee enters into after twelve (12) months following his or her**  
7 **retirement date.**

8 (10) If a member is receiving a retirement allowance, or has filed the forms required for  
9 a retirement allowance, and is employed within one (1) month of the member's  
10 initial retirement date in a position that is required to participate in the same  
11 retirement system from which the member retired, the member's retirement shall be  
12 voided and the member shall repay to the retirement system all benefits received.  
13 The member shall contribute to the member account established for him prior to his  
14 voided retirement. The retirement allowance for which the member shall be eligible  
15 upon retirement shall be determined by total service and creditable compensation.

16 (11) (a) If a member of the Kentucky Employees Retirement System retires from a  
17 department which participates in more than one (1) retirement system and is  
18 reemployed within one (1) month of his initial retirement date by the same  
19 department in a position participating in another retirement system, the retired  
20 member's retirement allowance shall be suspended for the first month of his  
21 retirement and the member shall repay to the retirement system all benefits  
22 received for the month.

23 (b) A retired member of the County Employees Retirement System who after  
24 initial retirement is hired by the county from which the member retired shall  
25 be considered to have been hired by the same employer.

26 (12) (a) If a hazardous member who retired prior to age fifty-five (55), or a  
27 nonhazardous member who retired prior to age sixty-five (65), is reemployed

1           within six (6) months of the member's termination by the same employer, the  
2           member shall obtain from his previous and current employers a copy of the  
3           job description established by the employers for the position and a statement  
4           of the duties performed by the member for the position from which he retired  
5           and for the position in which he has been reemployed.

6           (b) The job descriptions and statements of duties shall be filed with the retirement  
7           office.

8       (13) If the retirement system determines that the retired member has been employed in a  
9           position with the same principal duties as the position from which the member  
10          retired:

11          (a) The member's retirement allowance shall be suspended during the period that  
12               begins on the month in which the member is reemployed and ends six (6)  
13               months after the member's termination;

14          (b) The retired member shall repay to the retirement system all benefits paid from  
15               systems administered by Kentucky Retirement Systems under reciprocity,  
16               including medical insurance benefits, that the member received after  
17               reemployment began;

18          (c) Upon termination, or subsequent to expiration of the six (6) month period  
19               from the date of termination, the retired member's retirement allowance based  
20               on his initial retirement account shall no longer be suspended and the member  
21               shall receive the amount to which he is entitled, including an increase as  
22               provided by KRS 61.691;

23          (d) Except as provided in subsection (7) of this section, if the position in which a  
24               retired member is employed after initial retirement is a regular full-time  
25               position, the retired member shall contribute to a second member account  
26               established for him in the retirement system. Service credit gained after the  
27               member's date of reemployment shall be credited to the second member

1 account; and

2 (e) Upon termination, the retired member shall be entitled to benefits payable  
3 from his second retirement account.

4 (14) (a) If the retirement system determines that the retired member has not been  
5 reemployed in a position with the same principal duties as the position from  
6 which he retired, the retired member shall continue to receive his retirement  
7 allowance.

8 (b) If the position is a regular full-time position, the member shall contribute to a  
9 second member account in the retirement system.

10 (15) (a) If a retired member is reemployed at least one (1) month after initial  
11 retirement in a different position, or at least six (6) months after initial  
12 retirement in the same position, and prior to normal retirement age, the retired  
13 member shall contribute to a second member account in the retirement system  
14 and continue to receive a retirement allowance from the first member account.

15 (b) Service credit gained after reemployment shall be credited to the second  
16 member account. Upon termination, the retired member shall be entitled to  
17 benefits payable from the second member account.

18 (16) A retired member who is reemployed and contributing to a second member account  
19 shall not be eligible to purchase service credit under any of the provisions of KRS  
20 16.505 to 16.652, 61.510 to 61.705, or 78.510 to 78.852 which he was eligible to  
21 purchase prior to his initial retirement.

22 (17) Notwithstanding any provision of subsections (1) to (7)(a) and (10) to (15) of this  
23 section, the following shall apply to retired members who retired ~~prior to January~~  
24 ~~1, 2019,~~ and who are reemployed by an agency participating in one (1) of the  
25 systems administered by Kentucky Retirement Systems on or after September 1,  
26 2008:

27 (a) Except as provided by paragraphs (c) and (d) of this subsection, if a member is

1 receiving a retirement allowance from one (1) of the systems administered by  
2 Kentucky Retirement Systems, or has filed the forms required to receive a  
3 retirement allowance from one (1) of the systems administered by Kentucky  
4 Retirement Systems, and is employed in a regular full-time position required  
5 to participate in one (1) of the systems administered by Kentucky Retirement  
6 Systems or is employed in a position that is not considered regular full-time  
7 with an agency participating in one (1) of the systems administered by  
8 Kentucky Retirement Systems within three (3) months following the member's  
9 initial retirement date, the member's retirement shall be voided, and the  
10 member shall repay to the retirement system all benefits received, including  
11 any health insurance benefits. If the member is returning to work in a regular  
12 full-time position required to participate in one (1) of the systems  
13 administered by Kentucky Retirement Systems:

- 14 1. The member shall contribute to a member account established for him or  
15 her in one (1) of the systems administered by Kentucky Retirement  
16 Systems, and employer contributions shall be paid on behalf of the  
17 member by the participating employer; and
  - 18 2. Upon subsequent retirement, the member shall be eligible for a  
19 retirement allowance based upon total service and creditable  
20 compensation, including any additional service or creditable  
21 compensation earned after his or her initial retirement was voided;
- 22 (b) Except as provided by paragraphs (c) and (d) of this subsection, if a member is  
23 receiving a retirement allowance from one (1) of the systems administered by  
24 Kentucky Retirement Systems and is employed in a regular full-time position  
25 required to participate in one (1) of the systems administered by Kentucky  
26 Retirement Systems after a three (3) month period following the member's  
27 initial retirement date, the member may continue to receive his or her

1 retirement allowance during the period of reemployment subject to the  
2 following provisions:

3 1. **If a member is reemployed by a participating agency within twelve (12)**  
4 **months of the member's retirement date, the**~~[Both the employee and]~~  
5 participating agency shall certify in writing on a form prescribed by the  
6 board that no prearranged agreement existed between the employee and  
7 agency prior to the employee's retirement for the employee to return to  
8 work with the participating agency. If an elected official is reelected to a  
9 new term of office in the same position and retires following the election  
10 but prior to taking the new term of office, he or she shall be deemed by  
11 the system as having a prearranged agreement under the provisions of  
12 this subparagraph and shall have his or her retirement voided. If the  
13 participating agency ~~fails~~~~[or employer fail]~~ to complete the certification,  
14 the member's retirement shall be voided and the provisions of paragraph  
15 (a) of this subsection shall apply to the member and the employer.  
16 **Employment that is accepted by the retired member after twelve (12)**  
17 **months following the member's retirement date shall not constitute a**  
18 **prearranged agreement under this paragraph;**

19 2. Notwithstanding any other provision of KRS Chapter 16, 61, or 78 to  
20 the contrary, the member shall not contribute to the systems and shall  
21 not earn any additional benefits for any work performed during the  
22 period of reemployment;

23 3. Except as provided by KRS 70.291 to 70.293 and 95.022 and except for  
24 any retiree employed as a school resource officer as defined by KRS  
25 158.441, the employer shall pay employer contributions as specified by  
26 KRS 61.565 and 61.702 on all creditable compensation earned by the  
27 employee during the period of reemployment. The additional

1 contributions paid shall be used to reduce the unfunded actuarial liability  
2 of the systems; and

3 4. Except as provided by KRS 70.291 to 70.293 and 95.022 and except for  
4 any retiree employed as a school resource officer as defined by KRS  
5 158.441, the employer shall be required to reimburse the systems for the  
6 cost of the health insurance premium paid by the systems to provide  
7 coverage for the retiree, not to exceed the cost of the single premium.  
8 Effective July 1, 2015, local school boards shall not be required to pay  
9 the reimbursement required by this subparagraph for retirees employed  
10 by the board for eighty (80) days or less during the fiscal year;

11 (c) If a member is receiving a retirement allowance from the State Police  
12 Retirement System or from hazardous duty retirement coverage with the  
13 Kentucky Employees Retirement System or the County Employees Retirement  
14 System, or has filed the forms required to receive a retirement allowance from  
15 the State Police Retirement System or from hazardous duty retirement  
16 coverage with the Kentucky Employees Retirement System or the County  
17 Employees Retirement System, and is employed in a regular full-time position  
18 required to participate in the State Police Retirement System or in a hazardous  
19 duty position with the Kentucky Employees Retirement System or the County  
20 Employees Retirement System within one (1) month following the member's  
21 initial retirement date, the member's retirement shall be voided, and the  
22 member shall repay to the retirement system all benefits received, including  
23 any health insurance benefits. If the member is returning to work in a regular  
24 full-time position required to participate in one (1) of the systems  
25 administered by Kentucky Retirement Systems:

26 1. The member shall contribute to a member account established for him or  
27 her in one (1) of the systems administered by Kentucky Retirement

1 Systems, and employer contributions shall be paid on behalf of the  
2 member by the participating employer; and

3 2. Upon subsequent retirement, the member shall be eligible for a  
4 retirement allowance based upon total service and creditable  
5 compensation, including any additional service or creditable  
6 compensation earned after his or her initial retirement was voided;

7 (d) If a member is receiving a retirement allowance from the State Police  
8 Retirement System or from hazardous duty retirement coverage with the  
9 Kentucky Employees Retirement System or the County Employees Retirement  
10 System and is employed in a regular full-time position required to participate  
11 in the State Police Retirement System or in a hazardous duty position with the  
12 Kentucky Employees Retirement System or the County Employees Retirement  
13 System after a one (1) month period following the member's initial retirement  
14 date, the member may continue to receive his or her retirement allowance  
15 during the period of reemployment subject to the following provisions:

16 1. **If a member is reemployed by a participating agency within twelve (12)**  
17 **months of the member's retirement date the**~~[Both the employee and]~~  
18 participating agency shall certify in writing on a form prescribed by the  
19 board that no prearranged agreement existed between the employee and  
20 agency prior to the employee's retirement for the employee to return to  
21 work with the participating agency. If an elected official is reelected to a  
22 new term of office in the same position and retires following the election  
23 but prior to taking the new term of office, he or she shall be deemed by  
24 the system as having a prearranged agreement under the provisions of  
25 this subparagraph and shall have his or her retirement voided. If the  
26 participating agency **fails**~~[or employer fail]~~ to complete the certification,  
27 the member's retirement shall be voided and the provisions of paragraph

1 (c) of this subsection shall apply to the member and the employer.  
2 **Employment that is accepted by the retired member after twelve (12)**  
3 **months following the member's retirement date shall not constitute a**  
4 **prearranged agreement under this paragraph;**

5 2. Notwithstanding any other provision of KRS Chapter 16, 61, or 78 to  
6 the contrary, the member shall not contribute to the systems and shall  
7 not earn any additional benefits for any work performed during the  
8 period of reemployment;

9 3. Except as provided by KRS 70.291 to 70.293 and 95.022 and except for  
10 any retiree employed as a school resource officer as defined by KRS  
11 158.441, the employer shall pay employer contributions as specified by  
12 KRS 61.565 and 61.702 on all creditable compensation earned by the  
13 employee during the period of reemployment. The additional  
14 contributions paid shall be used to reduce the unfunded actuarial liability  
15 of the systems;~~and~~

16 4. Except as provided by KRS 70.291 to 70.293 and 95.022 and except for  
17 any retiree employed as a school resource officer as defined by KRS  
18 158.441, the employer shall be required to reimburse the systems for the  
19 cost of the health insurance premium paid by the systems to provide  
20 coverage for the retiree, not to exceed the cost of the single premium;

21 (e) Notwithstanding paragraphs (a) to (d) of this subsection, a retired member  
22 who qualifies as a volunteer for an employer participating in one (1) of the  
23 systems administered by Kentucky Retirement Systems and who is receiving  
24 reimbursement of actual expenses, a nominal fee for his or her volunteer  
25 services, or both, shall not be considered an employee of the participating  
26 employer and shall not be subject to paragraphs (a) to (d) of this subsection if:

27 1. Prior to the retired member's most recent retirement date, he or she did

- 1 not receive creditable compensation from the participating employer in  
2 which the retired member is performing volunteer services;
- 3 2. Any reimbursement or nominal fee received prior to the retired  
4 member's most recent retirement date has not been credited as creditable  
5 compensation to the member's account or utilized in the calculation of  
6 the retired member's benefits;
- 7 3. The retired member has not purchased or received service credit under  
8 any of the provisions of KRS 61.510 to 61.705 or 78.510 to 78.852 for  
9 service with the participating employer for which the retired member is  
10 performing volunteer services; and
- 11 4. Other than the status of volunteer, the retired member does not become  
12 an employee, leased employee, or independent contractor of the  
13 employer for which he or she is performing volunteer services for a  
14 period of at least twenty-four (24) months following the retired  
15 member's most recent retirement date.

16 If a retired member, who provided volunteer services with a participating  
17 employer under this paragraph violates any provision of this paragraph, then  
18 he or she shall be deemed an employee of the participating employer as of the  
19 date he or she began providing volunteer services and both the retired member
