10	WHEREAS, WIOA established the Eligible Training Provider process to help
11	support and ensure customer choice, performance accountability, and continuous
12	improvement; and
13	WHEREAS, participants in need of training services to enhance job readiness or
14	career pathways may access career training through a list of state-approved training
15	providers and their state-approved training programs; and
16	WHEREAS, only providers that a state determines to be eligible may receive
17	training funds under WIOA; and
18	WHEREAS, the Commonwealth has a one stop portal for participants to find
19	training opportunities through training providers; and
20	WHEREAS, the standards to approve training providers should be consistent with
21	WIOA requirements; and
22	WHEREAS, performance history, including graduation and job placement rates,
23	should be available to participants in order to choose appropriate, successful training
24	programs;

The General Assembly urges the Education and Workforce 2 Development Cabinet to: 3 (1) Establish reasonable, consistent standards for graduation and placement rates 4 for training providers in compliance with the requirements of the Workforce Innovation 5 and Opportunity Act before approval is given to a provider to be included on the 6 Kentucky Eligible Training Provider List; and 7 (2) Post all graduation and job placement rates of the eligible training providers 8 included on that list on the Cabinet's Web site by July 1, 2019, and annually thereafter, so 9 that the information is available to all participants of all educational programs and the 10 general public. 11 → Section 2. The Clerk of the House of Representatives shall send a copy of this 12 Resolution and notification of its adoption to Governor Matthew G. Bevin, the secretary 13 of the Education and Workforce Development Cabinet, and the Kentucky Workforce 14 Innovation Board.
