

1 A RESOLUTION commending Taiwan for its relations with the United States.

2 WHEREAS, Taiwan and the United States are longstanding allies who both deeply
3 cherish the common values of freedom, democracy, human rights, and the rule of law;
4 and

5 WHEREAS, in the year 2016, Taiwan held its sixth direct presidential election and
6 again demonstrated the strength and vitality of its democratic system, paving the way for
7 Taiwan as a beacon of democracy in Asia and beyond. Tsai Ing-wen was elected as the
8 14th President of Taiwan, becoming the first female president in the country's history, and
9 along with her Vice President Chen Chien-jen, she hopes to continue to build the
10 country's already rich tradition of economic vitality, cultural growth, and innovation; and

11 WHEREAS, Taiwan serves the best interests of the Asia-Pacific region in the
12 continuation of stability and growth; and

13 WHEREAS, Taiwan and mainland China have signed more than 20 agreements in
14 the past decade. United States businesses can collaborate with innovative Taiwanese
15 companies in Taiwan's comprehensive protection of intellectual properties right, and then
16 use Taiwan as a springboard for entering mainland China and other key Asian markets;
17 and

18 WHEREAS, since 1982, the Commonwealth of Kentucky and Taiwan have enjoyed
19 long, cordial, and mutually beneficial sister-state relations, a friendship that continues to
20 strengthen with each passing year; and

21 WHEREAS, Taiwan is the United States' ninth largest trading partner, and the
22 United States is Taiwan's second largest trading partner. In 2016, Kentucky's exports to
23 Taiwan reached \$174.1 million; Taiwan is Kentucky's seventh largest export market in
24 Asia; and

25 WHEREAS, the designation of Taiwan into the United States' Visa Waiver
26 Program is a significant step to draw travelers from Taiwan choosing the United States as
27 their destination for trade, investment, and sightseeing; and

1 WHEREAS, the Taiwan Relations Act, signed by the United States Congress 40
2 years ago in 1979, and the Taiwan Travel Act, signed in 2018, continue to encourage and
3 support Taiwan-U.S. relations; and

4 WHEREAS, by working together with Taiwan, Kentucky welcomes all
5 opportunities for an even closer economic partnership; and

6 WHEREAS, the Republic of China (Taiwan) Agricultural and Trade Mission of
7 2015 signed memorandums of understanding with Kentucky to purchase soybeans and
8 corn in 2016 and 2017; and

9 WHEREAS, Taiwan is an active member of the international community with a
10 long history of commitment to international health and humanitarian aid as well as
11 environmental protection; and

12 WHEREAS, the Taiwan Travel Act is an act of the United States Congress, passed
13 on February 28, 2018, and signed into law on March 16, 2018, to encourage visits
14 between the United States and Taiwan at all levels. The Taiwan Travel Act was a follow-
15 up to the Taiwan Relations Act, signed on April 10, 1979, upon its 40th anniversary;

16 NOW, THEREFORE,

17 ***Be it resolved by the House of Representatives of the General Assembly of the***
18 ***Commonwealth of Kentucky:***

19 ➔Section 1. The members of the House of Representatives commend and support
20 the democratization efforts of Taiwan and the nation's meaningful participation in the
21 World Health Organization, the International Civil Aviation Organization, and the UN
22 Framework Convention on Climate Change, as well as other international organizations
23 such as the International Criminal Police Organization, and extend their most sincere best
24 wishes for continued cooperation and success.
