1	A RESOLUTION encouraging the Tennessee Valley Authority board of directors to
2	delay its consideration of and voting on closing the Paradise Fossil Plant Unit 3 in
3	Muhlenberg County.
4	WHEREAS, the first commercial coal mine in Kentucky opened near Paradise,
5	Kentucky in 1820; and
6	WHEREAS, the Tennessee Valley Authority (TVA) was created as a federally
7	owned corporation in 1933 to provide for a national defense, improve navigation and
8	flood control, and create electricity generation, fertilizer manufacturing, and economic
9	development in the Tennessee Valley area which was hit hard by the Great Depression;
10	and
11	WHEREAS, in the early 1960's, TVA built a power plant, opening two units, in
12	Paradise, Kentucky, using abundant, local coal and water from the Green River; and
13	WHEREAS, in 1970, TVA put the Paradise Fossil Plant (PAF) Unit 3 online; and
14	WHEREAS, as of 2009, the coal industry paid 25% of total wages in Muhlenberg
15	County, and coal jobs have since declined more than 50%; and
16	WHEREAS, 131 jobs remain at the Paradise Fossil Plant (PAF) Unit 3, and the
17	mined coal that fuels PAF Unit 3 provides jobs for approximately 135 people; and
18	WHEREAS, in November 2018, TVA released an environmental assessment about
19	the potential retirement of PAF Unit 3 that found only "minor direct adverse economic
20	impacts"; and
21	WHEREAS, PAF Unit 3 is still one of the largest employers in Muhlenberg
22	County; and the indirect impact of closing PAF Unit 3 in terms of economic stability and
23	energy reliability is indeterminable; and
24	WHEREAS, having coal as part of the energy portfolio for baseload electric
25	generation is critical to ensure the reliability of the electric grid, which is a policy issue
26	being considered as part of maintaining the national defense of the United States; and
27	WHEREAS, the TVA board of directors statutorily shall be composed of nine (9)

- 1 members appointed by the President of the United States with the advice and consent of
- 2 the United States Senate; the current board consists of only seven (7) board members; and
- WHEREAS, in November 2018, the TVA President and Chief Executive Officer,
- 4 William D. Johnson announced he will retire after a successor is named as part of an
- 5 active candidate search;
- 6 NOW, THEREFORE,
- 7 Be it resolved by the House of Representatives of the General Assembly of the
- 8 Commonwealth of Kentucky:
- 9 → Section 1. The House of Representatives urges the Tennessee Valley Authority
- board of directors to delay its consideration of and voting on closing the Paradise Fossil
- 11 Plant Unit 3 in Muhlenberg County until the TVA board membership is fully appointed
- and a new TVA President and Chief Executive Officer has been retained.
- → Section 2. The Clerk of the House of Representatives is directed to provide a
- copy of this Resolution and notification of its adoption to all current TVA board members
- and Representative Melinda Gibbons Prunty.
