12	to his beloved hometown. He served as Mayor Pro Tem and Mayor of Owensboro, as the
13	president of the Owensboro-Daviess County Chamber of Commerce, on the Owensboro-
14	Daviess County Airport Board of Directors, as vice chair of the Owensboro Museum of
15	Fine Arts, and was the co-founder and chair of the Community Foundation of
16	Owensboro-Daviess County; and
17	WHEREAS, C. Waitman Taylor was instrumental in building the current City Hall
18	and Owensboro Riverport Authority, and he championed many projects that stand today
19	as testaments to his hard work and dedication to the people of Owensboro; and
20	WHEREAS, C. Waitman Taylor was a member of First Presbyterian Church, where
21	he served as an elder, deacon, and Sunday school teacher; and
22	WHEREAS, C. Waitman Taylor, legendary public servant; Owensboro treasure;
23	and beloved husband, father, grandfather, and brother, departed this earthly life and
24	entered into the kingdom of Heaven on January 25, 2019, leaving his family, friends, and
25	all those whose lives he touched in solemn mourning; and
