

1 AN ACT relating to the Work Ready Kentucky Scholarship and making an  
2 appropriation therefor.

3 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

4 ➔SECTION 1. A NEW SECTION OF KRS 164.740 TO 164.7891 IS CREATED  
5 TO READ AS FOLLOWS:

6 *(1) The General Assembly hereby establishes the Work Ready Kentucky Scholarship*  
7 *Program to ensure that all Kentuckians who have not yet earned a postsecondary*  
8 *degree have affordable access to an industry-recognized certificate, diploma, or*  
9 *associate of applied science degree.*

10 *(2) For purposes of this section:*

11 *(a) "Academic term" means a fall, spring, or summer academic term or other*  
12 *time period specified in an administrative regulation promulgated by the*  
13 *authority;*

14 *(b) "Academic year" means July 1 through June 30 of each year;*

15 *(c) "Approved dual credit course" means a dual credit course developed in*  
16 *accordance with KRS 164.098 that is a career and technical education*  
17 *course within a career pathway approved by the Kentucky Department of*  
18 *Education that leads to an industry-recognized credential;*

19 *(d) "Dual credit tuition rate ceiling" means the same as defined in 164.786;*

20 *(e) "Eligible institution" means an institution defined in KRS 164.001 that:*

21 *1. Actively participates in the federal Pell Grant program;*

22 *2. Executes a contract with the authority on terms the authority deems*  
23 *necessary or appropriate for the administration of its programs;*

24 *3. Charges no more than the dual credit tuition rate ceiling per credit*  
25 *hour, including any additional fees, for any dual credit course it offers*  
26 *to any Kentucky public or nonpublic high school student; and*

27 *4. Is a:*

- 1                    a. Kentucky Community and Technical College System institution;  
2                    b. Kentucky public university; or  
3                    c. College, university, or vocational-technical school that is  
4                    accredited by a recognized regional or national accrediting body  
5                    and licensed to operate at a site in Kentucky.
- 6                    (f) "Eligible program of study" means a program approved by the authority  
7                    that leads to an industry-recognized certificate, diploma, or associate of  
8                    applied science degree in one (1) of Kentucky's top five (5) high-demand  
9                    workforce sectors identified by the Kentucky Workforce Innovation Board  
10                   and the Education and Workforce Development Cabinet;
- 11                   (g) "Fees" means mandatory fees charged by an eligible institution for  
12                   enrollment in a course, including but not limited to online course fees, lab  
13                   fees, and administrative fees. "Fees" does not include tools, books, or other  
14                   instructional materials that may be required for a course; and
- 15                   (h) "Tuition" means the in-state tuition charged to all students as a condition  
16                   of enrollment in an eligible institution.
- 17                   (3) In consultation with the Education and Workforce Development Cabinet, the  
18                   Kentucky Department of Education, and the Council on Postsecondary  
19                   Education, the Kentucky Higher Education Assistance Authority shall administer  
20                   the Work Ready Kentucky Scholarship Program and promulgate administrative  
21                   regulations in accordance with KRS Chapter 13A as may be needed for the  
22                   administration of the scholarship.
- 23                   (4) An eligible high school student shall:
- 24                   (a) Be a Kentucky resident;  
25                   (b) Be enrolled in a Kentucky high school;  
26                   (c) Be enrolled, or accepted for enrollment, in an approved dual credit course  
27                   at an eligible institution; and

1        (d) Complete and submit a Work Ready Kentucky Scholarship dual credit  
2                    application to the authority.

3        (5) An eligible workforce student shall:

4            (a) Be a citizen or permanent resident of the United States;

5            (b) Be a Kentucky resident as determined by the eligible institution in  
6                    accordance with criteria established by the Council on Postsecondary  
7                    Education for the purposes of admission and tuition assessment;

8            (c) Have earned a high school diploma or a High School Equivalency Diploma  
9                    or be enrolled in a High School Equivalency Diploma program;

10          (d) Not have earned an associate's degree or higher level postsecondary degree;

11          (e) Complete the Free Application for Federal Student Aid for the academic  
12                    year in which the scholarship is awarded;

13          (f) Complete and submit a Work Ready Kentucky Scholarship application to  
14                    the authority;

15          (g) Enroll in an eligible program of study at an eligible institution;

16          (h) Not be enrolled in an ineligible degree program, such as a bachelor or  
17                    unapproved associate program, at any postsecondary institution;

18          (i) Following the first academic term scholarship funds are received, achieve  
19                    and maintain satisfactory academic progress as determined by the eligible  
20                    institution; and

21          (j) Not be in default on any program under Title IV of the federal act or any  
22                    obligation to the authority under any program administered by the authority  
23                    under KRS 164.740 to 164.7891 or 164.7894, except that ineligibility for this  
24                    reason may be waived by the authority for cause.

25        (6) (a) Beginning with the 2019-2020 academic year, the authority shall award a  
26                    Work Ready Kentucky Scholarship each academic term to any person who  
27                    meets the requirements of this section to the extent funds are available for

1           that purpose.

2           **(b) The scholarship amount awarded to an eligible workforce student for an**  
3           **academic term shall be the amount remaining after subtracting the**  
4           **student's federal and state grants and scholarships from the maximum**  
5           **scholarship amount. The maximum scholarship amount shall be the per**  
6           **credit hour in-state tuition rate at the Kentucky Community and Technical**  
7           **College System multiplied by the number of credit hours in which the**  
8           **student is enrolled and the fees charged to the student. The authority shall**  
9           **promulgate an administrative regulation in accordance with KRS Chapter**  
10           **13A to specify the maximum amount to be awarded for fees, except that for**  
11           **the 2019-2020 academic year the amount awarded for fees shall not exceed**  
12           **four hundred dollars (\$400).**

13           **(c) The scholarship award for an eligible high school student shall be limited to**  
14           **two (2) approved dual credit courses per academic year. The scholarship**  
15           **amount awarded shall be equal to the amount charged by an eligible**  
16           **institution for an approved dual credit course, in accordance with**  
17           **subsection (2)(e)3. of this section.**

18           **(7) An eligible workforce student's eligibility for the scholarship shall terminate**  
19           **upon the earlier of:**

20           **(a) Receiving the scholarship for four (4) academic terms;**

21           **(b) Receiving the scholarship for a total of sixty (60) credit hours; or**

22           **(c) Obtaining an associate's degree.**

23           **(8) The authority shall annually provide a report on the Work Ready Kentucky**  
24           **Scholarship Program, prepared in collaboration with the Office for Education**  
25           **and Workforce Statistics, to the secretary of the Education and Workforce**  
26           **Development Cabinet that includes the following:**

27           **(a) By academic term, academic year, institution, and workforce sector, the**

- 1           number of:
- 2           1. Students served by the scholarship and the total amount disbursed;
- 3                   and
- 4           2. Credits, certificates, diplomas, and associate of applied science degrees
- 5                   earned by students receiving the scholarship.
- 6   (9) The authority shall report Work Ready Kentucky Scholarship program data to
- 7           the Office for Education and Workforce Statistics for analysis of the program's
- 8           success in meeting the goal of increasing skilled workforce participation rates.
- 9   (10) (a) The Work Ready Kentucky Scholarship fund is hereby created as a trust
- 10           fund in the State Treasury to be administered by the authority for the
- 11           purpose of providing scholarships as described in this section.
- 12           (b) The trust fund shall consist of state general fund appropriations, gifts and
- 13           grants from public and private sources, and federal funds. All moneys
- 14           included in the fund shall be appropriated for the purposes set forth in this
- 15           section.
- 16           (c) Any unallotted or unencumbered balances in the trust fund shall be invested
- 17           as provided in KRS 42.500(9). Income earned from the investments shall be
- 18           credited to the trust fund.
- 19           (d) Notwithstanding KRS 45.229, any fund balance at the close of the fiscal
- 20           year shall not lapse but shall be carried forward to the next fiscal year and
- 21           continuously appropriated only for the purposes specified in this section.

22           ➔Section 2. The General Assembly confirms Executive Order 2018-571, dated

23   July 11, 2018, to the extent not otherwise confirmed or superseded by this Act.
