

1 A RESOLUTION honoring Robert J. Storer upon the auspicious occasion of his
2 retirement as the Superintendent of the Walton-Verona School District.

3 WHEREAS, it is appropriate that this honorable body recognize those Kentuckians
4 who have given so selflessly to educate and better the lives of their fellow citizens; and

5 WHEREAS, in so doing, this body commends Robert J. Storer on this day for all he
6 has accomplished on behalf of the students of the Walter-Verona School District and the
7 citizenry of this Commonwealth; and

8 WHEREAS, Robert J. Storer received his bachelor's degree from the University of
9 Kentucky. He then earned both his master's in education and his Rank 1 from Xavier
10 University, before returning to the University of Kentucky for his doctorate in education
11 degree; and

12 WHEREAS, since 1971, Robert J. Storer has built an education career worthy of
13 praise as a teacher, assistant principal, adjunct instructor, state director, instructional
14 supervisor, principal, and superintendent in schools across Kentucky; and

15 WHEREAS, Robert J. Storer has been widely recognized, receiving the Kentucky
16 Superintendent of the Year award from the American Association of School
17 Administrators; the A.D. Albright Award from the Northern Kentucky Chamber of
18 Commerce; and The Robert J. Storer, Individual Contribution to Collaboration Award,
19 from Toyota Motor Manufacturing Corporation, as well as numerous other awards; and

20 WHEREAS, Robert J. Storer has guided the Walton-Verona School District to
21 national regard. Walter-Verona has been named for the past two years as one of the "Best
22 Communities for Music Education" by the Northern American Music Merchants
23 Foundation, recognizing staffing, enrollment, scheduling, facilities, funding, and
24 community support for the arts; and

25 WHEREAS, the members of this body thank Robert J. Storer for his efforts to
26 educate and enrich the lives of citizens here in the Commonwealth, commend him for his
27 years of service, and grant him best wishes as he embarks on this new chapter of his life;
