

1 A RESOLUTION recognizing and honoring the many 4-H members who have
2 traveled to the seat of state government from throughout Kentucky to take part in a
3 multitude of civic, public policy, and educational activities as a part of the Kentucky 4-H:
4 A Capitol Experience.

5 WHEREAS, hundreds of youth in 4-H clubs and the 4-H Youth Development
6 Program are converging on the State Capital to take part in the many activities aimed at
7 enhancing their understanding of the legislative process, state government, and the history
8 of this great Commonwealth; and

9 WHEREAS, during their time here, the 4-H members will have the opportunity to
10 see their government in action, they will visit with legislators, attend committee meetings,
11 and, in turn, help give this General Assembly a greater awareness of the importance of
12 Kentucky's vibrant 4-H program; and

13 WHEREAS, the many 4-H clubs and the 4-H Youth Development Program are
14 sponsored by the cooperative extension programs of the University of Kentucky College
15 of Agriculture, Food, and Environment and Kentucky State University; and

16 WHEREAS, 4-H in Kentucky has a long and rich history beginning in the early
17 1900s when farm youth in the state were given the opportunity to try new practices on a
18 small portion of the family farm; and

19 WHEREAS, the 4-H Youth Development Program sponsors 4-H clubs in both rural
20 and urban areas of Kentucky, reaching almost 230,000 young people from ages 5 to 19;
21 and

22 WHEREAS, 4-H offers diverse programs that include leadership, citizenship,
23 agriculture, family and consumer sciences, healthy lifestyles, communications and
24 expressive arts, environment and natural resources, civic engagement, workforce
25 development, science, engineering, technology, and practical life skills; and

26 WHEREAS, all these programs help contribute to the development of well-rounded
27 youth; and

1 WHEREAS, almost 20,000 adult and teen citizens contribute to the success of the
2 4-H program, volunteering in endeavors aimed at enhancing the skills of these young
3 people; and

4 WHEREAS, the 2018-2019 Kentucky state 4-H officers represent diverse areas of
5 the state: Jonna Woodson, State President, Muhlenberg County; Walter Steely, State Vice
6 President, Webster County; Dylan Gentry, State Secretary, Green County; and Delaney
7 Simpson, State Treasurer, Boyle County;

8 NOW, THEREFORE,

9 *Be it resolved by the Senate of the General Assembly of the Commonwealth of*
10 *Kentucky:*

11 ➔Section 1. The Senate hereby recognizes and commends the hundreds of young
12 people taking part in Kentucky 4-H: A Capitol Experience, the Cooperative Extension
13 Service, the University of Kentucky, Kentucky State University, and the volunteer adults
14 who strive to make 4-H a success.

16 those involved in Kentucky 4-H: A Capitol Experience.
