3	WHEREAS, the National Action Network was founded in 1994 and is a leading
4	civil rights organization with chapters across the United States. Following the spirit and
5	tradition of Dr. Martin Luther King, Jr., the National Action Network promotes a modern
6	civil rights agenda that fights for a single standard for justice, decency, and equal
7	opportunities for all people regardless of race, religion, ethnicity, citizenship, criminal
8	record, economic status, gender, gender expression, and sexuality; and
9	WHEREAS, the Kentucky Chapter of the National Action Network was established
10	in 2014; and
11	WHEREAS, the National Action Network supports criminal justice reform and
12	believes that the right to equal justice under the law should not be conditional or based
13	upon a person's color or economic status. Utilizing principles of non-violent direct action
14	and civil disobedience, the National Action Network has helped level the field and ensure
15	a measure of justice for those who would abuse their status or seek to dispense justice
16	based upon race or other illegal factors; and
17	WHEREAS, the National Action Network supports police accountability, working
18	at the forefront in the fight for accountability and advocating locally and nationally; and
19	WHEREAS, the National Action Network supports crisis intake and victim
20	assistance, leading the fight against police misconduct and other injustice by ensuring that
21	those whose rights are violated are brought to justice; and
22	WHEREAS, the National Action Network supports voting rights, working to ensure
23	that every vote in every community across the nation is actually counted. As Dr. King
24	said in 1965 in Montgomery, Alabama, "The Civil Rights Act of 1964 gave Negroes
25	some part of their rightful dignity, but without the vote it was dignity without strength";
