17	Trust Bank Board of Trustees, Kentucky Medical Association Board of Trustees, Spring
18	View Hospital Board of Trustees where he served as Chairman for numerous years, and
19	the Marion County Board of Health where he served for more than 40 years; and
20	WHEREAS, Dr. Salem George founded several medical and nursing facilities to fit
21	the needs of his community and surrounding area, including the Cedars of Lebanon
