1	A RESOLUTION honoring the Laurel County Health Department for receiving the
2	Small Local Health Department of the Year award from the National Association of
3	County and City Health Officials.
4	WHEREAS, led by Executive Director Mark Hensley, the nationally accredited
5	Laurel County Health Department serves the London, Kentucky area with the mission "to
6	prevent, promote and protect the public health of its citizens by providing quality health
7	education, preventive health care and environmental services"; and
8	WHEREAS, the Laurel County Health Department provides ten essential public
9	health services: monitoring health status to identify and solve community health
10	problems; diagnosing and investigating health problems and health hazards in the
11	community; informing, educating, and empowering people about health issues;
12	mobilizing community partnerships and action to identify and solve health problems;
13	developing policies and plans that support individual and community health efforts;
14	enforcing laws and regulations that protect health and ensure safety; linking people to
15	needed personal health services and assuring the provision of health care when otherwise
16	unavailable; assuring a competent public and personal health care workforce; evaluating
17	effectiveness, accessibility, and quality of personal and population-based health services;
18	and researching for new insights and innovative solutions to health problems; and
19	WHEREAS, the Laurel County Health Department has facilitated private and public
20	partnerships and worked with other health departments to create programs responding to
21	identified needs from a community assessment. The Laurel County Health in Motion
22	Coalition has operated for a decade with representatives from across the community
23	conducting the assessment, helping draft and implement the community health
24	improvement plan and evaluating its effectiveness. This has allowed the partners to share
25	staff, expertise, and funding to strengthen the capacity to provide services; and
26	WHEREAS, the top priorities in the 2018 Community Health Improvement Plan
27	were substance use and chronic disease prevention and management. The department and

its partners successfully applied for \$300,000 to establish collaborations to increase clinical and community linkages, and the resulting initiatives assessed and planned for gaps and opportunities identified in substance use and opioid prevention, treatment, and recovery services. The Laurel County Health Department established a harm reduction program that includes a formal and mobile syringe exchange program operated by the department and by four independent health department jurisdictions. The program offers also HIV and hepatitis C testing, hepatitis A vaccines, condoms, education, peer counseling, and referral sources for treatment and recovery; and WHEREAS, addressing the harms of addiction to the family, the Laurel County Health Department has offered professional trainings on adverse child experiences to build protective health factors to increase community and family resilience, has provided awareness education of neonatal abstinence syndrome, and has partnered with the primary neonatal provider in the area to place a community health worker with the provider to work with addicted pregnant women receiving medication-assisted treatment; and WHEREAS, the Laurel County Health Department has established partnerships to implement chronic disease programs to tackle tobacco use and diabetes, partnered with a local primary care center to address health disparities in low-income pregnant women who smoke or use other tobacco products, and partnered with the Kentucky Department of Public Health Diabetes Program, two federally qualified health centers, and crossjurisdiction health districts to provide a bi-directional secure referral network to connect individuals to accredited diabetes self-management education and support; and WHEREAS, the Laurel County Health Department has received the Local Health Department of the Year award from the National Association of County and City Health Officials. The award, given to just one of the 3,000 health departments competing in the under-100,000 population category, was presented on July 10, 2019, at the association's annual conference in Orlando, Florida. With its many community partnerships and programs, the Laurel County Health Department personified the conference's "Improving UNOFFICIAL COPY 19 SS BR 62
