- 3 WHEREAS, Clyde W. Middleton was born in Cleveland, Ohio, on January 30,
- 4 1928; and
- 5 WHEREAS, a 1951 graduate of the United States Naval Academy, Clyde
- 6 Middleton served his country as a member of the United States Navy and the Naval
- 7 Reserve Advocate General's Corps; and
- 8 WHEREAS, in 1962, Clyde Middleton earned his master's degree from Xavier
- 9 University, and following his graduation he began an extraordinary career in public
- service and conservative advocacy; and
- WHEREAS, in 1967, Clyde Middleton was elected to the Kentucky State Senate.
- He always kept his love of Northern Kentucky and its people close to his heart, and
- focused his attention on legislation that improved the lives of so many of his grateful

- 15 WHEREAS, Clyde Middleton was instrumental in the creation of Northern
- 16 Kentucky University, where he later became a founding father. He also helped to bring
- 17 the Salmon P. Chase College of Law -- where he received his juris doctorate in 1974 -- to

- 19 WHEREAS, Clyde Middleton served in the Kentucky State Senate until 1986.
- 20 During his time as a member of this august body, he served as Minority Caucus chair and
- 21 Minority Whip; and
- WHEREAS, Clyde Middleton went on to serve as Kenton County Judge/Executive
- 23 from 1989 until 1998. For his many achievements, including the purchase and
- 24 development of more than 100 acres that would become Middleton-Mills Road Park, he
- 25 is still beloved in his community, and his many good works continue to touch the lives of
- 26 his fellow Northern Kentuckians; and
