

1 AN ACT relating to medicinal marijuana and making an appropriation therefor.

2 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

3 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 218A IS CREATED TO
4 READ AS FOLLOWS:

5 *For the purposes of Sections 1 to 30 of this Act, unless the context otherwise requires:*

6 *(1) "Bona fide practitioner-patient relationship" means a treatment or consulting*
7 *relationship, during the course of which the practitioner:*

8 *(a) Has completed an assessment of the patient's medical history and current*
9 *medical condition;*

10 *(b) Has consulted with the patient with respect to the possible therapeutic and*
11 *palliative properties of medicinal marijuana;*

12 *(c) Has advised the patient of the possible risks and side effects associated with*
13 *the use of medicinal marijuana; and*

14 *(d) Provides follow-up care and treatment to the patient;*

15 *The relationship may be established via telehealth as defined by KRS 304.17A-*
16 *005;*

17 *(2) "Cannabis business" means a cultivator, dispensary, processor, or a safety*
18 *compliance facility licensed under this chapter;*

19 *(3) "Cannabis business agent" means a principal officer, board member, employee,*
20 *volunteer, or agent of a cannabis business;*

21 *(4) "Cardholder" means:*

22 *(a) A registered qualified patient, designated caregiver, or visiting qualified*
23 *patient who has applied for, obtained, and possesses a valid registry*
24 *identification card issued by the department as required by this chapter; or*

25 *(b) A visiting qualified patient who has obtained and possesses a valid registry*
26 *identification card, or its equivalent, that was issued pursuant to the laws of*
27 *another state, district, territory, commonwealth, insular possession of the*

1 United States, or country recognized by the United States that allows the
2 person to use marijuana for medicinal purposes in the jurisdiction of
3 issuance;

4 (5) "Cultivator" means an entity licensed under this chapter that cultivates, harvests,
5 and delivers raw plant material to another cultivator, dispensary, processor, or
6 safety compliance facility;

7 (6) "Cultivator agent" means a principal officer, board member, employee,
8 volunteer, or agent of a cultivator;

9 (7) "Department" means the Department of Alcoholic Beverage and Cannabis
10 Control or its successor agency;

11 (8) "Designated caregiver" means a person who has registered as such with the
12 department as required by this chapter;

13 (9) "Dispensary" means an entity licensed under this chapter that acquires,
14 possesses, delivers, transfers, transports, sells, supplies, or dispenses medicinal
15 marijuana to cardholders;

16 (10) "Dispensary agent" means a principal officer, board member, employee,
17 volunteer, or agent of a dispensary;

18 (11) "Disqualifying felony offense" means:

19 (a) A felony offense that would classify the person as a violent offender under
20 KRS 439.3401; or

21 (b) A violation of a state or federal controlled substance law that was classified
22 as a felony in the jurisdiction where the person was convicted, except:

23 1. An offense for which the sentence, including any term of probation,
24 incarceration, or supervised release, was completed five (5) or more
25 years earlier; or

26 2. An offense that consisted of conduct for which Sections 1 to 30 of this
27 Act would likely have prevented a conviction, but the conduct either

1 occurred prior to the enactment of Sections 1 to 30 of this Act or was
2 prosecuted by an authority other than the Commonwealth of
3 Kentucky;

4 (12) "Enclosed, locked facility" means:

5 (a) An indoor growing space such as a room, greenhouse, building, or other
6 indoor enclosed area that is maintained and operated by a cultivator and is
7 equipped with locks and other security devices that permit access only by
8 agents of the cultivator, as required by the department; or

9 (b) An outdoor growing space that is maintained and operated by a cultivator
10 and is secured and electronically monitored to permit access only by agents
11 of the cultivator, as required by the department;

12 (13) "Gross receipts" means all amounts received in money, credits, property, or other
13 money's worth in any form, by a cannabis business;

14 (14) "Growth area" means the same as an enclosed, locked facility;

15 (15) "Marijuana," means the same as defined in KRS 218A.010;

16 (16) "Medicinal marijuana" means marijuana as defined in KRS 2108A.010 when
17 cultivated, harvested, processed, produced, transported, dispensed, distributed,
18 sold, possessed, or used in accordance with Sections 1 to 30 of this Act. The term
19 "medicinal marijuana" includes medicinal marijuana products and raw plant
20 material;

21 (17) "Medicinal marijuana accessories" means any equipment, product, or material
22 of any kind which is used, intended for use, or designed for use in the preparing,
23 storing, using, or consuming medicinal marijuana in accordance with Sections 1
24 to 30 of this Act;

25 (18) "Medicinal marijuana product" means any compound, manufacture, salt,
26 derivative, mixture, or preparation of any part of the plant Cannabis sp., its seeds
27 or its resin; or any compound, mixture, or preparation which contains any

1 quantity of these substances when cultivated, harvested, processed, produced,
2 transported, dispensed, distributed, sold, possessed, or used in accordance with
3 Sections 1 to 30 of this Act;

4 (19) "Minor" means a person less than eighteen (18) years of age;

5 (20) "Practitioner" means a physician, dentist, podiatrist, optometrist who is
6 authorized to prescribe controlled substances under KRS 320.240, or an
7 advanced practice registered nurse who is authorized to prescribe controlled
8 substances under KRS 314.042, who is authorized by a state licensing board to
9 provide written certifications pursuant to Section 5 of this Act;

10 (21) "Processor" means an entity licensed under this chapter that acquires raw plant
11 material from a cultivator in order to prepare, trim, manipulate, blend,
12 manufacture, or otherwise modify the raw plant material, and package products
13 containing or derived from the raw plant material for sale to a licensed
14 dispensary;

15 (22) "Processor agent" means a principal officer, board member, employee,
16 volunteer, or agent of a processor;

17 (23) "Qualified patient" means a person who has obtained a written certification from
18 a practitioner with whom he or she has a bona fide practitioner-patient
19 relationship;

20 (24) "Qualifying medical condition" means:

21 (a) A terminal illness as defined in KRS 217.5401;

22 (b) Acquired immune deficiency syndrome;

23 (c) Autism spectrum disorder;

24 (d) Chronic pain;

25 (e) Crohn's disease;

26 (f) Epilepsy or another seizure disorder;

27 (g) Glaucoma;

- 1 (h) Inflammatory bowel disease;
- 2 (i) Intractable spasticity;
- 3 (j) Multiple sclerosis;
- 4 (k) Opioid use disorder;
- 5 (l) Parkinson's disease;
- 6 (m) Positive status for human immunodeficiency virus;
- 7 (n) Post-traumatic stress disorder;
- 8 (o) Any chronic or debilitating disease, any medical condition, or the treatment
- 9 thereof that produces one (1) or more of the following:
- 10 1. Cachexia or wasting syndrome;
- 11 2. Severe, debilitating pain;
- 12 3. Severe nausea;
- 13 4. Seizures; or
- 14 5. Severe and persistent muscle spasms or muscle weakness;
- 15 (p) Any other disease or medical condition approved by the department;
- 16 (q) Any other disease or medical condition that a practitioner, in his or her
- 17 professional judgment, determines to be severe and resistant to conventional
- 18 medication;
- 19 (r) Any other disease or medical condition for which a practitioner, in his or
- 20 her professional judgment, believes a patient may receive therapeutic or
- 21 palliative relief from the use of medicinal marijuana; and
- 22 (s) Any other disease or medical condition for which a patient is admitted into
- 23 a hospice program or residential hospice facility licensed under KRS
- 24 Chapter 216B;
- 25 (25) "Raw plant material" means the trichome-covered part of the female plant
- 26 Cannabis sp. or any mixture of shredded leaves, stems, seeds, and flowers of the
- 27 Cannabis sp. plant;

- 1 (26) "Registry identification card" means a document issued by the department that
2 identifies a person as a qualified patient, visiting qualified patient, or designated
3 caregiver;
- 4 (27) "Registered qualified patient" means a qualified patient who has applied for,
5 obtained, and possesses a valid registry identification card or provisional
6 licensure receipt issued by the department;
- 7 (28) "Safety compliance facility" means an entity licensed under this chapter that
8 provides at least one (1) of the following services:
- 9 (a) Testing medicinal marijuana produced by a cannabis business licensed
10 under this chapter; or
- 11 (b) Training cardholders and cannabis business agents;
- 12 (29) "Safety compliance facility agent" means a principal officer, board member,
13 employee, volunteer, or agent of a safety compliance facility;
- 14 (30) "Seedling" means a marijuana plant that has no flowers and is taller than eight
15 (8) inches;
- 16 (31) "Smoking" means the inhalation of smoke produced from the combustion of raw
17 plant material when ignited by a flame. The term "smoking" does not include
18 vaporizing;
- 19 (32) "State licensing board" means any of the following:
- 20 (a) The Kentucky Board of Dentistry;
- 21 (b) The Kentucky Board of Medical Licensure;
- 22 (c) The Kentucky Board of Nursing;
- 23 (d) The Kentucky Board of Optometric Examiners; and
- 24 (e) The State Board of Podiatry;
- 25 (33) "Use of medicinal marijuana" or "medicinal use of marijuana" includes the
26 acquisition, administration, possession, transfer, transportation, or consumption
27 of medicinal marijuana or medicinal marijuana accessories by a cardholder in

1 accordance with Sections 1 to 30 of this Act. The terms "use of medicinal
2 marijuana" and "medicinal use of marijuana" do not include:

3 (a) Cultivation of marijuana by a cardholder; or

4 (b) The use or consumption of marijuana by smoking;

5 (34) "Vaporizing" means the inhalation of vapors produced from applying heat, at a
6 temperature lower than the point of combustion, to medicinal marijuana;

7 (35) "Visiting qualified patient" means a person who has registered as such through
8 the department as required under this chapter or who possesses a valid registry
9 identification card, or an equivalent document, that was issued pursuant to the
10 laws of another state, district, territory, commonwealth, insular possession of the
11 United States, or country recognized by the United States that allows the person
12 to use medicinal marijuana in the jurisdiction of issuance; and

13 (36) "Written certification" means a document dated and signed by a practitioner,
14 that:

15 (a) States that in the practitioner's professional opinion the patient may receive
16 therapeutic or palliative benefit from the use of medicinal marijuana;

17 (b) Specifies the qualifying medical condition or conditions for which the
18 practitioner believes that the patient may receive therapeutic or palliative
19 benefit; and

20 (c) Affirms that the practitioner has a bona fide practitioner-patient
21 relationship with the patient.

22 ➔SECTION 2. A NEW SECTION OF KRS CHAPTER 218A IS CREATED TO
23 READ AS FOLLOWS:

24 Notwithstanding any provisions to the contrary:

25 (1) The use of medicinal marijuana by a cardholder shall be considered lawful if
26 done in accordance with Sections 1 to 30 of this Act and any administrative
27 regulations promulgated thereunder.

1 (2) The acquisition, blending, cultivation, delivery, distribution, manufacturing,
2 manipulation, packaging for sale, preparation, possession, sale, testing,
3 transportation, or transfer of medicinal marijuana or medicinal marijuana
4 accessories to the use of medicinal marijuana by a cannabis business or cannabis
5 business agent shall be considered lawful if done in accordance with Sections 1
6 to 30 of this Act and any administrative regulations promulgated thereunder.

7 (3) The recommending of medicinal marijuana use by a practitioner shall be
8 considered lawful if the practitioner's recommendation is made in accordance
9 with Sections 1 to 30 of this Act and any administrative regulations promulgated
10 thereunder.

11 (4) A registered qualified patient or visiting qualified patient shall not be considered
12 to be under the influence of marijuana solely because of the presence of
13 metabolites or components of marijuana that appear in insufficient concentration
14 to cause impairment.

15 ➔SECTION 3. A NEW SECTION OF KRS CHAPTER 218A IS CREATED TO
16 READ AS FOLLOWS:

17 (1) The Department of Alcoholic Beverage and Cannabis Control is hereby charged
18 with the implementation, operation, oversight, and regulation of the medicinal
19 marijuana program established in Sections 1 to 4 and 11 to 30 of this Act, and
20 there is hereby created within the department a Division of Medicinal Marijuana.
21 The Division of Medicinal Marijuana shall consist of a director and the
22 necessary staff to fulfill its statewide regulatory responsibilities.

23 (2) No later than December 1 of each year beginning in 2020, the department, in
24 consultation with the University of Kentucky, College of Medicine shall submit
25 an annual report to the Legislative Research Commission. The report submitted
26 by the department shall, at a minimum, include:

27 (a) The number of applications and renewals received by the department for

- 1 registry identification cards for registered qualified patients, visiting
2 qualified patients, and designated caregivers, individually and collectively;
- 3 **(b) The number of applications and renewals for registry identification cards**
4 **that were approved and denied by the department;**
- 5 **(c) The number of registry identification cards revoked by the department for**
6 **misconduct and the nature of the misconduct;**
- 7 **(d) The number of practitioners authorized to provide written certifications;**
- 8 **(e) The nature of the qualifying medical conditions for which practitioners**
9 **have provided written certifications;**
- 10 **(f) The number of applications and renewals received by the department for**
11 **cannabis business licenses; the number of cannabis business licenses issued**
12 **for each business type and tier; and the number of cannabis business**
13 **license applications and renewals that were denied by the department;**
- 14 **(g) The number of cannabis business agents employed by each type of cannabis**
15 **business;**
- 16 **(h) An assessment of:**
- 17 **1. The ability of cardholders in all areas of the state to obtain timely**
18 **affordable access to medicinal marijuana;**
- 19 **2. The effectiveness of the cultivators licensed under this chapter,**
20 **individually and collectively, in serving the needs of processors,**
21 **dispensaries and cardholders, the reasonableness of their fees,**
22 **whether they are generating any complaints or security problems, and**
23 **the sufficiency of the number operating to serve processors,**
24 **dispensaries and cardholders in the Commonwealth;**
- 25 **3. The effectiveness of the processors licensed under this chapter,**
26 **individually and collectively, in serving the needs of dispensaries and**
27 **cardholders, the reasonableness of their fees, whether they are**

1 generating any complaints or security problems, and the sufficiency of
2 the number operating to serve dispensaries and cardholders in the
3 Commonwealth;

4 4. The effectiveness of the dispensaries licensed under this chapter,
5 individually and collectively, in serving the needs of cardholders,
6 including the provision of educational and support services, the
7 reasonableness of their fees, whether they are generating any
8 complaints or security problems, and the sufficiency of the number
9 operating to serve cardholders in the Commonwealth; and

10 5. The effectiveness of the licensed safety compliance facilities licensed
11 under this chapter, individually and collectively, in serving the needs
12 of other cannabis businesses including the provision of testing and
13 training services, the reasonableness of their fees, whether they are
14 generating any complaints or security problems, and the sufficiency of
15 the number operating to serve other cannabis businesses and
16 cardholders in the Commonwealth;

17 (i) The profits and expenditures by cannabis businesses, individually and
18 collectively;

19 (j) The amount of medicinal marijuana sold per month in the Commonwealth;

20 (k) The total amount of revenue generated from cannabis business licensure
21 and cardholder fees for each calendar year and aggregated by prior years;

22 (l) The total amount of revenue generated by the excise tax established in
23 Section 33 of this Act;

24 (m) The total cost of enforcement for the medicinal marijuana program at the
25 time of the report, by city, county, and overall;

26 (n) The sufficiency of the regulatory and security safeguards contained in
27 Sections 1 to 30 of this Act and adopted by the department through

- 1 administrative regulations to ensure that access to and use of medicinal
2 marijuana cultivated and processed in this state is provided only to
3 cardholders;
- 4 (o) Recommendations regarding medical conditions or disorders that the
5 department considers appropriate for inclusion on the list of qualifying
6 medical conditions established in Section 1 of this Act;
- 7 (p) Any recommended additions or revisions to Sections 1 to 30 of this Act or
8 administrative regulations promulgated thereunder, including those
9 relating to security, safe handling, labeling, and nomenclature;
- 10 (q) The results of any scientific research studies regarding the health effects of
11 marijuana; and
- 12 (r) Any other data requested by the Legislative Research Commission relating
13 to the medicinal marijuana program and Sections 1 to 30 of this Act.
- 14 (3) The department shall provide the University of Kentucky, College of Medicine
15 with all information necessary to allow collaboration with the department on the
16 preparation of this report. The University of Kentucky, College of Medicine may
17 also produce its own report regarding the medicinal marijuana program
18 established in Sections 1 to 30 of this Act which, if produced, shall be submitted
19 to the Legislative Research Commission upon completion.
- 20 (4) The information contained in the report described in subsection (2) of this section
21 shall be presented in a manner that does not disclose any identifying information
22 about cardholders or licensed cannabis businesses.
- 23 (5) Nothing in Sections 1 to 30 of this Act shall require the department to assume
24 duties in relation to the medicinal marijuana program that are more than
25 administrative in nature if federal law or a current and clear directive from the
26 federal government indicates that duties assumed by the department that are
27 more than administrative could result in federal prosecution or invalidation of

1 the medicinal marijuana program established in Sections 1 to 30 of this Act.

2 (6) If the department makes a determination that it is required by Sections 1 to 30 of
3 this Act to conduct duties that are more than administrative in nature, then it
4 shall continue to conduct duties that are administrative in nature and designate
5 or enter into a contract with a qualified nongovernmental entity to conduct any
6 duties required by Sections 1 to 30 of this Act that are more than administrative
7 in nature. The department may reimburse the state for any costs involved in
8 working with outside consultants to implement the program.

9 ➔SECTION 4. A NEW SECTION OF KRS CHAPTER 218A IS CREATED TO
10 READ AS FOLLOWS:

11 (1) A registered qualified patient shall not be subject to arrest, prosecution, or denial
12 of any right or privilege, including but not limited to a civil penalty or
13 disciplinary action by a court or occupational or professional licensing board, for
14 the use of medicinal marijuana, if the registered qualified patient does not
15 possess more than:

16 (a) An amount of medicinal marijuana determined by the department to
17 constitute an uninterrupted thirty (30) day supply at his or her residence; or

18 (b) An amount of medicinal marijuana determined by the department to
19 constitute an uninterrupted ten (10) day supply on his or her person, except
20 that an amount greater than a ten (10) day supply, including up to a thirty
21 (30) day supply, may be transported by a registered qualified patient from a
22 dispensary to his or her residence if the medicinal marijuana is contained
23 in a sealed package that requires at least a two (2) step process for initial
24 opening.

25 (2) A visiting qualified patient shall not be subject to arrest, prosecution, or denial of
26 any right or privilege, including but not limited to civil penalty or disciplinary
27 action by a court or occupational or professional licensing board, for the use of

1 medicinal marijuana, if the visiting qualified patient does not possess more than
2 an amount of medicinal marijuana determined by the department to constitute an
3 uninterrupted ten (10) day supply on his or her person.

4 (3) A designated caregiver shall not be subject to arrest, prosecution, or denial of any
5 right or privilege, including but not limited to civil penalty or disciplinary action
6 by a court or occupational or professional licensing board, for:

7 (a) Assisting a registered qualified patient to whom the designated caregiver is
8 connected through the department's registration process with the use of
9 medicinal marijuana if the designated caregiver does not possess more
10 than:

11 1. An amount of medicinal marijuana determined by the department to
12 constitute an uninterrupted thirty (30) day supply at his or her
13 residence for each registered qualified patient to whom the caregiver
14 is connected through the department's registration process; or

15 2. An amount of medicinal marijuana determined by the department to
16 constitute an uninterrupted ten (10) day supply on his or her person
17 for each registered qualified patient to whom the caregiver is
18 connected through the department's registration process, except that
19 an amount greater than a ten (10) day supply, including up to a thirty
20 (30) day supply for each registered qualified patient to whom the
21 caregiver is connected through the department's registration process,
22 may be transported by a designated caregiver from a dispensary to his
23 or her residence if the medicinal marijuana is contained in a sealed
24 package that requires at least a two (2) step process for initial
25 opening; or

26 (b) Receiving compensation for reasonable costs associated with assisting a
27 registered qualified patient in the use of medicinal marijuana if the

1 designated caregiver is connected to the registered qualified patient through
2 the department's registration process.

3 (4) Notwithstanding subsections (1) to (3) of this section:

4 (a) A registered qualified patient shall not be permitted to purchase more
5 medicinal marijuana than the amount determined by the department to
6 constitute an uninterrupted thirty (30) day supply of medicinal marijuana
7 during a given twenty-five (25) day period;

8 (b) A designated caregiver shall not be permitted to purchase more medicinal
9 marijuana than the amount determined by the department to constitute an
10 uninterrupted thirty (30) day supply of medicinal marijuana for each
11 registered qualified patient to whom the caregiver is connected through the
12 department's registration process during a given twenty-five (25) day
13 period; and

14 (c) A visiting qualified patient shall not be permitted to purchase more
15 medicinal marijuana than the amount determined by the department to
16 constitute an uninterrupted ten (10) day supply of medicinal marijuana
17 during a given eight (8) day period.

18 (5) A cardholder shall not be subject to arrest, prosecution, or denial of any right or
19 privilege, including but not limited to a civil penalty or disciplinary action by a
20 court or occupational or professional licensing board, for:

21 (a) Possession of marijuana that is incidental to the use of medicinal
22 marijuana;

23 (b) Possession of medicinal marijuana accessories; or

24 (c) Transferring medicinal marijuana to a safety facility for testing.

25 (6) No person shall be subject to arrest, prosecution, or denial of any right or
26 privilege, including but not limited to a civil penalty or disciplinary action by a
27 court or occupational or professional licensing board, for:

1 (a) Selling medicinal marijuana accessories to a cardholder upon presentation
2 of a valid registry identification card issued by the department in
3 accordance with Sections 11 to 13 of this Act, or its equivalent issued
4 pursuant to the laws of another state, district, territory, commonwealth,
5 insular possession of the United States, or country recognized by the United
6 States that allows the person to use medicinal marijuana in the jurisdiction
7 of issuance;

8 (b) Being in the presence or vicinity of the use of medicinal marijuana as
9 allowed under Sections 1 to 30 of this Act; or

10 (c) Assisting a registered qualified patient or visiting qualified patient with
11 using or administering medicinal marijuana. For purposes of illustration
12 and not limitation, this includes preparing a vaporizer or brewing tea for a
13 registered qualified patient or visiting qualified patient. It does not include
14 providing medicinal marijuana to a patient that the patient did not already
15 possess.

16 ➔SECTION 5. A NEW SECTION OF KRS CHAPTER 218A IS CREATED TO
17 READ AS FOLLOWS:

18 (1) Except as provided in subsection (11) of this section, a physician, dentist,
19 podiatrist, optometrist who is authorized to prescribe controlled substances under
20 KRS 320.240, or an advanced practice registered nurse who is authorized to
21 prescribe controlled substances under KRS 314.042 seeking to provide written
22 certifications for the use of medicinal marijuana shall apply to the same state
23 licensing board that issued his or her professional practice license, on a form
24 prescribed by the state licensing board, for authorization to provide written
25 certifications for the use of medicinal marijuana.

26 (2) (a) A state licensure board shall authorize an application for authorization to
27 provide written certifications for the use of medicinal marijuana if the

1 application is complete and meets the requirements established in
2 administrative regulations promulgated by the state licensing board; and

3 (b) A state licensure board shall not authorize an application for authorization
4 to provide written certifications for the use of medicinal marijuana if the
5 applicant has an ownership or investment interest in or compensation
6 agreement with a cannabis business licensed under this chapter. A state
7 licensure board may consult with the department to determine if an
8 applicant has an ownership or investment interest in or compensation
9 agreement with a cannabis business.

10 (3) Authorization to provide written certifications for the use of medicinal marijuana
11 granted under this section shall expire in accordance with administrative
12 regulations promulgated by a state licensing board.

13 (4) A practitioner authorized by a state licensing board to provide written
14 certifications for the use of medicinal marijuana may provide a patient with a
15 written certification only after:

16 (a) A bona fide practitioner-patient relationship has been established through:

17 1. An in-person examination or an examination conducted via
18 telehealth, as defined in KRS 304.17A-005, of the patient by the
19 practitioner;

20 2. A review of the patient's medical history and current medical
21 condition by the practitioner, including providing an initial diagnosis
22 for a qualifying medical condition or confirming a diagnosis for a
23 qualifying medical condition provided by another health care
24 provider; and

25 3. An expectation of providing care and receiving care on an ongoing
26 basis;

27 (b) The practitioner has reviewed a report of information from the electronic

1 system for monitoring controlled substances established in KRS 218A.202
2 related to the patient for a period of time that covers at least the twelve (12)
3 months immediately preceding the date of the report; and

4 (c) The practitioner has consulted with the patient with respect to the potential
5 benefits of medicinal marijuana as well as the possible risks and side
6 effects; and

7 (d) The practitioner has consulted with the patient's custodial parent or legal
8 guardian responsible for providing consent to treatment with respect to the
9 potential benefits of medicinal marijuana as well as the possible risks and
10 side effects and obtained the consent of the patient's parent or other person
11 responsible for providing consent to treatment, if the patient is a minor
12 child.

13 (5) (a) When issuing a written certification for the use of medicinal marijuana to a
14 patient, the practitioner shall use a form prescribed by the department.

15 (b) A written certification provided under this section shall be valid for a period
16 of not more than ninety (90) days. The practitioner may renew the
17 certification for not more than three (3) additional periods of not more than
18 ninety (90) days each. Thereafter, the practitioner may issue another
19 certification to the patient only after an in-person examination or an
20 examination conducted via telehealth, as defined in KRS 304.17A-005, of
21 the patient by the practitioner.

22 (c) Within twenty-four (24) hours of providing a patient with a written
23 certification for the use of medicinal marijuana, a practitioner shall record
24 the issuance of the written certification in the electronic system developed
25 by the department pursuant to subsection (1)(a) of Section 28 of this Act.

26 (6) A practitioner shall not:

27 (a) Dispense medicinal marijuana; or

1 (b) Provide a written certification for the use of medicinal marijuana to a
2 family member or for himself or herself.

3 (7) A practitioner shall not be subject to arrest, prosecution, or penalty in any
4 manner, or denied any right or privilege, including but not limited to a civil
5 penalty or disciplinary action by a state licensing board or by any other
6 occupational or professional licensing board, solely for providing written
7 certifications or for otherwise stating that, in the practitioner's professional
8 opinion, a patient may receive therapeutic or palliative benefit from the use of
9 medicinal marijuana, if done in accordance with this section.

10 (8) Nothing in Sections 1 to 30 of this Act shall prevent a practitioner from being
11 sanctioned for:

12 (a) Issuing a written certification without first obtaining authorization to
13 provide written certifications from a state licensing board;

14 (b) Issuing a written certification to a patient with whom the practitioner does
15 not have a bona fide practitioner-patient relationship;

16 (c) Failing to properly evaluate a patient's medical history and current medical
17 condition prior to issuing a written certification;

18 (d) Otherwise failing to use good faith in his or her treatment of the patient; or

19 (e) Any other violation of this section.

20 (9) A state licensing board may suspend or revoke a practitioner's authorization to
21 provide written certification for the use of medicinal marijuana and practice
22 license for multiple violations or a serious violation of this section or
23 administrative regulations promulgated thereunder.

24 (10) The state licensing boards shall:

25 (a) Within one hundred twenty (120) days after the effective date of this Act
26 promulgate administrative regulations to carry out the provisions of this
27 section, including but not limited to:

- 1 1. The procedures for applying for authorization to provide written
- 2 certifications;
- 3 2. The conditions that must be met to be eligible for authorization to
- 4 provide written certifications;
- 5 3. The process and procedures for renewing authorization to provide
- 6 written certifications;
- 7 4. Continuing education requirements for practitioners who are
- 8 authorized to provide written certifications;
- 9 5. The reasons for which authorization to provide written certifications
- 10 for the use of medicinal marijuana may be suspended or revoked; and
- 11 6. The minimal standards of care when providing written certifications;
- 12 (b) On a regular basis, provide the department with the names of all
- 13 practitioners authorized by the state licensing board to provide written
- 14 certifications; and
- 15 (c) Immediately provide the department with the name of any practitioner
- 16 whose authorization to provide written certifications is suspended or
- 17 revoked.
- 18 (11) This section does not apply to a practitioner who recommends treatment with
- 19 marijuana or a drug derived from marijuana under any of the following that are
- 20 approved by an investigational review board or equivalent entity, the United
- 21 States Food and Drug Administration, or the National Institutes for Health or
- 22 any of its cooperative groups or centers under the United States Department of
- 23 Health and Human Services:
- 24 (a) A research protocol;
- 25 (b) A clinical trial;
- 26 (c) An investigational new drug application; or
- 27 (d) An expanded access submission.

1 ➔SECTION 6. A NEW SECTION OF KRS CHAPTER 218A IS CREATED TO
2 READ AS FOLLOWS:

3 (1) An attorney shall not be subject to disciplinary action by the Kentucky Bar
4 Association or other professional licensing association for providing legal
5 assistance to any individual or cannabis business related to activity that is no
6 longer subject to criminal penalties under state law pursuant to Sections 1 to 30
7 of this Act.

8 (2) No person shall be subject to arrest, prosecution, or penalty in any manner, or
9 denied any right or privilege, including but not limited to a civil penalty or
10 disciplinary action by an occupational or professional licensing board, for
11 providing assistance or services, including but not limited to accounting services,
12 security services, or business consulting services to any individual or cannabis
13 business related to activity that is no longer subject to criminal penalties under
14 state law pursuant to Sections 1 to 30 of this Act.

15 ➔SECTION 7. A NEW SECTION OF KRS CHAPTER 218A IS CREATED TO
16 READ AS FOLLOWS:

17 (1) (a) Any medicinal marijuana, medicinal marijuana accessories, lawful
18 property, or interest in lawful property that is possessed, owned, or used in
19 connection with the medicinal use of marijuana or acts incidental to that
20 use, shall not be seized or forfeited.

21 (b) Sections 1 to 30 of this Act shall not prevent the seizure or forfeiture of
22 marijuana exceeding the amounts allowed under Section 4 of this Act nor
23 shall it prevent seizure or forfeiture if the basis for that action is unrelated
24 to the medicinal use of marijuana in accordance to Sections 1 to 30 of this
25 Act and any administrative regulation promulgated thereunder.

26 (2) Possession of, or application for, a registry identification card or cannabis
27 business license shall not constitute probable cause or reasonable suspicion, nor

1 shall it be used to support the search of the person, property, or home of the
2 person possessing or applying for the registry identification card or cannabis
3 business license. The possession of, or application for, a registry identification
4 card or cannabis business license shall not preclude the existence of probable
5 cause if probable cause exists on other grounds.

6 (3) (a) There shall be a presumption that a cardholder is engaged in the medicinal
7 use of marijuana, or in the case of a designated caregiver, assisting with the
8 medicinal use of marijuana, if the cardholder:

9 1. Possesses a valid registry identification card or, in the case of a
10 visiting qualified patient, an equivalent document issued pursuant to
11 the laws of another state, district, territory, commonwealth, insular
12 possession of the United States, or country recognized by the United
13 States that allows the person to use medicinal marijuana in the
14 jurisdiction of issuance; and

15 2. Possesses an amount of medicinal marijuana that does not exceed the
16 amount allowed under Section 4 of this Act.

17 (b) The presumption may be rebutted by evidence that conduct was unrelated to
18 the medicinal use of marijuana or was otherwise in violation of Sections 1
19 to 30 of this Act.

20 (4) No law enforcement officer employed by an agency which receives state or local
21 government funds shall expend any state or local resources, including the
22 officer's time, to effect any arrest or seizure of medicinal marijuana, or conduct
23 any investigation, on the sole basis of activity the officer believes to constitute a
24 violation of the federal Controlled Substances Act, 21 U.S.C. secs. 801 et seq., if
25 the officer should have reason to believe that such activity is in compliance with
26 Sections 1 to 30 of this Act.

27 ➔SECTION 8. A NEW SECTION OF KRS CHAPTER 218A IS CREATED TO

1 READ AS FOLLOWS:

2 (1) Sections 1 to 30 of this Act do not authorize any person to engage in, and shall
3 not prevent the imposition of any civil, criminal, or other penalties, including but
4 not limited to criminal prosecution or disciplinary action by the department or an
5 occupational or professional licensing board, for engaging in, the following
6 conduct:

7 (a) Operating, navigating, or being in actual physical control of any aircraft,
8 vehicle, vessel, or any other device known, or hereafter invented, that is
9 powered by machinery and that is or may be used to transport persons or
10 property while under the influence of medicinal marijuana;

11 (b) Consuming medicinal marijuana while operating, navigating, or being in
12 actual physical control of an aircraft, vehicle, vessel, or any other device
13 known, or hereafter invented, that is powered by machinery and that is or
14 may be used to transport persons or property;

15 (c) Possessing medicinal marijuana that is within the operator's arm's reach or
16 requires less than a two (2) step process to access while operating,
17 navigating, or being in actual physical control of an aircraft, vehicle, vessel,
18 or any other device known, or hereafter invented, that is powered by
19 machinery and that is or may be used to transport persons or property;

20 (d) Undertaking any task under the influence of medicinal marijuana, when
21 doing so would constitute negligence or professional malpractice;

22 (e) Possessing medicinal marijuana, or otherwise engaging in the use of
23 medicinal marijuana:

24 1. On a school bus, except as permitted under Section 10 of this Act;

25 2. On the grounds of any preschool or primary or secondary school,
26 except as permitted under Section 10 of this Act;

27 3. In any correctional facility; or

- 1 4. On any property of the federal government;
- 2 (f) Using marijuana, if that person is not a register qualified patient or visiting
- 3 qualified patient;
- 4 (g) Using or consuming marijuana by smoking; or
- 5 (h) Cultivating marijuana unless that person is licensed by the department as a
- 6 cannabis cultivator pursuant to Sections 16 to 19 of this Act or is a
- 7 cultivator agent.
- 8 (2) The penalty for a violation of subsection (1)(a) or (b) of this section shall be the
- 9 same as those established for operating a motor vehicle under the influence of
- 10 alcohol or any other substance in KRS 189A.010.
- 11 (3) (a) An individual who violates subsection (1)(g) of this section shall not be
- 12 considered to be in possession of medicinal marijuana or engaged in the use
- 13 of medicinal marijuana and shall not benefit from the legal protections
- 14 afforded by Sections 1 to 30 of this Act.
- 15 (b) The odor or smell of marijuana shall not constitute evidence of use or
- 16 consumption of marijuana by smoking.
- 17 (c) If an individual uses or consumes marijuana by smoking while on any form
- 18 of public transportation, in any public place as defined in KRS 525.010, or
- 19 in any place of public accommodation, resort, or amusement as defined in
- 20 KRS 344.130:
- 21 1. The department may revoke the individual's registry identification
- 22 card; and
- 23 2. The individual may be subject to prosecution under Section 38 of this
- 24 Act.
- 25 (d) Notwithstanding paragraph (a) of this subsection, if an individual violates
- 26 subsection (1)(g) of this subsection by using or consuming marijuana by
- 27 smoking on residential property owned or leased by that individual, the

1 penalty shall be a fine of not more than one hundred dollars (\$100) per
2 violation.

3 (4) Nothing in Sections 1 to 30 of this Act supersedes statutory laws relating to
4 driving while under the influence of intoxicants. Sections 1 to 30 of this Act shall
5 not prevent the enforcement of current laws pertaining to driving while
6 intoxicated, including KRS 183.061, 189.520, 189A.010, and 235.240.

7 (5) As used in this section:

8 (a) "Aircraft" means the same as defined in KRS 183.011;

9 (b) "Vehicle" means the same as defined in KRS 189.010; and

10 (c) "Vessel" means the same as defined in KRS 235.010.

11 ➔SECTION 9. A NEW SECTION OF KRS CHAPTER 218A IS CREATED TO
12 READ AS FOLLOWS:

13 (1) Nothing in Sections 1 to 30 of this Act shall:

14 (a) Require an employer to permit or accommodate the use, consumption,
15 possession, transfer, display, transportation, distribution, sale, or growing
16 of medicinal marijuana in the workplace;

17 (b) Prohibit an employer from implementing policies promoting workplace
18 health and safety by restricting the use of medicinal marijuana by
19 employees;

20 (c) Prohibit an employer from including in any contract provisions that
21 prohibit the use of medicinal marijuana by employees;

22 (d) Permit a cause of action against an employer for wrongful discharge or
23 discrimination;

24 (e) Except as provided in Section 10 of this Act, prohibit a person, employer,
25 corporation, or any other entity who occupies, owns, or controls a property
26 from prohibiting or otherwise regulating the use, consumption, possession,
27 transfer, display, transportation, sale, or growing of medicinal marijuana

1 on or in that property; or

2 (f) Prohibit an employer from establishing and enforcing a drug testing policy,
3 drug-free workplace, or zero-tolerance drug policy.

4 (2) An employee who is discharged from employment for consuming medicinal
5 marijuana in the workplace, working while under the influence of medicinal
6 marijuana, or testing positive for a controlled substance shall not be eligible to
7 receive benefits under KRS Chapter 341, if such actions are in violation of an
8 employment contract or established personnel policy.

9 (3) No employer may be penalized or denied any benefit under state law for
10 employing a cardholder.

11 ➔SECTION 10. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
12 TO READ AS FOLLOWS:

13 (1) A registered qualified patient or visiting qualified patient who uses medicinal
14 marijuana shall be afforded all the same rights under state and local law,
15 including those guaranteed under KRS Chapter 344, as the individual would
16 have been afforded if he or she were solely prescribed pharmaceutical
17 medications, as they pertain to drug testing required by any state or local law.

18 (2) A cardholder otherwise entitled to custody of, visitation time, or parenting time
19 with a minor child shall not be denied that right, and there shall be no
20 presumption of abuse, neglect or dependency, for conduct permitted under
21 Sections 1 to 30 of this Act unless the person's actions in relation to medicinal
22 marijuana created an unreasonable danger to the safety of the minor child as
23 established by clear and convincing evidence.

24 (3) (a) For the purposes of medical care, including organ transplants, a patient's
25 authorized use of medicinal marijuana is the equivalent of the authorized
26 use of any other medication used at the direction of a practitioner, and shall
27 not constitute the use of an illicit substance or otherwise disqualify a patient

1 from needed medical care.

2 (b) A health facility as defined in KRS 216B.015 may develop regulations to
3 allow a patient who is a registered qualified patient or visiting qualified
4 patient to use medicinal marijuana on the premises of the health facility.

5 (4) (a) No school may refuse to enroll, or otherwise penalize, a person solely for his
6 or her status as a cardholder, unless failing to do so would violate federal
7 law or regulations and cause the school to lose a monetary or licensing-
8 related benefit under federal law or regulations.

9 (b) No school may be penalized or denied any benefit under state law for
10 enrolling a cardholder.

11 (c) A local school board may develop regulations to permit a pupil who is a
12 cardholder to possess on a school bus and to possess and use medicinal
13 marijuana on the premises of a school.

14 (5) (a) No landlord may refuse to lease to, or otherwise penalize, a person solely for
15 his or her status as a cardholder, unless failing to do so would violate
16 federal law or regulations and cause the landlord to lose a monetary or
17 licensing-related benefit under federal law or regulations.

18 (b) No landlord may be penalized or denied any benefit under state law for
19 leasing to a cardholder.

20 (c) A landlord shall not include in a rental agreement terms and conditions
21 that prohibit the use of medicinal marijuana by a cardholder.

22 ➔SECTION 11. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
23 TO READ AS FOLLOWS:

24 (1) Except as provided in subsection (5) of this section, no person shall possess,
25 purchase, acquire, or otherwise engage, or assist, in the use of medicinal
26 marijuana in Kentucky without first applying for and receiving a registry
27 identification card for registered qualified patients, designated caregivers, or

- 1 visiting qualified patients issued by the department.
- 2 (2) A person shall be eligible to apply for a registry identification card as a registered
3 qualified patient if he or she is a resident of Kentucky, has been diagnosed with a
4 qualifying medical condition, has obtained a written certification from a
5 practitioner with whom he or she has a bona fide practitioner-patient
6 relationship, and has not been convicted of a disqualifying felony offense.
- 7 (3) A person shall be eligible to apply for a registry identification card as a
8 designated caregiver if he or she is a resident of Kentucky, is at least twenty-one
9 (21) years of age, has not been convicted of a disqualifying felony offense, and
10 has agreed to assist no more than three (3) registered qualified patients with the
11 use of medicinal marijuana.
- 12 (4) A person shall be eligible to apply for a registry identification card as a visiting
13 qualified patient if he or she is not a resident of Kentucky or has been a resident
14 of Kentucky for less than thirty (30) days, is at least twenty-one (21) years of age,
15 has not been convicted of a disqualifying felony offense, and possesses a valid
16 registry identification card, or an equivalent document, issued pursuant to the
17 laws of another state, district, territory, commonwealth, insular possession, of the
18 United States, or country recognized by the United States, that allows the person
19 to use medicinal marijuana in the jurisdiction of issuance.
- 20 (5) A person with a valid registry identification card, or its equivalent, that was
21 issued pursuant to the laws of another state, district, territory, commonwealth,
22 insular possession of the United States, or country recognized by the United
23 States that allows the person to use medicinal marijuana in the jurisdiction of
24 issuance may use that registry identification card, or its equivalent, for all
25 purposes established in Sections 1 to 30 of this Act and shall not be required to
26 apply for or receive a visiting qualified patient registry identification card from
27 the department.

1 (6) To apply for a registry identification card a qualified patient shall submit the
2 following, in accordance with administrative regulations promulgated by the
3 department:

4 (a) The name, address, and date of birth of the qualified patient, except that if
5 the applicant is homeless an address where the applicant may be reached
6 shall be provided to the department;

7 (b) A written certification issued by a practitioner within ninety (90) days
8 immediately preceding the date of an application;

9 (c) The name, address, and telephone number of the qualified patient's
10 practitioner;

11 (d) The application or renewal fee;

12 (e) The name, address, and date of birth of not more than two (2) individuals
13 chosen by the qualified patient to be designated as a caregiver, if the
14 qualified patient chooses to designate a caregiver;

15 (f) A statement, signed by the qualified patient, pledging not to divert medicinal
16 marijuana to anyone who is not permitted to possess marijuana pursuant to
17 Sections 1 to 30 of this Act. The statement shall contain a listing of potential
18 penalties, including criminal prosecution, for diverting marijuana; and

19 (g) A statement, signed by the individuals chosen by the qualified patient to be
20 designated as a caregiver, if any, agreeing to be designated as the patient's
21 designated caregiver and pledging not to divert medicinal marijuana to
22 anyone other than the registered qualified patient to whom the caregiver is
23 connected through the department's registration process. The statement
24 shall contain a listing of potential penalties, including criminal prosecution,
25 for diverting marijuana.

26 (7) To apply for a registry identification card a visiting qualified patient shall submit
27 the following, in accordance with administrative regulations promulgated by the

1 department:

2 (a) The name, address, and date of birth of the visiting qualified patient, except
 3 that if the applicant is homeless an address where the applicant may be
 4 reached shall be provided to the department;

5 (b) A copy of his or her valid registry identification card or its equivalent that
 6 was issued pursuant to the laws of the jurisdiction of the person's residence;

7 (c) The application or renewal fee; and

8 (d) A statement, signed by the visiting qualified patient, pledging not to divert
 9 medicinal marijuana to anyone who is not permitted to possess marijuana
 10 pursuant to Sections 1 to 30 of this Act. The statement shall contain a
 11 listing of potential penalties, including criminal prosecution, for diverting
 12 marijuana.

13 (8) The application for qualified patients' registry identification cards shall ask
 14 whether the patient would like the department to notify him or her of any clinical
 15 studies needing human subjects for research on the medicinal use of marijuana.
 16 The department shall notify interested patients if it is aware of studies that will be
 17 conducted in the United States.

18 (9) A registered qualified patient applying to renew a registry identification card
 19 issued by the department shall be required to submit to the department a written
 20 certification issued by a practitioner within ninety (90) days immediately
 21 preceding the date of a renewal application.

22 ➔SECTION 12. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 23 TO READ AS FOLLOWS:

24 (1) The department shall establish, implement, and operate a registry identification
 25 card program for registered qualified patients, visiting qualified patients, and
 26 designated caregivers.

27 (2) Registry identification cards shall contain the following:

- 1 (a) The name of the cardholder;
- 2 (b) A designation of whether the cardholder is a registered qualified patient,
- 3 visiting qualified patient, or designated caregiver;
- 4 (c) The date of issuance and expiration date of the registry identification card;
- 5 (d) A random alphanumeric identification number of at least ten (10)
- 6 characters, containing at least four (4) numbers and at least four (4) letters,
- 7 that is unique to the cardholder;
- 8 (e) A bar code or other marking that can be scanned electronically;
- 9 (f) A photograph of the cardholder, if the department's administrative
- 10 regulations require one;
- 11 (g) The telephone number and Web site address for the electronic verification
- 12 system developed by the department pursuant to subsection (1)(a) of Section
- 13 28 of this Act;
- 14 (h) If the cardholder is a designated caregiver, the random alphanumeric
- 15 identification number of the registered qualified patient the designated
- 16 caregiver is receiving the registry identification card to assist; and
- 17 (i) If the cardholder is under eighteen (18) years of age, a clear and obvious
- 18 designation or identifier indicating that the cardholder is under eighteen
- 19 (18) years of age.
- 20 (3) (a) Except as provided in this subsection, the expiration date for registry
- 21 identification cards shall be one (1) year after the date of issuance.
- 22 (b) If a practitioner states in the written certification that the qualified patient
- 23 would benefit from the use of medicinal marijuana until a specified earlier
- 24 date, then the registry identification card shall expire on that date.
- 25 (4) The department may, at its discretion, electronically store in the card all of the
- 26 information listed in subsection (2) of this section, along with the address and
- 27 date of birth of the cardholder, to allow it to be read electronically by law

1 enforcement agents and licensed cannabis businesses.

2 (5) The registry identification card application and renewal fees shall be as follows:

3 (a) A registry identification card for a qualified patient who is a Kentucky
4 resident shall be sixty dollars (\$60);

5 (b) A registry identification card for a visiting qualified patient shall be sixty
6 dollars (\$60); and

7 (c) A registry identification card for a designated caregiver shall be twenty
8 dollars (\$20) per registered qualified patient to whom the designated
9 caregiver is connected unless the designated caregiver is the spouse or adult
10 child of the qualified patient, in which case there shall be no fee for a
11 registry identification card.

12 (6) (a) The department shall operate a provisional licensure receipt system for
13 registered qualified patients, designated caregivers, and visiting qualified patients
14 that shall be valid for forty-five (45) days or until a permanent card can be issued
15 as if it is a registry identification card issued pursuant to this section and Sections
16 11 and 13 of this Act. This program shall be implemented and operational
17 simultaneously with the department's implementation of the registry
18 identification card program established in this section. A provisional licensure
19 receipt shall contain the following:

20 1. A temporary licensure number;

21 2. A barcode or other marking that can be scanned electronically;

22 3. The name of the applicant;

23 4. The effective date of the receipt;

24 5. The expiration date of the receipt;

25 6. An indication that the cardholder fee has been paid;

26 7. An indication that the application has been submitted and is
27 apparently complete; and

- 1 8. The name of the certifying practitioner.
- 2 (b) The licensure receipt system shall be designed so that this provisional
3 licensure receipt shall be produced by the application Web site upon
4 completion of an application that includes a practitioner recommendation
5 and payment of the cardholder fee. To reduce application errors and
6 processing time, a recommending practitioner or a dispensary may offer a
7 service that allows an applicant to use a computer and printer on the
8 premises of the practitioner's office or dispensary to complete an
9 application and receive a provisional licensure receipt pursuant to this
10 subsection.
- 11 (c) Notwithstanding any other provision of Sections 1 to 30 of this Act, a valid
12 provisional licensure receipt issued pursuant to this subsection shall convey
13 to the individual whose name appears on the provisional licensure receipt
14 all of the same rights and privileges as a registry identification card issued
15 pursuant to this section and Sections 11 and 13 of this Act and shall be
16 accepted by a cannabis business in place of a registry identification card.
- 17 (7) All registry identification card fees collected by the department pursuant to
18 subsection (5) of this section shall be forwarded to the medicinal marijuana trust
19 fund established in Section 31 of this Act.

20 ➔SECTION 13. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
21 TO READ AS FOLLOWS:

- 22 (1) Except as provided in subsection (2) of this section, the department shall:
- 23 (a) Acknowledge receipt of an application within fifteen (15) days of receipt,
24 and approve or deny an application or renewal within thirty (30) days of
25 receiving a completed application or renewal application; and
- 26 (b) Issue registry identification cards to a qualified patient and any individual
27 designated by the qualified patient as a designated caregiver, or a visiting

1 qualified patient within five (5) days of approving the application or
2 renewal. An individual designated as a caregiver shall be issued a
3 designated caregiver registry identification card for each registered
4 qualified patient to whom he or she is connected through the department's
5 registration process.

6 (2) The department shall not issue a registry identification card to a qualified patient
7 who is younger than eighteen (18) years of age unless the custodial parent or
8 legal guardian with responsibility for health care decisions for the qualified
9 patient consents in writing to:

10 (a) Allow the qualified patient's use of medicinal marijuana;

11 (b) Serve as the qualified patient's designated caregiver; and

12 (c) Control the acquisition of the medicinal marijuana, the dosage, and the
13 frequency of the use by the qualified patient.

14 (3) The department may deny an application or renewal of a qualified patient's or
15 visiting qualified patient's registry identification card for any reason that the
16 department, in the exercise of sound discretion, deems sufficient, including but
17 not limited to if the applicant:

18 (a) Did not provide the information or materials required by Section 11 of this
19 Act;

20 (b) Previously had a registry identification card revoked;

21 (c) Provided false or falsified information; or

22 (d) Does not meet the eligibility requirements established in Section 11 of this
23 Act.

24 (4) The department may deny an application or renewal for a designated caregiver
25 chosen by a qualified patient whose registry identification card was granted for
26 any reason that the department, in the exercise of sound discretion, deems
27 sufficient, including but not limited to if the applicant:

- 1 (a) Is already registered as a designated caregiver for more than three (3)
2 registered qualified patients;
- 3 (b) Does not meet the eligibility requirements established in Section 11 of this
4 Act;
- 5 (c) Did not provide the information or materials required by Section 11 of this
6 Act;
- 7 (d) Previously had a registry identification card revoked;
- 8 (e) Provided false or falsified information;
- 9 (f) Was previously convicted of a disqualifying felony offense; or
- 10 (g) Has applied as a designated caregiver for a qualified patient whose
11 application for a registry identification card was denied.
- 12 (5) The department may conduct a criminal background check of any applicant if the
13 criminal background check is conducted solely to determine whether the
14 applicant was previously convicted of a disqualifying felony offense.
- 15 (6) The department shall notify the registered qualified patient who has designated
16 someone to serve as his or her designated caregiver if the individual designated as
17 a caregiver is denied a registry identification card.
- 18 (7) The department shall notify the applicant in writing of the denial and reasons by
19 registered or certified mail at the address given in the application or supplement.
20 The applicant may, within thirty (30) days after the date of the mailing of the
21 department's notice, file a written request for an administrative hearing on the
22 application. The hearing shall be conducted on the application in compliance
23 with the requirements of KRS Chapter 13B.
- 24 (8) Final orders of the department after administrative hearings shall be subject to
25 judicial review. Jurisdiction and venue for judicial review are vested in the
26 Circuit Court of the county in which the appealing party resides.

27 ➔SECTION 14. A NEW SECTION OF KRS CHAPTER 218A IS CREATED

1 TO READ AS FOLLOWS:

2 (1) Cardholders shall be required to make the following notifications to the
3 department:

4 (a) A cardholder shall notify the department of any change in his or her name
5 or address;

6 (b) A registered qualified patient shall notify the department within thirty (30)
7 days if he or she ceases to suffer from the qualifying medical condition for
8 which a practitioner provided a written certification;

9 (c) A registered qualified patient shall notify the department if he or she wishes
10 to terminate a designated caregiver relationship with an individual who has
11 been designated as his or her caregiver;

12 (d) A designated caregiver shall notify the department within thirty (30) days if
13 he or she becomes aware that a registered qualified to whom the caregiver is
14 connected through the department's registration process has died or has
15 ceased to suffer from the qualified medical condition for which a
16 practitioner provided a written certification; and

17 (e) If a cardholder loses his or her registry identification card, he or she shall
18 notify the department within ten (10) days of becoming aware the card has
19 been lost.

20 (2) When a cardholder notifies the department of items listed in subsection (1) of this
21 section, but remains eligible under Sections 1 to 30 of this Act, the department
22 shall issue the cardholder a new registry identification card with a new random
23 ten (10) character alphanumeric identification number. If the department issues
24 a new registry identification card to a registered qualified patient, the department
25 shall also issue a new registry identification card with a new ten (10) character
26 alphanumeric number to the registered qualified patient's designated caregivers.
27 New registry identification cards issued under this subsection shall be issued by

1 the department within ten (10) days of receiving the updated information and a
2 twenty dollar (\$20) fee for each new registry identification card to be issued.

3 (3) If a registered qualified patient ceases to be a registered qualified patient or
4 changes his or her designated caregiver, the department shall promptly notify the
5 designated caregiver in writing. The designated caregiver's protections under
6 Sections 1 to 30 of this Act as to that registered qualified patient shall expire
7 fifteen (15) days after notification by the department.

8 (4) If a practitioner who provided a written certification notifies the department in
9 writing either that the registered qualified patient has died, ceased to suffer from
10 the qualifying medical condition for which a practitioner provided a written
11 certification, or that the practitioner no longer believes the patient might receive
12 therapeutic or palliative benefit from the use of medicinal marijuana, the
13 department shall promptly notify the registered qualified patient in writing. The
14 registered qualified patient's protections under Sections 1 to 30 of this Act shall
15 expire fifteen (15) days after notification by the department, and the registered
16 qualified patient shall have fifteen (15) days to dispose of or donate his or her
17 medicinal marijuana to a dispensary.

18 (5) All fees and penalties collected pursuant to this section shall be forwarded to the
19 medicinal marijuana trust fund established in Section 31 of this Act.

20 (6) A cardholder who fails to make a notification to the department that is required
21 by this section is subject to a violation, punishable by a penalty of no more than
22 one hundred fifty dollars (\$150).

23 ➔SECTION 15. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
24 TO READ AS FOLLOWS:

25 (1) Any cardholder who sells, distributes, or dispenses marijuana to a person who is
26 not permitted to possess or use marijuana under Sections 1 to 30 of this Act shall
27 have his or her registry identification card revoked and shall be subject to other

1 penalties, including but not limited to criminal prosecution under this chapter
 2 and KRS 138.870 to 138.889.

3 (2) The department may revoke the registry identification card of any cardholder
 4 who knowingly commits multiple violations or a serious violation of Sections 1 to
 5 30 of this Act.

6 (3) The department shall provide notice of revocation, fine, or other penalty by
 7 mailing, via certified mail, the same in writing to the cardholder. The cardholder
 8 may, within thirty (30) days after the date of the mailing of the department's
 9 notice, file a written request for an administrative hearing regarding the
 10 revocation, fine, or other penalty. The hearing shall be conducted in compliance
 11 with the requirements of KRS Chapter 13B.

12 (4) Final orders of the department after administrative hearings shall be subject to
 13 judicial review. Jurisdiction and venue for judicial review are vested in the
 14 Circuit Court of the county in which the appealing party resides.

15 ➔SECTION 16. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 16 TO READ AS FOLLOWS:

17 (1) No person shall cultivate, process, produce, possess, test, transfer, transport, or
 18 sell medicinal marijuana or otherwise operate a cannabis business in this state
 19 without first obtaining a license under this section.

20 (2) The department shall create separate licenses allowing persons to operate a
 21 cannabis business, pursuant to Sections 1 to 30 of this Act, as:

22 (a) A cannabis cultivator;

23 (b) A cannabis dispensary;

24 (c) A cannabis processor; or

25 (d) A cannabis safety compliance facility.

26 (3) A cannabis business shall be required to apply for and obtain from the
 27 department a separate license for each location it intends to operate.

1 (4) A cannabis business license issued under this section and Sections 17 to 19 of
 2 this Act shall be valid for one (1) year from the date of issuance. The department
 3 shall notify each licensee ninety (90) days prior to the date the license expires to
 4 allow the licensee to begin the renewal procedure promulgated by the department
 5 pursuant to Section 28 of this Act.

6 (5) The department shall approve a license holder's sale of a license issued pursuant
 7 to this section and Sections 17 to 19 of this Act if the purchaser and any new
 8 facilities meet the requirements of Sections 1 to 30 of this Act.

9 (6) The cannabis business licensure categories established in subsection (2) of this
 10 section shall be further tiered by business size pursuant to Section 17 of this Act.

11 ➔SECTION 17. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 12 TO READ AS FOLLOWS:

13 (1) The department shall establish three (3) licensure tiers for each of the licensure
 14 categories established in Section 16 of this Act.

15 (2) (a) A first tier cannabis business license shall be issued to:

16 1. A Person or entity applying for an initial cannabis business license for
 17 the first time; or

18 2. A cannabis business who, upon applying for renewal of a cannabis
 19 business license, had no more than two million dollars (\$2,000,000) of
 20 gross receipts during the previous calendar year.

21 (b) The initial license fee for a cannabis business license issued under
 22 subparagraph 1. of paragraph (a) of this subsection shall be five thousand
 23 dollars (\$5,000).

24 (c) The licensure renewal fee for a first tier cannabis business license renewed
 25 under subparagraph 2. of paragraph (a) of this subsection shall be five
 26 hundred dollars (\$500) plus one percent (1%) of all gross receipts during
 27 the previous calendar year.

1 (3) (a) A second tier cannabis business license shall be issued to a cannabis
 2 business who, upon applying for renewal of a cannabis business license,
 3 had more than two million dollars (\$2,000,000) but not more than eight
 4 million dollars (\$8,000,000) of gross receipts during the previous calendar
 5 year.

6 (b) The licensure renewal fee for a second tier cannabis business license shall
 7 be two thousand dollars (\$2,000) plus one and one-half percent (1.5%) of
 8 all gross receipts during the previous calendar year.

9 (4) (a) A third tier cannabis business license shall be issued to cannabis businesses
 10 who, upon applying for renewal of a cannabis business license, had over
 11 eight million dollars (\$8,000,000) of gross receipts during the previous
 12 calendar year.

13 (b) The licensure renewal fee for a third tier cannabis business license shall be
 14 four thousand dollars (\$4,000) plus two percent (2%) of all gross receipts
 15 during the previous calendar year.

16 (5) All licensure fees collected pursuant to this section shall be forwarded to the
 17 medicinal marijuana trust fund established in Section 31 of this Act.

18 ➔SECTION 18. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 19 TO READ AS FOLLOWS:

20 (1) The department shall create a uniform application form for the cannabis
 21 business licenses established in Section 16 of this Act.

22 (2) When applying for a license, the applicant shall submit the following in
 23 accordance with the department's administrative regulations:

24 (a) The proposed legal name of the cannabis business;

25 (b) The proposed physical address of the cannabis business and the global
 26 positioning system coordinates for any proposed cultivation activities;

27 (c) The name, address, and date of birth of each principal officer and board

1 member of the cannabis business;

2 (d) Any instances in which a business or not-for-profit entity that any of the
 3 prospective board members managed or served on the board of was
 4 convicted, fined, censured, or had a registration or license suspended or
 5 revoked in any administrative or judicial proceeding;

6 (e) Any information required by the department to evaluate the applicant
 7 pursuant to the competitive bid process described in Section 19 of this Act;
 8 and

9 (f) A nonrefundable licensure application fee of one hundred dollars (\$100).

10 (3) The application fee required under subsection (2) of this section shall be applied
 11 to the initial licensing fee if the license is approved; otherwise it shall be retained
 12 by the department for administrative purposes.

13 (4) If a cannabis business license application is approved:

14 (a) The cannabis business shall, before it begins operations, submit the initial
 15 license fee established in Section 17 of this Act, minus the one hundred
 16 dollars (\$100) application fee, to the department and, if a physical address
 17 had not been finalized when it applied, it shall submit its complete physical
 18 address; and

19 (b) The department shall issue a copy of the license that includes the business's
 20 identification number. The department shall also provide each licensed
 21 dispensary with the contact information for the cardholder verification
 22 system.

23 ➔SECTION 19. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 24 TO READ AS FOLLOWS:

25 (1) The department may deny an application for a cannabis business license for any
 26 reason that the department, in the exercise of sound discretion, deems sufficient,
 27 including but not limited to:

- 1 (a) The applicant failed to submit the materials required by this section and
2 Section 18 of this Act, including if the applicant's plans do not satisfy the
3 security, oversight, or recordkeeping administrative regulations
4 promulgated by the department;
- 5 (b) The applicant falsifies information on the licensure application;
- 6 (c) The applicant would not be in compliance with local cannabis business
7 prohibitions enacted pursuant to Section 26 of this Act;
- 8 (d) The applicant does not meet the requirements of Section 20 of this Act;
- 9 (e) One (1) or more of the prospective principal officers or board members:
- 10 1. Has been convicted of a disqualifying felony offense, the provisions of
11 KRS 335B.020 and 335B.030 notwithstanding;
- 12 2. Has served as a principal officer or board member for a cannabis
13 business that has had its license revoked;
- 14 3. Is younger than twenty-one (21) years of age; or
- 15 4. Is a practitioner who has been authorized by a state licensing board to
16 provide patients with a written certification; or
- 17 (f) 1. For a safety compliance facility, one (1) or more of the prospective
18 principal officers or board members is a principal officer or board
19 member of a cultivator, processor, or dispensary licensed to operate in
20 Kentucky; or
- 21 2. For a cultivator, processor, or dispensary, one (1) or more of the
22 prospective principal officers or board members is a principal officer
23 or board member of a safety compliance facility licensed to operate in
24 Kentucky.
- 25 (2) The department shall acknowledge receipt of an application for a cannabis
26 business license within fifteen (15) days of receipt, and approve or deny the
27 application within forty-five (45) days of receiving a completed application.

- 1 (3) The department shall notify the applicant in writing of a license denial and
2 reasons by registered or certified mail at the address given in the application or
3 supplement. Except for license denials based upon subsections (5) and (6) of this
4 section, the applicant may, within thirty (30) days after the mailing of the
5 department's notice, file a written request for an administrative hearing on the
6 application. The hearing shall be conducted on the application in compliance
7 with the requirements of KRS Chapter 13B.
- 8 (4) Final orders of the department after administrative hearings shall be subject to
9 judicial review as provided in KRS 13B.140. Jurisdiction and venue for judicial
10 review are vested in the Circuit Court of the county in which the applicant
11 business would be located.
- 12 (5) Notwithstanding subsection (1) of this section, the department shall not be
13 required to issue more cannabis business licenses than market pressures dictate,
14 except that the department shall not place a limit on the number of licenses
15 issued for safety compliance facilities.
- 16 (6) If the department receives a greater number of cannabis business license
17 applications in any cannabis business category than it deems necessary to meet
18 the demonstrated or anticipated needs for current or anticipated cardholders, the
19 department shall use an impartial and numerically scored competitive bid process
20 developed by the department to evaluate cannabis business license applications.
21 The competitive bid process shall consider the following criteria:
- 22 (a) The suitability of the proposed location or locations, including compliance
23 with any local zoning laws and the geographic convenience to patients
24 throughout the Commonwealth should the applicant be approved;
- 25 (b) The principal officers' and board members' relevant experience, including
26 any training or professional licensing related to medicine, pharmaceuticals,
27 natural treatments, botany, or medicinal marijuana cultivation and

1 preparation, and their experience running any other business or not-for-
2 profit entity;

3 (c) The proposed cannabis business's plan for operations and services,
4 including:

5 1. Staffing and training plans;

6 2. A plan to provide employees with a safe, healthy, and economically
7 sustainable working environment;

8 3. Whether it has sufficient capital to operate; and

9 4. The ability to assist with the provision of an adequate supply of
10 medicinal marijuana to the cardholders in its locality, area
11 development district, or the state;

12 (d) The sufficiency of the applicant's plans for recordkeeping;

13 (e) The sufficiency of the applicant's plans for safety, security, and the
14 prevention of diversion, including proposed locations and security devices
15 employed;

16 (f) The applicant's plan for making medicinal marijuana available on an
17 affordable basis to registered qualified patients who are veterans, or who
18 are enrolled in Medicaid or receiving Supplemental Security Income or
19 Social Security disability insurance;

20 (g) The applicant's plan for safe and accurate packaging and labeling of
21 medicinal marijuana, including the applicant's plan for ensuring that all
22 medicinal marijuana is free of contaminants; and

23 (h) The absence of violations by the applicant or one (1) or more of its principal
24 officers of any local, state, or federal tax, criminal, public safety, food
25 safety, discrimination, workplace safety, employment, or other laws relevant
26 to the operation of its business.

27 (7) Notwithstanding subsection (5) of this section:

1 (a) 1. No later than one (1) year after the effective date of this Act, if a
2 sufficient number of cannabis business license applications has been
3 submitted to the department, the department shall issue a cannabis
4 business license to at least the fifteen (15) highest-scoring applicants
5 within each cannabis business category, except that the need to ensure
6 an adequate geographic distribution of cannabis businesses may
7 supersede the requirement that the department approve license
8 applications based solely on the competitive bid process described in
9 subsection (4) of this section, and the department may divide the state
10 into geographical areas and grant a license to the highest-scoring
11 applicant within each cannabis business category in each geographic
12 area.

13 2. If the department decides to divide the state into geographic areas,
14 pursuant to this subsection, the department is encouraged to use the
15 area development district counties as established in KRS 147A.050 on
16 the effective date of this Act;

17 (b) No later than two (2) years after the effective date of this Act, if a sufficient
18 number of cannabis business license applications has been submitted to the
19 department, the department shall issue a cannabis business license to at
20 least one (1) cannabis business in each cannabis business category within
21 each geographical area; and

22 (c) After reviewing a report issued pursuant to Section 3 of this Act, if the
23 department determines that additional cannabis businesses are needed to
24 meet the needs of cardholders either within an area development district or
25 throughout the state, the department shall expand the number of cannabis
26 business licenses issued within an area development district, city, or county
27 and shall issue an appropriate number of cannabis business licenses to

1 ensure that the needs of cardholders can be adequately met.

2 ➔SECTION 20. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
3 TO READ AS FOLLOWS:

4 (1) A cannabis business licensed under this chapter shall:

5 (a) Comply with Sections 1 to 30 of this Act and any administrative regulations
6 promulgated thereunder by the department;

7 (b) Conduct a criminal background check into the criminal history of each
8 person seeking to become a principal officer, board member, agent,
9 volunteer, or employee before that person begins work. A cannabis business
10 shall not employ, accept as a volunteer, or have as a board member,
11 principal officer, or agent any person who:

12 1. Was convicted of a disqualifying felony offense; or

13 2. Is under twenty-one (21) years of age;

14 (c) Implement appropriate security measures to deter and prevent the theft of
15 medicinal marijuana and unauthorized entrance into areas containing
16 medicinal marijuana;

17 (d) Demonstrate sufficient capital such that it can establish its business and
18 meet the needs for its type of cannabis business;

19 (e) Display their license on the premises at all times; and

20 (f) Be subject to reasonable inspection by the department and the Department
21 for Public Health pursuant to the department's procedures or
22 administrative regulations. The department and the Department for Public
23 Health may inspect any licensed premises without having to first obtain a
24 search warrant.

25 (2) A practitioner who has been authorized by a state licensing board to provide
26 patients with a written certification shall not be permitted to be a board member
27 of any cannabis business or to own any portion of a cannabis business.

- 1 (3) The operating documents of a cannabis business shall include procedures for its
2 oversight and procedures to ensure accurate recordkeeping and inventory
3 control.
- 4 (4) A cannabis business shall not be located within one thousand (1,000) feet of an
5 existing elementary or secondary school or a day-care center.
- 6 (5) When transporting medicinal marijuana on behalf of a cannabis business that is
7 permitted to transport medicinal marijuana, a cannabis business agent shall
8 have:
- 9 (a) A copy of the cannabis business license for the business that employs the
10 agent;
- 11 (b) Documentation that specifies the amount of medicinal marijuana being
12 transported and the date on which the medicinal marijuana is being
13 transported; and
- 14 (c) The cannabis business license number and telephone number of any other
15 cannabis business receiving or otherwise involved in the transportation of
16 the medicinal marijuana.
- 17 (6) A cannabis business shall only acquire, possess, cultivate, manufacture, deliver,
18 transfer, transport, supply, or dispense medicinal marijuana for the purposes of
19 distributing medicinal marijuana to cardholders who possess a valid registry
20 identification card issued by the department, or for visiting qualified patients, an
21 equivalent document issued in another jurisdiction.
- 22 (7) A cannabis business is prohibited from acquiring, possessing, delivering,
23 transferring, transporting, supplying, dispensing, or selling any product that
24 contains or is derived from marijuana unless that product was manufactured or
25 otherwise produced by a cannabis business licensed under this chapter.
- 26 (8) All cultivation of medicinal marijuana for cannabis businesses licensed in this
27 state shall be done by cultivators licensed under this chapter and shall take place

1 in an enclosed, locked facility which can only be accessed by cultivator agents
 2 working on behalf of the cultivator at the physical address provided to the
 3 department during the registration process.

4 (9) A cannabis business shall not acquire, possess, cultivate, process, manufacture,
 5 deliver, transfer, transport, supply, dispense, or sell:

6 (a) Raw plant material with a delta-9 tetrahydrocannabinol content of more
 7 than thirty-five percent (35%);

8 (b) Medicinal marijuana products intended for oral consumption as an edible,
 9 oil, or tincture with more than ten (10) milligrams of delta-9
 10 tetrahydrocannabinol per serving, except that this paragraph shall not apply
 11 to oils intended for consumption by vaporization; or

12 (c) Oils intended for consumption by vaporization or any medicinal marijuana
 13 product not described in paragraph (b) of this subsection with a delta-9
 14 tetrahydrocannabinol content of more than seventy percent (70%).

15 ➔SECTION 21. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 16 TO READ AS FOLLOWS:

17 (1) A cultivator or cultivator agent acting on behalf of a cultivator shall not be
 18 subject to prosecution under state or local law, to search or inspection except by
 19 the department and the Department for Public Health pursuant to Sections 20
 20 and 25 of this Act, or to seizure or penalty in any manner, or be denied any right
 21 or privilege, including but not limited to civil penalty or disciplinary action by a
 22 court or business licensing board, for acting pursuant to Sections 1 to 30 of this
 23 Act and the department's administrative regulations for:

24 (a) Acquiring, possessing, planting, cultivating, raising, harvesting, trimming,
 25 or storing cannabis seeds, seedlings, plants, or raw plant material;

26 (b) Delivering, transporting, transferring, supplying, or selling raw plant
 27 material and related supplies to other licensed cannabis businesses in this

1 state; or

2 (c) Selling cannabis seeds or seedlings to similar entities that are licensed to
3 cultivate cannabis in this state or in any other jurisdiction; or

4 (2) Cultivators and cultivator agents acting on behalf of a cultivator shall:

5 (a) Only deliver raw plant material to a licensed cultivator, licensed processor,
6 licensed safety compliance facility, or licensed dispensary for fair market
7 value;

8 (b) Only deliver raw plant material to a licensed dispensary or processor after it
9 has been checked by a safety compliance facility agent for cannabinoid
10 contents and contaminants; and

11 (c) Not supply a dispensary with more than the amount of medicinal marijuana
12 reasonably required by a dispensary.

13 (3) The following square footage limits shall apply to cultivators licensed within each
14 of the tier levels established in Section 17 of this Act:

15 (a) A cultivator operating within the first tier shall not exceed a growth area of
16 two thousand five hundred (2,500) square feet for an indoor growth area or
17 three (3) times that amount for an outdoor crop;

18 (b) A cultivator operating within the second tier shall not exceed a growth area
19 of ten thousand (10,000) square feet for an indoor growth area or three (3)
20 times that amount for an outdoor crop; and

21 (c) A cultivator operating within the third tier shall not exceed a growth area of
22 twenty-five thousand (25,000) square feet for an indoor growth area or
23 three (3) times that amount for an outdoor crop.

24 (4) If a need for additional marijuana cultivation in this state is demonstrated by
25 cannabis businesses or the department's own analysis, the department may
26 increase the cultivation area square footage limits for either indoor or outdoor
27 cultivation, or both, in any or all three (3) licensure tiers by up to three (3) times

1 the limits established in this section. Any increase in cultivation area square
2 footage limits authorized by the department, pursuant to this subsection, shall not
3 result in an increase in the licensure application and renewal fees established in
4 Sections 17 and 18 of this Act.

5 ➔SECTION 22. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
6 TO READ AS FOLLOWS:

7 (1) A dispensary or dispensary agent acting on behalf of a dispensary shall not be
8 subject to prosecution under state or local law, to search or inspection except by
9 the department and the Department for Public Health pursuant to Sections 20
10 and 25 of this Act, to seizure or penalty in any manner, or be denied any right or
11 privilege, including but not limited to a civil penalty or disciplinary action by a
12 court or business licensing board, for acting pursuant to Sections 1 to 30 of this
13 Act and the department's administrative regulations for:

14 (a) Acquiring or possessing medicinal marijuana from a cultivator or processor
15 in this state;

16 (b) Acquiring or possessing medicinal marijuana accessories or educational
17 material;

18 (c) Supplying, selling, dispensing, or distributing medicinal marijuana,
19 medicinal marijuana accessories, or educational material to cardholders or
20 other dispensaries;

21 (d) Selling cannabis seeds to similar entities that are licensed to cultivate
22 cannabis in this state or in any other jurisdiction; or

23 (e) Acquiring, accepting, or receiving medicinal marijuana products from a
24 cardholder, except that a dispensary may not offer anything of monetary
25 value in return for medicinal marijuana received from a cardholder. Any
26 medicinal marijuana received by a dispensary under this paragraph shall be
27 destroyed by the dispensary or its agents and shall not be sold, dispensed, or

1 distributed to another cardholder.

2 (2) A dispensary or dispensary agent acting on behalf of a dispensary shall:

3 (a) Maintain records that include specific notations of the amount of medicinal
4 marijuana being dispensed to a cardholder and whether it was dispensed
5 directly to a registered qualified patient or visiting qualified patient, or to a
6 registered qualified patient's designated caregiver. Each entry shall include
7 the date and time the medicinal marijuana was dispensed. The data
8 required to be recorded by this paragraph shall be entered into the
9 electronic system developed by the department pursuant to subsection (1)(a)
10 of Section 28 of this Act in accordance with administrative regulations
11 promulgated by the department for the record of medicinal marijuana
12 dispensing;

13 (b) Only dispense or sell medicinal marijuana after it has been checked by a
14 safety compliance facility agent for cannabinoid contents and
15 contaminants;

16 (c) Only dispense or sell medicinal marijuana to a registered qualified patient,
17 visiting qualified patient, or designated caregiver after making a diligent
18 effort to verify:

19 1. That the registry identification card, or its equivalent for a visiting
20 qualified patient, presented to the dispensary is valid, including by
21 checking the verification system, if it is operational, or other
22 department-designated databases;

23 2. That the person presenting the registry identification card, or its
24 equivalent for a visiting qualified patient, is the person identified on
25 the registry identification card or its equivalent by examining at least
26 one (1) other form of government-issued photo identification; and

27 3. The amount of medicinal marijuana the person is legally permitted to

1 purchase at the time of verification pursuant to subsection (4) of
 2 Section 4 of this Act by checking the electronic system developed by
 3 the department pursuant to subsection (1)(a) of Section 28 of this Act,
 4 if it is operational, or other department-designated databases;

5 (d) Not acquire medicinal marijuana from any person other than cannabis
 6 businesses licensed under this chapter, or an agent thereof, a registered
 7 qualified patient, or a designated caregiver; and

8 (e) Not rent office space to a practitioner.

9 (3) If a dispensary fails to comply with subsection (2)(c) of this section, the
 10 department may issue the dispensary a civil fine of up to fifty thousand dollars
 11 (\$50,000), except that the fine shall be one hundred thousand dollars (\$100,000)
 12 if the person purchasing or attempting to purchase medicinal marijuana is a
 13 minor. All fines collected pursuant to this subsection shall be forwarded to the
 14 medicinal marijuana trust fund established in Section 31 of this Act.

15 ➔SECTION 23. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 16 TO READ AS FOLLOWS:

17 (1) A processor or processor agent acting on behalf of a processor shall not be
 18 subject to prosecution under state or local law, to search or inspection except by
 19 the department and the Department for Public Health pursuant to Sections 20
 20 and 25 of this Act, to seizure or penalty in any manner, or be denied any right or
 21 privilege, including but not limited to civil penalty or disciplinary action by a
 22 court or business licensing board, for acting pursuant to Sections 1 to 30 of this
 23 Act and the department's administrative regulations for:

24 (a) Acquiring or purchasing raw plant material from a cultivator or processor
 25 in this state;

26 (b) Possessing, processing, preparing, manufacturing, manipulating, blending,
 27 preparing, or packaging medicinal marijuana;

1 (c) Transferring, transporting, supplying, or selling medicinal marijuana and
 2 related supplies to other cannabis businesses in this state; or

3 (d) Selling cannabis seeds or seedlings to similar entities that are licensed to
 4 cultivate cannabis in this state or in any other jurisdiction.

5 (2) In no case shall a processed or produced medicinal marijuana product intended
 6 for oral consumption as an edible, oil, or tincture exceed ten (10) milligrams of
 7 delta-9 tetrahydrocannabinol per serving. For the purposes of this subsection, oil
 8 intended for consumption as a vaporizing product shall not be limited to ten (10)
 9 milligrams of delta-9 tetrahydrocannabinol per serving.

10 ➔SECTION 24. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 11 TO READ AS FOLLOWS:

12 A safety compliance facility or safety compliance facility agent acting on behalf of a
 13 safety compliance facility shall not be subject to prosecution, search except by the
 14 department and the Department for Public Health pursuant to Sections 20 and 25 of
 15 this Act, seizure, or penalty in any manner, or be denied any right or privilege,
 16 including but not limited to civil penalty or disciplinary action by a court or business
 17 licensing board, for acting in accordance with Sections 1 to 30 of this Act and the
 18 department's administrative regulations to provide the following services:

19 (1) Acquiring or possessing medicinal marijuana obtained from cardholders or
 20 cannabis businesses in this state;

21 (2) Returning the medicinal marijuana to cardholders or cannabis businesses in this
 22 state;

23 (3) Transporting medicinal marijuana that was produced by cannabis businesses in
 24 this state;

25 (4) The production or sale of approved educational materials related to the use of
 26 medicinal marijuana;

27 (5) The production, sale, or transportation of equipment or materials other than

1 medicinal marijuana, including but not limited to lab equipment and packaging
 2 materials that are used by cannabis businesses and cardholders, to cardholders or
 3 cannabis businesses licensed under this chapter;

4 (6) Testing of medicinal marijuana produced in this state, including testing for
 5 cannabinoid content, pesticides, mold, and contamination;

6 (7) Training cardholders and cannabis business agents. Training may include but
 7 need not be limited to:

8 (a) The safe and efficient cultivation, harvesting, packaging, labeling, and
 9 distribution of medicinal marijuana;

10 (b) Security and inventory accountability procedures;

11 (c) Up-to-date scientific and medical research findings related to medicinal use
 12 of marijuana; and

13 (8) Receiving compensation for actions allowed under this section.

14 ➔SECTION 25. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 15 TO READ AS FOLLOWS:

16 (1) Cannabis businesses shall be subject to reasonable inspection by the department
 17 and the Department for Public Health pursuant to the department's procedures
 18 or administrative regulations. The department and the Department for Public
 19 Health may inspect any licensed cannabis business premises without having to
 20 first obtain a search warrant.

21 (2) Except as provided in Section 22 of this Act, the department may issue a civil fine
 22 of up to three thousand dollars (\$3,000) to a cannabis business for a violation of
 23 Sections 1 to 30 of this Act. All fines collected pursuant to this section shall be
 24 forwarded to the medicinal marijuana trust fund established in Section 31 of this
 25 Act.

26 (3) The department may, on its own motion or on complaint, after investigation and
 27 opportunity for a public hearing at which the cannabis business has been

- 1 afforded an opportunity to appear and be heard pursuant to KRS Chapter 13B,
2 suspend or revoke a cannabis business license for multiple violations or a serious
3 violation of Sections 1 to 30 of this Act or any administrative regulations
4 promulgated thereunder by the licensee or any of its agents. A suspension shall
5 not be for a period of time longer than six (6) months.
- 6 (4) The department shall provide notice of suspension, revocation, fine, or other
7 penalty, as well as the required notice of the hearing, by mailing, via certified
8 mail, the same in writing to the cannabis business at the address on the license.
9 The cannabis business may, within thirty (30) days after the date of the mailing
10 of the department's notice, file a written request for an administrative hearing
11 regarding the suspension, revocation, fine, or other penalty. The hearing shall be
12 conducted in compliance with the requirements of KRS Chapter 13B.
- 13 (5) Final orders of the department after administrative hearings shall be subject to
14 judicial review. Jurisdiction and venue for judicial review are vested in the
15 Circuit Court of the county in which the cannabis business is physically located.
- 16 (6) A cultivator may continue to cultivate and possess marijuana plants during a
17 suspension, but it shall not transfer or sell medicinal marijuana during a
18 suspension.
- 19 (7) A dispensary may continue to possess its existing medicinal marijuana inventory
20 during a suspension, but it shall not acquire additional medicinal marijuana, or
21 dispense, transfer, or sell medicinal marijuana during a suspension.
- 22 (8) A processor may continue to process and possess its existing medicinal marijuana
23 inventory during a suspension, but it shall not acquire additional medicinal
24 marijuana, or dispense, transfer, or sell medicinal marijuana products during a
25 suspension.
- 26 (9) A safety compliance facility may continue to possess medicinal marijuana during
27 a suspension, but it shall not receive any new medicinal marijuana, test or

1 otherwise analyze medicinal marijuana, or transfer or transport medicinal
2 marijuana during a suspension.

3 ➔SECTION 26. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
4 TO READ AS FOLLOWS:

5 (1) For the purposes of this section, "local government" means a city, county,
6 urban-county government, consolidated local government, charter county
7 government, or unified local government.

8 (2) A local government may:

9 (a) Enact ordinances, not in conflict with Sections 1 to 30 of this Act or with
10 the department's administrative regulations, regulating the time, place, and
11 manner of cannabis business operations, except that a local government
12 shall not enact ordinances that impose an undue burden or make cannabis
13 business operations unreasonable or impractical;

14 (b) Prohibit all cannabis business operations within its territory through the
15 passage of an ordinance; or

16 (c) Enact resolutions directing that the question of prohibiting cannabis
17 businesses from operating within its territory be submitted to the voters of
18 its territory at the next regular election pursuant to subsection (5)(j) of this
19 section.

20 (3) If a county, consolidated local government, charter county government, or
21 unified local government prohibits all cannabis business operations, the
22 legislative body of a city located within the county, consolidated local
23 government, charter county government, or unified local government may:

24 (a) Approve cannabis business operations within the limits of the city through
25 the passage of an ordinance; or

26 (b) Enact resolutions directing that the question of allowing cannabis
27 businesses to operate within the limits of the city be submitted to the voters

1 who are eligible to vote in that city's elections at the next regular election
2 pursuant to subsection (5)(j) of this section.

3 (4) If a local government legislative body with jurisdiction prohibits cannabis
4 business operations through the passage of an ordinance, a public question that
5 is initiated by petition and that proposes allowing a cannabis business to operate
6 within the affected territory is authorized.

7 (5) A public question that is initiated by petition and is authorized by subsection (4)
8 of this section shall be submitted to the voters within the affected territory at the
9 next regular election by complying with the following requirements:

10 (a) Before a petition for submission of the proposal may be presented for
11 signatures, an intent to circulate the petition, including a copy of the
12 unsigned petition, shall be filed with the county clerk of the affected
13 territory by any person or group of persons seeking the submission of the
14 public question. The statement of intent shall include the addresses of the
15 person or group of persons and shall specify the person or group of persons,
16 as well as the address, to whom all notices are to be sent. Within ten (10)
17 days after the intent to circulate the petition is filed, the county clerk shall
18 deliver a copy of the intent to circulate the petition, including a copy of the
19 unsigned petition, to the legislative body of the affected territory;

20 (b) The petition shall set out in full the following question: "Are you in favor of
21 the sale of medicinal marijuana at a licensed dispensary and the operation
22 of other cannabis businesses in (affected territory)?";

23 (c) The petition for the submission of the proposal shall be signed by a number
24 of constitutionally qualified voters of the territory to be affected equal to five
25 percent (5%) of registered voters for the affected territory;

26 (d) Each signature shall be executed in ink or indelible pencil and shall be
27 followed by the legibly printed name of each voter, followed by the voter's

1 residence address, year of birth, and the correct date upon which the voter's
2 name was signed;

3 (e) No petition for the submission of the proposal shall be circulated for more
4 than six (6) months prior to its filing;

5 (f) After a petition for the submission of the proposal has received no fewer
6 than the number of qualifying signatures required by paragraph (c) of this
7 subsection, the signed petition shall be filed with the county clerk. When it
8 is filed, each sheet of the petition shall have an affidavit executed by the
9 circulator stating that he or she personally circulated the sheet, the number
10 of signatures thereon, that all signatures were affixed in his or her
11 presence, that he or she believes them to be the genuine signatures of
12 registered voters within the affected territory, and that each signer had an
13 opportunity before signing to read the full text of the proposal;

14 (g) No signer of the petition may withdraw his or her name or have it taken
15 from the petition after the petition has been filed. If the name of any person
16 has been placed on the petition for submission of the public question
17 without that person's authority, the person may, at any time prior to
18 certification of sufficiency of the petition by the county clerk as required by
19 paragraph (h) of this subsection, request the removal of his or her name by
20 the county board of elections and, upon proof that the person's name was
21 placed on the petition without his or her authority, the person's name and
22 personal information shall be eliminated, and he or she shall not be
23 counted as a petitioner;

24 (h) Within thirty (30) days after the petition is filed, the county clerk shall
25 complete a certificate as to its sufficiency or, if it is insufficient, specifying
26 the particulars of the insufficiency, and shall send a copy to the person or
27 persons specified in the statement of intent to receive all notices and to the

1 legislative body of the affected territory, all by registered mail. A petition
2 certified insufficient for lack of the required number of valid signatures
3 may be amended once by filing a supplemental petition upon additional
4 sheets within thirty (30) days after receiving the certificate of insufficiency.
5 The supplemental petition shall comply with the requirements applicable to
6 the original petition and, within ten (10) days after it is filed, the county
7 clerk shall complete a certificate as to the sufficiency of the petition as
8 amended and promptly send a copy of the certificate to the person or
9 persons specified to receive all notices and to the legislative body of the
10 affected territory by registered mail;

11 (i) A final determination as to the sufficiency of a petition shall be subject to
12 review in the Circuit Court of the county of the affected territory and shall
13 be limited to the validity of the county clerk's determination. A final
14 determination of insufficiency shall not prejudice the filing of a new
15 petition for the same purpose; and

16 (j) If, not later than the second Tuesday in August preceding the day
17 established for a regular election, the county clerk has certified that a
18 petition is sufficient or has received a local government resolution pursuant
19 to subsection (2) or (3) of this section, the county clerk shall have prepared
20 to place before the voters of the affected territory at the next regular election
21 the question, which shall be "Are you in favor of the sale of medicinal
22 marijuana at a licensed dispensary and the operation of other cannabis
23 businesses in (affected territory)? Yes....No....". The county clerk shall
24 cause to be published in accordance with KRS Chapter 424, at the same
25 time as the remaining voter information, the full text of the proposal. The
26 county clerk shall cause to be posted in each polling place one (1) copy of
27 the full text of the proposal.

- 1 (6) If the question submitted to the voters under subsection (3) or (5) of this section
2 fails to pass, three (3) years shall elapse before the question of medicinal
3 marijuana sales and cannabis business operations may be included on a regular
4 election ballot for the affected territory.
- 5 (7) If the question submitted to the voters under subsection (3) or (5) of this section
6 passes, medicinal marijuana sales and cannabis business operations may be
7 conducted in the affected territory, notwithstanding any local government
8 ordinances which prohibit all cannabis business operations within its territory.
- 9 (8) In circumstances where a county, consolidated local government, charter county
10 government, or unified local government prohibits cannabis business operations
11 but a city within that county, consolidated local government, charter county
12 government, or unified local government approves cannabis business operations
13 either through the adoption of an ordinance or following the affirmative vote of a
14 public question allowing cannabis business operations, then:
- 15 (a) The cannabis business operations may proceed within the limits of the city;
16 and
- 17 (b) The county, consolidated local government, charter county government, or
18 unified local government may assess an additional reasonable fee to
19 compensate for any additional corrections impact caused by the approval of
20 cannabis business operations. Any additional fees collected pursuant to this
21 subsection shall not exceed the additional corrections impact caused by the
22 approval of cannabis business operations.
- 23 (9) In circumstances where neither a city or the county, urban-county government,
24 consolidated local government, charter county government, or unified local
25 government in which the city is located prohibit cannabis business operations, a
26 cannabis business that is located within the jurisdiction of both the city and the
27 county shall only pay the reasonable established local fees of either the city or the

1 county. The fee shall be established, assessed, collected, and shared between the
2 city and the county, in a manner to be negotiated between the city and the county.

3 (10) The provisions of general election law shall apply to public questions submitted to
4 voters under this section.

5 ➔SECTION 27. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
6 TO READ AS FOLLOWS:

7 (1) The department shall maintain a confidential list of the persons to whom the
8 department has issued registry identification cards and their addresses, telephone
9 numbers, and registry identification numbers.

10 (2) The department shall, only at a cardholder's request, confirm his or her status as
11 a registered qualified patient, visiting qualified patient, or designated caregiver to
12 a third party, such as a landlord, employer, school, medical professional, or
13 court.

14 (3) The following information received and records kept pursuant to the
15 department's administrative regulations promulgated for purposes of
16 administering Sections 1 to 30 of this Act shall be confidential and exempt from
17 the Open Records Act, KRS 61.870 to 61.884, and shall not be subject to
18 disclosure to any individual or public or private entity, except as necessary for
19 authorized employees of the department to perform official duties pursuant to
20 Sections 1 to 30 of this Act:

21 (a) Applications and renewals, their contents, and supporting information
22 submitted by qualified patients, visiting qualified patients, and designated
23 caregivers in compliance with Section 12 of this Act, including information
24 regarding their designated caregivers and practitioners;

25 (b) The individual names and other information identifying persons to whom
26 the department has issued registry identification cards;

27 (c) Any dispensing information required to be kept under Section 22 of this Act

1 or the department's administrative regulations which shall only identify
2 cardholders by their registry identification numbers and shall not contain
3 names or other personal identifying information; and

4 (d) Any department hard drives or other data-recording media that are no
5 longer in use and that contain cardholder information. These hard drives
6 and other media shall be destroyed after a reasonable time or after the data
7 is otherwise stored.

8 Data subject to this section shall not be combined or linked in any manner with
9 any other list or database maintained by the department or the Public Protection
10 Cabinet and shall not be used for any purpose not provided for in Sections 1 to 30
11 of this Act.

12 (4) Nothing in this section shall preclude the following:

13 (a) Notification by the department's employees to state or local law enforcement
14 about falsified or fraudulent information submitted to the department or of
15 other apparently criminal violations of Sections 1 to 30 of this Act if the
16 employee who suspects that falsified or fraudulent information has been
17 submitted has conferred with his or her supervisor and both agree that
18 circumstances exist that warrant reporting;

19 (b) Notification by the department's employees to state licensing board if the
20 department has reasonable suspicion to believe a practitioner did not have a
21 bona fide practitioner-patient relationship with a patient for whom he or
22 she signed a written certification, if the department has reasonable
23 suspicion to believe the practitioner violated the standard of care, or for
24 other suspected violations of Sections 1 to 30 of this Act by a practitioner;

25 (c) Notification by dispensary agents to the department of a suspected violation
26 or attempted violation of Sections 1 to 30 of this Act or the administrative
27 regulations promulgated thereunder;

1 (d) Verification by the department of registry identification cards issued
 2 pursuant to Sections 11 to 13 of this Act; and

3 (e) The submission of the report required by Section 3 of this Act to the
 4 General Assembly.

5 (5) It shall be a misdemeanor punishable by up to one hundred eighty (180) days in
 6 jail and a one thousand dollar (\$1,000) fine for any person, including an
 7 employee or official of the department or another state agency or local
 8 government, to knowingly breach the confidentiality of information obtained
 9 pursuant to Sections 1 to 30 of this Act.

10 ➔SECTION 28. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 11 TO READ AS FOLLOWS:

12 (1) Within one hundred twenty (120) days after the effective date of this Act, the
 13 department shall:

14 (a) Establish, maintain, and operate an electronic system for monitoring the
 15 medicinal marijuana program. The electronic system established pursuant
 16 to this paragraph shall be designed to enable:

17 1. Practitioners to record the issuance of written certifications to
 18 qualified patients, as required by Section 5 of this Act;

19 2. The department and state licensing board to monitor the issuance of
 20 written certifications by practitioners to qualified patients;

21 3. Department personnel, law enforcement personnel, and dispensary
 22 agents to verify the validity of registry identification cards issued by
 23 the department by entering a registry identification number to
 24 determine whether or not the identification number corresponds with
 25 a current, valid registry identification card. The system shall only
 26 disclose whether the identification card is valid and whether the
 27 cardholder is a registered qualified patient, visiting qualified patient,

- 1 or designated caregiver;
- 2 5. Dispensary agents to record the amount of medicinal marijuana that
- 3 is dispensed to a cardholder during each transaction as required by
- 4 Section 22 of this Act; and
- 5 6. The sharing of dispensing data recorded by dispensary agents
- 6 pursuant to Section 22 of this Act with all dispensaries in real time.
- 7 (b) Establish, maintain, and operate an electronic inventory tracking system
- 8 that is capable of tracking medicinal marijuana from the point of
- 9 cultivation to the point of sale to cardholders; and
- 10 (c) Promulgate administrative regulations to establish:
- 11 1. Procedures for the issuance, renewal, suspension, and revocation of
- 12 registry identification cards, including the creation of a standardized
- 13 written certification form and a uniform application form;
- 14 2. Procedures for the issuance and revocation of registry identification
- 15 cards;
- 16 3. Procedures for the issuance, renewal, suspension, and revocation of
- 17 cannabis business licenses, including the creation of a uniform
- 18 licensure application form and the competitive bid process described
- 19 in Section 19 of this Act, with all such procedures subject to the
- 20 requirements of KRS Chapters 13A and 13B;
- 21 4. A convenience fee to be assessed and collected by dispensaries for
- 22 visiting qualified patients who do not possess a valid registry
- 23 identification card issued by the department and who purchase
- 24 medicinal marijuana with a registry identification card or its
- 25 equivalent issued pursuant to the laws of another state, district,
- 26 territory, commonwealth, insular possession of the United States, or
- 27 country recognized by the United States that allows the person to use

1 medicinal marijuana in the jurisdiction of issuance. The convenience
2 fee established pursuant to this subparagraph shall not exceed fifteen
3 dollars (\$15) per transaction;

4 5. A definition of the amount of medicinal marijuana or delta-9
5 tetrahydrocannabinol that constitutes a daily supply, a ten (10) day
6 supply, and a thirty (30) day supply as well as the amount of raw plant
7 material that medicinal marijuana products are considered to be
8 equivalent to;

9 6. Provisions governing the following matters related to cannabis
10 businesses with the goal of protecting against diversion and theft,
11 without imposing any undue burden that would make cannabis
12 business operations unreasonable or impractical on cannabis
13 businesses or compromising the confidentiality of cardholders:

14 a. Recordkeeping and inventory control requirements including the
15 use of the electronic systems developed by the department
16 pursuant to paragraphs (a) and (b) of this subsection;

17 b. Procedures for the verification and validation of a registry
18 identification card, or its equivalent, that was issued pursuant to
19 the laws of another state, district, territory, commonwealth,
20 insular possession of the United States, or country recognized by
21 the United States that allows for the use of medicinal marijuana
22 in the jurisdiction of issuance;

23 c. Security requirements for safety compliance facilities,
24 processors, dispensaries, and cultivators, which shall include at
25 a minimum lighting, video security, alarm requirements, on-site
26 parking, and measures to prevent loitering;

27 d. Procedures for the secure transportation and storage of

- 1 medicinal marijuana by cannabis business licensees and their
2 employees or agents;
- 3 e. Employment and training requirements for licensees and their
4 agents, including requiring each licensee to create an
5 identification badge for each of the licensee's agents or
6 employees; and
- 7 f. Restrictions on visits to licensed cultivation and processing
8 facilities, including requiring the use of visitor logs;
- 9 7. Procedures to establish, publish, and annually update a list of varieties
10 of marijuana that possess a low but effective level of
11 tetrahydrocannabinol, including the substance cannabidiol, by
12 comparing percentages of chemical compounds within a given variety
13 against other varieties of marijuana;
- 14 8. A rating system that tracks the terpene content of at least the twelve
15 (12) major terpenoids within each strain of marijuana available for
16 medicinal use within the Commonwealth;
- 17 9. Requirements for random sample testing of medicinal marijuana to
18 ensure quality control, including testing for cannabinoids, terpenoids,
19 residual solvents, pesticides, poisons, toxins, mold, mildew, insects,
20 bacteria, and any other dangerous adulterant;
- 21 10. Requirements for licensed cultivators and processors to contract with
22 an independent safety compliance facility to test the medicinal

1 11. Standards for the operation of safety compliance facilities which may
2 include:

3 a. Requirements for equipment;

4 b. Personnel qualifications; and

5 c. Requiring facilities to be accredited by a relevant certifying
6 entity;

7 12. Standards for the packaging and labeling of medicinal marijuana sold
8 or distributed by cannabis businesses, including:

9 a. Standards for packaging that requires at least a two (2) step
10 process of initial opening;

11 b. A warning label which may include the length of time it typically
12 takes for the product to take effect, how long the effects of the
13 product typically last, and any other information deemed
14 appropriate or necessary by the department;

15 c. The amount of medicinal marijuana the product is considered
16 the equivalent to;

17 d. Disclosing ingredients and possible allergens;

18 e. A nutritional fact panel;

19 f. Opaque, child-resistant packaging;

20 g. A requirement that all raw plant material packaged or sold in
21 this state be marked or labeled as "NOT INTENDED FOR
22 CONSUMPTION BY SMOKING";

23 h. A requirement that medicinal marijuana products be clearly
24 marked with an identifiable and standardized symbol indicating
25 that the product contains marijuana; and

26 i. A requirement that medicinal marijuana products not be visually
27 reminiscent of major brands of edible noncannabis products or

13. Health and safety requirements for the processing of medicinal marijuana and both the indoor and outdoor cultivation of medicinal marijuana by licensees;

14. Restrictions on:

a. Additives to medicinal marijuana that are toxic or increase the likelihood of addiction; and

b. Pesticides, fertilizers, and herbicides used during medicinal marijuana cultivation which pose a threat to human health and safety;

15. Standards for the safe processing of medicinal marijuana products created by extracting or concentrating compounds from raw plant material;

16. Standards for determining the amount of unprocessed raw plant material that medicinal marijuana products are considered the equivalent to;

17. Restrictions on advertising, marketing, and signage in regard to operations or establishments owned by licensees necessary to prevent the targeting of minors;

18. The requirement that evidence-based educational materials regarding dosage and impairment be disseminated to registered qualified patients, visiting qualified patients, and designated caregivers who purchase medicinal marijuana products;

19. Policies governing insurance requirements for cultivators, dispensaries, processors, and safety compliance facilities;

20. The process by which the board will consider adding additional diseases and medical conditions to the list of qualifying medical

1 conditions established in Section 1 of this Act; and
 2 21. Standards, procedures, or restrictions that the department deems
 3 necessary to ensure the efficient, transparent, and safe operation of
 4 the medicinal marijuana program, except that the department shall
 5 not promulgate any administrative regulation that would impose an
 6 undue burden or make cannabis business operations unreasonable or
 7 impractical.

8 (2) The department shall perform all acts necessary or advisable for the purpose of
 9 contracting with a third party for the development and maintenance of the
 10 electronic systems described in subsection (1)(a) and (b) of this section.

11 (3) When promulgating administrative regulations under this section, the
 12 department shall consider standards, procedures, and restrictions that have been
 13 found to be best practices relative to the use and regulation of medicinal
 14 marijuana.

15 ➔SECTION 29. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 16 TO READ AS FOLLOWS:

17 Nothing in Sections 1 to 30 of this Act shall require a government medical assistance
 18 program, private health insurer or workers' compensation carrier, or self-funded
 19 employer providing workers' compensation benefits to reimburse a person for costs
 20 associated with the medicinal use of marijuana.

21 ➔SECTION 30. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
 22 TO READ AS FOLLOWS:

23 The provisions of KRS 138.870 to 138.889 shall not apply to any individual or entity
 24 for:

25 (1) Any amount of medicinal marijuana that is necessary or reasonably necessary
 26 for use of a license or registry identification card issued pursuant to Sections 1 to
 27 30 of this Act; or

1 (2) Any use of medicinal marijuana that complies with Sections 1 to 30 of this Act
2 and any administrative regulations promulgated thereunder.

3 ➔SECTION 31. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
4 TO READ AS FOLLOWS:

5 (1) The medicinal marijuana trust fund is hereby created within the State Treasury.
6 The fund shall consist of funds collected from registration fees, licensing fees,
7 finances, and penalties established pursuant to Sections 1 to 26 and Sections 28 and
8 30 of this Act, a portion of the excise taxes imposed under Section 33 of this Act,
9 and any proceeds from grants, contributions, appropriations, or other moneys
10 made available for purposes of this fund.

11 (2) The medicinal marijuana trust fund shall be administered by the Finance and
12 Administration Cabinet.

13 (3) Trust fund moneys shall be used as follows:

14 (a) Fifteen percent (15%) shall be transferred to the Kentucky State Police for

20 patients enrolled in Medicaid, receiving Supplemental Security Income or
21 Social Security disability insurance, or veterans of the United States Armed
22 Forces; and

23 (c) No more than seventy percent (70%) shall be used to offset the department's
24 actual cost and expenses of operating the medicinal marijuana program
25 and enforcement activities established in Sections 1 to 30 of this Act.

26 (4) Notwithstanding KRS 45.229, moneys in the fund not expended at the close of the
27 fiscal year shall not lapse but shall be carried forward to the next fiscal year.

1 (5) Any interest earnings of the trust fund shall become part of the fund and shall
2 not lapse.

3 (6) Moneys transferred to the fund are hereby appropriated for the purposes set forth
4 in this section.

5 ➔SECTION 32. A NEW SECTION OF KRS CHAPTER 218A IS CREATED
6 TO READ AS FOLLOWS:

7 (1) The local medicinal marijuana trust fund is hereby created within the State
8 Treasury. The fund shall consist of funds collected from a portion of the excise
9 taxes imposed under Section 33 of this Act.

10 (2) The local medicinal marijuana trust fund shall be administered by the Finance
11 and Administration Cabinet.

12 (3) (a) The Finance and Administration Cabinet shall, on a quarterly basis,
13 distribute the funds deposited into the local medicinal marijuana trust fund
14 during the fiscal quarter immediately preceding the most recent fiscal
15 quarter. Funds shall be distributed among those cities, counties, urban-
16 county governments, consolidated local governments, charter county
17 governments, and unified local governments in which at least one (1)
18 cannabis business licensed as a cultivator, processor, or dispensary was
19 permitted to operate during the fiscal quarter immediately preceding the
20 most recent fiscal quarter.

21 (b) 1. A city in which at least one (1) cannabis business licensed as a
22 cultivator, processor, or dispensary operated during the fiscal quarter
23 immediately preceding the most recent fiscal quarter shall receive an
24 amount equal to seventy-five percent (75%) of the total excise tax
25 revenue collected from all cannabis businesses licensed to operate
26 inside the territory of the city and deposited into the trust fund during
27 the fiscal quarter immediately preceding the most recent fiscal quarter

1 unless the county, consolidated local government, charter county
2 government, or unified local government in which the city is located
3 has, pursuant to Section 26 of the Act, prohibited the operation of
4 cannabis businesses.

5 2. If the county, consolidated local government, charter county
6 government, or unified local government in which the city is located
7 has prohibited the operation of cannabis businesses, then the city shall
8 receive an amount equal to one hundred percent (100%) of the total
9 excise tax revenue collected from all cannabis businesses licensed to
10 operate inside the territory of the city and deposited into the trust fund
11 during the fiscal quarter immediately preceding the most recent fiscal
12 quarter.

13 (c) A county that has not prohibited the operation of cannabis businesses,
14 pursuant to Section 26 of this Act, and in which at least one (1) cannabis
15 business licensed as a cultivator, processor, or dispensary was operated
16 during the fiscal quarter immediately preceding the most recent fiscal
17 quarter shall receive an amount equal to one hundred percent (100%) of the
18 total excise tax revenue collected from all cannabis businesses licensed to
19 operate inside the territory of the county but outside the territory of any
20 city and deposited into the trust fund during the fiscal quarter immediately
21 preceding the most recent fiscal quarter plus twenty-five percent (25%) of
22 the total excise tax revenue collected from all cannabis businesses licensed
23 to operate inside the territory of an incorporated municipality inside the
24 territory of the county and deposited into the trust fund during the fiscal
25 quarter immediately preceding the most recent fiscal quarter.

26 (4) Trust fund moneys may be used for the purposes of local enforcement of
27 medicinal marijuana laws by local law enforcement agencies, local medicinal

1 marijuana licensing, the hiring or training of additional Drug Recognition
 2 Experts (DRE), Advanced Roadside Impaired Driving Enforcement (ARIDE)
 3 training, local evidence-based drug addiction rehabilitation projects, or
 4 educational activities within local jails.

5 (5) Notwithstanding KRS 45.229, moneys in the fund not expended at the close of the
 6 fiscal year shall not lapse but shall be carried forward to the next fiscal year.

7 (6) Any interest earnings of the trust fund shall become part of the fund and shall
 8 not lapse.

9 (7) Moneys transferred to the fund are hereby appropriated for the purposes set forth
 10 in this section.

11 ➔SECTION 33. A NEW SECTION OF KRS CHAPTER 138 IS CREATED TO
 12 READ AS FOLLOWS:

13 (1) As used in this section:

14 (a) "Cultivator" has the same meaning as in Section 1 of this Act;

15 (b) "Department" means the Department of Revenue;

16 (c) "Dispensary" has the same meaning as in Section 1 of this Act;

17 (d) "Medicinal marijuana" has the same meaning as in Section 1 of this Act;

18 and

19 (e) "Processor" has the same meaning as in Section 1 of this Act.

20 (2) Effective January 1, 2021:

21 (a) An excise tax is hereby imposed on the gross receipts of a cultivator or
 22 processor received from the sale of medicinal marijuana by a cultivator or
 23 processor to a dispensary, to be paid by the cultivator or processor at a rate
 24 of twelve percent (12%) of the actual price for which a cultivator or
 25 processor sells medicinal marijuana to a dispensary in this state.

26 (b) The tax shall be charged against and be paid by the cultivator or processor
 27 and shall not be added as a separate charge or line item on any sales slip,

1 invoice, receipt, or other statement or memorandum of the price paid by the
2 dispensary.

3 (3) (a) Eighty percent (80%) of the revenue from the excise tax established in this
4 paragraph shall be deposited in the medicinal marijuana trust fund
5 established in Section 31 of this Act for the purpose of administration of the
6 medicinal marijuana program and for the purposes established in that
7 section.

8 (b) Twenty percent (20%) of the revenue from the excise tax established in this
9 paragraph shall be deposited in the local medicinal marijuana trust fund
10 established in Section 32 of this Act for the purposes of distributing tax
11 proceeds among participating local governments and for the purposes
12 established in that section; and

13 (4) Cultivators and processors of medicinal marijuana products shall:

14 (a) Register with the department;

15 (b) Report and pay the tax levied under this section on or before the twentieth
16 day of the calendar month immediately following the month in which the
17 medicinal marijuana was sold. A tax return shall be filed for each reporting
18 period whether or not tax is due; and

19 (c) Identify the county and city, if any, in which the medicinal marijuana
20 business is located.

21 (5) Any person who violates any provision of this section shall be subject to the
22 uniform civil penalties imposed pursuant to KRS 131.180 and interest at the tax
23 interest rate as defined in KRS 131.010(6) from the date due until the date of
24 payment.

25 (6) (a) Notwithstanding any other provision of this section, the president, vice
26 president, secretary, treasurer, or any other person holding any equivalent
27 corporate office of any corporation subject to the provisions of this section

1 shall be personally and individually liable, both jointly and severally, for the
2 taxes imposed under this section.

3 (b) Corporate dissolution, withdrawal of the corporation from the state, or the
4 cessation of holding any corporate office shall not discharge the liability of
5 any person. The personal and individual liability shall apply to every person
6 holding a corporate office at the time the tax becomes or became due.

7 (c) Notwithstanding any other provision of this chapter, KRS 275.150, 362.1-
8 306(3) or predecessor law, or 362.2-404(3) to the contrary, the managers of
9 a limited liability company, the partners of a limited liability partnership,
10 and the general partners of a limited liability limited partnership, or any
11 other person holding any equivalent office of a limited liability company,
12 limited liability partnership, or limited liability limited partnership subject to
13 the provisions of this section shall be personally and individually liable,
14 both jointly and severally, for the tax imposed under this section.

15 (d) Dissolution, withdrawal of the limited liability company, limited liability
16 partnership, or limited liability limited partnership from the state, or the
17 cessation of holding any office shall not discharge the liability of any
18 person. The personal and individual liability shall apply to every manager
19 of a limited liability company, partner of a limited liability partnership, or
20 general partner of a limited liability limited partnership at the time the tax
21 becomes or became due.

22 (e) No person shall be personally and individually liable under this section who
23 had no authority to truthfully account for, or pay over, any tax imposed by
24 this section at the time the tax imposed becomes or became due.

25 (f) "Taxes" as used in this section includes interest accrued at the rate
26 provided by KRS 131.183, all applicable penalties imposed under the
27 provisions of this chapter, and all applicable penalties imposed under KRS

1 131.180, 131.410 to 131.445, and 131.990.

2 **(7) The department shall administer the provisions of this chapter and shall have all**
 3 **of the powers, rights, duties, and authority with respect to the assessment,**
 4 **collection, refunding, and administration of the taxes levied by this section,**
 5 **conferred generally upon the department by the Kentucky Revised Statutes,**
 6 **including KRS Chapters 131, 134, and 135.**

7 **(8) Every cultivator and processor shall keep records, receipts, invoices, and other**
 8 **pertinent papers in such form as the department may require for not less than**
 9 **four (4) years from the making of such records, receipts, invoices, and other**
 10 **pertinent papers.**

11 ➔Section 34. KRS 342.815 is amended to read as follows:

12 (1) The authority may provide coverage for insurance, authorized in KRS 342.803, to
 13 any employer in the Commonwealth, and who tenders the required premium for
 14 coverage and comply with other conditions and qualifications for obtaining and
 15 maintaining coverage adopted by the authority to protect and ensure its actuarial
 16 soundness and solvency.

17 (2) The authority shall provide coverage to any employer who is unable to secure
 18 coverage in the voluntary market unless:

19 **(a)** The employer owes undisputed premiums to a previous workers'
 20 compensation carrier or to a workers' compensation residual market
 21 mechanism; **or**

22 **(b) Providing coverage to the employer would subject the authority or its**
 23 **employees to a violation of federal or state law.**

24 ➔Section 35. KRS 139.470 is amended to read as follows:

25 There are excluded from the computation of the amount of taxes imposed by this chapter:

26 (1) Gross receipts from the sale of, and the storage, use, or other consumption in this
 27 state of, tangible personal property or digital property which this state is prohibited

1 from taxing under the Constitution or laws of the United States, or under the
2 Constitution of this state;

3 (2) Gross receipts from sales of, and the storage, use, or other consumption in this state
4 of:

5 (a) Nonreturnable and returnable containers when sold without the contents to
6 persons who place the contents in the container and sell the contents together
7 with the container; and

8 (b) Returnable containers when sold with the contents in connection with a retail
9 sale of the contents or when resold for refilling;

10 As used in this section the term "returnable containers" means containers of a kind
11 customarily returned by the buyer of the contents for reuse. All other containers are
12 "nonreturnable containers";

13 (3) Gross receipts from occasional sales of tangible personal property or digital
14 property and the storage, use, or other consumption in this state of tangible personal
15 property or digital property, the transfer of which to the purchaser is an occasional
16 sale;

17 (4) Gross receipts from sales of tangible personal property to a common carrier,
18 shipped by the retailer via the purchasing carrier under a bill of lading, whether the
19 freight is paid in advance or the shipment is made freight charges collect, to a point
20 outside this state and the property is actually transported to the out-of-state
21 destination for use by the carrier in the conduct of its business as a common carrier;

22 (5) Gross receipts from sales of tangible personal property sold through coin-operated
23 bulk vending machines, if the sale amounts to fifty cents (\$0.50) or less, if the
24 retailer is primarily engaged in making the sales and maintains records satisfactory
25 to the department. As used in this subsection, "bulk vending machine" means a
26 vending machine containing unsorted merchandise which, upon insertion of a coin,
27 dispenses the same in approximately equal portions, at random and without

1 selection by the customer;

2 (6) Gross receipts from sales to any cabinet, department, bureau, commission, board, or
3 other statutory or constitutional agency of the state and gross receipts from sales to
4 counties, cities, or special districts as defined in KRS 65.005. This exemption shall
5 apply only to purchases of tangible personal property, digital property, or services
6 for use solely in the government function. A purchaser not qualifying as a
7 governmental agency or unit shall not be entitled to the exemption even though the
8 purchaser may be the recipient of public funds or grants;

9 (7) (a) Gross receipts from the sale of sewer services, water, and fuel to Kentucky
10 residents for use in heating, water heating, cooking, lighting, and other
11 residential uses. As used in this subsection, "fuel" shall include but not be
12 limited to natural gas, electricity, fuel oil, bottled gas, coal, coke, and wood.
13 Determinations of eligibility for the exemption shall be made by the
14 department;

15 (b) In making the determinations of eligibility, the department shall exempt from
16 taxation all gross receipts derived from sales:

17 1. Classified as "residential" by a utility company as defined by applicable
18 tariffs filed with and accepted by the Public Service Commission;

19 2. Classified as "residential" by a municipally owned electric distributor
20 which purchases its power at wholesale from the Tennessee Valley
21 Authority;

22 3. Classified as "residential" by the governing body of a municipally owned
23 electric distributor which does not purchase its power from the
24 Tennessee Valley Authority, if the "residential" classification is
25 reasonably consistent with the definitions of "residential" contained in
26 tariff filings accepted and approved by the Public Service Commission
27 with respect to utilities which are subject to Public Service Commission

1 regulation.

2 If the service is classified as residential, use other than for "residential"
3 purposes by the customer shall not negate the exemption;

4 (c) The exemption shall not apply if charges for sewer service, water, and fuel are
5 billed to an owner or operator of a multi-unit residential rental facility or
6 mobile home and recreational vehicle park other than residential
7 classification; and

8 (d) The exemption shall apply also to residential property which may be held by
9 legal or equitable title, by the entireties, jointly, in common, as a
10 condominium, or indirectly by the stock ownership or membership
11 representing the owner's or member's proprietary interest in a corporation
12 owning a fee or a leasehold initially in excess of ninety-eight (98) years;

13 (8) Gross receipts from sales to an out-of-state agency, organization, or institution
14 exempt from sales and use tax in its state of residence when that agency,
15 organization, or institution gives proof of its tax-exempt status to the retailer and the
16 retailer maintains a file of the proof;

17 (9) (a) Gross receipts derived from the sale of, the following tangible personal
18 property to a manufacturer or industrial processor if the property is to be
19 directly used in the manufacturing or industrial processing process of tangible
20 personal property at a plant facility and which will be for sale:

21 1. Materials which enter into and become an ingredient or component part
22 of the manufactured product;

23 2. Other tangible personal property which is directly used in the
24 manufacturing or industrial processing process, if the property has a
25 useful life of less than one (1) year. Specifically these items are
26 categorized as follows:

27 a. Materials. This refers to the raw materials which become an

1 ingredient or component part of supplies or industrial tools exempt
2 under subdivisions b. and c. below;

3 b. Supplies. This category includes supplies such as lubricating and
4 compounding oils, grease, machine waste, abrasives, chemicals,
5 solvents, fluxes, anodes, filtering materials, fire brick, catalysts,
6 dyes, refrigerants, and explosives. The supplies indicated above
7 need not come in direct contact with a manufactured product to be
8 exempt. "Supplies" does not include repair, replacement, or spare
9 parts of any kind; and

10 c. Industrial tools. This group is limited to hand tools such as jigs,
11 dies, drills, cutters, rolls, reamers, chucks, saws, and spray guns
12 and to tools attached to a machine such as molds, grinding balls,
13 grinding wheels, dies, bits, and cutting blades. Normally, for
14 industrial tools to be considered directly used in the manufacturing
15 or industrial processing process, they shall come into direct contact
16 with the product being manufactured or processed; and

17 3. Materials and supplies that are not reusable in the same manufacturing
18 or industrial processing process at the completion of a single
19 manufacturing or processing cycle. A single manufacturing cycle shall
20 be considered to be the period elapsing from the time the raw materials
21 enter into the manufacturing process until the finished product emerges
22 at the end of the manufacturing process.

23 (b) The property described in paragraph (a) of this subsection shall be regarded as
24 having been purchased for resale.

25 (c) For purposes of this subsection, a manufacturer or industrial processor
26 includes an individual or business entity that performs only part of the
27 manufacturing or industrial processing activity, and the person or business

1 entity need not take title to tangible personal property that is incorporated into,
2 or becomes the product of, the activity.

3 (d) The exemption provided in this subsection does not include repair,
4 replacement, or spare parts;

5 (10) Any water use fee paid or passed through to the Kentucky River Authority by
6 facilities using water from the Kentucky River basin to the Kentucky River
7 Authority in accordance with KRS 151.700 to 151.730 and administrative
8 regulations promulgated by the authority;

9 (11) Gross receipts from the sale of newspaper inserts or catalogs purchased for storage,
10 use, or other consumption outside this state and delivered by the retailer's own
11 vehicle to a location outside this state, or delivered to the United States Postal
12 Service, a common carrier, or a contract carrier for delivery outside this state,
13 regardless of whether the carrier is selected by the purchaser or retailer or an agent
14 or representative of the purchaser or retailer, or whether the F.O.B. is retailer's
15 shipping point or purchaser's destination.

16 (a) As used in this subsection:

17 1. "Catalogs" means tangible personal property that is printed to the special
18 order of the purchaser and composed substantially of information
19 regarding goods and services offered for sale; and

20 2. "Newspaper inserts" means printed materials that are placed in or
21 distributed with a newspaper of general circulation.

22 (b) The retailer shall be responsible for establishing that delivery was made to a
23 non-Kentucky location through shipping documents or other credible evidence
24 as determined by the department;

25 (12) Gross receipts from the sale of water used in the raising of equine as a business;

26 (13) Gross receipts from the sale of metal retail fixtures manufactured in this state and
27 purchased for storage, use, or other consumption outside this state and delivered by

1 the retailer's own vehicle to a location outside this state, or delivered to the United
2 States Postal Service, a common carrier, or a contract carrier for delivery outside
3 this state, regardless of whether the carrier is selected by the purchaser or retailer or
4 an agent or representative of the purchaser or retailer, or whether the F.O.B. is the
5 retailer's shipping point or the purchaser's destination.

6 (a) As used in this subsection, "metal retail fixtures" means check stands and
7 belted and nonbelted checkout counters, whether made in bulk or pursuant to
8 specific purchaser specifications, that are to be used directly by the purchaser
9 or to be distributed by the purchaser.

10 (b) The retailer shall be responsible for establishing that delivery was made to a
11 non-Kentucky location through shipping documents or other credible evidence
12 as determined by the department;

13 (14) Gross receipts from the sale of unenriched or enriched uranium purchased for
14 ultimate storage, use, or other consumption outside this state and delivered to a
15 common carrier in this state for delivery outside this state, regardless of whether the
16 carrier is selected by the purchaser or retailer, or is an agent or representative of the
17 purchaser or retailer, or whether the F.O.B. is the retailer's shipping point or
18 purchaser's destination;

19 (15) Amounts received from a tobacco buydown. As used in this subsection, "buydown"
20 means an agreement whereby an amount, whether paid in money, credit, or
21 otherwise, is received by a retailer from a manufacturer or wholesaler based upon
22 the quantity and unit price of tobacco products sold at retail that requires the retailer
23 to reduce the selling price of the product to the purchaser without the use of a
24 manufacturer's or wholesaler's coupon or redemption certificate;

25 (16) Gross receipts from the sale of tangible personal property or digital property
26 returned by a purchaser when the full sales price is refunded either in cash or credit.
27 This exclusion shall not apply if the purchaser, in order to obtain the refund, is

- 1 required to purchase other tangible personal property or digital property at a price
2 greater than the amount charged for the property that is returned;
- 3 (17) Gross receipts from the sales of gasoline and special fuels subject to tax under KRS
4 Chapter 138;

2 danger or peril and a high degree of physical conditioning; and

3 2. The employee's duties are not primarily clerical or administrative.

4 (c) The effective date of participation under hazardous duty coverage for
5 positions in the Department of Alcoholic Beverage and Cannabis Control
6 shall be April 1, 1998. The employer and employee contributions shall be paid
7 by the employer and forwarded to the retirement system for the period not
8 previously reported.

9 (2) (a) Each employer may request of the board hazardous duty coverage for those
10 positions as defined in subsection (1) of this section. Upon request, each
11 employer shall certify to the system, in the manner prescribed by the board,
12 the names of all employees working in a hazardous position as defined in
13 subsection (1) of this section for which coverage is requested. The
14 certification of the employer shall bear the approval of the agent or agency
15 responsible for the budget of the department or county indicating that the
16 required employer contributions have been provided for in the budget of the
17 employing department or county. The system shall determine whether the
18 employees whose names have been certified by the employer are working in
19 positions meeting the definition of a hazardous position as provided by
20 subsection (1) of this section. This process shall not be required for employees
21 who elect coverage under KRS 196.167(3)(b)2.

22 (b) Each employer desiring to provide hazardous duty coverage to employees who
23 begin participating in the County Employees Retirement System on or after
24 September 1, 2008, may request that the board approve hazardous duty
25 coverage for those positions that meet the criteria set forth in subsection (1)(b)
26 of this section. Each employer shall certify to the system, in the manner
27 prescribed by the board, the names of all employees working in a hazardous

1 position as defined in subsection (1)(b) of this section for which coverage is
2 requested and a job description for each position or employee. The
3 certification of the employer shall bear the approval of the agent or agency
4 responsible for the budget of the department or county indicating that the
5 required employer contributions have been provided for in the budget of the
6 employing department or county. Each employer shall also certify, under
7 penalty of perjury in accordance with KRS Chapter 523, that each employee's
8 actual job duties are accurately reflected in the job description provided to the
9 system. The system shall determine whether the employees whose names have
10 been certified by the employer are working in positions meeting the definition
11 of a hazardous position as defined in subsection (1)(b) of this section. The
12 board shall have the authority to remove any employee from hazardous duty
13 coverage if the board determines the employee is not working in a hazardous
14 duty position or if the employee is classified in a hazardous duty position but
15 has individual job duties that do not meet the definition of a hazardous duty
16 position or are not accurately reflected in the job descriptions filed by the
17 employer with the system.

18 (3) (a) An employee who elects coverage under KRS 196.167(3)(b)2., and an
19 employee participating in the Kentucky Employees Retirement System who is
20 determined by the system to be working in a hazardous position in accordance
21 with subsection (2) of this section, shall contribute, for each pay period for
22 which he receives compensation, eight percent (8%) of his creditable
23 compensation. An employee participating in the County Employees
24 Retirement System who is determined by the system to be working in a
25 hazardous duty position in accordance with subsection (2) of this section shall
26 contribute, for each pay period for which he receives compensation, eight
27 percent (8%) of his creditable compensation.

- 1 (b) Each employer shall pay employer contributions based on the creditable
2 compensation of the employees determined by the system to be working in a
3 hazardous position at the employer contribution rate as determined by the
4 board. The rate shall be determined by actuarial methods consistent with the
5 provisions of KRS 61.565.
- 6 (c) If the employer participated in the system prior to electing hazardous duty
7 coverage, the employer may pay to the system the cost of converting the
8 nonhazardous service to hazardous service from the date of participation to
9 the date the payment is made, or the employer may establish a payment
10 schedule for payment of the cost of the hazardous service above that which
11 would be funded within the existing employer contribution rate. The employer
12 may extend the payment schedule to a maximum of thirty (30) years.
13 Payments made by the employer under this subsection shall be deposited to
14 the retirement allowance account of the proper retirement system and these
15 funds shall not be considered accumulated contributions of the individual
16 members. If the employer elects not to make the additional payment, the
17 employee may pay the cost of converting the service and provide payment for
18 the cost as provided by KRS 61.552(14). Payments made by the employee
19 under this subsection shall not be picked up, as described in KRS 61.560(4),
20 by the employer. If neither the employer nor employee makes the payment, the
21 service prior to hazardous coverage shall remain nonhazardous. The
22 provisions of this paragraph shall not apply to members who begin
23 participating in the systems administered by Kentucky Retirement Systems on
24 or after January 1, 2014.
- 25 (4) The normal retirement age, retirement allowance, hybrid cash balance plans, other
26 benefits, eligibility requirements, rights, and responsibilities of a member in a
27 hazardous position, as prescribed by subsections (1), (2), and (3) of this section, and

1 the responsibilities, rights, and requirements of his employer shall be as prescribed
2 for a member and employer participating in the State Police Retirement System as
3 provided for by KRS 16.505 to 16.652.

4 (5) Any person employed in a hazardous position after July 1, 1972, shall be required to
5 undergo a thorough medical examination by a licensed physician, and a copy of the
6 medical report of the physician shall be retained on file by the employee's
7 department or county and made available to the system upon request.

8 (6) If doubt exists regarding the benefits payable to a hazardous position employee
9 under this section, the board shall determine the benefits payable under KRS 61.510
10 to 61.705, or 78.510 to 78.852, or 16.505 to 16.652.

11 ➔Section 49. KRS 62.160 is amended to read as follows:

12 (1) The state officers elected by the voters of the state at large, except the Governor and
13 the Lieutenant Governor, the heads of departments, offices, and cabinets of the state
14 government, the adjutant general, the members of the Public Service Commission,
15 the members of the State Fair Board and Fish and Wildlife Resources Commission,
16 and the members of the Kentucky Claims Commission and the Alcoholic Beverage

6 (1) Whenever it is determined that a taxpayer, who holds a license under KRS Chapter
 7 243, is a delinquent taxpayer as defined in subsection (2) of this section, the
 8 department may, after giving notice as provided in subsection (3) of this section,
 9 submit the name of the taxpayer to the Department of Alcoholic Beverage ***and***
 10 ***Cannabis*** Control for revocation of any license issued under KRS Chapter 243.

11 (2) Any of the following situations shall be sufficient to cause a taxpayer to be
 12 classified as a "delinquent taxpayer" for purposes of this section:

13 (a) When a taxpayer has an overdue state tax liability arising directly or indirectly
 14 from the manufacture, sale, transportation, or distribution of alcoholic
 15 beverages, for which all protest and appeal rights granted by law have expired,
 16 and the taxpayer has been contacted by the department concerning the overdue
 17 tax liability. This does not include a taxpayer who is making current timely
 18 installment payments on the overdue tax liability under agreement with the
 19 department;

20 (b) When a taxpayer has not filed a required tax return as of ninety (90) days after
 21 the due date or after the extended due date, and the taxpayer has been
 22 contacted by the department concerning the delinquent return; or

23 (c) When an owner, partner, or corporate officer of a proprietorship, partnership,
 24 or corporation holding a license under KRS Chapter 243 held a similar
 25 position in a business whose license was revoked as a "delinquent taxpayer,"
 26 and the tax liability remains unpaid as of ninety (90) days after the due date.

27 (3) At least twenty (20) days before submitting a taxpayer's name to the Department of

1 Alcoholic Beverage and Cannabis Control as provided in subsection (1) of this
2 section, the department shall notify the taxpayer by certified mail that the action is
3 to be taken. The notice shall state the reason for the action and shall set out the
4 amount of any tax liability including any applicable penalties and interest and any

- 9 (1) There is hereby created the malt beverage educational fund which shall provide
10 moneys on a matching basis for educational information and materials that deter or
11 eliminate underage drinking. The fund shall consist of moneys generated from one
12 percent (1%) of the excise tax collected from the sale and distribution of malt
13 beverages under KRS 243.720 and one percent (1%) of the wholesale tax collected
14 from distributors of malt beverages and microbreweries under KRS 243.884.
- 15 (2) The malt beverage educational fund shall be established in the State Treasury as a
16 trust and revolving account under KRS 45.253. Moneys in the account shall be
17 distributed by the State Treasurer to the Malt Beverage Educational Corporation, a

19 authorization of the secretary of the Cabinet for Health and Family Services. The
20 moneys shall be awarded to the corporation solely to fund educational programs to
21 deter or eliminate underage drinking.
- 22 (3) The secretary of the Cabinet for Health and Family Services shall authorize that
23 moneys from the fund be disbursed to the corporation upon the secretary's receipt of
24 a certification from the corporation showing the moneys the corporation has
25 received from malt beverage distributors, microbreweries, and other private sources
26 since the last certification. The moneys disbursed from the fund shall be equal to the
27 contributions that the corporation has received from its members and other private

1 sources during that period. The moneys in the fund shall be disbursed in accordance
2 with a schedule established by the secretary, and shall be disbursed until the moneys
3 in the fund are exhausted or until the moneys in the fund lapse in accordance with
4 subsection (4) of this section, whichever comes first.

5 (4) Moneys that are credited to the fund and not issued to the corporation shall lapse at
6 the end of the fiscal year and shall be returned to the general fund.

7 (5) As a condition of receiving the governmental funds, the corporation's board of
8 directors shall include the following among its directors:

9 (a) The Governor or his or her designee;

10 (b) The Attorney General or his or her designee;

11 (c) The President of the Senate or his or her designee;

12 (d) The Speaker of the House or his or her designee;

13 (e) The secretary of the Cabinet for Health and Family Services or his or her
14 designee; and

15 (f) The commissioner of the Department of Alcoholic and Cannabis Beverage
16 Control or his or her designee.

17 (6) All expenditures of moneys from the fund shall be approved by a majority of those
18 persons set out in subsection (5)(a) to (f) of this section. If the moneys from the
19 fund are not expended in their entirety, any moneys that remain unused by the

21 (7) Any moneys from the fund that are not expended shall be returned to the general

3 As used in KRS Chapters 241 to 244, unless the context requires otherwise:

4 (1) "Alcohol" means ethyl alcohol, hydrated oxide of ethyl or spirit of wine, from
5 whatever source or by whatever process it is produced;

6 (2) "Alcoholic beverage" means every liquid, solid, powder, or crystal, whether
7 patented or not, containing alcohol in an amount in excess of more than one percent
8 (1%) of alcohol by volume, which is fit for beverage purposes. It includes every

10 alcoholic beverages, whether containing any alcohol or not. It does not include the

14 Institute of Homeopathy;

15 (b) Patented, patent, and proprietary medicines;

16 (c) Toilet, medicinal, and antiseptic preparations and solutions;

17 (d) Flavoring extracts and syrups;

18 (e) Denatured alcohol or denatured rum;

19 (f) Vinegar and preserved sweet cider;

20 (g) Wine for sacramental purposes; and

21 (h) Alcohol unfit for beverage purposes that is to be sold for legitimate external
22 use;

23 (3) (a) "Alcohol vaporizing device" or "AWOL device" means any device, machine,
24 or process that mixes liquor, spirits, or any other alcohol product with pure
25 oxygen or by any other means produces a vaporized alcoholic product used for
26 human consumption;

27 (b) "Alcohol vaporizing device" or "AWOL device" does not include an inhaler,

1 nebulizer, atomizer, or other device that is designed and intended by the
2 manufacturer to dispense a prescribed or over-the-counter medication or a
3 device installed and used by a licensee under this chapter to demonstrate the
4 aroma of an alcoholic beverage;

5 (4) "Automobile race track" means a facility primarily used for vehicle racing that has a
6 seating capacity of at least thirty thousand (30,000) people;

7 (5) "Bed and breakfast" means a one (1) family dwelling unit that:

8 (a) Has guest rooms or suites used, rented, or hired out for occupancy or that are
9 occupied for sleeping purposes by persons not members of the single-family
10 unit;

11 (b) Holds a permit under KRS Chapter 219; and

12 (c) Has an innkeeper who resides on the premises or property adjacent to the
13 premises during periods of occupancy;

14 (6) "Board" means the State Alcoholic Beverage Control Board created by KRS
15 241.030;

16 (7) "Bottle" means any container which is used for holding alcoholic beverages for the
17 use and sale of alcoholic beverages at retail;

18 (8) "Brewer" means any person who manufactures malt beverages or owns, occupies,
19 carries on, works, or conducts any brewery, either alone or through an agent;

20 (9) "Brewery" means any place or premises where malt beverages are manufactured for
21 sale, and includes all offices, granaries, mash rooms, cooling rooms, vaults, yards,
22 and storerooms connected with the premises; or where any part of the process of the
23 manufacture of malt beverages is carried on; or where any apparatus connected with
24 manufacture is kept or used; or where any of the products of brewing or
25 fermentation are stored or kept;

26 (10) "Building containing licensed premises" means the licensed premises themselves
27 and includes the land, tract of land, or parking lot in which the premises are

1 contained, and any part of any building connected by direct access or by an entrance
2 which is under the ownership or control of the licensee by lease holdings or
3 ownership;

4 (11) "Caterer" means a person operating a food service business that prepares food in a
5 licensed and inspected commissary, transports the food and alcoholic beverages to
6 the caterer's designated and inspected banquet hall or to an agreed location, and
7 serves the food and alcoholic beverages pursuant to an agreement with another

9 (12) "Charitable organization" means a nonprofit entity recognized as exempt from

13 and which expends at least sixty percent (60%) of its gross revenue exclusively for

16 more alcohol by volume and includes hard cider and perry cider;

17 (14) "City administrator" means city alcoholic beverage control administrator;

18 (15) "Commercial airport" means an airport through which more than five hundred
19 thousand (500,000) passengers arrive or depart annually;

20 (16) "Commercial quadricycle" means a vehicle equipped with a minimum of ten (10)
21 pairs of fully operative pedals for propulsion by means of human muscular power
22 exclusively and which:

23 (a) Has four (4) wheels;

24 (b) Is operated in a manner similar to that of a bicycle;

25 (c) Is equipped with a minimum of thirteen (13) seats for passengers;

26 (d) Has a unibody design;

27 (e) Is equipped with a minimum of four (4) hydraulically operated brakes;

- 1 (f) Is used for commercial tour purposes; and
- 2 (g) Is operated by the vehicle owner or an employee of the owner;
- 3 (17) "Commissioner" means the commissioner of the Department of Alcoholic Beverage
4 and Cannabis Control;
- 5 (18) "Convention center" means any facility which, in its usual and customary business,
6 provides seating for a minimum of one thousand (1,000) people and offers
7 convention facilities and related services for seminars, training and educational
8 purposes, trade association meetings, conventions, or civic and community events
9 or for plays, theatrical productions, or cultural exhibitions;
- 10 (19) "Convicted" and "conviction" means a finding of guilt resulting from a plea of
11 guilty, the decision of a court, or the finding of a jury, irrespective of a
12 pronouncement of judgment or the suspension of the judgment;
- 13 (20) "County administrator" means county alcoholic beverage control administrator;
- 14 (21) "Department" means the Department of Alcoholic Beverage and Cannabis Control;
- 15 (22) "Dining car" means a railroad passenger car that serves meals to consumers on any
16 railroad or Pullman car company;
- 17 (23) "Discount in the usual course of business" means price reductions, rebates, refunds,
18 and discounts given by wholesalers to distilled spirits and wine retailers pursuant to
19 an agreement made at the time of the sale of the merchandise involved and are
20 considered a part of the sales transaction, constituting reductions in price pursuant
21 to the terms of the sale, irrespective of whether the quantity discount was:

- 23 (b) Given in a lump sum after the entire quantity of merchandise purchased had

- 25 (c) Based on dollar volume or on the quantity of merchandise purchased;
- 26 (24) "Distilled spirits" or "spirits" means any product capable of being consumed by a
27 human being which contains alcohol in excess of the amount permitted by KRS

- 1 Chapter 242 obtained by distilling, mixed with water or other substances in
2 solution, except wine, hard cider, and malt beverages;
- 3 (25) "Distiller" means any person who is engaged in the business of manufacturing
4 distilled spirits at any distillery in the state and is registered in the Office of the
5 Collector of Internal Revenue for the United States at Louisville, Kentucky;
- 6 (26) "Distillery" means any place or premises where distilled spirits are manufactured for
7 sale, and which are registered in the office of any collector of internal revenue for
8 the United States. It includes any United States government bonded warehouse;
- 9 (27) "Distributor" means any person who distributes malt beverages for the purpose of
10 being sold at retail;
- 11 (28) "Dry" means a territory in which a majority of the electorate voted to prohibit all
12 forms of retail alcohol sales through a local option election held under KRS Chapter
13 242;
- 14 (29) "Election" means:
- 15 (a) An election held for the purpose of taking the sense of the people as to the
16 application or discontinuance of alcoholic beverage sales under KRS Chapter
17 242; or
- 18 (b) Any other election not pertaining to alcohol;
- 19 (30) "Horse racetrack" means a facility licensed to conduct a horse race meeting under
20 KRS Chapter 230;
- 21 (31) "Hotel" means a hotel, motel, or inn for accommodation of the traveling public,
22 designed primarily to serve transient patrons;
- 23 (32) "Investigator" means any employee or agent of the department who is regularly
24 employed and whose primary function is to travel from place to place for the
25 purpose of visiting licensees, and any employee or agent of the department who is
26 assigned, temporarily or permanently, by the commissioner to duty outside the main
27 office of the department at Frankfort, in connection with the administration of

- 1 alcoholic beverage statutes;
- 2 (33) "License" means any license issued pursuant to KRS Chapters 241 to 244;
- 3 (34) "Licensee" means any person to whom a license has been issued, pursuant to KRS
4 Chapters 241 to 244;
- 5 (35) "Limited restaurant" means:
- 6 (a) A facility where the usual and customary business is the preparation and
7 serving of meals to consumers, which has a bona fide kitchen facility, which
8 receives at least seventy percent (70%) of its food and alcoholic beverage
9 receipts from the sale of food, which maintains a minimum seating capacity of
10 fifty (50) persons for dining, which has no open bar, which requires that
11 alcoholic beverages be sold in conjunction with the sale of a meal, and which
12 is located in a wet or moist territory under KRS 242.1244; or
- 13 (b) A facility where the usual and customary business is the preparation and
14 serving of meals to consumers, which has a bona fide kitchen facility, which
15 receives at least seventy percent (70%) of its food and alcoholic beverage
16 receipts from the sale of food, which maintains a minimum seating capacity of
17 one hundred (100) persons of dining, and which is located in a wet or moist
18 territory under KRS 242.1244;
- 19 (36) "Local administrator" means a city alcoholic beverage administrator, county
20 alcoholic beverage administrator, or urban-county alcoholic beverage control
21 administrator;
- 22 (37) "Malt beverage" means any fermented undistilled alcoholic beverage of any name or
23 description, manufactured from malt wholly or in part, or from any substitute for
24 malt, and includes weak cider;
- 25 (38) "Manufacture" means distill, rectify, brew, bottle, and operate a winery;
- 26 (39) "Manufacturer" means a winery, distiller, rectifier, or brewer, and any other person
27 engaged in the production or bottling of alcoholic beverages;

- 1 (40) "Minor" means any person who is not twenty-one (21) years of age or older;
- 2 (41) "Moist" means a territory in which a majority of the electorate voted to permit
3 limited alcohol sales by any one (1) or a combination of special limited local option
4 elections authorized by KRS 242.022, 242.123, 242.1238, 242.124, 242.1242,
5 242.1243, 242.1244, or 242.1292;
- 6 (42) "Population" means the population figures established by the federal decennial
7 census for a census year or the current yearly population estimates prepared by the
8 Kentucky State Data Center, Urban Studies Center of the University of Louisville,
9 Louisville, Kentucky, for all other years;
- 10 (43) "Premises" means the land and building in and upon which any business regulated
11 by alcoholic beverage statutes is operated or carried on. "Premises" shall not include

14 separation of the premises is maintained, excluding employee access by keyed entry

18 subsection, be ineligible to continue to hold his or her license or obtain a renewal,

- 20 (44) "Primary source of supply" or "supplier" means the distiller, winery, brewer,
21 producer, owner of the commodity at the time it becomes a marketable product,
22 bottler, or authorized agent of the brand owner. In the case of imported products, the
23 primary source of supply means either the foreign producer, owner, bottler, or agent
24 of the prime importer from, or the exclusive agent in, the United States of the
25 foreign distiller, producer, bottler, or owner;
- 26 (45) "Private club" means a nonprofit social, fraternal, military, or political organization,
27 club, or entity maintaining or operating a club room, club rooms, or premises from

1 which the general public is excluded;

2 (46) "Public nuisance" means a condition that endangers safety or health, is offensive to
3 the senses, or obstructs the free use of property so as to interfere with the
4 comfortable enjoyment of life or property by a community or neighborhood or by
5 any considerable number of persons;

6 (47) "Qualified historic site" means:

7 (a) A contributing property with dining facilities for at least fifty (50) persons at
8 tables, booths, or bars where food may be served within a commercial district
9 listed in the National Register of Historic Places;

10 (b) A site that is listed as a National Historic Landmark or in the National
11 Register of Historic Places with dining facilities for at least fifty (50) persons
12 at tables, booths, or bars where food may be served;

5 obtained. The Department of Alcoholic Beverage and Cannabis Control shall
6 prepare annually, for submission by the Governor to the Secretary of the United
7 States Department of Health and Human Services, the report required by Section
8 1926 of Subpart 1 of Part B of Title XIX of the Federal Public Health Service Act.

9 (2) The Department of Alcoholic Beverage and Cannabis Control shall develop and
10 implement the survey sampling methodologies to carry out the inspections as
11 described in this section.

12 ➔Section 68. KRS 438.337 is amended to read as follows:

13 (1) Except for violations of the provisions of KRS 438.311, 438.313, and 438.315 by a
14 juvenile, which shall be under the jurisdiction of the juvenile session of the District
15 Court, the Department of Alcoholic Beverage and Cannabis Control shall carry out
16 the enforcement provisions of KRS 438.305 to 438.340.

17 (2) The Department of Alcoholic Beverage and Cannabis Control shall be entitled to
18 the revenue produced by one-twentieth of one cent (\$0.0005) of the three-cent
19 (\$0.03) per pack revenue collected by the Finance and Administration Cabinet from
20 the state excise tax on the sale of cigarettes as imposed by KRS 138.140 to be
21 deposited in a trust and agency account created in the State Treasury, and to keep
22 fifty percent (50%) of any fines collected under KRS 438.305 to 438.340 to offset
23 the costs of enforcement of KRS 438.305 to 438.340.

24 (3) The Department of Alcoholic Beverage and Cannabis Control shall be responsible
25 for maintaining statistics for compilation of required reports to be submitted to the
26 United States Department of Health and Human Services.

27 (4) The Department of Alcoholic Beverage and Cannabis Control shall devise a plan

1 and time frame for enforcement to determine by random inspection if the percentage
2 of retailers or distributors making illegal sales to minors does or does not exceed
3 federal guidelines preventing tobacco sales to minors.

4 ➔Section 69. KRS 438.340 is amended to read as follows:

5 The Department of Alcoholic Beverage and Cannabis Control and the Department of
6 Agriculture are authorized to promulgate administrative regulations pursuant to KRS
7 Chapter 13A as necessary to implement and carry out the provisions of KRS 438.305 to
8 438.340.
