3	Section 1. KRS 527.010 is amended to read as follows:
4	The following definitions apply in this chapter unless the context otherwise requires:
5	(1) (a) "Assault weapon" means:
6	1. A semiautomatic rifle that has the capacity to accept a detachable
7	magazine and has at least two (2) of the following characteristics:
8	a. A folding or telescoping stock;
9	b. A pistol grip that protrudes conspicuously beneath the action of
10	<u>the weapon;</u>
11	c. A protruding grip that can be held by the nontrigger hand;
12	d. A thumbhole stock;
13	e. A suppressor, flash suppressor, muzzle break, muzzle
14	compensator, or threaded barrel designed to accommodate a
15	flash suppressor, muzzle break, or muzzle compensator; or
16	<u>f. A grenade launcher;</u>
17	2. A semiautomatic shotgun that has at least two (2) of the following
18	characteristics:
19	a. A folding or telescoping stock;
20	b. A protruding grip that can be held by the nontrigger hand;
21	c. A fixed magazine capacity in excess of ten (10) rounds; or
22	d. An ability to accept a detachable magazine;
23	3. A semiautomatic pistol that has the capacity to accept a detachable
24	magazine and has at least two (2) of the following characteristics:
25	a. A folding or telescoping stock;
26	b. A protruding grip that can be held by the nontrigger hand;
27	c. The capacity to accept a detachable magazine at any location

1		outside of the pistol grip;
2		d. A threaded barrel capable of accepting a barrel extender, flash
3		suppressor, forward handgrip, or suppressor;
4		e. A shroud that is attached to, or partially or completely encircles,
5		the barrel and that permits the shooter to hold the firearm with
6		the nontrigger hand without being burned; or
7		f. A manufactured weight of fifty (50) ounces or more when the
8		pistol is unloaded;
9		4. A semiautomatic version of an automatic rifle, shotgun, or firearm;
10		5. A revolving cylinder shotgun; or
11		6. Conversion kit, part, or combination of parts, from which an assault
12		weapon can be assembled if those parts are in the possession or under
13		the control of the same person.
14	<u>(b)</u>	"Assault weapon" does not include:
15		1. Any rifle, shotgun, or pistol that is manually operated by bolt, pump,
16		lever, or slide action, which has been rendered permanently
17		inoperable, or which is an antique firearm as defined in 18 U.S.C. sec.
18		921(a)(16);
19		2. A semiautomatic rifle that cannot accept a detachable magazine that
20		holds more than five (5) rounds of ammunition; or
21		3. A semiautomatic shotgun that cannot hold more than five (5) rounds
22		of ammunition in a fixed or detachable magazine;
23	<u>(2)</u> "Boo	by trap device" shall have the same meaning as set forth in KRS 237.030.
24	<u>(3)</u> [(2)]	"Deface" means to remove, deface, cover, alter, or destroy the manufacturer's
25	seria	l number or any other distinguishing number or identification mark.
26	<u>(4)</u> [(3)]	"Destructive device" shall have the same meaning as set forth in KRS
27	237.	030.

1 "Firearm" means any weapon which will expel a projectile by the action of an (5)[(4)]2 explosive. 3 "Handgun" means any pistol or revolver originally designed to be fired by the <u>(6)[(5)]</u> 4 use of a single hand, or any other firearm originally designed to be fired by the use 5 of a single hand; and 6 "Large-capacity ammunition-feeding device" means a magazine, belt, drum, feed (7) 7 strip, or similar device that has a capacity of, or that can be readily restored or converted to accept, more than ten (10) rounds of ammunition, but does not 8 9 include an attached tubular device designed to accept, and capable of operating 10 only with, .22 caliber rimfire ammunition or a feeding device that is a curio or 11 relic. To qualify as a curio or relic feeding device under this subsection, it must 12 be a feeding device that: Was manufactured at least fifty (50) years prior to the current date, not 13 (a)14 including replicas thereof; (b) Is only capable of being used exclusively in a firearm, rifle, or shotgun that 15 was manufactured at least fifty (50) years prior to the current date, not 16 17 including replicas thereof; and (c) Is possessed by an individual who is not prohibited by state or federal law 18 19 from possessing a firearm. → SECTION 2. A NEW SECTION OF KRS CHAPTER 527 IS CREATED TO 20 21 **READ AS FOLLOWS:** 22 Except as provided in subsection (3) of this section, a person is guilty of (1) 23 possession or transfer of a large-capacity ammunition-feeding device when he or 24 she knowingly either: 25 (a) Possesses a large-capacity ammunition-feeding device; **(b**) Transfers a large-capacity ammunition-feeding device to another person. 26 (2) Possession or transfer of a large-capacity ammunition-feeding device is a Class A 27

2	<u>(3)</u>	This section shall not apply to a person who is:
3		(a) A member of the Armed Forces of the United States, a reserve component
4		thereof, or the National Guard;
5		(b) A law enforcement officer as defined in KRS 15.310; or
6		(c) In compliance with Section 3 of this Act.
7		→SECTION 3. A NEW SECTION OF KRS CHAPTER 527 IS CREATED TO
8	REA	AD AS FOLLOWS:
9	(1)	Within one (1) year after the effective date of this Act, a person who lawfully
10		owns any large-capacity ammunition-feeding device on the effective date of this
11		<u>Act shall:</u>
12		(a) Register with the Department of Kentucky State Police as the certified
13		owner of each large-capacity ammunition-feeding device that the person
14		elects to continue to possess;
15		(b) Transfer the large-capacity ammunition-feeding device to any person
16		outside of Kentucky lawfully entitled to own or possess the device; or
17		(c) Render the large-capacity ammunition-feeding device permanently
18		<u>inoperable.</u>
19	(2)	The Department of Kentucky State Police shall administer a program through
20		which the owners of large-capacity ammunition-feeding devices who elect to
21		continue to possess those devices more than one (1) year after the effective date of
22		this Act shall register as the owners of individual large-capacity ammunition-
23		feeding devices.
24	<u>(</u> 3)	The department shall promulgate administrative regulations to administer this
25		program, and may establish a fee sufficient to cover the costs of its
26		administration.

A NEW SECTION OF KRS CHAPTER 237 IS CREATED TO **READ AS FOLLOWS:** 13 14 (1) (a) 1. As used in this section, "permanently inoperable" means that the 15 assault weapon is altered in such a manner that it cannot be fired and 16 that the owner or possessor of the firearm does not possess or have control over the parts necessary to make the firearm operable; and 17 As used in this section, "temporarily inoperable" means that when the 18 *2*. 19 assault weapon is not in the direct control of the registered owner, it is 20 stored using an integrated design feature or attachable accessory that will prevent the use of the weapon by an unauthorized user. 21 22 (b) Within one (1) year after the effective date of this Act, a person who lawfully owns any assault weapon as defined in Section 1 of this Act on the 23 effective date of this Act shall: 24 Register with the Department of Kentucky State Police as the 25 1. a. 26 certified owner of each assault weapon that the person elects to 27 continue to possess; and

1	b. Store the weapon with devices which render the weapon
2	temporarily inoperable, in accordance with subsection (2) of this

4	2. Transfer the assault weapon to any person lawfully entitled to own or
5	possess the firearm;
6	3. Transfer the assault weapon to the Department of Kentucky State
7	Police buyback program in accordance with subsection (3) of this
8	section; or
9	4. Render the assault weapon permanently inoperable.
10	(2) (a) The Department of Kentucky State Police shall administer a program
11	through which the owners of assault weapons who elect to continue to
12	possess assault weapons more than one (1) year after the effective date of
13	this Act shall:
14	1. Register as the owners of individual assault weapons; and
15	2. Receive devices approved by the department and designed to render
16	the weapon temporarily inoperable when it is not under the direct
17	control of the registered owner.
18	(b) The department shall promulgate administrative regulations to administer
19	this program, and may establish a fee sufficient to cover the costs of its
20	administration.
21	(3) The Department of Kentucky State Police shall administer a buyback program
22	through which an assault weapon is voluntarily transferred to the Department of
23	Kentucky State Police by the owner of the weapon in exchange for the estimated
24	cash value of the weapon. The buyback program shall be funded by the fees
25	collected from the registration of assault weapons under this section.
26	(4) (a) A trust and agency account to be known as the Assault Weapon
27	<u>Registration fund is hereby established in the State Treasury. The fund</u>

→ Section 6. KRS 16.220 is amended to read as follows:	
25 (1) Subject to the duty to return confiscated firearms to innocent owners purs	uant to

1 auction to federally licensed firearms dealers holding a license appropriate for the 2 type of firearm sold. Any provision of KRS Chapter 45 or 45A relating to 3 disposition of property to the contrary notwithstanding, the Department of Kentucky State Police shall: 4 5 Conduct any auction specified by this section; (a) 6 (b) Retain for departmental use twenty percent (20%) of the gross proceeds from 7 any auction specified by this section; and 8 (c) Transfer remaining proceeds of the sale to the account of the Kentucky Office 9 of Homeland Security for use as provided in subsection (4) of this section. 10 Prior to the sale of any firearm, the Department of Kentucky State Police shall make (2)11 an attempt to determine if the firearm to be sold has been stolen or otherwise 12 unlawfully obtained from an innocent owner and return the firearm to its lawful 13 innocent owner, unless that person is ineligible to purchase a firearm under federal 14 law. 15 (3)The Department of Kentucky State Police shall receive firearms and ammunition 16 confiscated by or abandoned to every law enforcement agency in Kentucky. However, firearms which are not retained for official 19 use, returned to an innocent lawful owner, or transferred to another government agency or public museum shall be sold as provided in subsections (1) and (3) of this 20 21 section. 22 (4) The proceeds of firearms sales shall be utilized by the Kentucky Office of 23 Homeland Security to provide grants to city, county, charter county, unified local 24 government, urban-county government, and consolidated local government police

departments; university safety and security departments organized pursuant to KRS
164.950; school districts that employ special law enforcement officers as defined in
KRS 61.900; and sheriff's departments for the purchase of:

7 In awarding grants under this section, the Kentucky Office of Homeland Security 8 shall give first priority to providing and replacing body armor and second priority to 9 providing firearms and ammunition, with residual funds available for the purchase 10 of body-worn cameras, electronic control devices, electronic control weapons, or 11 electro-muscular disruption technology. Body armor purchased by the department 12 receiving grant funds shall meet or exceed the standards issued by the National 13 Institute of Justice for body armor. No police or sheriff's department shall apply for 14 a grant to replace existing body armor unless that body armor has been in actual use 15 for a period of five (5) years or longer. Any department applying for grant funds for 16 body-worn cameras shall develop a policy for their use and shall submit that policy 17 with its application for the grant funds to the Office of Homeland Security as part of 18 the application process.

19 (5)The Department of Kentucky State Police may transfer a machine gun, short-20 barreled shotgun, short-barreled rifle, silencer, pistol with a shoulder stock, any 21 other weapon, or destructive device as defined by the National Firearms Act which 22 is subject to registration under the National Firearms Act and is not properly 23 registered in the national firearms transfer records for those types of weapons, to the 24 Bureau of Alcohol, Tobacco, and Firearms of the United States Department of 25 Justice, after a reasonable attempt has been made to transfer the firearm to an 26 eligible state or local law enforcement agency or to an eligible museum and no 27 eligible recipient will take the firearm or weapon. 9		have the right to revoke, suspend, limit the use of, or otherwise impair the validity
10		of the right of any person to purchase, transfer, loan, own, possess, carry, or use a
11		firearm, firearm part, ammunition, ammunition component, or any deadly weapon
12		or dangerous instrument.
13	(2)	No person, unit of government, or governmental organization shall, during a period
14		of disaster or emergency as specified in KRS Chapter 39A or at any other time,
15		take, seize, confiscate, or impound a firearm, firearm part, ammunition, ammunition
16		component, or any deadly weapon or dangerous instrument from any person.
17	(3)	The provisions of this section shall not apply to the taking of an item specified in
