

1 AN ACT relating to the selling farmers tax credit.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. There is appropriated out of the general fund, federal funds, and the  
4 transportation fund in the State Treasury for the purpose of compensating persons and  
5 companies named below for claims which have been duly audited and approved  
6 according to law, but have not been paid because of lapsing or insufficiency of former  
7 appropriations against which the claims were chargeable, or the lack of an appropriate  
8 procurement document in place, the amounts listed below:
