Beginning on page 33, line 5, and continuing to page 34, line 6, by deleting paragraph (c) and (d) in its entirety and inserting the following in lieu thereof:

- "(c) 1. The minimum service requirement to participate in benefits as provided by paragraph (a) of this subsection shall be waived for a member who receives a satisfactory determination of a hazardous disability that is ~~disabled as~~ a direct result of an act in line of duty as defined in KRS 16.505, and the member or his spouse and eligible dependents shall be entitled to the benefits payable under this subsection as though the member had twenty (20) years of service in a hazardous position.
- ~~2. The minimum service required to participate in benefits as provided by paragraph (a) of this subsection shall be waived for a member who is disabled by a duty related injury as defined in KRS 61.621, and the member shall be entitled to the benefits payable under this subsection as though the member has twenty (20) years of service in a nonhazardous position.~~
- ~~3.~~ Notwithstanding the provisions of this section, the minimum service required to participate in benefits as provided by paragraph (a) of this subsection shall be waived for a member who dies as a direct result of an act in line of duty as defined in KRS 16.505, who becomes totally and permanently disabled as a

*direct result of an act in line of duty as defined in Section 1 of this Act,* ~~for~~  
who dies as a result of a duty-related injury as defined in KRS 61.621, *or*  
*becomes disabled as a result of a duty-related injury as defined in Section 3 of*  
*this Act,* and the premium for the *member,* member's spouse, and for each  
dependent child as defined in KRS 16.505 shall be paid in full by the systems so  
long as they individually remain eligible for a monthly retirement benefit.

- (d) Except as provided by paragraph *(c)2.*~~*(c)3.*~~ of this subsection, the monthly insurance contribution amount shall be increased July 1 of each year by one and one-half percent (1.5%). The increase shall be cumulative and shall continue to accrue after the member's retirement for as long as a monthly insurance contribution is payable to the retired member or beneficiary."
