1 A JOINT RESOLUTION directing all hospitals offering emergency services, the 2 Kentucky Board of Nursing, the Kentucky Association of Sexual Assault Programs, and 3 the Kentucky Office of Victim Advocacy to report information relating to sexual assault 4 nurse examiners and sexual assault medical-forensic examinations.

5 WHEREAS, nearly one in two women and one in five men in Kentucky reported 6 being violated by contact sexual violence at some point in their lives, an estimated one in 7 five women have experienced sexual violence involving rape, nearly one in two women 8 in have experienced sexual violence in some form other than rape, and almost one in five 9 men in Kentucky have experienced sexual violence at some point in their lifetime; and

WHEREAS, the purpose of a sexual assault medical-forensic exam is to provide trauma informed care while assessing a victim's healthcare needs, coordinating treatment of any injuries, and collecting evidence for use during any potential case investigation and prosecution; and

WHEREAS, a medical-forensic examination includes gathering a medical forensic history or narrative statement from the patient, conducting a thorough head-to-toe physical examination of the patient, consulting for the appropriate treatment of the patient's injuries, collecting physical evidence from the patient, providing the patient with information, making referrals any necessary treatment, and following up with the patient as needed to provide additional treatment or evidence collection; and

WHEREAS, medical-forensic examinations are meant to document and collect evidence on assault-related trauma such as scratches, bruises, abrasions, and other injuries on a body, including photos of injuries, DNA swabs, and observations of the patient's behavior that could be used in a criminal trial; and

WHEREAS, people who have been sexually assaulted are encouraged to have a sexual assault medical-forensic evidence nurse examination performed as soon as possible after an assault because past a 96-hour period, any collectable evidence could potentially have been lost; and

1 WHEREAS, not all hospitals have credentialed sexual assault nurse examiners so 2 patients sometimes are required to travel long distances to obtain sexual assault medical-3 forensic examinations, which means that patients are faced with increased wait times and 4 transfers to other facilities, or receiving an examination by medical professionals who 5 have not received sexual assault medical-forensic training; and

6 WHEREAS, the facilities that have credentialed sexual assault nurse examiners
7 must be ready to do what they can to help every patient who walks in the door; and

8 WHEREAS, in cases where toxicology information is relevant, sexual assault nurse 9 examiners may also gather blood and urine specimens as appropriate to perform 10 necessary tests; and

11 WHEREAS, the effects of experiencing an assault can be both physical and 12 psychological, necessitating specialized care that embodies the concept of care for the 13 entire person;

14 NOW, THEREFORE,

# 15 Be it resolved by the General Assembly of the Commonwealth of Kentucky:

Section 1. The Cabinet for Health and Family Services shall direct each hospital
licensed in Kentucky that offers emergency services to submit a report by July 1, 2021, to
the Sexual Assault Response Team Advisory Committee including the following
information:
